Several changes in our teaching positions were necessitated this year through the loss of 4 teachers to other school systems. We were fortunate in securing replacements for these teachers. Principal Robert Anderson is to be commended for his efforts in the administration of the school. Under his direction a physical education program, patterned along the lines of the President's Physical Fitness program, has been started.

The hot lunch program continues to prove successful under the guidance of Mrs. Jones. We again commend the Mothers' Club for their continued interest in this project.

During the summer months the school was painted both inside and out. This has done much to enhance the beauty of the building as well as, to afford surface protection.

I wish to point out that the hiring of competent teachers has become extremely competitive. If we are to continue to provide adequate educational opportunities to our children, we must try to keep our salaries somewhat near the level of those paid in nearby communities.

Another big item in our budget is the secondary tuition charges. These increase each year as the surrounding communities increase their own expenditures for secondary education. We also have plans for the improvement of our offerings in the field of science. This is necessary in order that our pupils are not placed at a disadvantage when they move on to the secondary level.

We are also investigating the possibility of adding the phonetics approach to reading now being experimented with in nearby communities.

ANNUAL REPORT OF PUBLIC

HEALTH NURSE

Arundel, Maine

It hardly seems possible that the year 1962, my first, as Public Health Nurse, in Arundel, Maine, has rolled by. It has been an interesting, enjoyable and rewarding one for me. Much of the success that I have had, belongs to the people themselves.

As you know Public Health is the sum total of the health of individuals and families living in a community. An organized program for public health is one that offers those individuals and their families every possible chance of living and enjoying life free from the handicaps of preventable and controllable disease and disability. The objective of a public health program is to bring to all people the benefits of modern medicine and science, including the care and rehabilitation of the sick and disabled.

A number of people are involved in attaining this objective. Together these people make up the health team. A vital dynamic health team in the local community strengthens the health ot the community, the state and the Nation. The strength of the nation depends more upon the health of its citizens, than, upon the number of its missiles.

The public health nurse as a member of the health team has many objectives, one of which, is to promote the independence of the family in caring for its own health problems. The nurse will supplement family care as necessary. Health guidance may be given directly, as part of the nursing visit, or, through conferences with parents, teachers, or other health members.

Since health habits good or bad are established early in the formative years, it is important to see that children get a healthy start in life which should improve their chances of having good health in adult life.

School Health Services

Conferences were held with the principal and teachers regarding health problems. Physical examinations were given to those pupils who did not have an examination by their own physician. Grades 1, 3, 5, 7 were examined a total of 53 pupils. Hearing tests were done on pupils in these grades a total of 82 tests. Vision tests were done on those pupils referred by the teachers. Retests were essentially the same as those found by the teachers, parents were notified and most of the pupils in need of glasses have them.

The hot lunch program under the supervision of Mrs. Mildred Jones has been a valuable teaching tool in providing good nutrition for those pupils in the school, as well as the teachers, parents and members of the health council.

Child Health Conferences

Child health Conferences were held from April through November on the second Tuesday of the month between the hours of 10:00 and 12:00 noon. Immunizations for Polio, Diphtheria, Whooping-Cough, tetanus and small pox vaccinations are offered at these clinics. A total attendance for the year was 132.

Two days, or sixteen hours a week is allotted to the Town of Arundel for service, school, child health conferences, and, home visits. For the year I made 264 visits. They were as follows:

HISTORY OF ARUNDEL HEALTH COUNCIL

AND COMMUNITY CLUB

In 1942 the Town of Kennebunkport requested North Kennebunkport's cooperation in securing the services of a public health nurse under the Enabling Act. However, it was not until the spring of 1947 that a nurse was available for these towns. Under the Enabling Act, the state agreed to pay half of the nurse expense (salary and mileage), Kennebunkport two-thirds of the remaining half and North Kennebunkport one-third. The first child health conference was held in June of 1947 and these have been held each year until the present time.

The Health Council was organized officially in September of 1947. A blanket raffle was held to finance the first physical examinations for the school children. In May of 1948 a bean supper was held to raise money for a dental hygiene program for the schools the following year.

As accurately as dates can be ascertained from old records the North Chapel Mother's Club was organized in 1943, the Burnham School Mother's Club was organized in 1950, and the Mother's Clubs combined with the Health Council in September of 1957.

Many hours of labor have been donated by conscientious members over the years in an effort to improve the general health of our school children and to make our whole community more aware of our health needs.

Methods of raising funds have been food sales, raffles, bean suppers, bazaars, Chinese auctions, rummage sales, dances, profits from selling articles (vanilla, pepper, aprons, cosmetics, toothbrushes, Christmas candy, Christmas corsages), cake decorating classes, a toy party, and a silk party. A certain sum has been realized from dues, penny collections and mystery prize collections at meetings, child health clinic fees for shots, and nursing fees. We have also been fortunate in that there were various donations at the time of the opening of our new school in 1960 for equipping the kitchen.

Listed below are some of the ways our funds have been used: Health Clinics—Present expenses Doctor \$15.00 (formerly paid by the state)

REPORT OF TREE WARDEN FOR 1962

This year, again, your Tree Warden has been concerned principally with control of Dutch Elm Disease. To make our appropriation of \$300.00 go as far as possible the State Forestry Service agreed to continuing concentration of this work in two areas;—Lower River Road, next to Kennebunkport, and Arundel Market, U.S. 1 and Old Limerick Road, with other action limited to badly diseased roadside trees.

In all areas the property owners paid one half the cost of removing diseased roadside trees, while the State Highway Department removed the debris to the dump after cutting. Dormant spray and "Sanitation" (pruning) needed to keep Arundel eligible for State rebates was carried out in the control areas in cooperation with the property owners.

Sharing removal costs with property owners, State rebates on last year's work and aid from the State Highway Department enabled us to get over \$1,000.00 worth of work, removal, sanitation and spraying for our appropriation of \$300.00.

All last year's cuttings were burned or buried at the dump by April 15th. In July an additional 18 diseased and two dying elms were identified. 14 had been removed by December 15th with the remaining six, all off the roadsides, still remaining to be taken down by the property owners. Each tree has been tagged and the owners notified. The State requires this to be completed by April 15th 1963.

Only one tree was removed from the River Road area this year compared with a total of eight in the past two seasons, indicating the possibility of some progress toward reducing losses from Dutch Elm Disease through rigid application of the control program. But a tremendous job still exists in the rest of the town. No control work and little inspection has been carried out beyond the fringes of the present areas. Until more is known about the disease we must extend our efforts if we are to save any of the remaining Elms.

Since help from the State Highway Department is limited to

removal of roadside trees, after cutting, on properties adjoining or near to U.S. 1, we can look forward to less and less assistance from that source.

Yet, results in our own River Road area as well as those in Kennebunkport, prove that the disease can be greatly reduced if not completely eliminated. Accordingly a further increase m the Arundel appropriation for this purpose will be recommended for consideration by the Budget Committee for the 1963-64 year.

The white pine blister rust control work in Arundel was limited to 326 acres during 1962. However, on this area we found and destroyed 4,840 wild currant and gooseberry plant which are the alternate hosts of the disease. The total cost of this work was \$398.20 which was equally divided between Arundel and the State of Maine.

There is nearly 2,000 acres scheduled for work in Arundel during 1963 and I expect that you will soon receive a letter from the Forest Commissioner relating to this.

COMMENTS

Cash

The cash balances, as noted in the balance sheet, were reconciled with the bank statements and a written confirmation of the balances was made.

Uncollected Taxes

A percentage of the uncollected taxes, as shown on the collector's records at December 31, 1962, and unpaid tax liens, were verified by written confirmation with the taxpayer.

Special Funds

Cemetery Trust Funds were found to be on deposit in properly designated accounts and were verified by written confirmation with the several bank depositories.

General

The procedure for keeping the municipal records of the town officers were examined, and found to be adequate, and in compliance with the General Laws of the State of Maine, as approved by State Department Audit.

Scope of Audit

This audit was made as required by the State Department of Audit, Chapter 405, Section 26, of the General Laws of 1957.

Records were checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as to the handling of cash and other matters of financial concern. External verifications, on a test basis, were utilized to determined the corrections of recorded assets and liabilities.

Receipts, vouchers and cancelled checks were examined, for authenticity, for a selected period. Bond and insurance coverages were examined. Excise tax collections for a selected period were verified with copies of the receipts retained by the Tax Collector.

Art. 27. To see if the Town will vote to raise and appropriate by assessment the sum of \$1,500.00 for the purchase of a fire truck.

Art. 28. To see if the Town will vote to authorize a 2% discount on all property taxes paid in full within thirty days of receiving the bill.

Art. 29. To see if the Town will authorize the Collector of Taxes to charge interest at 6% on all unpaid property after December 1st.
