Report of the Superintendent of Schools

To the Honorable School Committee, Board of Selectmen and Citizens of North Kennebunkport:

LADIES AND GENTLEMEN:

It gives me great pleasure to submit this, my ninth, annual report of schools.

This year we have felt the real strength of the depression. The enrollment of the schools has more than held its own. Six new seats were purchased for Iron Bridge School, but the older pupils of this school who were over the compulsory school age went off into industry so that only part of these were needed. Some were transferred to Burnham School and some of them were sent to the Irving School.

The roof on the Irving School building was in such a poor condition that, although the appropriation was insufficient to care for this item, Mr. Ernest Ricker consented to have this fixed, after consultation with the school committee.

Your school buildings are in a very poor state of repair outside. All five buildings are suffering for paint. At the Irving School, under the direction of the teacher, the pupils put on a program and box supper which netted them sufficient funds to paint this building. They expect to carry the project through in the early spring.

Some of the schoolrooms are beginning to be very dark and smoked up and should be murescoed this spring. The light is so very poor at present that much eye strain is caused toward the close of the school day during the winter months. In the cities they have electric lights for the very dark days, but reflected light from.

newly freshened ceiling helps amazingly. I recommend that two schools, the Durell and the Burnham, be done this summer.

The textbook needs are increasing somewhat, due to the very much larger classes than formerly at some of the schools. In the schools recently opened, we have more pupils than had been expected. Each time these pupils are promoted, they have to be supplied with such texts as are used in their particular grade.

The expense attached to the school committee which should have come in on last year's account did not arrive until it was too late to be included, so makes a slightly larger overdraft than was anticipated.

Let me point out that Burnham School is now carrying a capacity enrollment. If there are increases at this school in the enrollment, you must either re-allocate the pupils or place the extra room in repair and hire another teacher.

Determined demands were made by parents living on Route 1, Atlantic highway, for transportation. The committee consulted both the State Supervisor and the selectmen as to what should be the attitude of the town toward transportation for these people who are nearly midway between the Iron Bridge and the Durell Schools. The distance was measured from Durell over the woods road emerging on the Atlantic highway .near the Log Cabin and was found to be 1 and 3/10 miles. It is not more than 5/10 of a mile from the Log Cabin to Bedard's Hill opposite their house, making the total distance to the school building at Durell 1 and 8/10 miles. Wishing to be perfectly fair with these people who desire transportation for their children, it was determined to call a town meeting. Consequently a town meeting was called and the results were decidedly against extra expense at this time. The committee was instructed to enforce the truancy law.

FINANCIAL

Your attention is called to a comparison of school and municipal costs of North Kennebunkport and the average costs prevailing throughout the State. The average school rate of Maine is .01087. The school rate for North Kennebunkport is .01104. Your school rate is, therefor .00017 above the average. You are now maintaining five schools, whereas formerly you only maintained three schools. One of these five schools will be overcrowded this coming fall. The average municipal rate is .018. The . town rate is .0428 or .0052 below the State rate.

The gross amount of State subsidy was more this year than last, due to the increased census, number of schools maintained and the large enrollment of pupils in High School on which these returns were made.

There are six pupils in Kennebunk High School. three in Thornton Academy, four in Biddeford High School, and one in Kennebunkport High School.

There are eight pupils of North Kennebunkport at the Alewive School in Kennebunk, three in the Kennebunk port town house Grammar School, and four in the Kennebunkport town house Primary School. The tuition of these elementary pupils is \$1.00 per week. A 1 tuition charges are in the nature of fixed costs since thev cannot be changed. The greatly increased enrollment of pupils since the depression is especially evident in your elementary schools. You can readily see that if conditions continue until the larger classes now coming along in the grades begin to enter High School, as they w "1 shortly, school costs must further increase. Your widely scattered districts seem to compel the set-up you now have. There are abundant evidences that another teacher may be needed this year in the Burnham district.

Your attention is directed to the financial statement appended to this report.

Let me take this space to express to the superintending school committee, board of selectmen, and other Hofficers of your town, and to the many citizens at large, my firm conviction that you desire the best for your children and will not, whatever the depression may bring, allow your children to be handicapped because of curtailed educational privilege.

These are difficult times and our faith has been tested, but we have confidence in our institutions and our goveminent to adjust to this new day that lies ahead.

WARRANT

For Town Meeting, March 5, 1934

STATE OF MAINE

COUNTY OF YORK, SS.

To Florence R. Hayes, Constable of the Town of North Kennebunkport, in said County, GREETING:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the town house, in said town, on the 5th day of March, 1934, at ten o'clock in the forenoon, to act on the following articles, to wit:

- Article 1. To choose a moderator to preside at said meeting.
- Article 2. To see if the town will vote to dispense with the use of the check list at this meeting.
- Article 3. To choose all necessary town officers for the ensuing year.
- Article 4. To see what sum of money the town will vote to raise for the support of the common schools.
- Article 5. To see what sum of money the town will vote to raise for high school tuition.
- Article 6. To see what sum the town will vote to raise for repairs and insurance on school buildings.
- Article 7. To see what sum the town will vote to raise for free textbooks.
- Article 8. To see what sum the town will vote to raise for school supplies.

Article 9. To see if the town will vote to raise a sum of money for purchase of school flags.

Article 10. To see what sum of money the town will vote to raise for salary of superintendent of schools.

Article 11. To see what sum of money the town will vote to grant and raise for the repair of roads and bridges, and see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on highways.

Article 12. To see if the town will vote, grant and raise a sum of money to cut and destroy all bushes on State highway. State Aid, and third class roads, to comply with Chapter 145, P. L., 1927, and if so, how much.

Article 13. To see if the town will vote, grant and raise the sum of three hundred sixty-two dollars to repair and maintain third class road, to comply with Sections 43 to 47 of Chapter 28, Revised Statutes, 1930, as amended by Chapter 175, Public Laws, 1933.

Article 14. To see if the town will vote "Yes" or "No" on the question of appropriating and raising money necessary to entitle the town to State Aid, as provided in Section 20, Chapter 28, Revised Statutes, 1930.

Article 15. To see what sum the town will appropriate and raise for the improvement of the section of State

Aid road as outlined in the report of the State Highway

Commission (in addition to the amounts regularly raised for the care of ways, highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 175,

Public Laws, 1933.

Article 16. To see what action the town will take as regards settlement of cost of Durrell bridge.

Article 17. To see what sum the town will vote to raise for the removal of snow.

Article 18. To see what sum the town will vote to raise for the support of poor.

Article 19. To see what sum the town will vote to, raise for the contingent fund.

Article 20. To see if the town will raise a sum of money to be used in payment for services of out of town fire companies.

Article 21. To see if the town will raise a sum of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925—see Section 58, Chapter 140, of the 1925 Statutes.

Article 22. To see if the town will vote to raise a sum of money to reduce the indebtedness.

Article 23. On petition of Henry G. Sinnott and thirty-one others, to see if the town will vote to raise a sufficient sum of money to buy a new tractor and snow plow for the lower end of the town, the same to be used on the following highways, namely: River road, Nason Mills road, Biddeford road, Lombard's road, Camp Ground road, Proctor road, Old State road, road to residence of Joshua Thompson, and Limerick road to Durrell's bridge on the Limerick road, so-called.

Article 24. To see if the town will instruct the three selectmen to have charge of breaking the roads in winter and also to use the tractor for the removal of snow only.

Article 25. To see if the town will vote to discontinue the Bandigo road, running between Limerick road and Alfred road.

Article 26. To see if the town will vote to discontinue the Mill road, running between Smith road and Saco.

Article 27. To see what sum the town will vote to pay for the collection of taxes.

Article 28. To see if the town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and he is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Article 29. To act on any other business which may legally come before said meeting.

The selectmen hereby give notice that they will be in session at the town house at nine o'clock in the fore-noon of the day of said meeting, for the purpose of revising and correcting the list of voters.
