Report of the Superintendent of Schools

To the Honorable School Committee, Board of Selectmen and Citizens of North Kennebunkport:

LADIES AND GENTLEMEN:

It is with special pleasure and satisfaction that I submit this, my thirteenth annual report of schools, for your approval.

I have recently made a statistical study of your census, enrollment, elementary tuition pupils, and secondary tuition pupils covering the thirteen years I have been supervisor of your schools. These figures, as a table, will appear appended to this report.

In the first place, your census has greatly increased. As you. will recall, in 1926 there were only 140 boys and girls in North Kennebunkport between the ages of 5 and 21 years, in 1938 there were reported 226 pupils.

In 1926 there were only 54 pupils enrolled n the town schools with 21 pupils attending elementary schools outside the towns for which you paid tuition. In the same year there were only 10 high school students for whom you paid tuition.

Contrast the conditions just enumerated with the present figures. Of the 226 census group, 135 of these are in your town's elementary schools while 15 others are in elementary schools outside the town and are tuition pupils. At the same time there are 25 pupils in high school which for two years in succession has marked the largest enrollment in the years covered by the report.

In 1926 only three schools were operated. These other schools had been closed for many years. In 1938 all six schools are operated, with four of them crowded to capacity.

It appears from this study that in the near future more school facilities and space must be provided. The attention of your citizenry should be directed as to how best to plan when these tendencies have become actualities, some have advocated a school with several rooms operated as a consolidated school. Others have considered the advisability of enlarging schools already in use. I have no recommendation at this time but, however, would point out that with the rapid rates of population increase on route one, the Durell School and the Iron Bridge School will shortly be overcrowded.

In December I was informed by the State Commissioner of Education, Dr. Bertram K. Packard, that North Kennebunkport would again share in the State Equalization Fund. A special grant of \$152.00 to be allocated for permanent library purposes and special school accessories, such as maps, globes, etc., was sent to the treasurer, along with the State subsidy. This enables the schools to have some things that would otherwise be difficult to provide. This should in no way be confused with the regular textbook appropriation. This fund is for things not contemplated in the usual lines of textbooks and supplies.

When school was opened last September, it was found that there were not enough seats at three of the schools.

Moreover, these conditions may arise again this fall.

This need was met as an emergency. Accordingly, twelve seats and desks were purchased by order of the superintending school committee and conference and approval of Mr. Benson, first selectman. There was no appropria-

tion to cover the expenditure and therefore was carried. presumably, to the contingent fund.

The Durell School was painted inside and outside in June. This was a much needed bit of repair work and made a great change at this school.

The primary school at Burnham was done over inside. The flagpole at Iron Bridge was reset and some inside work was done to walls, and ceiling. The flag pole at North Chapel had to be reset. A new flagpole at Irving-School was supplied and set without expense by Mr. Philip Steel. The town furnished the paint and hardware. We wish to acknowledge this public service.

The annual cleaning of toilets and oiling of floors and varnishing of seats were carried through where needed.

Mr. Andrew Lux had charge of the repair work in the schools, and gave it his personal supervision and approval.

TEXTBOOKS

The policy inaugurated last year, in regard to textbooks, helped to partly equip those grades that were the most desperately in need. However, the very large enrollment and the fact that many textbooks were completely worn out and obsolete left many grades and certain types of textbooks impossible to furnish under that appropriation.

Your schools will not be better in the long run than the textbooks that are used. Textbooks are the tools of the teacher and the child. The State Commissioner of Education in the Maine State School Bulletin of January, 1938, has this to say: "Towns should make adequate appropriations for textbooks. During the past few years many towns have failed to appropriate a sufficient amount for textbooks. Probably a safe guide to determine the necessary amount would be anywhere from two dollars to three dollars per pupil per year. It is

rather a short-sighted policy to expect results even with good teachers if the pupils are inadequately provided with suitable textbooks and instructional materials. The textbook appropriation, at the lowest estimate as set down by the State authorities, is two dollars per pupil. our enrollment is 135 pupils. Therefore, your textbook appropriation should be \$270. There are many textbooks now in use in North Kennebunkport that are past use as an intellectual text. The extra State subsidy that came in last year earmarked for library books was spent for dictionaries and Lincoln Library books. One set was allocated to each school. These are used over and over again by all upper grade pupils as reference books.

It seems to me that the State recommendations, as regards textbook appropriations, should be followed in the appropriation for textbooks this year.

I fully realize that the tax rate in your town has been high. We all realize that six schools have a higher operating cost than three schools. Furthermore, I realize. perhaps, better than anyone else, how much you desire to maintain your schools on a satisfactory basis and appreciate the willingness you have so often manifested in being willing, for the sake of your children, to sacrifice other desirable town improvements for your schools. These troublous days in the world at large indicate plainly that appropriation of funds for education is the most important of the municipality.

The only values that endure beyond that indefinite range of depressions and inflations are human values. Your expenditures for education are your best investments and the safest.

HEALTH

The health conditions have been generally good, except at the Iron Bridge School. During the fall term impetigo broke out at this school and necessitated the

calling of the Board of Health, who closed the school for a week and ordered the room thoroughly cleaned and scrubbed with disinfectant. Those affected with the malady were excluded until they had recovered. There was considerable loss of school time and attendance will need to be without interruption for the remainder of the year at this school to make the usual grade placement in May.

The Durell School was closed for a week in February on account of teacher illness, and the Irving School lost a day or two by sickness of the teacher. This time, if over three days, will lie made up either during the week of regular vacation or in May.

A word at this time about the high school tuition may be in order. It appears from such data as is now available that only one pupil is scheduled to graduate from the high school group. There are nine pupils who will be eligible to enter high school this coming fall from the elementary schools of your town. There will, therefore, be thirty-five tuition pupils in high school and perhaps more. This means that your appropriations for high schools must care for the advanced registration.

1 wish to take this occasion to express my high regard for the cooperation accorded me by the teaching staff and express my confidence in their ability to render to your youth a service far beyond the remuneration accorded them in monetary return.

Your school committee have counseled with me and given of their time and energy without limit, and we extend to you all a hearty welcome to come and inspect the various schools of your town.

Report of County Nurse

To the Citizens of the Town of North Kennebunkport, I hereby submit my report for the period beginning January 1. 1937, and ending December 31, 1937.

In January arrangements were made with the selectmen for a family of seven to be transported to clinic at the Maine Eye and Ear Infirmary in Portland. The nurse accompanied the family at clinic and assisted in the transportation back to their homes. Other visits of investigation were made to homes of children regarding persistent cases of pediculosis found at schools. Visits were made to the home and to the family physician regarding children reported in need of tonsil and adenoid operations. Numerous other follow-up visits were made to homes of school children regarding defective visions found at school.

At the request of one teacher the nurse called at school and took two children to the office of Dr. Hancom at Sanford to have teeth corrections.

WARRANT

For Town Meeting, March 7, 1938

STATE OF MAINE

COUNTY OF YORK, SS.

To Florence R. Haye, Constable of the Town of North Kennebunkport, in said County, GREETING:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of North Kennebunkport, qualified by law to vote in town affairs to assemble at the Town House, in said town on the 7th day March, 1938, at ten o'clock in the forenoon to act on the following articles, to wit:

- Article 1. To choose a moderator to preside at said meeting.
- Article 2. To see if the town will vote to dispense with the check list at this meeting.
- Article 3. To choose all necessary town officers for the ensuing year.
- Article 4. To see what sum of money the town will vote to raise for the support of common schools.
- Article 5. To see what sum of money the town will vote to raise for high school tuition.

Article 6. To see what sum of money the town will vote to raise for repairs and insurance on school buildings.

Article 7. To see what sum of money the town will vote to raise for free textbooks.

Article 8. To see what sum of money the town will vote to raise for school supplies.

Article 9. To see what sum of money the town will vote to raise for salary of superintendent of schools.

Article 10. To see if the town will vote to raise the sum of \$182.40 for seats and desks bought during the past year.

Article 11. To see what sum of money the town will vote to raise for the repair of roads and bridges.

Article 12. To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on the highways.

Article 13. To see if the town will vote to divide the common road appropriation between its road commissioners on a mileage basis.

Article 14. To see what sum the town will appropriate for State aid road construction (in addition to the amounts regularly raised for the care of ways. highways and bridges) under the provisions of Section 19. Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3. Chapter 229, Public Laws of 1937.

Article 15. To see if the town will vote to raise a sum of money to cut and destroy all bushes on State highway.

State aid, and third class roads, to comply wiith Chapter 145. Public Laws of 1927, and if so, how much.

Article 16. To see if the town will vote to raise the sum of four hundred and sixty-five dollars to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930. as amended by Chapter 175. Public Laws of 3933.

Article 17. To see if the town will raise a sum of money to pay bond and interest coming due this year.

Article 18. To see what sum the town will raise for the removal of snow.

Article 19. To see what sum the town will raise for the support of poor.

Article 20. To see what sum the town will raise for the contingent fund.

Article 21. To see if the town will vote to raise a sum of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925, Section 58 Chapter 140, Public Laws of 1925.

Article 22. To see if the town will authorize the treasurer and collector to sell and dispose of all tax titles held by the town on such terms as they deem advisable, and to execute quit claim deeds for such property.

Article 23. To see what sum the town will vote to pay for the collection of excise taxes.

Article 24. To see what sum the town will vote to pay for the collection of taxes.

Article 25. To see if the town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Article 26. To see if the town will vote to authorize the sale of its interest in the Frank Furbish property, on the payment to it of all back taxes and claims against said property not in excess of \$500.00, and if not, to see what sum the town will vote to accept in payment for its interest in said property.

Article 27. To see if the town will vote to authorize the treasurer to execute and deliver to any purchaser a good and sufficient quit claim deed of its interest in the Frank Furbish property on the payment to it of the sum voted in Article 26.

Article 28. To see if the town will vote to raise the sum of \$300.00 for the services of out-of-town fire companies.

Article 29. To see if the town will vote to instruct the selectmen to appoint a building inspector.

Article 30. To act on any further business that may come before this meeting.

The selectmen hereby give notice that they will be in session at the Town House at nine o'clock in the fore-noon of the day of said meeting, for the purpose of revising and correcting list of voters.
