Dear Mr. Welch:

I had hoped last spring to report to you this winter that we had completed coverage of No Kennebunkport on white pine blister rust control, but such is not the case. There remains most of one road block in the north west section of the town that still needs work. During 1955 we covered 2514 acres to protect 1468 acres of young growing white pine. On this area we found and destroyed 19,870 wild currant and gooseberry bushes. We would never have been able to do this much if we had not had a commercial brush killer to spray on the clumps of bushes. The remaining area should not be an expensive job to accomplish.

The costs of the works are divided as follows: - Town of North Kennebunkport \$397.95 State of Maine \$408.99 and Federal Gov't. \$251.45.

I hope to see you soon after the first of the year regarding the balance of this work.

#### Report of the Public Health Nurse

Public health is public wealth. How little we think about health until illness strikes, and then we realize that we have lost one of our most prized possessions. Public Health Nursing is a service which helps bring to the home and community the benefit of modern medicines, skill and knowledge. During the year, 21 visits were made to give or demonstrate nursing care in the home. The use of modern drugs has greatly reduced the average length of days the patient remains in bed.

Parents are the most important influence in their children's lives but they are not to blame for everything that goes wrong. Young parents are becoming more aware of the value of protective "shots" against certain diseases,

During the year six child health conferences were held with a total attendance of 48. Thirteen infants and 21, preschool children were given physical examinations. Eighteen children were vaccinated against smallpox and 12 were Immunized against diphtheria, whooping cough and tetanus.

During the early part of 1956, polio inoculations will be offered free to all children from five through 14. Parents must sign consent slips and return them before these shots are given.

During the year, a total of 51 infants and 203 preschool children were visited. During these visits health problems are discussed and the parents are advised about using existing community facilities. The extent to which this service is effective is determined by the number of children who enter school without any significant untreated physical defect.

Because teachers have day to day contacts with children. their help is invaluable in bringing attention to conditions which might otherwise go unnoticed. When defects are discovered, we must recognize that corrections will not be made unless the parents are convinced that there is a health problem and are willing to take steps for the benefit of the child. There has been a great deal of improvement in the condition of the teeth as a result of the mouth health project. This program has been sponsored by your local health council.

This report would not be complete without mention of the high caliber of the individuals who support the program.

I am especially grateful to the selectmen, health officer, superintendent of schools, the teaching staff and last but not least to the health council members for their loyal support. Without

their cooperation our problems would be increased many times over.

#### PROGRESS REPORT ON MOUTH HEALTH PROJECT

For the fifth year, during October 1955, North Kennebunkport elementary school and 3 year old children have participated in a dental decay prevention program of sodium fluoride applications and mouth health educational procedures, conducted by a dental hygienist from the Division of Dental Health of the State Department of Health and Welfare.

The children seen in 1955 showed an increase of 41 percent in dental decay needs cared for as compared to the children seen in 1952.

A recent study of the 750 children three years after their first participation in this type of program, contrasted with an equal number from towns that do not have a similar program, shows that children who received the sodium fluoride applications have fewer decayed teeth and a larger proportion of children have no decay at all.

The system of limiting the number of grades to a building as adopted in September 1954, has proved of great advantage in improving instruction. The Iron Bridge School was closed in September 1955 because of the small registration in that area.

We have been fortunate in finding teachers for vacancies that have occurred during the past few years. It is becoming increasingly difficult to obtain teachers for rural schools The salary schedule will definitely need improvement if we are to be placed in a position so that we can compete in the market for good teachers. At present we are in a situation, where it is probable that four teachers will retire this summer.

Again this year we are faced with the old problem of what the Town will do to improve the school situation The State Building Authority method of raising money is still available to the town. We have been through this process twice and I

think that it is still the best method available at the present There are bills before Congress to provide aid for school buildings, but the immediate prospect is not too bright, although I feel that eventually some federal aid will be available. Under the new state valuation of \$860,000.00 the Town is allowed to borrow 7 1/2% or \$64,500.00.

As the present state valuation has changed the valuation per pupil, the town, under the new law is now in class 5, which will give a state subsidy of \$13,348.38 in December 1956. The state subsidy of December 1955 was \$10,785.00. The new classification returns to the town 55% of what it spends for schools, not including outlay and repairs.

I want to congratulate the Parents' Club on their efforts. I hope they will continue to work for the improvement of the schools. Our health services have continued under the guidance of the Health Council. The work of the Council has been a real contribution to the welfare of the schools. The state dental clinic continued with their program this year.

If we must remain in the present buildings, the procurement of a good water supply is still a problem. I wish steps might be taken to locate a good supply adjacent to each building.

It is my sincere hope that better school conditions may be provided in the not too distant future.

I appreciate the efforts of all those persons who have exhibited an interest in the schools.

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town Hall in said Town on the fifth day of March, 1956 at ten o'clock in the forenoon to act on the following articles to wit

- Art. 1. To choose a moderator to preside at said meeting.
- Art. 2. To see if the Town will vote to dispense with the check list at this meeting.
- Art. 3. To choose all necessary Town Officers for the ensuing year.

- Art. 4. To see if the Town will vote to carry forward the balance or overdraft on each account.

- Art. 5. To see if the Town will vote to authorize the Selectmen, to credit the Contingent Account with sums of money received, such as Bank Stock Tax, Dog License Refund, Costs and Interest on Taxes, Supplemental Taxes and Licenses; and to charge the Contingent Account with Discounts and Abatement of Taxes.

Art. 21 To see if the Town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said Town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year. The Town Treasurer be and hereby is authorized and directed to borrow from time to time a sum or sums not to exceed in the aggregate; Ten Thousand Dollars, and to execute and deliver the note or notes of the Town therefore signed by the Town Treasurer and countersigned by the municipal Officers of the Town.

Art. 22. To see if the Town will authorize the Treasurer of the Town (with the approval of the Selectmen) to sell and dispose of all tax titles held by the Town, and the Town's interest in tax liens whether completely foreclosed or not, on such terms as the Selectmen deem advisable and to execute quit-claim deeds for such property.

Art. 23. To see what sum of money the Town will vote to raise and appropriate by assessment for the cutting of bushes along roads.
