Annual Report of Public Health Nurse

Public health is largely a matter of self-help; since to take advantage of the knowledge and the services which are available, personal acceptance is required. Providing for public health at a local level is primarily a local responsibility.

We have become so accustomed to hearing of improvements in the nation's health that we are inclined to regard them as automatic. They are not so; they require each one of us to make efforts on behalf of ourselves and our families. The goals of the program should not be set beyond the financial or human means of the community. There is, however, a toll that we pay with regularity—it is that of unnecessary disease and premature death.

Active cooperation on the part of the public is of utmost importance for the success of the program. Members of your local health council have given freely of their time and effort in supporting the activities, but the burden has fallen on a small group.

Child health conferences have been held on the second Tuesday of each month between 3 and 5 p.m. from May through October at your local town hall. A total of 87 attended the conferences during the year. Twenty were given physical examinations, 12 completed their diphtheria, whooping cough and tetanus series and six received boosters. Six were vaccinated against smallpox. A total of 63 first, second, and third polio immunizations were given. These child health conferences are open to all children from birth to school age who are not under supervision of their family physician.

The object of public health is not merely to prolong life, but to increase the vigor, efficiency, and happiness of all members of society. One of our jobs as a public health nurse is to help people understand what diseases are communicable and what to do to prevent passing them on to their neighbors. Since there is such an increase in the life span, it is evident that our public health program of the future will be concentrated on older persons among whom chronic disease and disability are more prevalent.

Home visits are made to expectant mothers who are under medical supervision. Infants are visited during the first year, the frequency of these visits is made according to specific needs.

Because of the many demands made upon the nurse, some of the visits to the chronically ill must necessarily be limited. An attempt is made to teach someone in the home to take over the care of the patient. It is impossible to give adequate care even if daily visits were made by the nurse if there is no one in the home to share this responsibility. In some cases arrangements have been made to transfer patients to nursing homes.

Teaching good habits must start at a very early age, but the teaching acquired in the home must be reinforced when the infant reaches school age. In order for this teaching to be effective, safe and sanitary facilities must be provided. Little progress can be anticipated in environmental sanitation without community support. Everything we do to assure children a healthy start in life improves their chances of health in maturity. Periodic visits are made to the schools to assist teachers with special health problems.

I would like to take this opportunity to thank all who have helped in any way to make the program a success. With your continued support I hope the services will expand in 1958.

We have been fortunate in obtaining and retaining teachers who are doing an excellent job. Their interest in the welfare of the children is outstanding, and the results are good, considering the handicaps under which teachers are working.

In the first place all rooms are overcrowded. We had hoped that a new building would be available this year, and for that reason we thought we could get along with overcrowding during the interim. Again, if there is a possibility of a new building this year, it will be better to get along with present facilities until the school is ready. If there is no possibility of a new building, another room should be opened at the Iron Bridge School in September, or some other arrangement for relief of the overcrowded rooms should be made. We definitely need six rooms and six teachers. When and if the new building is occupied six rooms will be needed at once.

If a new building is occupied next September there will be some cost beyond the proposed budget for 1958, due to additional cost of fuel, extra teacher, janitors' service, public utilities and insurance. This increase would amount to about \$5,-600 for a full year. If a new school is opened in September, this year's budget should be increased about \$2,240 as only .4 of the total increase would be paid in 1958.

A School Building Investigating Committee has been working hard over a period of time to bring about a building program. Unforeseen difficulties have caused delays.

An application to the Maine State School Building Authority, voted by the School Committee and Selectmen, was filed on July 20 1957. The anticipated cost of construction and grading was reported as \$70,500. When the name of the Town was changed to Arundel, the Authority in Augusta required a new application to be filed. This was done on October 31, 1957. On November 6, 1957 we were notified that there was a question as to the title of the property and that the title must be cleared before the Maine School Building Authority would approve the application. Steps are being taken to clear the title of the proposed site, and as of January 25, the title has not been cleared.

The amount that can be borrowed by a town is dependent upon many factors, all of which must be investigated by any committee raising money for building construction and before borrowing capacity can be determined. The final limit of indebtedness in any town is the State valuation, for example the new Sinclair Bill states as follows regarding District borrowing:

ANNUAL REPORT

Chapter 41—Revised Statutes Section 111-J: ". . . the limit of indebtedness of 7 1/2% of the total of the last preceding state valuation of all participating towns." Any town borrowing money must consider other factors: (1) no town can borrow beyond 7 1/2% of its local valuation but this may be corrected to meet full State valuation by raising the local valuation and lowering the tax rate. (2) the outstanding debt of a town affects the borrowing capacity. (3) the standing of the town with the bank or banks will also determine how much may be borrowed. All these factors and others must be explored to determine the final borrowing capacity.

As to the matter of raising money through the Maine School Building Authority, the Authority investigates all angles of the financial situation of a town and has the power to determine the amount of money it will make available to a town.

The new Sinclair Educational Bill provides certain money for building construction but any such grant will be made only to newly created school districts. It appears that this Town will not join any district in the immediate future, although the possibility of reorganization should not be entirely discounted, as there are many advantages in such a move. I recommend that the Town authorities keep abreast of the developments pertaining to the Sinclair Bill. I believe at present the best action for the Town to take, is to accept the Maine School Building Authority loan, if and when it is offered. The Town made a similar request to the State Building Authority in 1952 for \$56,000, which was rejected by the Town Meeting.

It should be understood that if and when the loan is approved by the Maine School Building Authority, it must be presented to the Town Meeting for acceptance or rejection.

There appears to be no hope at present for federal aid for building construction.

I wish to thank all members of the School Committee for their continued cooperation.

17. Budget Committee recommends 1 1/2%.

Art. 18. To see what sum of money the Town will vote to raise and appropriate by assessment for the collection of excise taxes.

18. Budget Committee recommends \$150.00.

Art. 19. To see if the Town will vote to authorize a 2 discount on all property taxes paid in full within thirty days of receiving bill.

19. Budget Committee recommends adoption of this article.

Art. 20. To see if the Town will vote to authorize the collector of taxes to charge interest of 6% on all unpaid property taxes after Dec. 1st.

20. Budget Committee recommends adoption of this article.

Art. 21. To see if the Town will vote to authorize the Selectmen to procure a temporary loan or loans, not to exceed in the aggregate: Ten Thousand Dollars, within the 1958 taxable year in anticipation of taxes for the purpose of paying obligations of the town; such loan or loans to be paid during said taxable year.

21. Budget Committee recommends adoption of this article.

Art. 22. To see if the Town will authorize the Treasurer of the Town (with approval of the Selectmen) to sell and dispose of all tax titles held by the Town, and the Town's interest in tax liens whether completely foreclosed or not, on such terms as the Selectmen deem advisable and to execute quit-claim deeds for such property.

24. Budget Committee recommends \$250.00.

Art 25 To see what sum of money the Town will vote to raise and appropriate by assessment for the removal of snow.

25. Budget Committee recommends \$2,000.00.

Art 26 To see whether or not the Town will vote to raise and appropriate the sum of Twenty-five Dollars (\$25.00) to be paid to the State of Maine Publicity Bureau to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine in accordance with the provision of Chapter 91, Sec. 108, of the R. S. of 1954.

Art 27 To see if the Town will vote to renominate the present School Building Committee for the ensuing year.

Art. 28. To see what action the Town will take in regard to having the Town surveyed.

Art 29 To see if the Town will vote to have the school bus pick up Proctor Road children on the Northerly side of the Overpass.

Art. 30. To act on any further business that may be legally brought before this meeting.
