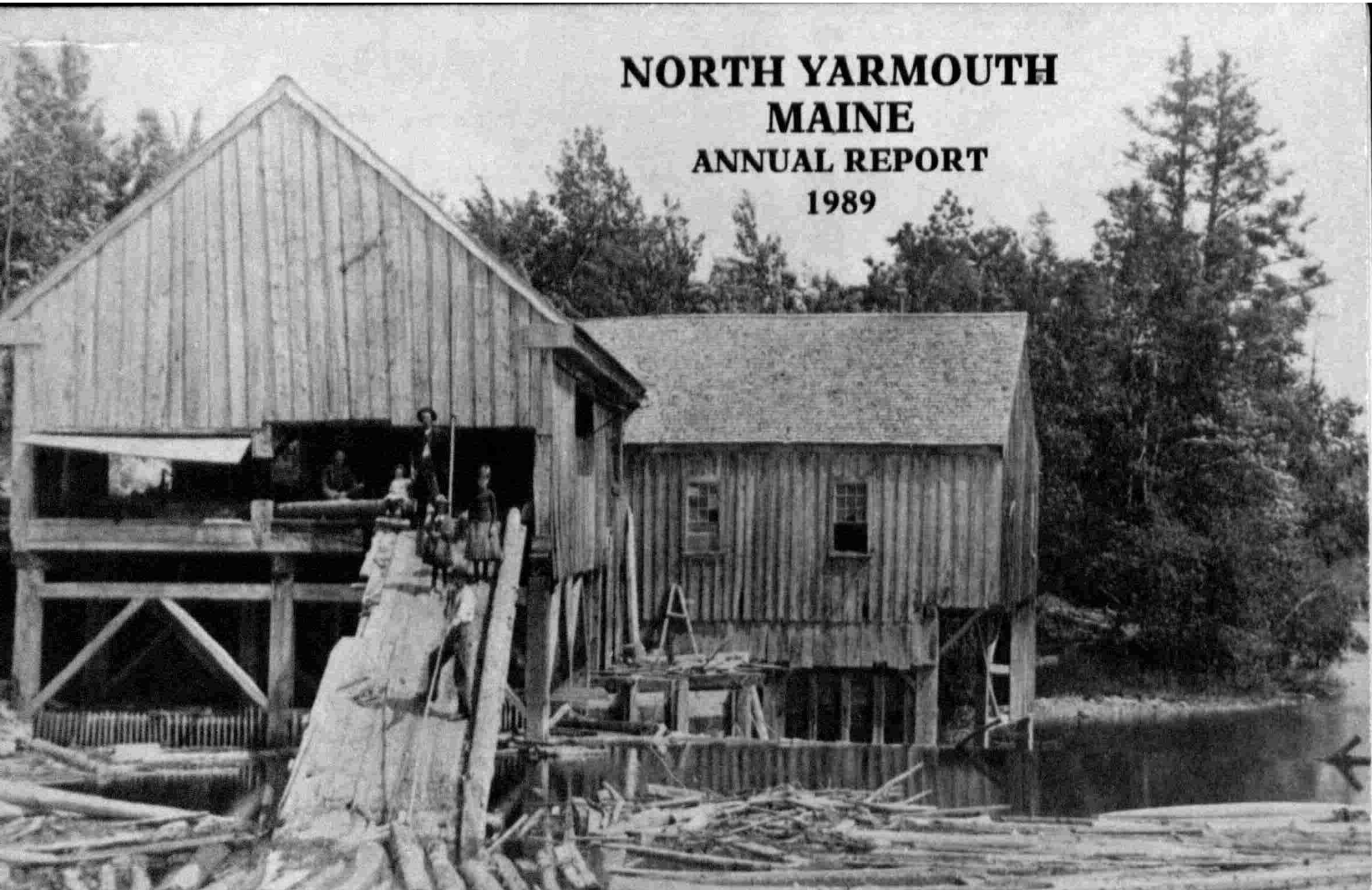

One of North Yarmouth's early industrial sites: The old PORTER'S MILL on the Mill Road. Built and run by Barbour B. Porter in 1850, it was bought by Isaac Hayes in 1886 who is (probably) pictured here with his family about 1900.

Like many small early water-powered mills it was at one time both a grist mill as well as a saw mill. This building burned in 1908 and was replaced with a more up to date mill with a circular saw instead of the old up-and-down saw previously used.

Even the dam is now gone and only part of the building's foundation is left to mark the site of a once thriving lumber industry. It stood on the east bank of Royal's River, below the bridge on Mill Road (also known as "Porters' Road", "Hayes Mill Road," or "Special Resolve Road!") near the old Royal River Brickyard.

The only other commercial water mill in present day North Yarmouth was on Chandler's Brook below Milliken Road. This was a large, much earlier water-driven mill, which powered several up-and-down saws, long known as Marston's (later Morse's) Mill. It was in operation by 1773. When the area would have been surrounded by dense first-growth forest, until the 1860's by which time the Town was largely agricultural. There is little sign of this mill today and no pictures of it are known to exist.

REPORT OF THE BOARD OF SELECTMEN*North Yarmouth 1989*

The Board of Selectmen's year was highlighted by two State mandates:

1. To establish the planning process for a Comprehensive Plan for our Town—a plan which will provide an opportunity for residents to come together, assess our present needs as well as resources, identify common concerns and make a statement—one which will reflect our values and which will guide our town through the 1990's and beyond.

2. And the controversial new Mobile Home Park Law, one of the State's ways to address affordable housing. Following two well-attended Special Town Meetings, the town adopted a Mobile Home Park Ordinance.

The Recycling Program has taken hold for plastic bottles, green and brown glass and newspapers. The problem now affronting towns is disposing of the newspaper. We presently share a recycling dumpster with the Town of Pownal on a 2-week here, 2-week there basis.

Recycling and Solid Waste is becoming an ever-increasing expense each year for taxpayers.

The Town voted to enter the Regional Waste Systems Demolition and Stump Project which is located in the Town of Gorham. This site will not be in operation for some months.

Our Town Dump is still open on Saturday mornings to receive white goods (refrigerators, washers, etc.) and building debris.

The Town Gravel Pit was opened up this year. It is located on the same parcel of land as the Public Works Department.

The Board voted to allow the spreading of Portland Water District Sludge on approved sections of land of four farms in town. Sludge to be spread according to DEP regulations and as specified in each individual permit. Portland Water District agreed there would be no winter stockpiling of the sludge.

A 5000' section of the Sligo Road was rebuilt and paved.

The new overpass over the Maine Central Railroad on Route 9 was completed and opened for traffic.

The Board meets in public sessions. Please feel free to drop in to any meeting; also to contact us, if you have any questions or concerns.

REPORT OF THE ADMINISTRATIVE ASSISTANT

I am pleased to present this report for the year 1989 to you. Once again, I can start this report by saying—"It has been a busy year!" As I look over the reports from previous years, that is the one thought that is common. As municipal services and requirements come under growth pressures, the same services and processes become more complex.

The challenges of this office are many, the least of which is scheduling the vast array of meetings and activities being held either at the Municipal Building or in other places on behalf of the community. The following are activities and reports on some of those various items:

Board of Selectmen: This year, as the Board has increased its awareness of the activities of other Town Committess, the Selectmen have found it necessary to meet on an increased frequency and often find meetings running later into the evening. Your Board of Selectmen has become increasingly involved in the overall municipal picture, and I appreciate their support and confidence over the past year.

Board of Assessors: The Board meets several times throughout the year, and the Town continues to employ John O'Donnell Associates of Auburn as the Assessor's Agent. It is becoming increasingly clear that a revaluation of property throughout the Town will be necessary within 2-3 years. This will be fairly expensive, about \$40,000; but will maintain a fair assessment policy throughout the Town. My special thanks to Ted, Tom and George for their cooperation throughout 1989.

Planning Board: While new home starts stayed about equal to previous years, the Planning Board saw a marked decrease in the number

of subdivisions and new lots created in 1989. Obviously this is a sign of the times, although activity is still somewhat encouraging. The Planning Board went straight forward into the controversy created by the passage of the state's Mobile Home Park Law and made it clear that a decision at Town Meeting would come only after all were made aware of implications of all possible decisions. I applaud Ford Reiche for his countless hours of work on this item. The other members of the Board shared his resolve and still are working with Representative Foss to remedy this legislation.

Board of Appeals: Continued an increased work load of hearings throughout most of the year. As zoning laws and state statutes become more and more complex, so do the appeals proceedings that accompany them.

Comprehensive Plan Committee: It is hoped that as you read this report, you will also be receiving a survey. This survey will be one of the most important parts of this Committee's work. Please make an effort to return it. Bring it back to election or Town Meeting. It will be the basis for many of the ideas that you will be asked to endorse in the next several months. This Committee is working along, slowly but surely coming to this point of gathering your opinion. The basic data has been gathered, now to analyze and implement changes.

Facility Study Committee: Chaired by Ed Gervais, this committee met throughout the summer, visited facilities and grilled both the Fire Chief and myself regarding our projected needs and wants, spoke with the Selectmen regarding their perspective of any changes that were needed, and looked long and hard at the financial capability of the town to support any type of addition. Their recommendation, as outlined in their report (which is available at the Town Office for those who wish to read it) is to add a meeting room to the existing Municipal Office and a deep, 2 bay addition with office area to the existing Fire Department side. It is an aggressive plan, and will enable both the fire department and the Municipal Office to serve you satisfactorily for many years to come.

Recycling Committee: Under a cooperative program with the Town of Pownal, the Town of Freeport Recycling Center and with the generous support and cooperation of Yarmouth Rubbish Removal, recycling has been accomplished in North Yarmouth!! About 5 tons of glass, approximately 20 tons of newspaper and a "whole bunch" of high

density plastic containers have been collected and recycled. This committee continues to work and is presently supporting a grant proposal for a recycling trailer which would be compatible with the system at Freeport. The committee has also recommended utilizing the services of Regional Waste Systems should that entity be able to provide the Town with a more comprehensive recycling program. Ken Allen has been energetic in this program, and we would both like to thank Cynthia Strout of the Freeport Recycling Center. The Town also thanks Russ Stull of Yarmouth Rubbish Removal for his dedication to this pilot program. His generosity in supplying equipment and manpower has made this a success.

Cable TV Commission: At the request of Public Cable Company and with the cooperation of the Cable TV Commission, the cable franchise agreement for the Town of North Yarmouth has been extended through December of 1999.

As you can see, staffing these committee meetings is becoming a challenging part of my job. These are a very important part of the municipal function and I personally thank all who participate.

Other activities and projects:

Regional Waste Systems. I continue to represent North Yarmouth, Pownal and Gray on the Board of Directors, its executive committee and the committee developing the material recycling facility in Gorham.

Served on the Executive Committee of the Maine Municipal Tax Collectors and Treasurers Association.

I wish to thank the Board of Selectmen in supporting these activities which take me out of the office. Activities that are of regional and statewide importance need our attention also.

Your Municipal Office has had a busy year serving the citizens of North Yarmouth. Activities have included:

A note as Tax Collector and Treasurer—I have recommended and the Selectmen have supported, moving the due date for real estate taxes to October 1st for 1990. This move alone can save over \$10,000 in interest next year. It is our intent to continue to advance the due date over the next several years until taxes are due 30 days after the delivery of bills.

In closing, I would like to take a few lines to address the budget. The Budget Committee, under the chairmanship of Clark Whittier, has done an outstanding job this year. They were critical of expenses, looked to the future in considering all requests, and really put us through our paces. They all should be proud of the review process they undertook on behalf of the Town.

A proposal to employ a full time Code Enforcement Officer/Inspector for the Town has been made and received the support of the Selectmen and of the Budget Committee.

Once again, as is all too often the case, I close my report with a remembrance of a loyal North Yarmouth supporter—S. Von Day. At the time of his death last fall, Von was very active in town affairs. As a member of the Planning Board, he was looked upon for his knowledge of soil conservation and environmental issues. As a member of the Recycling Committee, he was chosen for his forward thinking and co-operative nature. He was also a most active member of his church. Although he would be outspoken on issues that he cared deeply for, his enthusiasm for his community would always shine through. Von is greatly missed as a participant in Town Affairs, a sometimes critical but ever watchful eye, and most of all, a true personal friend—one does not get many of them.

My thanks to the Board of Selectmen—Rosalyn, Don and Kenny—and to the office staff—Deborah Thoits and Marie Lausier—for their help, support and “pushes” through the year. We all look forward to the challenges of 1990 and beyond.

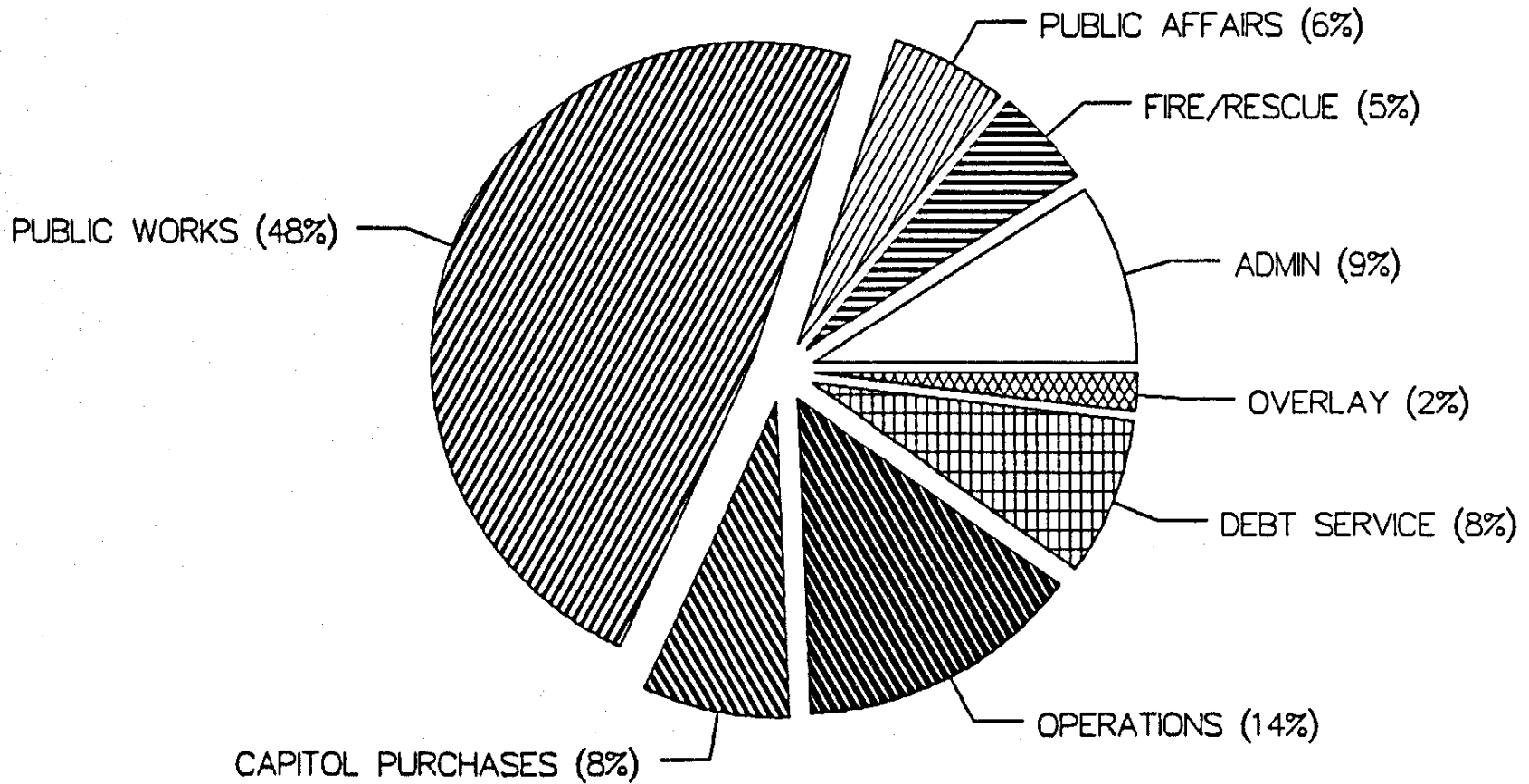

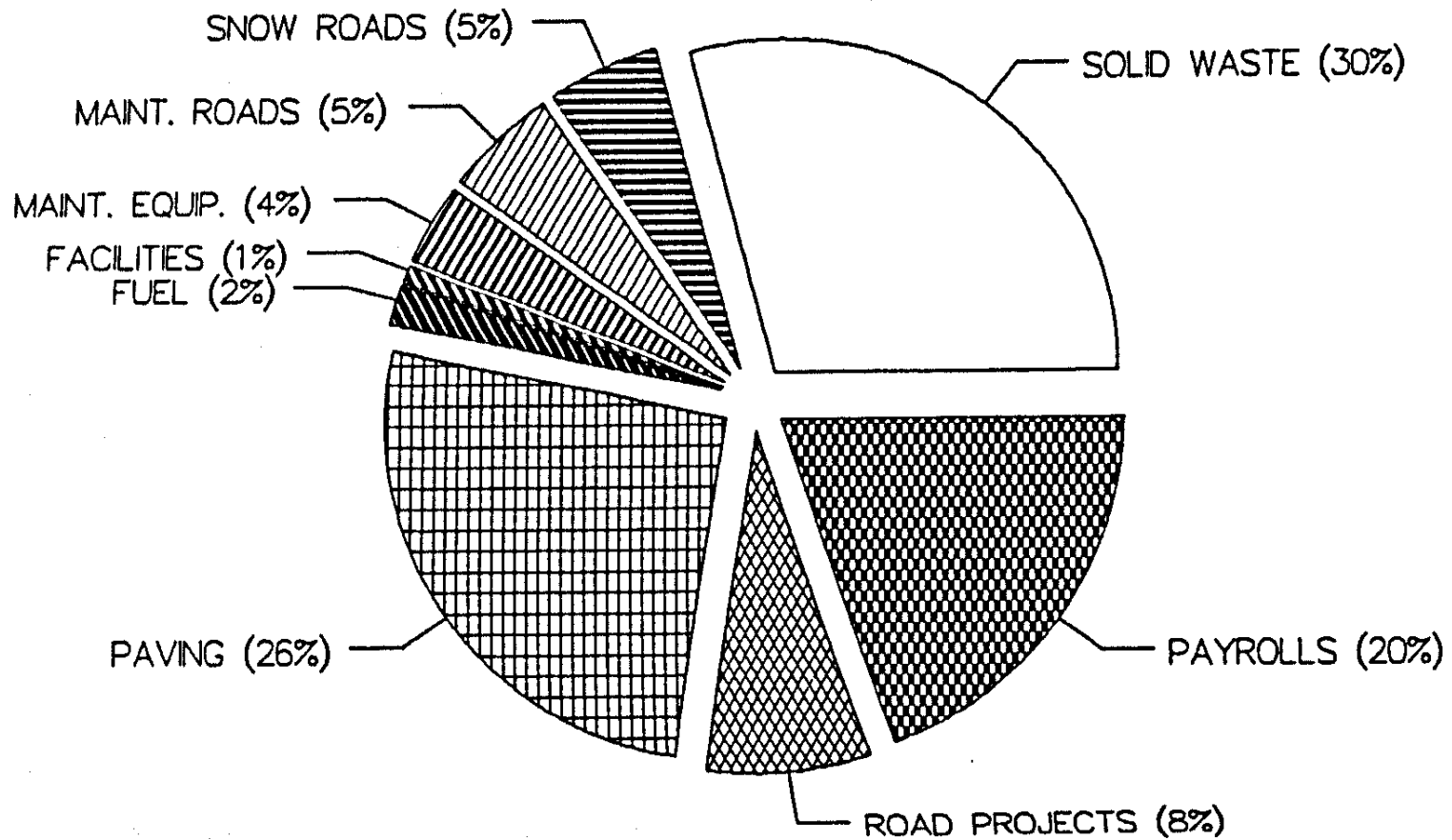

Reviewing North Yarmouth's annual report of a year ago, it is interesting for your assessors to see how close they came to their predictions. 1989 has been a challenging year, particularly for those in the real estate business, in that the activities in home sales for less than \$150,000 was extremely poor. This pertained to both newly constructed homes as well as pre-owned homes. The zealous construction of condominiums has caused banking institutions to "write-off" millions of dollars of over valued properties. The recent revaluation performed in Boothbay Harbor, has brought the residents out en masse, complaining about the new valuations on their properties.

Market conditions of a year ago, suggested a re-entrenchment of home values. This did not happen. Instead, the market-place became stagnant as the potential buyer could not afford the monies necessary to complete the transaction. On the other hand, the State Valuation projection for North Yarmouth in 1990 has increased considerably over in inflationary projections of two years ago. In the meantime our sales ratio compared to the State broadens. This too, is not good for two reasons. One, school subsidy is directly related to valuation. Second, if we do not maintain a certain percentage of the sales ratio, the state will call for a revaluation. We are already contemplating this to happen in the next four years. State law requires a revaluation every ten years.

Again, the consensus still remains, that our economy will recede within the next two years. Perhaps during this period the real estate market will adjust itself, and perhaps the valuation of North Yarmouth will be closer to the target. Most important, is to remain realistic, and continue to fight for equalization and just value of all properties in our Town. The **Citizens For Property Tax Reform**, for example are suggesting a "user system" that would tax property based upon the burden it places on local services, chiefly education and solid-waste disposal. Thus a retired couple or a single person with no children would pay lower taxes than a large family, even if the properties were equal. Other inequalities proposed would be allowances made for small business as

compared to the valuation procedures for the larger business. One can see immediately a return to the old days, during which many of the procedures were extremely unjust.

As your elected Board of Assessors, we will continue to strive for equality in our Town of North Yarmouth. At one of our scheduled meetings, we will be happy to review the valuation on your property. Please call the Town Office for an appointment.

NORTH YARMOUTH FIRE DEPARTMENT ANNUAL REPORT 1989

The North Yarmouth Fire Department responded to 84 calls during the year 1989.

18 calls to assist the Rescue (10:55)
7 grass or brush fires
20 structure or car fires
25 miscellaneous (wires down, smell of smoke, water problem)
14 calls for mutual aid

It was a good year for the Department and the residents of town with no real serious structure fires. I hope that fire detectors and an awareness of fire danger was the answer. Keep up the good fire safe record for the year ahead! Only you the residents can do this! With the OSHA laws on safety in effect, our Fire Department must continue to upgrade both equipment and training. This is requiring many hours of special training for the volunteers. Included in this year's budget request is a small sum of money to give to each volunteer who meets the Department's training requirements. I hope by doing this we can keep volunteers interested in the Fire and Rescue Service.

The Town's Fire Wardens gave out 400 fire permits this year. Permits are required year-round for any outside fire.

Besides the 102 Emergency Rescue calls our 16 members tended, we were on the scene for fires, to direct traffic and to be readily available in case needed by the Firemen.

Due to a lack of space we recommended at last Annual Town Meeting that a new ambulance not be purchased. However, with the present unit now eleven years old, we feel it is a top priority to purchase a new one. The goals of the committee looking into this purchase are to assure that we have an efficient, convenient, non-elaborate vehicle.

During the past year three of our members have upgraded their

license level, which means putting in a lot of extra hours. Members attending evening, day-long and sometimes, weekend classes share new ideas and techniques with the rest of the squad.

Through donations received by Rescue, and funds raised by the Ladies Auxiliary of the Fire Department we were able to purchase a \$7100 Automatic Advisory Defibrillator. (For an explanation and/or demonstration speak to a Rescue Member.)

Realizing that emergencies arise day or night we urge you to call for our assistance when you feel the need without regard for what the clock says. Not only are we available at all times, but we have excellent mutual aid with the surrounding towns. A hearty thank you to each of them.

STATE OF MAINE CERTIFICATION ONLY WILL BE ACCEPTED ACCORDING TO STATE LAW. PROOF OF NEUTERING OR SPAYING MUST ALSO BE PRESENTED AT THIS TIME. DOGS LICENSED AFTER APRIL 1ST OF EACH YEAR SHALL BE SUBJECT TO A CONSTABLE'S FEE OF \$4.00 EACH.

Licensing your dog is really for your own benefit and the protection of your pet. If your dog is found running at large or as a stray, you will be required to show proof of current license and pay all costs associated with the detention of the animal prior to the animal being released to you.

With its new coat of paint and new green door, the Old Town House again is looking distinguished. Look for program notices on the door.

Our first ever "Annual Appeal" brought approximately one hundred donors and we thank everyone who gave. Your donation not only helps support activities and maintenance, but demonstrates to us that we have grassroots support for what we are doing.

REPORT OF THE YARMOUTH-NORTH YARMOUTH SHELLFISH CONSERVATION COMMITTEE

To the Citizens of North Yarmouth:

This past year only 62 mess licenses were sold, all of which were resident licenses. There were no commercial licenses sold.

The Shellfish Committee recommended that no commercial licenses and 200 mess licenses be sold in 1990. Our shellfish population once again failed to demonstrate any noticeable growth. We still do not have any scientific reason to explain this phenomena but believe it can be attributed to the recent over-harvesting by commercial diggers, the abnormally warm weather the past summers, and finally the practice of the town of discharging its sewer effluent into the Royal River during rainstorms.

Our Committee will continue to focus its attention on water quality and any new developments that have the potential to compromise our shellfish resources. We will continue to work closely with the Department of Environmental Resources and the Department of Marine Resources. We appreciate the dedicated assistance provided to our town by Brad Sterl, Maine State Biologist.

The Committee was planning to conduct a formal shellfish survey last spring in the area between Cousins and Littlejohn Islands to determine the status of the shellfish population. An initial survey

conducted last spring by a few members of the Committee recommended the survey be postponed a year. The Committee will once again complete an informal survey to determine if a full survey is warranted in the Cousins and Littlejohn Island area.

The Shellfish Committee applauds Yarmouth's acquisition of the Vail Property. Besides preserving a historic quarry that provided a great deal of granite for the building of Portland, it provides an important access to the ocean. The Committee encourages that Yarmouth pursue additional purchases that were recommended in the Yarmouth Open Space Committee Final Report.

Until recently the entire coast was closed by the state to shellfish harvesting due to potential health problems caused by poorly maintained overboard sewer discharges and illegal, unlicensed sewer overboard discharges. Last month the islands were once again opened but the more accessible coastal areas still remain closed. Due to the limited state staff available to complete the remaining collection and testing of shellfish, and amount of coastline they are responsible for, the opening of coastal areas could easily be delayed for many months.

However, we are still confronted with the situation of very few shellfish to harvest. Your Committee will continue to address this problem and will always welcome suggestions.

The Committee participated in the Coastal Cleanup last fall and encourages all citizens to do so this year. We also welcome the formation of the Yarmouth Land Trust and support their effort to preserve the delicate balance of our exceptional community.

NOTE 1 - SUMMARY OF ACCOUNTING POLICIES:

The Town of North Yarmouth, Maine currently operates under a Chief Financial Officer-Selectmen form of Government.

Except for not maintaining a record of its general fixed assets, the accounting policies of the Town conform to generally accepted accounting principles as applicable to state and local governmental units. The following is a summary of the more significant policies.

Basis of Presentation:

The accounts of the Town are organized on the basis of funds and account groups, each of which is considered a separate accounting entity. The operations of each fund are accounted for by providing a separate set of self-balancing accounts which comprise its assets, liabilities, fund equities, revenues and expenditures. The various funds, which are segregated for the purpose of carrying on specific activities or attaining certain objectives in accordance with special regulations, restrictions or limitations, are grouped by type in the financial statements as follows:

Governmental Funds:

General Fund - The general fund is the general operating fund of the Town. All general tax revenues and other receipts that are not allocated by law or contractual agreement to another fund are accounted for in this fund. From the fund are paid the general operating expenditures, the fixed charges and the capital improvement costs that are not paid through other funds.

Special Revenue Funds - Special revenue funds are used to account for the proceeds of specific revenue sources (other than special assessments, expendable trust, or major capital projects) requiring separate accounting because of legal or regulatory provisions or administration action.

Capital Projects Fund - Capital projects funds are used to account for financial resources segregated for the acquisition or construction of major capital facilities other than those financed by special assessments or enterprise operations.

Fiduciary Funds:

Trust Funds - Trust funds are used to account for assets received by the Town and held in the capacity of trustee, custodian or agent.

Basis of Presentation (Continued):

Account Group:

General Long-Term Debt Group of Accounts - This account group is established to account for the long-term debt that is backed by the Town's full faith and credit.

Basis of Accounting:

Governmental fund revenues and expenditures are recognized on the modified accrual basis. Revenues are recognized in the accounting period in which they become available and measurable for property taxes. Available means collected in the current period or within sixty (60) days after the end of the current period. Property taxes due but not available within the required period are recorded in a deferred revenue account on the balance sheet. Expenditures for governmental fund types are recognized in the accounting period in which the fund liability is incurred, if measurable, except for unmatured interest on general long-term debt which is recognized when paid.

All other funds included in these financial statements are maintained and reported on the accrual basis.

Budget:

General:

The Town is currently preparing budgets under a net budgeting concept which does not estimate total revenues of the Town.

Interfund Transactions:

During the course of normal operations, the Town has numerous transactions between funds including expenditures and transfers of resources to provide resources, construct assets and service debt. These transactions are reported as operating transfers.

Inventories of Supplies:

Inventories of supplies are considered to be expenditures at the time of purchase and are not included in the general fund balance sheet.

NOTE 1 - SUMMARY OF ACCOUNTING POLICIES (Continued):

Fixed Assets:

Fixed assets are not capitalized in the accounting records when acquired. Funds used to acquire fixed assets are accounted for as expenditures in the year payments are made.

NOTE 2 - DEPOSITS AND INVESTMENTS:

The Town's policy is to invest all available funds at the highest possible rates, in conformance with legal and administrative guidelines, while avoiding unreasonable risk. The funds are invested in liquid investments planned to coincide with its cash needs during the year.

The Town's deposits are categorized as follows to give an indication of the level of risk assumed by the Town at year end: Category 1 includes deposits covered by federal depository insurance or by collateral held by the Town or by the Town's agent in the Town's name; Category 2 includes uninsured deposits covered by collateral held by the pledging financial institution's trust department or agent in the Town's name; and Category 3 includes uninsured and uncollateralized deposits.

During the year, the Town voted appropriations of general fund balances which are reflected as the excess of budgeted expenditures and other uses over budgeted revenues and other sources as per Exhibit B-2.

NOTE 4 - PROPERTY TAX:

The Town's property tax is levied on the assessed value listed as of April 1 for all real and taxable personal property located in the Town. Assessed values are periodically established by the assessors at 100% of assumed market value. Each property must be reviewed no less than once every four years. The assessed value for the list of April 1, 1989, upon which the levy for the year ended December 31, 1989 was based, was \$85,424,806.

The Town is permitted by the laws of the State of Maine to levy taxes up to 105% of its net budgeted expenditures for the related fiscal period. The amount raised in excess of 100% is referred to as overlay, and amounted to \$15,340. for the year ended December 31, 1989. (Schedule 2 summarizes the 1989 levy).

Tax liens are placed on real property within twelve months following the tax commitment date if taxes are delinquent. The Town has the authority to foreclose on property eighteen months after the filing of the lien if tax liens and associated costs remain unpaid.

In accordance with 30 MRSA, Section 5061, as amended, no municipality shall incur debt for specified purposes in excess of certain percentages of state valuation of such municipality. Additionally, no municipality shall incur debt in the aggregate in excess of 15% of its stated assessed valuation. The Town's outstanding debt at December 31, 1989 of \$202,000. was \$12,611,721. below the Town's statutory debt limit.

NOTE 6 - OVERLAPPING DEBT:

The Town is liable for its proportional share of any defaulted debt issued by Cumberland County and Maine School Administrative District No. 51. The overlapping debt applicable to the Town at December 31, 1989 is .73% (\$53,035.) of Cumberland County's outstanding debt of \$7,265,000., and 20.40% (\$147,900.) of Maine School Administrative District No. 51's outstanding debt of \$725,000.
