During his three days with us, Dr. John Burns met with students and faculty at both Colvin (Honors) and Little Hall (Modern Languages and Classics), in addition to his public lecture in Hill Auditorium, "Rebels and Prophets in Latin American Poetry," and his narration, on Friday evening, of "America in the Poetic Imagination," the opening concert of this year's Music Faculty Series in Minsky Hall. In addition, John taught an English class at Orono High School for his mentor there, Mr. Al McLean.
