The Department of Philosophy is applying for funding from the Cultural Affairs/Distinguished Lecture Series for its 2013-2014 Colloquium Series. This series of public presentations will provide opportunities for students, faculty, and community members, both within and outside the Department of Philosophy, to hear and discuss stimulating lectures on a wide range of topics. Each lecture program includes considerable time for questions and discussion. Several of the scholars are willing to spend more time at UMaine interacting with students and others in addition to their colloquium program. Speakers include Professor Fred Dallmayr, one of the outstanding philosophers in the world, as well as several other scholars of highest international and national status and several outstanding Maine philosophers. The topics reflect our department's commitment to diversity and to raising philosophical issues of the greatest relevance for members of our university community, Maine citizens, and the contemporary world. Topics relate to the core themes of our department's curriculum as well as contemporary issues of ethical, political, social, and philosophical significance.

The Cultural Affairs/Distinguished Lecture Series Grant Application for funding for the 2013-2014 Philosophy Colloquium Series was submitted on September 26, 2013. The 6 speakers listed on the application form all came to UMaine during 2013-2014, and they delivered the colloquium lectures listed on the application. In addition to the 6 colloquium lectures, speakers delivered 3 other lectures and agreed to meet with students for several other offerings. The CA/DLS fund provided the requested \$1,868.00, and this was spent on four of the speakers. \$2,115.12 was provided from other funds (the Department's Visiting Scholar funds and Student Government funds). All of the lecture programs were free and open to the entire university community and the public.

Summary of Programs and Attendance

Event 1: Nico Jenkins, Professor of Philosophy, Husson College, and Preceptor, Honors College, UMaine

"Pedagogy With/In the Disaster: Thinking with Heidegger and Blanchot"

October 24, 2013

Levinson Room, The Maples

Attendance: 60. The packed room included many students from the Honors program and students who had previously taken Philosophy with Nico Jenkins. The lecture was followed by a very lively question and discussion session, which then led to an informal discussion gathering at the Bears Den with faculty and students.

Note: The grant application included an Honorarium of \$150. However, Nico Jenkins was not eligible for an honorarium since he is a Temporary Salaried Employee.

Instead, the \$150 was paid from his own salary, using the Non-Faculty Temporary accounting numbers (5360100 51012-00) and was not included in the \$1,868.00 grant or the additional \$2,115.12 provided from other funds.

Event 2: Jana Sawicki, Professor of Philosophy, Williams College

"Precarious Life: Butler and Foucault on Biopolitics"

November 14, 2013

Bangor Room, Memorial Union

Attendance: 65. This well-attended lecture was followed by a very lively question and discussion period. Professor Sawicki agreed to do two days of programs and personal interactions with students and faculty. The most active students from the student Philosophy Club communicated with her, read and discussed several of her

publications in late October and early November, and then met with her on Nov. 15 for a very rewarding session. The Philosophy Club students submitted a funding proposal to Student Government and received \$500 for Jana Sawicki's honorarium.

Event 3: J. Gray Cox, Professor of Philosophy, The College of the Atlantic
"An Alternative Paradigm for Ethics"

January 23, 2014

Levinson Room, The Maples

Attendance: 45-50. This topic attracted a large attendance and a very lively discussion period with many challenging questions. Prof. Cox also delivered a second public lecture, held in the Bangor Room on Jan. 23, on "Rogue AI, IBM's 'Smarter Planet', and Other Existential Threats from Artificial Intelligence" that was attended by 10-15 people.

Event 4: Douglas Allen, Professor of Philosophy, The University of Maine
"Mahatma Gandhi's Philosophical Interpretation of Value"

February 13, 2014

Levinson Room, The Maples

Attendance: 40. The lecture presentation was followed by many good questions and a productive discussion.

Event 5: Robert Segal, Professor of Religious Studies, The University of Aberdeen, U.K.

"Do the Social Sciences Bear on Either the Truth or Falsity of Religious Belief?"

William James and Sigmund Freud"

April 3, 2014

Bangor Room, Memorial Union

Attendance: 30-35

Prof. Segal also delivered a second public lecture, held in the Bangor Room on April 3, on "Engels's Incoherent Theory of Religion" that was attended by 30 people.

Event 6: Fred Dallmayr, Professor of Philosophy and Political Science, The University of Notre Dame

"Taming Leviathan: Toward a Global Alliance for Peace"

April 10, 2014

Bangor Room, Memorial Union

Attendance: 30

Prof. Dallmayr was the 2014 Distinguished Visiting Scholar in Philosophy. As such, the Department of Philosophy was able to provide most of the funding for the visit. Prof. Dallmayr, one of the world's leading authorities in several scholarly areas, agreed to come to UMaine for over 3 days, and he was able to enrich the life of the department and the university community. He delivered a second public lecture, held in the Bangor Room on April 9, entitled "The Owners of the World: Chomskyan Reflections," that had 35 people in attendance. The students in the Philosophy Capstone seminar read 5 of Prof. Dallmayr's book chapters and articles, and they

had a very informative capstone class with him during which he answered their prepared questions and shared his analysis.

Promotion

The 2013-2014 Philosophy Colloquium Series programs were promoted very intensively through the series and individual event flyers, calendar listings on campus and in the community, email and social media communications, announcements in classes, working with the student Philosophy Club, and newspaper, radio, and other media work. The promotional material contained the following credit, which was stated in the introduction to each of the lectures: "This event is sponsored by the University of Maine's Department of Philosophy and is supported in part by a grant from the Cultural Affairs/Distinguished Lecture Series." The flyers for the series and the individual programs are attached. The thorough promotional efforts were essential for the excellent attendance for a departmental colloquium series.

Concluding Comments

The 2013-2014 Philosophy Colloquium Series was remarkably successful. Relatively few departments organize lecture series, and for the Department of Philosophy, a very small department, to organize 6 lecture programs is a remarkable achievement and a great contribution toward enriching the life of our department, our college, the university, and the community. Every one of the 6 lecture programs was very well attended and had lectures that were challenging, significant, and presented at a high level of analysis. Especially noteworthy is the fact that each of the presentations generated so many good questions and such lively discussion so that each program went over the listed end time for the program. The level of attentiveness and engagement shown by our students, faculty, and other community members in attendance impressed all of our speakers. We are grateful for the grant support from the CA/DLS that made the colloquium series possible.

Budget

A final budget is attached. We spent the requested CA/DLS fund of \$1,868.00 on four of the speakers. We provided an additional \$2,115.12 in funding for the 2013-2014 Philosophy Colloquium Series. Two of the flyers were provided by Marketing and Communications, and the other flyers were provided by the Department of Philosophy.
