Olive and Dennis were married in 1956. They have lived in Oxford all of their adult lives. They lived on Mill Street until 1974, and then they moved on to Gore Road where they still reside. They had three sons, Laurence, William, Jay. They also have six grandchildren.

Dennis graduated from Oxford high school. He played and captained the OHS Western Maine Champion basketball team. He was also Class Marshal.

As many did before him he started working at Robinson MFG but soon found work with Central Maine Power Company where he was a lineman, first class for over 30 years retiring about 14 years ago.

Currently serves on the board of selectmen .He also served on the board of selectmen in the mid 1970's. His grandfather Porter had also been a selectman at one time.

Dennis serves as a director for the Oxford County Fair, and as trustee of Kora Shrine Temple.

Once upon a time

Served as sexton for Town's Riverside Cemetery for over thirty years, selling grave sites and supervising and conducting mowing and maintenance of the cemetery. He also served as secretary of the Lake Thompson Fish and Game. And was instrumental in getting the Federal Hatcheries to stock Whitney and Hogan with Bass.

Dennis also coached farm team baseball for Oxford in the early 1970's.

In the mid 1960 he helps organize the little league baseball league consisting of Mechanic falls, Poland, Oxford and others. Spent many days and evening clearing trees and brush from around the legion ball field. He built seats and dugouts for the ball clubs. He also spent many days and evening clearing brush and coordinating excavation of the ball field at Pismo. Found services to get the lighting installed at the Pismo Park doing much of the electrical install himself.

He built a laundry mat in Oxford Village which later became the old police department building. Approached by selectmen at the time to sell, he sold the laundry in the mid 1980. in order to give the fire dept more space by having the police in its own building.

Interests and offerings

Known throughout the state for philanthropic work related to raising monies for various charities accumulated many fryolator, popcorn machines, hot dog steamers, slush puppy machines and flat top griddles. He repaired and offered them for use by various organizations for their fund raising efforts. I think that everyone knew that if they needed cooking equipment they could go to Dennis to find it.

Recognized for his generosity with charities he has been honored by the Lions Club, the Rotary Club, the Shriners and other notables with honorary membership or awards of highest distinction.

For many years Dennis provided all the fryolators at the shrine's all star high school football games.

Known for his knowledge of Model A automobile he collected and restored many with his father Laurence, notably the 1929 US mail delivery truck that served its life at the Norway Post Office. Many have traveled to find parts or get his help in restoration work.

OLIVE-

Olive Graduated from Oxford High School. She attended Farmington Teachers College.

Olive also started working in Robinson Manufacturing but eventually went to work as a school bus driver for sad 17 driving for over 30 years.

Currently has returned to work at the coffee shop doing cooking and managing day to day activities part time.

Currently she sits on the Board of Director's for the School District. As well as on the town's Budget Committee and the Cemetery Committee.

Olive has also coached basketball for girls for town ball, and was a den mother for the cub scouts.

For 30 plus years she has done mowing and maintenance at the Riverside Cemetery. jointly as sexton selling gravesites for the town.

Town of Oxford Changes Voting Procedure

The Town of Oxford has changed the way its candidates are nominated and the way its citizens vote. Last November 20, 2008 at a Special Town Meeting the citizens voted to change to a majority vote as required when a population surpasses 4,000 according to the census. Last census in 2000 had the town's population at 3,960. Since the next census is in 2010, the town decided to be proactive and make the change prior to that census when it would be mandated. This means that anyone interested in running for a town office needs to take out nomination papers for that position and gather at least 25 valid voter signatures. Nomination papers must be turned in to the Clerk by April 27, 2009. This will put those candidates on the Town's ballot, along with any referendum question, to be voted on Tuesday June 9, 2009. Now citizens may absentee vote for those positions. In the past only those present at Town Meeting had a say in who was elected and nominations came only from the floor. Offices up for election are two seats for Selectman/Assessor with a three year term, one seat for Oxford Water District Trustee with a three year term, one seat for MSAD#17 Director with a three year term, and Fire Chief for a three year term.

If any town resident is interested in seeking office, they may come in and get nomination papers. Absentee ballots should be available May 11th. Polls open 8:00am and close at 8:00pm on June 9 at the Public Safety Building. The budgetary part of the Town Meeting will be held on Saturday, June 13, 2009 at the Oxford Elementary School.

TOWN MANAGER'S REPORT

To the Board of Selectmen and Residents of the Town of Oxford:

I am again pleased to report that due to strong community involvement, a pro-active Board of Selectmen and a dedicated Town Staff, 2009 was another positive and productive year for the Town of Oxford.

Due to the implementation by the Town of several strong and fiscally prudent financial policies several years ago, the Town of Oxford is quite healthy when viewed in a financial light. The Town is in a position to address ongoing capital improvements without sharp increases in the tax rate while being able to weather short-term revenue problems caused by the slowing economy and the lack of strong fiscal policies at the State level. Annual auditing continues to test the practices and procedures of the Town's finances and prudent fiscal management continues to keep our finances healthy.

The Town has undertaken many projects in the last year that are at various levels of completion. Some of these projects include:

- A safety grant allowed the town to replace much of its worn out safety devices paying for 75% of the cost;
- The Town Clerk's office has been remodeled and is now A.D.A. compliant;
- The outdoor rink was paved to allow for year round use;
- Several severely damaged roads have been scheduled to be reclaimed and paved (due to the 100% increase in liquid asphalt prices, many paving projects were postponed until next year); and,
- Handicapped accessibility continues to be improved.

The 2009 Property Revaluation Program for the Town of Oxford is almost completed and the new assessments from this program will be effective as of April 1, 2009. Property owners will see the results reflected in their tax bills in late 2009.

The Town hired the firm to conduct its revaluation program which is required by State law. A revaluation ensures that future property valuations are equitable which simply means that no single taxpayer pays more or less than their fair share of the property tax burden.

The Town will continue to aggressively address the problem of the extensive deterioration of the municipality's infrastructure (public buildings, streets, bridges, water systems and recreational areas), caused by age and deferred maintenance.

This year the Town again worked very hard to maintain the current level of services without increasing the mil rate and I believe we were successful; however, as I stated last year, the overall tax burden placed on property taxes is a shared responsibility between the Town, State, County Government and MSAD #17.

I would again like to take this opportunity to thank all of the boards, committees, countless volunteers and the Town's staff for their continual support and hard work. Without the dedication and community involvement of these groups and individuals it would be impossible to provide the existing level of services at current tax rates. It has sincerely been an honor and a pleasure to work for the citizens of the Town of Oxford.

KAY HOUSE REPORT

The Kay House was donated by the heirs of Mary Kay Wilder for use as a museum type building and accepted for that use by a vote of the town in 1985. The Selectmen and the Historical Society entered into a management agreement whereby the Historical Society would manage and maintain the house while collecting and displaying local artifacts pertaining to the history of the house, the town and the region. Maintenance beyond the capacity of the Historical Society would be referred to the Selectmen.

From 1 January 2006 through 1 May 2007, the Historical Society spent \$8899.69 on building maintenance. The society is currently investigating the cost of re-roofing the building. The current asphalt shingles are brittle and parts of some have been lost in the wind.

The house and artifacts are open for viewing by groups or individuals on request and on pre-announced special occasions. Two such occasions will be during our fund raiser yard sale in July and August. For other times, please contact a member of the Historical Society—better yet, join and become a member.

Beryl Moore Memorial Fund

When Dr. Beryl Moore died on May 9, 1987, the townspeople of Oxford, where she had served as a physician for nearly 50 years, wanted to do something to perpetuate her memory in the community. A fund drive was established and it was decided to provide furnishings for the Family Room of the obstetrical section of the Stephens Memorial Hospital. This seemed particularly appropriate as Dr. Moore had delivered over 2,500 babies during her career and had been a member of the original hospital staff when it opened in 1957.

Monies were raised and after paying for the furnishings and having a portrait of Dr. Moore painted for the room, there was still a small amount of money left over. It was decided to establish the Dr. Beryl Moore Memorial Fund for the purpose of providing scholarships to those Oxford residents graduating from high school and furthering their educations.

Since that time, many young people have received financial aid through this fund. The program has been kept alive through donations. This year the scholarships awarded were in the amount of \$1,000 each.

To the Residents of the Town of Oxford:

As I sit here reviewing the calls of the past year preparing to write this letter to you all, I realize that the pro-active approach that the Town of Oxford has taken with its emergency services has been money well spent. Almost 74% of our emergency calls are received between the hours of 6am and 6 pm for Fire and Rescue. Those calls range from medical emergencies to structure fires. In April the Fire Department responded to a reported brush fire, when the crews arrived on scene the fire was just starting to catch the barn on fire. Fire crews were able to extinguish the fire before it could severely damage the old farm house. Another couple minutes and that brush fire would have destroyed the farm house, displaced its occupants and cause a loss of tax revenue for the Town. When it comes to Fire and Rescue calls, time is EVERYTHING!!

Once again this past year the Fire Relief organization has done a great job. This dedicated group of people comes out at all hours to provide food and drinks to our members and to our neighboring departments as well. They raise money to help buy equipment and keep them self-supporting. The group did a fund raiser this spring and it was a huge success, they raised over \$5000.00 thanks to a matching grant from the Modern Woodsmen Insurance Company. If you were one of the many that donated, I thank you for your support and it is greatly appreciated. I am always amazed by the generosity of the citizens of Oxford and surrounding towns even in these hard economic times.

I would like to remind you all once again that first aid and CPR classes are available here at the Public Safety Building. If you are interested please contact Patty Hesse at 539-4509.

One other service the Fire Department offers is that if you have a fire extinguisher (which we all should have) in your home and you have a question on if it is still usable or if you have used it bring it to the Fire Department and we will handle getting it checked and refilled if necessary. We also have extinguishers that we can let you borrow until your returns.

Lastly, I would like to thank the members for all their hard work and dedication. I realize that nothing can ever replace the time you have lost spending with your loved ones, the birthday parties and family get together. Just know that your dedication is noted by many and I would like to personally like to thank each and everyone one of you.

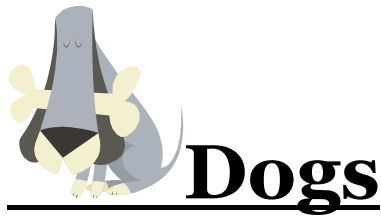
Message from the Clerk
