Ronald Taylor McAllister was born in Portland Maine on September 18, 1938 and has been a life long resident of Lovell. He is the son of Ralph and Ina Taylor McAllister. Ron grew up in Lovell, attended the Annie Heald School and graduated from Fryeburg Academy. On July 13, 1968 Ron married Althea (Sally) McCoombe and together they raised three girls, Althea, Catherine and Diana. Rons childhood years were spent living on Kezar Lake in the manager's house at Severance Lodge where his father worked. As a young man Ron went to heavy equipment school in North Carolina. **WARRANT FOR TOWN MEETING**

To: Larry Fox, constable of the Town of Lovell, in the County of Oxford and State of Maine.

Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Lovell in said county, qualified to vote in town affairs, to meet at the Town Hall in said town on Saturday, March 3, 2007, at 9:00 A.M. then and there to act on the following articles, to wit:

**Art. 1.** To see if the Town will nominate and elect a moderator to preside at said meeting.

**Art. 2.** To see if the Town will nominate and elect one member of the Board of Selectmen, Assessors and Overseers of the poor for a term of three (3) years.

**Art. 3.** To see if the Town will nominate and elect a Building Inspector for the ensuing year.

**Art. 4.** To see if the Town will make a recommendation to the Selectmen for an appointment of a C.E.O. The appointment is required by Maine State Law.

**Art. 5.** To see what the Town wishes to do regarding fixing the compensation of the town officers.

Budget Committee recommends we give all salaried employees a 5 % raise. (9 -0)

**Art. 6.** To see if the Town will nominate and elect one member to a five-year term on the Planning Board. (2012)

**Art. 7.** To see if the Town will nominate and elect one 1st associate member to serve a term of one year on the Planning Board.

**Art. 8.** To see if the Town will nominate and elect one 2nd associate member to serve a term of one year on the Planning Board.

**Art. 9.** To see if the Town will nominate and elect one member to serve a term of seven years on the Budget Committee. (2014)

**Art. 10.** To see if the Town will nominate and elect a second member to serve a term of seven years on the Budget Committee. (2014)

**Art. 11.** To see if the Town will nominate and elect one alternate for one year term on the M.S.A.D. #72 Board of Directors.

**Art. 12.** To see if the Town will nominate and elect all other necessary town officers for the ensuing year. (Board of Health, School Fund Officers, School Fund Trustees, Surveyors, Fence Viewers, Fire Wards, Forest Committee).

**Art. 13.** To see if the Town will vote to authorize the municipal officers to spend an amount not to exceed 3/12 of the budgeted amount in each budget category of the Lovell annual budget during the period from January 1, 2008 to the first Saturday in March 2008 Annual Town Meeting.

**Art. 14.** To see if the Town will vote to increase the property tax levy limit of \$811,779.71 established for the Town of Lovell by state law in the event that the municipal budget approved under the following articles will result in a tax commitment that is greater than that property tax levy limit.

**Art. 15.** To see what sum of money, if any, the Town will vote to authorize the municipal officers to appropriate from unappropriated surplus as they deem advisable to meet unanticipated expenses and emergencies that occur during the fiscal year.

Selectmen recommend take from surplus up to \$25,000.

**Art. 16.** To see if the Town will vote to allow the Selectmen to accept, at their discretion, any unrestricted contributions, properties, and any and all grants that they may apply for.

**Art. 17.** To see if the Town will vote to raise and or appropriate \$3,419.06 for overdrafts in the following accounts; \$3,233.41 for Planning Board; \$185.65 Board of Appeals.

Selectmen recommend take \$3,419.06 from Surplus.

**Art. 18.** To see if the Town will vote to purchase a new truck for Public Works Department, with a cap of \$140,000.00.

Selectmen recommend we do so.

**Art. 19.** To see how the Town wishes to finance the new truck. Selectmen recommend raise \$45,000.00 and finance balance as they deem appropriate.

**Art. 20.** To see what sum of money the Town will vote to raise and/or appropriate for the campership fees, unexpended balance to be carried forward. Request \$3,500.00.

Budget Committee recommends raise \$3,500.00(9-1)  
Expended \$3,440.00; balance forward \$1,188.24.

**Art. 21.** To see what sum of money the Town will vote to raise and/or appropriate to be expended under the supervision of the Lovell Recreation Commission, unexpended balance to be carried forward. Request \$15,000.00.

Budget Committee recommends raise \$15,000.00. (7-1-2)  
Expended \$42,368.35; balance forward \$6,340.38.

**Art. 22.** To see what sum of money the Town will vote to raise and/or appropriate for the Lovell Recreation Director, unexpended balance to be carried forward. Request \$25,480.16.

Budget Committee recommends raise \$25,480.16, which would include up to \$2,500.00 for mileage. (10-0)  
Expended \$18,874.86; balance forward \$1,972.67.

**Art. 23.** To see what sum of money the Town will raise and/or appropriate for the Josie Armington Flag Account, unexpended balance to be carried forward. Request \$500.

Budget Committee recommends raise \$500.00 (9-0)  
Expended \$300.00; balance forward \$ 00.00

**Art. 24.** To see if the Town will vote to have any unappropriated interest, interest and cost income from taxes, clerk fees, commissions and fees from processing registrations and boat & airplane excise credited to the Town Charges Account.

**Art. 25.** To see if the Town will authorize the Selectmen on behalf of the town to sell and dispose of any real estate acquired by the town for non-payment of taxes thereon, on such terms as they deem advisable, after due advertisement, and to execute quit-claim deeds for said property.

**Art. 26.** To see what sum of money the Town will vote to raise and/or appropriate for Town Charges for the ensuing year, unexpended balance to be carried forward.

Budget Committee recommends raise \$ 185,000.00 and carry the balance forward.  
Expended \$ 258,006.19; balance forward \$67,500.14 (8-0)

**Art. 27.** To see what sum of money the Town will vote to raise and/or appropriate for the care and maintenance of Town Buildings & Grounds, unexpended balance to be carried forward.

Budget Committee recommends raise \$20,000.00 (9-0)  
Expended \$13,370.80; carried forward \$3,889.90.

**Art. 28.** To see what sum of money the Town will vote to raise and/or appropriate for the Planning Board, unexpended balance to be carried forward.

Budget Committee recommends raise \$9,000.00 and take the overdraft of \$3,233.41 from Surplus. (9-0)

**Art. 31.** To see what sum of money the Town will vote to raise and/or appropriate for the purpose of updating the Town Valuation in 2007, unexpended balance to be carried forward. Request \$5,000.

Budget Committee recommends raise \$5,000. (9-0)  
Expended \$5,000.00; carried forward \$ 0.00

**Art. 32.** To see what sum of money the Town will vote to raise and/or appropriate to be held by the Lovell Volunteer Fire Company as a Capital Fund in anticipation of needed equipment. This is a joint account with the Town. Request \$30,000.00.

Budget Committee recommends raise \$30,000.00 (7-0-2)

**Art. 33.** To see what sum of money the Town will vote to raise and/or appropriate for the Fire Protection Operating Account to be expended under the supervision of the Lovell Volunteer Fire Company. Request \$40,000.00.

Budget Committee recommends raise \$40,000.00 (7-0-2)

**Art. 34.** To see what sum of money the Town will vote to raise and/or appropriate for the new LVFD Truck Fund. Request \$10,000.00.

Budget Committee recommends raise \$10,000.00 (7-0-2)

**Art. 35.** To see what sum of money the Town will vote to raise and/or appropriate to cover the cost of Street Lighting furnished the town for the current fiscal year, unexpended balance to be carried forward.

Budget Committee recommends raise \$6,500.00 (9-0)  
Expended \$6,423.05, carried forward \$487.37.

**Art. 36.** To see what sum of money the Town will vote to raise and/or appropriate for Civil Emergency Preparedness, unexpended balance to be carried forward.

Budget Committee recommends raise no money. (9-0)  
Expended \$00.00; carried forward \$ 1,583.55

**Art. 37.** To see if the Town will vote to appropriate some of the funds from the Town Conservation account to be put into Town Charges Account. This article reverses the action of the 2006 Annual Town Meeting under Art. 42.

**Art. 38.** To see if the Town will vote to allocate up to the first \$5,000.00 of funds received from penalties assessed on properties removed from Tree Growth or Open Space status and then 50% over that to a Town Conservation Account for use only in the purchase of conservation easements or conservation lands by the Town independently or in partnership with conservation organizations.

**Art. 39.** To see if the Town will authorize the Board of Selectmen to negotiate and enter into an agreement with the Town of Chatham, New Hampshire and the Town of Stow Maine to offer Lovell's Transfer Station and dump sites for Chatham's shared use for a term not to exceed five (5) years, upon the following terms: \$10,000.00 one time up front fee and \$15,000.00 per year for five years, payable annually. The Board of Selectmen shall set any additional costs, terms and conditions as they deem in the best interests of the Town of Lovell.

**Art. 40.** Shall an ordinance entitled “Ordinance governing the use of public boat ramps within the Town of Lovell, Maine” be enacted? (Copies of the ordinance will be available at the Town Clerk’s Office, and will be distributed at the town meeting).

**Art. 41.** To see if the Town will vote to recognize the public right to “beach” privately owned recreational watercraft, for brief durations of time in any given day, at the town beach known as Farrington’s Beach in an area situate westerly of the swim dock, and to authorize the Board of Selectmen to adopt and enforce reasonable regulations pertaining thereto to preserve the safety of all users of said beach and swimming area associated therewith.

**Art. 42.** To see what sum of money the Town will vote to raise and/or appropriate for Law Enforcement, unexpended balance to be carried forward. Budget Committee recommends raise \$2,000.00 and balance carried balance. (9-0)  
Expended \$1,777.25; carried forward \$61.36.

**Art. 43.** To see what sum of money the Town will vote to appropriate from monies received from the State for Snowmobile Registration Refund. Budget Committee recommends all monies received from the Snowmobile Registration Refund to be expended by the Kezar Trailbreakers Snowmobile Club. (9-0)

**Art. 44.** To see what sum of money the Town will vote to raise and/or appropriate for the replacement of the West Lovell landing dock, unexpended balance carried forward.  
Budget Committee recommends raise \$500.00 and carry balance forward. (10-0)  
Expended \$3,446.60; carried forward \$163.53.

**Art. 45.** To see what sum of money the Town will vote to raise and/or appropriate for Directional Signs Account (E911 road names) balance to be carried forward.  
Budget Committee recommends carry the balance. (9-0)  
Expended \$ 894.62; balance forward \$2,572.34.

**Art. 46.** To see what sum of money the Town will vote to raise and/or appropriate for Fryeburg Rescue Service. Request \$4,880.00.  
Budget committee recommends raise \$4,880.00. (10-0)

**Art. 47.** To see what sum of money the Town will vote to raise and/or appropriate for Fryeburg Rescue Service’s Investment Fund toward the purchase of a new rescue vehicle. Request \$3,300.00.  
Budget Committee recommends raise \$3,300.00 (10-0)

**Art. 48.** To see what sum of money the Town will vote to raise and/or appropriate for the Stoneham Rescue Service. Request \$10,116.00.  
Budget Committee recommends raise \$10,116.00. (5-0-5)

**Art. 49.** To see what sum of money the Town will vote to raise and/or appropriate for the Stephens Community Health Care.  
Budget Committee recommends take no action. (9-1-0)

**Art. 50.** To see what sum of money the Town will vote to raise and/or appropriate for Home Health Visiting Nurses of So Maine. Request \$375.00.  
Budget Committee recommends raise \$375.00 (10-0)

**Art. 51.** To see what sum of money the Town will vote to raise and/or appropriate for Tri County Mental Health. Request \$4,000.00.  
Budget Committee recommends raise \$4,000.00 (10-0)

**Art. 52.** To see what sum of money the Town will vote to raise and/or appropriate for Western Maine Transportation Services, Inc. Request \$150.00.  
Budget Committee recommends raise \$150.00 (10-0)

**Art. 53.** To see what sum of money the Town will vote to raise and/or appropriate for Community Concepts, Inc. to help defray the cost and maintain services provided to the residents of the town." Request \$2,400.00.  
Budget Committee recommends raise \$2,400.00 (10-0)

**Art. 54.** To see what sum of money the Town will vote to raise and/or appropriate for Androscoggin Home Care. Request \$880.00.  
Budget committee recommends raise \$880.00 (10-0)

Budget Committee recommends raise no money. (9-0)  
Expended \$ 353.68; balance forward \$2,067.76.

**Art. 58.** To see if the Town will authorize the Selectmen to make payment to Maine Bond Bank for our MMWAC bond issue, unexpended balance to be carried forward.  
Budget Committee recommends raise \$52,775.82 (9-0)  
Expended \$ 54,853.42; balance forward \$370.35.

**Art. 59.** To see what sum of money the Town will vote to raise and/or appropriate for maintenance and operation of all waste facilities (to include compacting, white goods, stump dump and septic waste spreading dump), unexpended balance to be carried forward.  
Budget Committee recommends raise \$101,000.00. (9-0)  
Expended \$ 113,382.83; balance forward \$11,366.71.

**Art. 60.** To see if the Town will vote to allow the Selectmen to make a final determination on whether or not to close certain roads to winter maintenance.

**Art. 61.** To see what the Town will vote to do with money received from Auto Excise Tax.

Budget Committee recommends \$62,000.00 to Winter Roads, and the remainder to Maintenance and Repair of Roads and Bridges. (Collected \$209,435.96) (9-0)

**Art. 62.** To see what sum of money the Town will vote to raise and/or appropriate for Snow Removal and other care of Winter Roads, unexpended balance to be carried forward.

Budget Committee recommends take \$62,000.00 from Excise tax, raise \$20,000.00 and carry the balance forward. (9-0)  
Expended \$50,424.76; balance forward \$ 49,595.24

**Art. 63.** To see what sum of money the Town will vote to raise and/or appropriate for the upgrading of Town Roads, unexpended balance to be carried forward. Request \$75,000.00.

Budget Committee recommends raise \$75,000.00 (9-0)  
Expended \$115,666.93; balance forward \$34,333.07

**Art. 64.** To see what sum of money the Town will vote to raise and/or appropriate for the Maintenance of Roads & Bridges, unexpended balance to be carried forward.

Budget Committee recommends apply the M.D.O.T. Block Grants and remainder of the excise tax. (9-0)

## SELECTMEN REPORT

We hope that you all have a healthy and prosperous 2007!

We have a few areas that we feel you all need to be aware of for this coming year.

First of all we are requesting that all elected officials and their respective committees meet with the Selectmen at least twice a year so as to inform us as to the issues that they are dealing with. This should hopefully keep us all better informed.

Secondly, we will be initiating a new Voluntary Boat Inspection and Form to be used this year at the North Lovell Landing. We are in hopes that this will be well received.

Thirdly, We have been getting some mixed messages about your concerns about Property taxes. At the November election, Lovell voted in favor of the proposed Tabor Bill, however at last years annual Town meeting the voters all voted in favor of every warrant article which resulted in a 40% budget increase. We are required to follow LD 1, which limits the % increase in our municipal budget unless we have an article that we vote on at Town Meeting that allows us to spend over that limit. (There will be an article to allow us to do this at this years Town Meeting.) If you, the voters do not want increases in you taxes, it is up to each and everyone of you to decide where cuts need to be made on all budget request. This will not be easy but it is the only way to keep taxes down. We cannot just cost shift because this ultimately does not reduce your individual expenses.

Once again as a reminder for those of you who still do not register your vehicles in Lovell and choose to live here we need you to know that the rest of us are subsidizing your roads with our excise taxes. State law does say to register in the Town your vehicle is garaged.

We all recognize how special Lovell is and we need to all work together to in order to keep Lovell growing and to guide it towards the future.

## Greater Lovell Land Trust

The mission of the Greater Lovell Land Trust (GLLT) is to protect the ecosystems of Kezar Lake and adjacent watersheds by promoting an appreciation of natural resources and responsible preservation, conservation, stewardship, development and public policy. We continue to work closely with private landowners and community leaders to set aside our most valuable natural assets for community benefit. We are committed to building strong human ties to our natural world by offering high quality, diverse environmental educational programs. The GLLT is thankful for the broad community support for our mission and programs and particularly grateful to the many volunteers and donors that make our efforts possible.

The GLLT serves the communities of Lovell, Stoneham and Stow, an area totaling 68,341 acres. The GLLT in conjunction with the voluntary efforts of private landowners has permanently protected 2,469 acres within these communities. Conservation easements protect 720 acres of privately owned land most of which is working forest or farmland, and 70 acres owned by the Town of Lovell. In addition the GLLT owns 1,679 acres of forest and wetlands which are open to the public for traditional uses including hunting and fishing. The GLLT properties are managed to insure water quality and wildlife habitat protection as well as for sustainable forestry, public access with special attention for endangered species protection. GLLT properties support over 13 miles of hiking trails and 2 miles of snowmobile trails for public use. New property and trail maps will be available in the spring of 2007. We invite and encourage all to visit and enjoy these special places you have helped to protect for ourselves and future generations.

The U.S. Department of Agriculture has chosen the GLLT to lead the development of a watershed Conservation Plan for the Kezar Lake, Kezar River and Cold River watersheds. The project goal is to identify the ecological systems present and potential strategies to protect their current and future functional integrity for water quality protection and the benefit of human and natural communities. The Conservation Plan is scheduled for completion in 2007. The Plan will guide future GLLT land protection efforts and be a resource to support and guide voluntary public and private land use decisions for years to come.

Volunteers are needed to advance programs and projects in the coming year. Help is needed to develop several new trails on 330 recently acquired acres and on the Kezar River Tract. In early October we need additional volunteers to join our enthusiastic core volunteers to help pick and ship wild Kezar Cranberries for customers nationwide through our Cranberries for Conservation™ program. We are also seeking literary contributions to our popular "Land Trust Notes" which focuses on interesting topics regarding our native environments. We welcome your time and talents and look forward to offering you interesting and rewarding opportunities to participate.

### PLANNING BOARD

The Board reviewed and approved two applications for Conditional Use Permits this year and the review begun in 2004, of the Farrington Shores subdivision proposal. The subdivision, consisting of nine large lots along the shores of the pond was approved by Board action in August. A second subdivision proposed in 2005 was withdrawn early this year.

Based on our work with Farrington Shores we found that our subdivision regulations, adopted some ten years ago, should be updated. This work was completed late in the year. We will schedule a public hearing on the proposed changes in 2007 before adopting them.

The State of Maine has directed all municipalities to revise their Land Use Regulations as they pertain to shoreland areas by 2008. Accordingly, with the help of the Southern Maine Regional Planning Commission, we began work on this task during the summer. The Board is studying the mandated changes to see how Lovell's Zoning Ordinance can best be adapted to them for the circumstances of our Town. We expect to complete this work in 2007, and plan to present the needed amendments for voter approval at the 2008 Town Meeting.

Planning Board meetings are usually on the first Wednesday of each month. We start business at 7:30pm. All of our meetings are open and the public is welcome to attend.

2006 got off to a very busy start. Being my first year as Chief it was filled with many changes, challenges and great expectations. I had a lot to learn but with a great support team, I believe I'm making great strides. With over half of our calls for the year coming in the first four months of the year, I managed to get a lot of on the job training! The remainder of the year had less than average call volume, giving me some time to regroup and leaving the department with our call numbers up about 10%.

The department completed the first part of the ISO project early in 2006. As a result of all the hard work that went into this project the town's fire rating was dropped from a 9/10 to a 7/10. This rating change could mean substantial insurance rate savings for some property owners in the Town of Lovell. If you have not already done so you should check with your insurance company to see how this rating change might affect your insurance premium. With this part of the ISO project completed the department is now focusing on maintenance, testing, and record keeping necessary to keep this lower rating as well as looking for ways to further improve and maximize our capabilities ultimately reaching our goal of a 6/10 rating.

With ever increasing government controls and training requirements the department is constantly looking for ways to improve our training program. We are looking into bringing in more outside instructors as well as joining up with neighboring departments to get the necessary training.

The department is also looking at upgrading some of our aging fleet in an attempt to be proactive and continue to provide the best possible service to the Town of Lovell, while still watching our bottom line. We are at this time looking for a replacement for our 1978 squad truck. Our hope is to replace this truck with a more modern better equipped vehicle.

On behalf of the entire membership of the Lovell Volunteer Fire Department I would like to express thanks and appreciation to every member of our community for their continued support. I look forward to working closely with you in the coming year. I also encourage you to contact me if you have any questions, concerns or are interested in joining the department.

**KEZAR LAKE WATERSHED ASSOCIATION  
ANNUAL REPORT – 2006**

The summer of 2006 ended on a sad note with the sudden passing of our long-time President and Trustee, Joan Irish. Joan's great love for Kezar Lake and her passion for environmental causes were well known throughout the Lovell community and beyond. The Kezar Lake Watershed Association has indeed lost a dedicated leader, mentor and friend. She will be missed dearly.

We plan to honor Joan's memory and pay tribute to her many years of service at our annual Membership Meeting next summer to be held on Saturday, July 14, 2007. We are fortunate to have the VFW Hall in Lovell as our new venue with David Littell, Commissioner of the Department of Environmental Protection for the State of Maine, as our guest speaker. We hope many of you will join us on this special occasion. Refreshments will be served!

The Kezar Lake Watershed Association is dedicated to preserving our pristine lake and its surrounding ponds for the enjoyment of generations to come. With the help of Scott Williams, Aquatic Biologist, and his capable VLMP staff, we have monitored Kezar Lake every spring, summer and fall for nearly thirty years. To insure that the exceptional quality of Kezar Lake is sustained, tests for water clarity, oxygen levels, acidity (pH), algae growth, nutrient phosphorous as well as zooplankton concentration are conducted several times each summer. Importantly, these tests have now been extended to all seven ponds and lakes in our watershed. The results for 2006 are, in a nutshell, very good. However, with our lakes and ponds not only sensitive but vulnerable to the effects of extensive land use, we must be on the lookout and ever vigilant to insure responsible development within our watershed in the future.

The Officers and Trustees of the Kezar Lake Watershed Association are mindful of the growing challenges we face to keep our lakes and ponds free from contamination and misuse. Special thanks go out to Paul Sirois and Katrina Soucy for their contributions to this cause year after year. Throughout the summer months, you can see Paul motoring up and down the lake in his new 16 foot Boston Whaler patrol boat, keeping a watchful eye on recreational boaters while Katrina, with her cadre of volunteers, coordinates countless inspections to insure that invasive plants remain as far from our shores as possible. We thank, also, our sister associations whose missions are closely aligned with our own.

As a volunteer organization, the KLWA depends upon the goodwill and support of our members and the entire Lovell community to keep our programs active and enduring.

### 2005 CHARLOTTE HOBBS MEMORIAL LIBRARY

In 2006, the town's library in Lovell Village begun making preparations for celebrating a century of service to the community in the same quaint and friendly structure. We will observe our building centennial in 2007. We continue to depend on a mix of municipal funding and private fund raising to keep our doors open.

The library provides not only an impressive book collection, but a seires of ongoing programs for adults and children, a meeting place for the town, and a wireless internet site convenient for laptop computer users. MINERVA links us by computer to other Maine libraries. The annual Arts and Artisans Fair and the December Tree Lighting are now established annual activities for the town and a wider public. We sponsor cooperative programs eith the Greater Lovell Land Trust, the town Recreation Department, and Historical Society.

Our book circulation, computer use, and program attendance *all continue to increase*, putting us among the top libraries in Maine on a per capita basis:

After keeping detailed statistics on traffic flow in the library, and after consulting with patrons, we are reducing library opening hours from 44 to 35 per week, increasing them in July and August to 46 hours to meet summer needs.

**Operating Budget Request:** For 2007, we are requesting from the Town of Lovell, a contribution of \$40,000 toward our operating budget. This represents a decrease of \$5,000 from our 2005 and 2006 contribution of \$45,000. By reducing hours and tightening our belts in other ways, we hope to keep the library open as many hours as possible to meet community needs.

The library also continues to pursue it's capital campaign for a much neede building expansion. We are working with local builders and contractors to modify our design and keep costs at a minimum. We are grateful for the continuing support of the Town of Lovell, which has a first-rate town library to maintain.

**LOVELL INVASIVE PLANT PREVENTION COMMITTEE  
(A.K.A. MILFOIL COMMITTEE)**

First of all we want to recognize two of this Committee's outstanding founding members who passed away in 2006. Joan C. Irish and C. George Scala not only recognized the threat posed by invasive aquatic plants, they did something about the problem by going to the Selectmen and to the town to raise public awareness and to provide funding for the Committee's activities to protect the Town's lakes and ponds.

We will surely miss them both but we are ever grateful for their vision and public service.

This year the committee has a number of summary reports for the taxpayers and residents of the town to review, and they are presented as follows:

**Courtesy Boat Inspection**

This summer was probably the most comfortable summer for Courtesy Boat Inspection (CBI) duty because of the beautiful, well-made, and bug-free shelter!!

Thanks to the outstanding efforts of several Committee members the CBI program now has a "Headquarters at the Narrows". Not only was it protective cover, but it also sent a strong message to boaters that our community is serious about protecting our waterways!

We covered a total of five bass tournaments and conducted a total of 921 boat and gear inspections.

Our Adopt-a-Saturday program ran well this year with a strong turn out. If you have a group of neighbors and friends who would like to adopt a ramp for a day, please call Katrina @647-3042.

**Invasive Aquatic Plant Screening Survey**

During 2006 a Level 3 (entire shoreline area) survey was conducted on six water bodies in the Kezar Lake Watershed. Trained biologists looked for any occurrence of the eleven invasive aquatic plant species on Maine's watch list. Cushman Pond was not included in this survey but is surveyed 5 times each season under another program.

No invasive aquatic plants were detected. The water bodies surveyed were; Kezar Lake (Lower and Middle Bay), Trout Lake, Heald Pond, Farrington Pond, Horseshoe Pond, Bradley Pond.

**Cushman Pond Invasive Aquatic Plant Control Program**

During 2006 a total of three gallons of milfoil plants were found and removed from various locations in the pond. This program which has been ongoing since 1997 operates under the auspices of the Lovell Invasive Plant Prevention Committee (LIPPC) and permits and oversight by the Maine Dep't of Environmental Protection (MDEP).

We received a permit from the MDEP to install eight benthic (bottom) barriers which kill milfoil plants by excluding light. This program is a valuable tool in our continuing fight to control and ultimately eradicate milfoil from Cushman Pond.

**Cushman Pond Dam Replacement**

The Cushman Pond Dam was built over 100 years ago and is now in exceptionally poor condition. The scattered rocks and granite blocks which are the remains of the original dam have been displaced by winter ice and heavy water flow conditions and much of the water from the pond bypasses the dam over a wide adjacent area. This bypass area has resulted from erosion and soil slumpage along many feet of the adjacent shoreline.

Milfoil fragments are kept from escaping from the pond by two courses of netting suspended from rebar stakes installed across approximately 70 feet of the outlet area. This netting is easily damaged, must be replaced almost annually, and must be examined frequently for holes and tears that might allow a milfoil fragment to escape. Every effort is made to locate and remove milfoil plants from the entire pond several times per season, however there is always the danger that milfoil fragments may escape from the pond and migrate to Heald Pond and then in all probability to Kezar Lake.

The LIPP Committee has been working with the State and a professional dam engineer on plans to resolve this problem for some time. A preliminary set of design drawings and construction specifications have been developed and reviewed by the State.

At a pre-application meeting with the Permits Dep't of the Maine Department of Environmental Protection (MDEP) in early 2006 we were advised that due to the extremely poor condition of the existing dam the State would only issue a permit for replacing the dam and the option of repairing the existing dam was not acceptable.

The new dam will incorporate features specifically designed to keep milfoil fragments from escaping from the pond, along with conventional features for managing water levels to insure the best health of the pond.

A straightforward engineering approach has been taken in developing this project to insure that State regulations are complied with, that a valuable water resource is protected and preserved, and that the funds expended will result in a dam that will last for many years.

There will be items in the Town Warrant regarding the funding for this project. Members of the LIPP Committee are available to discuss the dam project or any of the LIPP Committee activities with anyone who is interested.

**FRYEBURG RESCUE TOWN REPORT 2006**

To the citizens of Fryeburg, Brownfield, Lovell, Stow, and Chatham

Once again another year has come to a close on the books of Fryeburg Rescue. Fryeburg Rescue responded to 604 calls in 2006. The breakdown was as follows: Fryeburg 396; Brownfield 91; Lovell 53; Stow 24; and Chatham 37. Fryeburg Rescue would like to thank and acknowledge the help and support of all other agencies and organizations that assist us in our duties. We made several calls on the Saco River with the help and support of the Police Department and the use of the Airboat. The helicopter support of Life Flight and Dart continue to assist us with calls and are extremely valuable services to have supporting us. United Ambulance, Conway Rescue, North Conway Ambulance, and PACE have provided us with Paramedic Intercept coverage when we require it. And we can't forget the faithful local fireman, police and sheriff deputies who are always willing to lend a hand.

We continually train and have held several multiple agencies trainings. We have a wonderful dedicated squad of EMS personnel and without their support as well as the moral and financial support we receive from our local communities we would be unable to continue providing emergency services. We still remain as one of the few remaining all volunteer, non-billing services in the state.

We were notified in April that we had been selected for a Community Facilities loan in the amount of \$149,000.00 and a grant of \$36,000.00 from the United States Department of Agriculture. This along with our other funds raised allowed us to purchase and take receipt of our new ambulance (503) and we are now awaiting our new extrication (crash) truck. We would like to remind the communities that our budget requests from the towns are what pay for our operating expenses with a contribution towards our new unit fund. All other expenses such as training, licensing, new equipment, radios, turn out gear, and office supplies are paid for from rescue association raised funds. These expenses range between \$30,000.00 and \$60,000.00 annually. These monies are also needed in order for Rescue to operate. Our Association Budget funds these additional categories.

We are always looking for people who would like to join our squad. We offer a way for you to serve your community while learning some very valuable skills. Involvement does not require a doctor's medical expertise just a willingness to help people in need. We have applications in the rescue building, if you are interested please stop by and fill one out.

The mission of the Lovell Recreation Department is: *to provide sports and recreation programs and activities that will benefit the health and wellness of all our Lovell community members and the neighboring towns our department serves.* First, the department cannot thank enough the coaches, committee members, and parents for the many hours they volunteer to make the Lovell Recreation Department a successful, fun-filled, caring organization.

The Lovell Recreation Department had a busy 2006-year introducing seven new programs and two new fundraising activities. Girls Lacrosse, Track & Field, a Teen Day Hike and an Adult Exercise Class were among the new programs. The two inaugural annual fundraising activities were the Tour de Lovell (a 20-mile bicycle race/tour in August), and the Gasping Gobbler 5K (a 3.1-mile run/walk in November) raised funds for the department as well as providing a recreational fitness activity for the community. The combination of these activities and the Lovell Old Home Days 5K in July allowed the Town of Lovell to be ranked in the top ten sporting events of the year in the Bridgton News.

Department infrastructure improvements included the creation of the Lovell Rec. web site: [www.lovellrec.com](http://www.lovellrec.com) and setting up the hotline for weather cancellations, etc. Additionally, a coaching orientation program was established to instill our department's coaching philosophy and better prepare our coaches for handling current sport/recreation issues. Participation totals for the year increased 15%, and predictions indicate increases will likely occur in 2007.

Also new in Lovell Recreation was the creation of travel teams in track, soccer and basketball, comprised of Lovell and surrounding Recreation Departments. The goal is to improve skill levels of advanced youth players while continuing the intramural programs for recreation developmental needs. Collaboration and sharing youth talent within the local area recreation departments helps those youths to be better prepared for SAD 72 school system sports programs.

The 2007 Lovell Recreation year will be even busier with the department hoping to reactivate the Lovell Enrichment After-School Program at the New Suncook School; enroll the department in the National Little League Baseball program; improve existing facilities and resources; and raise funds with fun-filled activities while applying for grants. Our department will continue to request input on the recreation needs of the Lovell community and towns we serve, and introduce programs to fulfill those needs and meet our mission to *Renew-Refresh-through Recreation.*

As you gather for your Annual Town Meeting, I welcome this opportunity to share some of the work that has made me proud to represent the people of Lovell and all of Maine in the United States Senate.

As Chairman of the Senate Homeland Security Committee, I am pleased to report that Congress made real progress in 2006 to protect our nation, including major legislation that I coauthored to improve the security of America's seaports. 

In 2006, I helped secure a record level of funding for the Low Income Home Energy Assistance Program (LIHEAP), and Congress renewed the tax deduction I authored for teachers who spend their own money on classroom supplies and my renewable energy tax credit. The landmark Postal Reform legislation I coauthored will ensure affordable rates and preserve universal service. Major Defense bills include my provisions to help secure the future of Bath Iron Works and the jobs of our skilled shipbuilders.

**IMPORTANT****ALL TAXPAYERS SHOULD READ THE FOLLOWING  
REQUIREMENTS AND COMPLY WITH THEM**

Chapter 81, Section 35 of the Revised Statutes of Maine require the Assessors to give notice to bring up lists of taxable property. If no lists are brought in, no claim for abatement.

“Before making an assessment, the assessors shall give reasonable notice in writing to the inhabitants by posting notifications in some public places in town, or shall notify them in such other way as the town directs, to make and bring in to them true and perfect lists of their polls, and all their estates, real and personal, not by law exempt from taxation, of which they are possessed on the first day of April of the same year. If any resident owner after such notice, or any nonresident owner after being reasonable requested thereto by the assessors, does not bring in such a list, he is thereby barred of his right to make application to the assessors, or county commissioners, for any abatement of his taxes, unless he offers such list with his application and satisfies them that he was unable to offer it at the time appointed. The request upon nonresident owners may be proved by a notice sent by mail to the last known address of the taxpayer or given by any other method that brings notice home to the taxpayer.”

It is your responsibility to license your dogs, not the Animal Control Officer. His duty is to dispose of any who are not licensed.

Please see that your dog is under your control - on your own property at all times.
