Warrant

To *Harold E. Boynton*, Constable of town of Howland, in said County,
Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of Howland, qualified by law to vote in town affairs to assemble at the Town Hall in said town on Monday, the eighth day of March, A. D. 1926, at 10 o'clock in the forenoon, to act on the following articles, to wit:

Art. 1. To choose a Moderator to preside at said meeting.

Art. 2. To choose all necessary Town Officers for the ensuing year.

Art. 3. To choose a Fire Inspector and Fire Chief, and fix his compensation and to see what sum of money the town will raise for Support of Fire Department, including new hose.

Art. 4. To see if the town will vote to have the Chief Constable or Police Officer of the town collect the Taxes for the ensuing year under the same terms as past year, or vote any other form of compensation.

Art. 5. To choose a Collector of Taxes.

Art. 6. To see if the town will allow a Discount of five per cent. on all taxes assessed in the year 1926, on real and personal estates which are paid on or before July 1st of that year; and see if the town will vote to have all taxes assessed in the year 1926 collected and paid into the town treasury, at least two weeks before the next annual town meeting.

Art. 7. To see what sum of money the town will raise for the Support of Poor.

Art. 8. To see what sum of money the town will raise for the Support of Schools, (Common and High).

Art. 9. To see what sum of money the town will raise for Repair of Schoolhouses.

Art. 10. To see what sum of money the town will raise for Physical Education in Schools.

Art. 11. To see what sum of money the town will raise for the Building of Road on Valley Avenue, Cross Street, and Improvement of School Ground Athletic Field.

Art. 12. To see what sum of money the town will raise for Decoration Day.

Art. 13. To see what sum of money the town will raise for Support of Thomas Free Library.

Art. 14. To see what sum of money the town will raise for Highway and Bridges.

Art. 15. To see what sum of money the town will raise for Winter Roads.

Art. 16. To see if the voters of Howland will vote to raise \$1,000.00 for Improvement (under direction of Selectmen) of so called Ralph Emery Road.

Art. 17. To see if the voters of Howland will vote to raise \$1,000.00 for Improvement (under direction of Selectmen) of Penobscot Street north of "Cemetery Road," and Mattamiscontis Road.

Art. 18. To see what sum of money the town will vote to raise for Repairs of Piscataquis Bridge.

Art. 19. To see if the town will vote "Yes" or "No" on the question of appropriating and raising money necessary to entitle the town to State-aid as provided in Section 19, Chapter 25, of the Revised Statutes of 1916.

Art. 20. To see if the town will appropriate and raise the sum of \$798.00 for the Improvement of State-aid Road as outlined in the Report of the State Highway Commission, in addition to the amounts regularly raised for the care of Ways, Highways and Bridges; the above amount being the maximum which the town is allowed to raise under the provisions of Section 18, Chapter 25, of the Revised Statutes of 1916.

Art. 21. To see what sum of money the town will vote to raise for Maintenance of State-aid Road.

Art. 22. To see what sum of money the town will raise for the Care of Cemetery.

Art. 23. To see what sum of money the town will raise for Street Lighting.

Art. 24. To see what sum of money will be raised for paying Interest on and retiring Town Bonds and Notes maturing the next fiscal year.

Art. 25. To see what sum of money will be raised for operating Town Hall.

Art. 26. To see what sum of money the town will raise for Insurance on Town Buildings.

Art. 27. To see what sum of money the town will raise for Incidentals.

Art. 28. To see what sum of money the town will raise for Discount, Commission and Abatement on Taxes, and Interest on Temporary Town Loans.

Art. 29. To see if the town will vote to grant to the Lee Graham Post No. 97, American Legion, the exclusive rights to operate motion picture shows in the Town Hall and town of Howland.

Art. 30. To see if the town will vote to authorize the Town Treasurer and Selectmen to hire money for town purposes, if necessary, in anticipation of the Collection of Taxes the ensuing municipal year.

Art. 31. To see what night the town will vote to allow the free use of Town Hall to the American Legion.

Art. 32. To see if the town will vote to furnish free the use of Town Hall one or two nights, excepting holidays, to each of the three church organizations, the schools, and Local No. 87 and one night to the Advance Bag & Paper Company Basketball Team, and free use of the hall for basketball practice of High School team.

Art. 33. To see what sum of money will be raised for Sewer and Water, including operation and maintenance, and for the extension of water on Lagrange Road.

Art. 34. To Revise the Jury List.

Art. 35. To see if the town will vote to accept the new type Traffic Beacons, and if accepted will raise the sum of \$580.00 for their purchase.

Art. 36. To see if the town will vote to accept the provisions of the Workmen's Compensation Act.

Art. 37. To transact any other business which may legally come before said meeting.

The Selectmen give notice that they will be in session at Town Hall on Monday, the 8th day of March, at 9 o'clock in the forenoon for the purpose of correcting the voting list.

I have the honor to submit the following report for the Library for the year 1925.

The Library has been opened for the circulation of books its regular number of hours each week throughout the year except legal holidays.

This report shows the usual statistics giving in detail information concerning the work of the Library. The year's growth was as follows:

making a total of 1848 catalogued volumes in the Library February 15th, 1926.

\$48.32 Stipend Fund was received from the State.

\$44.10 was collected for fines on books kept beyond the specified limit of two weeks, making \$76.69 Fund money, \$24.31 was used for books, magazines and supplies.

The circulation for the year has been 6,463, mostly fiction and children's books.

The largest day's circulation was Monday Evening, December 28th when 89 books were given out. The smallest circulation was May 20th when only 21 were issued. The average daily circulation was 45. October was the largest month with a circulation of 696 and April the smallest months record with only 434 given out. The figures for the largest and smallest circulation of books have no real value but are inserted merely for interest.

Total number of card holders is 375 an increase of 35 over previous year.

We are subscribers to the following magazines: American Boy, American, McCalls, Pictorial Review, Good Housekeeping, Geographical, W. H. Companion, L. H. Journal and Sun Up, Maine's Own Magazine.

More shelf room should be provided in the children's department, the floor needs painting also an outside glass storm door is needed, more money should be raised for these purposes.

School Report

To the Citizens of Howland:

We submit the following annual report of condition of schools and a financial statement of same.

GENERAL CONDITIONS

We were able to secure teachers with experience and some normal training. There are two normal graduates and all others have had several years of experience and some normal school training. This applies to grade teachers. It was necessary to make a few changes in pupils and teachers rooms so that all could be accommodated. Changes were as follows: Grade 4 changed to Grade 5; Grades 5-6 changed to Grade 6; Grade 3 changed to Grades 3-4; Grade 2 changed to Grades 2 and Div. of 4th.

Changes are necessary on account of increase of pupils in various grades from one year to the other. Many new pupils have come here from other towns. There have been few removals.

Next year the largest number of pupils will be in the Grammar Room, Grades 7-8. Estimate at present is about 50 pupils. More seats will have to be ordered. A suitable increase in salary ought to be given to principal, due to increase in size of school.

We had to secure two new teachers for grades and two for the High School.

Principal L. W. Moan has been in charge of the High School for the past two years. Mr. C. P. Jones has had charge of the Latin and French Departments. This is also his second year here. Mr. F. C. Ingalls and Miss Pauline Colesworthy have been in charge of Athletics. Results obtained have been satisfactory. For further information, in regard to High School, I refer you to Report of Principal of Howland High School.

The school at North Howland is very small; but according to information received and climatic conditions; it was considered advisable to continue this school. Expense is much less than any other method that could be used.

BOOKS AND SUPPLIES ACCOUNT

The High School is supplied with plenty of books for present classes. New purchases will be necessary to replace old books. Some will be needed for use of pupils as they advance from one class to the other; but not as many as have been bought during the past four years.

The grades will have the greater increase in pupils next year and many books will be needed for this purpose. At present time there are only two small grades in the schools the 3d and 4th. All others average 35-40. We will need about the same amount of supplies as last year. The most of these are used in grades as paper is not furnished for use of High School pupils, except for written lessons.

There were plenty of Chemicals so that purchases in this department have been very small. It will be necessary to secure a few more supplies for Physic's Laboratory. This will also depend on size of classes.

REPAIRS ACCOUNT

A large amount was appropriated for repair of schoolhouse roof; to take care of snow and ice. This was not done as material ordered did not arrive as soon as expected. This may be done next year.

Some of this money was used to improve the Athletic Field that was purchased last year. Some gravel would improve this field, as it cannot be used in wet weather. This is something that the town needs so that the boys and young men can have a good opportunity to take part in athletic work.

Some new seats will have to be ordered for next year. This will accommodate pupils for the next school year; provided increase is not too great.

Another new building will be necessary for the High School if grades increase, as much as they have, for the past two years. It will

not be necessary to make arrangements for this until the time comes; but it is well to think about it and decide what shall be done in the near future.

Some minor repairs were made on school building such as; new windows, locks for doors, repairs on electric bells and pump. Cost has not been very large.

We wish to thank the citizens, parents, teachers and town officials who have helped to make the schools a success during the year.

REPORT OF PRINCIPAL OF HIGH SCHOOL

To the Superintending School Committee and Citizens of Howland:

I herewith submit my second annual report as Principal of Howland High School.

On returning to Howland in September, I found that we had two new teachers to work with. This fact presented many new thoughts and possibilities, for the success of the school, naturally depends on the kind of teachers, one has to work with. I soon found that I had two splendid assistants who were well qualified for their work and were willing to take part in all school activities and to cooperate with the school officials and myself. This is the proper spirit for every teacher to have.

In order that the citizens of Howland, may know more about their teachers I have compiled the following table:

The Course of Study is practically the same as last year. Some of the requirements have been changed. English History is given in place of Biology, French is not required until the 3d year, Geometry is required, only for students who wish it for college credit.

Attendance has been very good. Total enrollment was 77 and the average attendance was 69. Some of the pupils have left school this term.

It is very hard, indeed, to express our gratitude to the townspeople and school committee for the excellent Athletic Field that they provided this Summer. It enabled us to start football, which could not have been done otherwise. It will be very useful for baseball and track also for the town teams in baseball, etc. The Howland, Lincoln and Lee Track meet will be held here next Spring.

Although we did not win many games in football, we have developed a team that will give a good account of itself later. The boys have learned the rudiments of the game and this is worth a great deal. Many of them had never seen a game and did not know what was expected of them.

We trust that the citizens will continue to give their generous support to all of our teams and they will not get discouraged over some of the failures to win. We wish you to remember that our school has just started in athletic work and we have to compete with teams that have won many games and have had years of experience where we have had a limited amount and in some cases, none at all.

School activities consist of Athletic Teams in Baseball, Track, Football, Basket-ball, School Plays and Entertainments. We also publish a school paper and have a small orchestra. Mr. Jones has taken an active part in our musical program. We try to have every boy or girl take part in some school activities. This custom is now being followed in all of the leading colleges.

This year a new set of Compton's Encyclopedia and 25 new books, written by standard authors of English and American Literature, were added to our school library.

We had an old set that Mrs. Swan kindly loaned to the school. She made the school a present of it when she left. The above books have been very helpful for students who needed more information for History, English, Science, etc.

We have a new electric gong on the building and all students know when school begins. It prevents much of the tardiness that has happened in the past.

Our Commencement Program will be about the same as last year. All exercises will be held in the Town Hall.

In closing I wish to thank the citizens, school committee, Supt. of schools and teachers for their kindness and interest during the past year. I sincerely hope that this interest will remain the same even if your boys and girls have completed the work and entered upon other branches of work.
