## Report of the Superintendent of Schools

To the Superintending School Committee and  
to the Citizens of Owl's Head:

At the close of the last school year, Mrs. Myra Scammon felt obliged to leave her duties at the Timber hill School because of poor health. Mrs. Scammon has taught there for ten years and her faithful service has been very much appreciated. Mrs. Bernice Sleeper of South Thomaston has taught there since September. Mrs. Winifred Lamb Barbour, who taught at Ash Point last year with success, decided to engage in different work and Miss Ellen Birmingham of Bangor, a Castine Normal school graduate was employed for the Ash Point school. She proved to be capable and well liked by the pupils. She left at the Winter term recess for a more lucrative position and Miss Anna Avery of Prospect will teach for the remainder of the year. Miss Avery is a Farmington Normal School graduate and comes well recommended. The Junior High School opened in the Town Hall in Sept. with Mr. Bradley Dennett of Gorham as teacher. This young man has been graduated from the three year course at Gorham and has taught successfully.

The schools have done good work. Pupils have cooperated and there have been no very serious disciplinary difficulties. A few cases of suspected truancy among the older pupils have been the cause of concern. If this should continue to trouble us serious steps will be taken. An apparent improvement, however, has been quite reassuring in recent weeks.

The teachers employ well tested and approved methods and seem to get good results. It seems that pupils forget very much during the long summer vacations, and often in the fall term things seem very discouraging especially to a new teacher.

The establishment of the Junior High School appears to have justified itself by the superior training now being given to the upper grades.

At some time in the not too distant future our citizens should recognize the desirability of a further grading of the children of the town in a central school. It would be unwise to attempt such a step before the people are ready for it, but any school superintendent, who is at all informed on educational matters of the present time, cannot fail to see that such a school would fill the educational needs of the town much more efficiently than the one room schools can fill them, and the cost should not be prohibitive. I believe that the citizens will recognize this need in the near future and that they will act accordingly.

The establishment of the Junior High School, by

(Page 42)

taking the upper grades from the rural schools have radically changed their programs and class periods and in the adjustment many new textbooks have had to be purchased. All our school accounts have shown large expenditures. The expenditures for high school tuition will probably be higher than ever, and this is something that your school officials are unable to change. Their only duty is to bring about payment of such tuition bills as have been legally contracted.

The cost of alterations at the Town Hall was considerable but was kept within the limits of the Repairs appropriation.

The overdrawn accounts for textbooks and supplies do not look well but all expenditures were legitimate and made with care. As a whole the expenditures were less than the resources.

For another year I must recommend a much increased appropriation for high school tuition. More will also be needed for textbooks and supplies, but the total school appropriations may be some smaller than those of last year.

The Parent-Teacher Association has functioned this year and we hope that it may continue in various ways to assist our schools especially in maintaining good understanding between teachers and parents.

The work in clinics and similar projects is helpful.

In conclusion I wish to express my thanks to all

officials and citizens who have cooperated with the schools and to all who have given loyal support to the cause of education in the town of Owl's Head.

To see what sum of money the Town will raise and appropriate for State Aid road construction (in addition to the amounts regularly raised for the care of ways, highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Art. 29. To see if the Town will vote to authorize the Assessors to rescind any amounts appropriated by the Town for State Aid Highway construction in excess of the amount required to meet State Apportionments.

Art. 30. To see what sum, if any the Town would recommend to take from the joint state aid account for the purpose of applying bituminous surface treatment to State Aid Roads, in excess of the Requirements of Sect. 2, Chap. 132 P. L. 1935.

Art. 31. To see what sum of money the Town will vote to raise for construction of Roads and Bridges.

Art. 32. To see if the Town will vote to raise and appropriate a sum of money to extend the present Town Road from where it now ends, at the beach near the Pearson's cottage, to a point at or near the Lane leading to the Hiram Small property.

Art. 33. To see what sum the Town will appropriate to continue the road on the land of Dudley M. Holman authorized by the vote of the last Town Meeting from where it left off last fall to Beach Street, title to said roadway being conveyed by deed from Dudley M. Holman to the Town of Owls Head.

Art. 34. To see what sum will be appropriated to continue the construction of the road from the main highway beginning at the west side of the cemetery to Beach Street to connect with the road on the land deeded by Dudley M. Holman to the Town of Owls Head.

Art. 35. To see if the Town will vote to raise and appropriate the sum of \$300.00 to be used for repairs on the Ballyhack Road.

Art. 36. To see if the Town will vote to raise a sum of money to repair the road starting at Ocean Avenue in a Southerly direction, approximately 300 feet to the left turn near the Homer Cottage.

Art. 37. To see if the Town will vote to appropriate a sum of money to construct a road from the main highway at the south side of Harry Spaulding and on the north side of Mrs. Elbert Rappleye, thence to the land owned by Victoria Seifert.

Art. 38. To see if the Town will vote to raise a sum of money to build a road starting at the main highway in an easterly direction to the bend of the road by the Crescent Beach Inn Pavillion.

Art. 39. To see if the Town will vote to raise the sum of Two Hundred Dollars (\$200.00) to be expended on the Town Cemeteries; Selectmen to appoint a Committee of three from each section of the Town.

Art. 44. To see if the Town will vote to name for, and have dedicated to, the late Merle Foster, the square which was remodelled last year (1940) located in Ash Point and furnish a suitable metal sign marker from current expense or State Aid Fund.

Art. 45. To see if the Town will vote to raise and appropriate the sum of Two Hundred Dollars (\$200.00) to purchase a snow scraper.

Art. 46. To see if the Town will vote to raise and appropriate the sum of Fifty Dollars (\$50.00) to purchase addition snow fence.

Art. 47. To see if the Town will accept the sum of \$150.00 the income of which is to be used annually for the care of the Thomas Maddocks lot in the Owls Head Village Cemetery.
