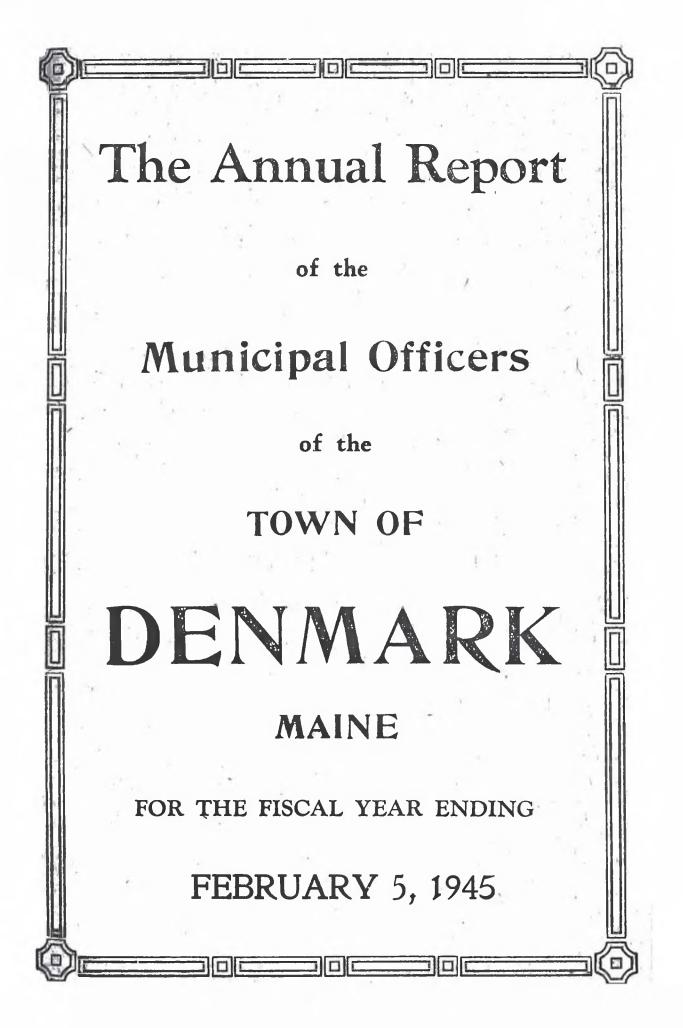

WARRANT FOR TOWN MEETING

To Albert F. Wentworth, Constable in the Town of Denmark, County of Oxford, and State of Maine,

GREETING:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of said Town of Denmark, qualified by law to vote in town affairs, to assemble at the town house in said town on Monday, the fifth day of March A.D. 1945, at ten o'clock in the forenoon, to vote upon the following Articles, to wit:

Article 1. To choose a moderator to preside at said meeting.

Art. 2. To choose a town clerk for the year ensuing.

Art. 3. To choose a board of selectmen, assessors, and overseers of the poor, and town treasurer for the year ensuing.

Art. 4. To choose a tax collector for the year ensuing.

Art. 5. To choose a member of the superintending school committee for a term of three years.

Art. 6. To choose one or more road commissioners for the year ensuing.

Art. 7. To choose one or more fire wards for the year ensuing.

Art. 8. To see if the town will elect or authorize the selectmen to appoint a cemetery commission, consisting of one or more persons, whose duty shall consist of caring for the cemeteries and burial lots, including the graves of old soldiers now in care of town, for the year ensuing.

Art. 9. To choose all other officers for the year ensuing.

Art. 10. To vote the compensation of the tax collector for the year ensuing.

Art. 11. To see what sum of money the town will grant and raise for the payment of town charges for the year ensuing.

Art. 12. To see what sum of money the town will grant and raise for the support of street lights for the year ensuing.

Art. 13. To see if the town will appropriate and raise \$300 to repair the Fessenden Hill road.

Art. 14. To see what sum of money the town will grant and raise for support of roads and bridges for the year ensuing.

Art. 15. To see what sum of money the town will appropriate and raise for tar for third class road.

Art. 16. To see what sum of money the town will grant and raise for the payment of snow bills for the year ensuing.

Art. 17. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State aid, as provided in Section 20 of Chapter 28 of the Revised Statutes of 1930.

Art. 18. To see what sum the town will raise and appropriate for the maintenance of State highways for the year ensuing, under the provisions of Sections 9, 18, 36, 38, and 39, Chapter 28, of the Revised Statutes of 1930. Art. 19. To see what sum of money the town will grant and raise for the cutting of bushes on the highways for the year ensuing.

Art. 20. To see if the town will grant and raise the sum of \$592 for the maintenance of third class highways for the year ensuing.

Art. 21. To see what sum of money the town will grant and raise for school repairs for the year ensuing.

Art. 22. To see what sum of money the town will grant and raise for the support of common schools for the year ensuing.

Art. 23. To see what sum of money the town will grant and raise for the payment of school supplies and textbooks for the year ensuing.

Art. 24. To see what sum the town will grant and raise for the support of a free high school for the year ensuing.

Art. 25. To see what sum the town will grant and raise for electric lights and power for schoolhouses for the year ensuing.

Art. 26. To see if the town will vote to raise and appropriate the sum of \$25 for Public Health Nursing in said town. This sum to be expended by the State Bureau of Health for local services.

Art. 27. To see what sum the town will grant and raise for the care of the soldiers' monument for the year ensuing.

Art. 28. To see what sum the town will grant and raise for Memorial Day observances for the year ensuing. Art. 29. To see if the town will vote that poll taxes become due and payable of May 1st as under the provisions of Chapter 16 of the Public Laws of 1917.

Art. 30. To see if the town wishes to give a discount on taxes and if so to fix the date and amounts of same.

Art. 31. To see if the town will vote to authorize the selectmen to procure a temporary loan or loans in anticipation of taxes for the purpose of paying obligations of the town, such loan or loans to be paid during the current municipal year out of money raised during said current municipal year by taxes.

Art. 32. To see if the town will vote to buy the lot of land now owned by the Fire Committee and to grant and raise money for the same.

Art. 33. To see what sum of money the town will grant and raise for the purchase of a truck for fire equipment.

Art. 34. To see what sum of money the town will grant and raise for a proper building for the use of a fire house.

Art. 35. To see what action the town will take in regard to electing a fire committee and a fire chief to execute Articles 33 and 34 and to act as the fire committee.

Art. 36. To see if the town will appropriate and raise \$3,000 to pay note due February 1946. Fire Equipment Note [so-called]. Art. 37. To see if the town will vote to authorize the selectmen to bring suit in the name of the town for back taxes for the years 1930 to 1936 both inclusive or to approve of their abatement in whole or in part.

Art. 38. To see if the town will authorize the selectmen, on behalf of the town, to sell and dispose of any real estate acquired by the town for non-payment of taxes thereon, on such terms as they deem advisable, and to execute quit-claim deeds for such property.

Art. 39. To see what sum of money the town will raise and appropriate for advertising our natural resources, advantages and attractions, under the provisions of Chapter 5, Section 82 of the Revised Statutes of 1930, said sum to be expended under the direction of State of Maine Publicity Bureau.

The selectmen give notice that they will be in session at the town house on Monday, the fifth day of March, 1945, at 9 o'clock A.M. for the purpose of correcting the list of voters.

Given under our hands this fifth day of February, A.D. 1945.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Committee and Citizens of the Town of Denmark:

Herewith my twenty-second annual report.

MYRTIE A. DEERING

The school officials and indeed every citizen of Denmark was shocked and grieved to learn of the sudden passing of Mrs. Myrtie A. Deering who died on Sept. 13, 1944.

Mrs. Deering was one of the best known and most highly respected citizens of the town. Since 1939 she had served as a member of the School Committee and last spring was, for the second time, elected as its chairman. Her interest in all that pertained to the schools was well known. Her loyalty to them was unceasing. Her sacrifice of time and effort for them was very great. Her constant effort and her wise counsel is missed in very great measure by her associates.

While quite a few items of school building repairs had been planned few of them were completed. The steel for the roof of the East building was purchased but it has not been laid. Other repairs that had been planned have had to await an easier labor situation. Small minor repairs were made as they became necessary. This situation may seem illogical when we discover that we have an overdraft in the repair account. However, the steel for the East building roof cost more than our entire resources for the repair account. This roofing job must be completed this year in any event. No changes have been made in the laboratory as yet. Such must await the time when materials and labor will be possible or easier to obtain.

The repair bills in and about the village building would be far less had we there more students who respected public property and the burden of the taxpayers. Wanton destruction is taking place each year and this has been the case for many years. This method of having fun, of showing off, this exhibitionism, this sort of hick performance—out of date elsewhere fifty years ago—is a reproach upon the intelligence of the whole student body of the high school and also upon some in the grammar school. Someone, somewhere should do some missionary work it would seem to a non citizen of the town. Such continued misuse and abuse of school property does not occur elsewhere, at least within our knowledge. It is, of course, not our intention to imply that all students are guilty. At the same time we should suppose that those who are not might have some influence upon those who are. No high school student anywhere is of so tender an age not to know the expected rules of correct conduct and decent behavior both in school and out of school.

Conveyance arrangements are nearly the same as last year. The present operational expense is now \$58.00 per week. A family with five pupils living in the former Liberty Corner school house and attending the East Fryeburg School cost together for conveyance and tuition, \$10.00 per week. For this, the present year for these now temporary residents, the state will refund the conveyance charges but the town is obligated for the tuition charges. Next year this family if then in town will not be temporary residents.

This year we received from Camp Wyonegonic the sum of \$25.00 which is being expended for noon lunches in the East and Village elementary schools. The East School also received from Camp Walden a piano which, after being repaired and tuned is "as good as any and better than some." For these gifts hearty thanks and appreciation are extended.

School Census: Persons in town, April 1, 1944 from five to twenty-one years of age: Girls 60, boys 59, total 119, a decrease of 11 from last year.

For the resident pupils we pay \$10.00 per week for conveyance making the total cost of the pupils at East Fryeburg not more than \$548.00 including the amount to be refunded for conveyance.

REPORT OF THE PRINCIPAL OF DENMARK HIGH SCHOOL

Denmark. Maine, February 1, 1945.

To the Superintendent of Schools, School Committee, and the citizens of Denmark. I hereby submit the annual report on the status of Denmark High School.

Our current school year, 1944-1945, began, at the opening of the Fall Term on September 18, 1944, with an enrollment of 20. There are, at present, 17 pupils in the school: 2 seniors, 6 juniors, 5 sophomores, and 4 freshmen. The average attendance at the close of the Fall Term, December 22, 1944, was 16.86.

Our school continues to be on the approved list of Grade A High Schools of the State of Maine, and we have received our certificate for the current year to confirm this rating, from the State Department of Education. In compliance with their requirements, we are pursuing the following courses this year: English I-IV, French II, Latin I-II, World History, American History, General Mathematics, Geometry, General Science, Economic Geography, and Pre-Flight Training in Aeronautics. Music is being continued under the supervision of Mr. John Gatchell, with the efficient assistance of Mrs. Rolfe.

Since we have so few boys in school, it is impossible to maintain any athletic teams. An organized program for individual Physical Training would seem to be very timely and worthwhile.

In the field of extra-curricular activities, we presented a very successful comedy-drama, "Waiting at the Church," last February, and held the annual speaking contest in May. For both these functions the school orchestra, mixed quartet, and girls' glee club furnished several excellent numbers. At present we are at work on a better type of play to be presented later in the year, and are planning for our speaking contest in the spring.

Our Student Council is functioning most efficiently. Under its direction we are carrying out various patriotic programs. In the fall several of our students aided in gathering milkweed floss which was collected from all parts of the country to be used as a substitute for kapok in making life preservers for our ships in all branches of the service.

Our seniors are preparing to enter the National Student Contest on the subject of International Peace, which is being sponsored by the League of Nations Association.

Between the opening of school in September and the present time our school has invested over \$400.00 in

war bonds and stamps, which we think is a remarkable showing for a school of this size, since that means an average of \$21.50 per pupil for the 18 weeks.

Since our country, and the world as a whole, is passing through such an uncertain period, and we are living under such rapidly changing political and economic conditions, it is the aim of the teachers to stress the objective, rather than the subjective point of view in the presentation of the various subjects. Although our school has a small enrollment, we feel that it has a very definite and important part in the work of this community for the promotion of good citizenship, by presenting to cur young people, at an impressionable age, the knowledge of the duties, rights and privileges which all the people of our country enjoy, and by trying to inculcate in our pupils an intelligent and ethical attitude toward life in general. A direct and gratifying result is that both our seniors are planning to continue, at more advanced institutions of learning, preparation for a definite profession. This 100% record is very unusual at the present time.

We wish to thank Supt. Snow, and the school committee for their kindly and untiring assistance and aid in all crises which have arisen; assistance which is so essential to the maintainance of a school. We would also thank the people of the community for their loyal support. We hope and trust that this support and aid may be rewarded by the type of future citizens produced by Denmark High School.

REPORT OF THE SUPERVISOR OF MUSIC

To the School Officials and Citizens of the Town of Denmark:

During 1944, the music program in your schools has continued as in the preceding war years.

On the vocal side we have continued to work on the standard three-fold program: teaching to "carry a tune," teaching to read music, teaching part singing.

Music Appreciation has been offered through recordings.

New books which have been added in the Elementary grades have been most helpful.

Instrumental music has been carried on mainly privately, outside school hours, as before. There is a great need for parents to start their children on instruments other than piano if our school orchestra is to continue. Violin and 'cello beginners are particularly needed, as are one or two each on trumpet, clarinet, and drums.

As we face plans and hopes for the peace which is to come, we should be thinking about the instrumental program. At present it reaches too few, even though the Supervisor is forced to work twelve or more hours per day to keep the work going. We should study the systems where all children are reached both vocally and instrumentally according to scientifically determined abilities. Then we should plan our own system according to scale.

As the years pass, in your service, I am more and more grateful for the cooperation and loyal friendship which I have received and enjoyed from so many of you.

ANNUAL REPORT DENMARK — DECEMBER, 1944

The Farm Bureau women of Denmark cooperated with your Public Health Nurse and sponsored a Child Health Conference. Transportation to the Conference was furnished by these women. 12 children were examined at this Conference, 5 of them received diphtheria toxoid and 9 received smallpox vaccination.

Thirty-two home visits were made in your town to infants and preschool children in an effort to secure protection against diphtheria and smallpox in early life the time when this protection is most valuable. Some of these visits were made to help mothers secure the correction of defects found at the Child Health Conference. Mothers are looking to the Public Health Nurse for information concerning the best type of care for the new babies.

The Audiometer was used in Denmark schools in January to test hearing of school children.

Nine visits were made to school children. Four of these were in the interest of crippled children.

I wish to thank the Farm Bureau, Mr. Pingree and Mr. Trumbell for the assistance given me on health problems.

With such interest and health conscious citizens we hope next year to secure a physical examination for each school child.

REPORT OF STATE DEPARTMENT OF AUDIT

September 14th, 1944.

To the Inhabitants of the Town of Denmark: In accordance with the request of your municipal officers, this department, represented by M. G. Allen, has completed an examination of the accounts of your town officials for the municipal year ended February 10, 1944.

In our opinion, based upon such examination, the accompanying exhibits and schedules fairly present the financial condition of your municipality as of that date, and summarize its fiscal transactions during the municipal year then ended.

COMMENTS

CASH

All receipts as recorded during the year were examined and the cash for same was found to have been deposited in the bank currently, as summarized on Exhibit B.

Expenditures were made by check from properly authorized warrants, supported by invoices and payrolls on file, as summarized on Exhibits B and D. It was necessary to check all disbursements in detail in order to arrive at the correct balance.

The cash balance was reconciled with the bank as per detail shown on Schedule 1. We also checked the Treasurer's cash to September 5, 1944.

TAXES-PROPERTY AND POLL

The 1943 tax commitment was found to be in agreement with the Assessors' records. The balance due from the Collector on this commitment is represented by unpaid taxes taken from the records, as summarized and detailed on Schedule 2. The unpaid prior years' taxes are also shown on Schedule 2.

Payments recorded as received during the year on tax liens and deeds appeared to have been applied against the proper items and those still remaining unpaid are summarized and detailed on Schedules 3 and 4.

The cash collection of the current year's taxes was 97.5%; while all taxes collected during 1943, both current and prior, amounted to 103.1%, as referred to the current commitment.

EXCISE TAX

The excise tax collections were verified with the copies of the receipts as follows:

TRUST FUNDS

The trust fund investments were examined and are shown in detail on Schedule 5. Dividends on impounded funds, new funds received and income from bonds was still in general cash at the close of the year, although at the time of this audit, these amounts had been properly deposited.

NET DEFICIT

Reference to Exhibit A indicates that as of the close of the municipal year, there was a Net Deficit in the amount of \$457.79 as compared to a Net Deficit of \$527.94 shown the year previous. This represents a beneficial change of \$70.15, which is analyzed on Exhibit E of this report.

GENERAL

Our test check of paid invoices and payrolls indicated they were proper charges and correctly recorded.

Victory and Withholding Tax deductions were examined and appeared to be properly recorded. Deductions were made and payments sent to the Collector of Internal Revenue each period.

The records of dog licenses issued by your Town Clerk showed collection in the sum of \$122.30, however, \$122.40 was paid to the State Treasurer.

With the exception of cash and trust funds, no external verification was made of your asset and liability accounts.
