Greetings!

I am adjunct faculty in the School of Social Work. Sandy Butler forwarded email requesting COVID19-related syllabus or materials to all faculty who taught in the spring term. I am attaching 2 syllabi here, one for an ungrad (BSW) social welfare policy course, SWK 440, and the other for a graduate (MSW) policy advocacy class, SWK 640. I taught both in the spring term, and had to adapt both to the online learning environment midway through the semester. As you will see, I adapted several assignments and created options in both classes to allow students to respond to assignments using COVID19 as their focus for the content.

The SWK 640 COVID19 assignment changed format a little from what is in the syllabus based on feedback/ input from the students. I am also including a link to a shared Google file so you can have access to the final slideshow presentation that was created. The students and I found the assignment quite moving and powerful in the end.
