**ARTICLE 40:** To see if the Town will vote to close the North Shapleigh Road and Orchard Road from the old orchard gate at 413 Orchard Road to the Goding Road, for summer and winter maintenance for a period of ten (10) years.

**ARTICLE 41:** To see if the Town will vote to accept the following roads as Town Ways:

ACTON RIDGE ROAD – from the Newfield town line at Balch dam to the N.H. state line at Wakefield (approx. 2.3 miles)

BAKERS LANE – from the intersection with Milton Mills Road to the intersection with Sanborn Road (approx. 0.1 mi.)

BUZZELL ROAD – from the intersection with Foley Way and Lakeside Drive to the road laid out and accepted in 1894 and now known as Buzzell Road (approx. 0.47mi.). This would make the current Buzzell Road approximately 1.27 miles long.

CANAL ROAD - from the intersection with Young's Ridge Road and New Bridge Road to the NH state line at Wakefield (approx. .32 mi.)

COUNTY ROAD – from the intersection with Milton Mills Road to the intersection with Foxes Ridge Road (approx. 1.6 mi.)

DANDY ROAD – from the intersection with Mann Road for 0.1 miles to the turnaround at the McGlincy property

FRENCH STREET – from the intersection with Foxes Ridge Road to the intersection with Milton Mills Road (approx. 0.22 mi.)

GARVIN ROAD - from the intersection with Route 109 to the turnaround at the top of the hill (approx. 1.6 mi.)

GODING ROAD – from the intersection with Milton Mills Road to the Lebanon town line (approx. 2.2 mi.)

GOOSE POND ROAD –from the intersection with Route 109 to the Shapleigh town line (approx. 1.4 mi.)

H ROAD – from the intersection with Route 109 to the intersection with Acton Ridge Road (approx 5.72 mi.)

HOPPER ROAD – from the intersection with Sam Page Road to the N.H. state line at Milton Mills (approx. 3.1mi.)

LAKEWOOD DRIVE – from the intersection with Acton Ridge Road to the turnaround at #208 Lakewood Drive (approx. 0.4 mi)

LAKESIDE DRIVE – from the intersection with H Road for approximately 0.3 miles to the intersection with Red Gate Lane.

LEBANON ROAD – from the Sanford town line to the Shapleigh town line (approx. 0.8 mi.)

MANN ROAD – from the intersection with Acton Ridge Road to the end of the pavement just past #492 Mann Road (approx. 0.9 mi.)

NASON ROAD – from the intersection with Sam Page Road to the intersection with Goose Pond Road (approx. 0.6 mi.)

NEW BRIDGE ROAD – from the intersection with Young’s Ridge Road to the intersection with Young’s Ridge Road and Canal Road (approx. 1 mi.)

NORTH SHAPLEIGH ROAD – from the intersection with the H Road to the Shapleigh town line (approx. 1 mi.)

ORCHARD ROAD – from the intersection with Milton Mills Road to the intersection with Goding Road. (approx. 1.5 mi.)

PECK ROAD – from the intersection with Milton Mills Road to #458 Peck Road. (approx. 0.8 mi.)

POINT ROAD – from the intersection with Peacock Road to the turnaround (approx. 0.3 mi.)

SAM PAGE ROAD – from the intersection with Goose Pond Road, across the H Road, across Route 109, past the Hopper Road intersection, and back to Route 109 at #2039 Route 109 (approx. 1.7 mi.)

SANBORN ROAD – from the intersection with Route 109 to the intersection with Milton Mills Road (approx.1.9 mi)

YOUNG’S RIDGE ROAD – from the intersection with Route 109 to the intersection with Canal Road and New Bridge Road (approx. 1.8 mi.)
