At the end of the second year in the new building we find that continual improvement in instruction has taken place, aided materially by the better facilities provided. The teachers have been able to do a better job in the new building. We have been fortunate in retaining the same teachers for a number of years, which makes for continuity of instruction. Principal Clara E. Stone has given the school a strong administration. She has instituted a testing and record program which will greatly improve efficiency of the school.

A Hot Lunch Program under the guidance of Mrs. Stone and Mrs. Jones, has proven to be highly successful, both financially and in lunch service to the school children. Much credit is due to the interest of the Mothers' Club in this project.

I call attention to the annual increases in secondary tuition charges. According to our best information, these rates will continue to rise each year. Teachers salaries will need to be improved annually in order to hold and employ good teachers. School bus service will doubtless involve additional money, when new contracts are drawn for the next three year period. I recommend that the school be painted on the outside this summer, in order to protect the exterior.

ANNUAL REPORT OF THE PUBLIC

HEALTH NURSE

Arundel — 1961

The general purpose of public health nursing is to help people and the community as a whole to achieve and maintain optimal health.

On July 1, 1961, the annual contractual arrangement between the State Division of Public Health Nursing and the town of Kennebunkport and Arundel was no longer available. This contract provided that a nurse employed by the State Division of Public Health Nursing, was assigned full time to the towns. The towns in turn provided office space, equipment, and some supplies. The towns were billed for 99% of the nurse's salary and travel. Under agreement with the town of Kennebunkport, Arundel paid one-third of the cost of this program. It was necessary to discontinue this service because the 100th Legislature failed to enact a bill designed to clarify already existing legislation—legislation that was not clear in its intent.

From July until October 31st, the program in Arundel remained the same. During the last two months, following my transfer to the office maintained by the State Division of Public Health Nursing in Kennebunk, and the assignment of new towns, home visits for health supervision continued, but of necessity, no regular bedside nursing service was available.

Nine child health conferences were held during 1961 with a total attendance of 85. Since the conferences were cancelled due to storms in February and March 1961, and the attendance is low during these months due to difficult traveling, it was decided not to have any for the winter months in 1962.

Participation at preschool registration, and interviews with the parents at this time revealed that most of the children entering school had been immunized.

An immunization clinic was held in March with a total attendance of 36. The following immunizations were given:

Eye rechecks were done on 25 pupils referred by the teachers and parents were notified of the findings.

Audiometer tests were done on 41 pupils from the second grade and teacher referrals.

Arundel should be proud of its school lunch program. This will not only benefit the children by providing a hot lunch, but also can be a very valuable tool in teaching good nutrition.

Periodic visits were made to the schools and conferences held with teachers regarding specific health problems.

I would like to take this opportunity to thank everyone who has helped make the program a success. I am especially grateful to the selectmen, Health officer, superintendent of schools, principal, teachers, and members of the Community and Health Club for their loyal support of the program.

ADVICE TO LOCAL HEALTH OFFICERS—

READMISSION TO SCHOOL

One of the most vexing problems encountered by many new local health officers is the interpretation of the health officer's role in getting children back to school after illness. The "return

Annual Report

to school" law, page 108 of Health Laws of the State of Maine, 1957, states:

"The superintending school committee or school directors shall cause to be referred to a school physician for examination and diagnosis every child returning to school without a certificate from the local health officer or family physician after absence on account of illness or whenever in the judgment of the teacher the circumstances of the absence were such as to require such a certificate, and every child in the schools under its jurisdiction who shows signs of being in ill health or of suffering from infectious or contagious disease, unless he is at once excluded by the teacher; except that in case of schools in remote or isolated situations, the school committee or school directors may make such other arrangements as may best carry out the purpose of sections 57 to 64, inclusive."

It is evident that no particular problem exists if there is a family physician to sign the certificate for return to school; or if the health officer is himself a physician, able to evaluate the child's condition; or if the town has a school physician to whom the school committee, superintendent or teacher can refer the child who has no certificate. However, in the small towns where the health officer is a lay person, with the nearest physician miles away, and where there is no school physician, the health officer is sometimes put in a difficult position in the matter of signing certificates.

Many of the children in these towns will not have had a doctor because they were not sick enough for the parents to call one, often for a long and expensive trip. Consequently the health officer is frequently expected to use his judgment about signing the certificate. Sometimes an uncooperative family sends the child back anyway, without a certificate.

The local health officer should always remember that the law places solely on the school committee the responsibility for seeing that the child returns to school with proper precautions. The health officer does not have to see that each child has a certificate, and if he is faced with a problem in the matter he should take it up with the committee.

If a town has no school physician—even though its situation

is not particularly "remote" or "isolated"—it is highly advisable for the school committee and health officer to work out a general policy as to who shall sign "return to school" certificates and under what circumstances. Establishing such a policy may need to involve others besides the health officer and the school authorities. There may be situations in which the municipal officers should be consulted; the District Health Officer will be ready to advise, if needed; often the public health nurse can help.

The chart now appearing on the revised sheet, Important Facts About Communicable Diseases, will be found useful, since it indicates the diseases in which a physician should definitely be consulted before a child is sent back to school, and gives specific advice about length of exclusion for other diseases. Important Facts also carries other information which will be valuable to all those who are concerned with school health. These sheets may be obtained in any number from the Maine Department of Health and Welfare, State House, Augusta.

REPORTABLE DISEASES:

Conjunctivitis of New Born, Diarrhea, Epidemic, of New Born, Food Infections (Salmonellosis), Hepatitis, Infectious, Rat-bite Fever, Acute Rheumatic Fever.

Reportable to Local Health Officer

Actinomycosis, anthrax, botulism, chickenpox, cholera, Asiatic, dengue, diphtheria, Dysentery (a) Amebic, (b) bacillary; encephalitis, epidemic, food poisoning, german measles, glanders, hookworm disease, influenza, leprosy, malaria, measles, meningitis (a) meningococcal, (b) tuberculous; mumps, paratyphoid fever, plague, pneumonia, poliomyelitis, psittacosis, rabies, Rocky Mt. spotted fever, scarlet fever, septic sore throat, smallpox, trachoma, trichinosis, tuberculosis, all forms; tularemia, typhoid fever, typhus fever, undulant fever, Weil's disease, whooping cough, yellow fever.

However not being a physician I am not qualified to issue admission certificates.

REPORT OF TREE WARDEN FOR 1961

Since authorization of Dutch Elm Disease control at the 1961 town meeting, the State Forest Service has agreed on establishing two control areas in Arundel. #1—along the Arundel and lower River Roads approximately 1/4 mile on each side of Goffs Creek; #2—along U. S. 1 at the intersection of Old Limerick Road, Arundel Market area. In addition two property owners in other locations were helped in identifying and removing diseased trees.

Thirty-four samples from suspected trees were taken, nineteen were submitted to the State for analysis and thirteen were identified as having Dutch Elm Disease. Four of these were removed and destroyed at the Kennebunkport town dump in the winter of 1960-61. Nine were removed to the Arundel town dump in the winter of 1961-62 and must be burned or covered with dirt before April 15th, 1962.

All costs for removing seven trees were paid by the property owners. The cost of cutting six "line" trees near the Arundel Market was shared equally by the owners and the town, while the State Highway Department handled the entire cost of removal to the town dump.

On trees removed in 1960-61 the owners were reimbursed 40% of the cost by the State. On trees removed in 1961-62 we expect the town and owners will be reimbursed for 30% of the cost under the latest State Forest program.

The 1962 Dutch Elm Disease control plan recently announced by the State Forest Service requires sanitation (pruning and clean up) as well as removal of diseased trees. It is recommended that Arundel continue to co-operate with the State on the basis of limited control areas supplemented by any additional locations whose owners will pay control costs.

We have received \$74.00 reimbursement money from the State. Including reimbursements we have expended \$204.80. This leaves a balance of \$169.20 to carry over into 1962 but out of this we must pay for consolidating, burning and covering the 1961 debris left in the Arundel dump.

This is a brief report of the work we accomplished on white pine blister rust control in Arundel in 1961.

Our men examined 3645 acres that had been previously worked ten years ago. We found and destroyed 642 wild gooseberry plants one of the hosts of the disease. This is a great improvement over conditions prevailing ten years back when we destroyed thousands of the bushes. We try to examine each pine growing area once in ten years, unless it was a particularly heavily infected when the interval between inspections is reduced to five years. The work this year was paid for by the Town of Arundel and the State of Maine. Arundel paid \$293.35 and the State of Maine paid \$230.00.

Arundel does have pine areas scheduled for re-examination in 1962 that fall in the five year status. I believe that the Forest Commissioner will write you about these early in 1962. I appreciate the cooperation that you and the Board gave us, as well as, the cooperation of the citizens of Arundel.

COMMENTS

Cash

The cash balances, as noted in the balance sheet, were reconciled with the bank statement and a written confirmation of the balances was made.

Uncollected Taxes

A percentage of the uncollected taxes, as shown on the collector's records at December 31, 1961, and unpaid tax liens, were verified by written confirmation with the taxpayer.

Special Funds

Cemetery Trust Funds were found to be on deposit in properly designated accounts and were verified by written confirmation with the several bank depositories.

General

The procedure for keeping the municipal records of the town officers was examined, and found to be adequate, and in compliance with the General laws of the State of Maine, as approved by the State Department of Audit.

Scope of Audit

This audit was made as required by the State Department of Audit, Chapter 405, Section 26, of the General Laws of 1957.

Records were checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as to the handling of cash and other matters of financial concern. External verifications, on a test basis, were utilized to the correctness of recorded assets and liabilities.

Receipts, vouchers and cancelled checks were examined, for authenticity, for a selected period. Bond and insurance coverages were examined. Excise tax collections for a selected period were verified with copies of the receipts retained by the Tax Collector.

Art. 28. To see if the Town will vote to authorize a 2% discount on all property taxes paid in full within thirty days of receiving the bill.

Budget Committee recommends adoption of this article.

Art. 29. To see if the Town will authorize the Collector of Taxes to charge interest at 6% on all unpaid property after December 1st.

Budget Committee recommends adoption of this article.

Art. 30. To see if the Town will vote to raise and appropriate by assessment the sum of \$600.00 for Civil Defense.

Budget Committee recommends \$600.00.

Art. 31. To see if the Town will vote to authorize the Selectmen to procure a Temporary loan or loans not to exceed in the aggregate, fifteen thousand dollars within the 1962 taxable year in anticipation of taxes for the purpose of paying obligations of the Town; such loan or loans to be paid during said taxable year.

Budget Committee recommends adoption of this article.

Town of Arundel

Art. 32. To see if the Town will authorize the Treasurer (with the approval of the Selectmen) to sell and dispose of all tax titles by the Town and the Town's interest in tax liens whether completely foreclosed or not, on such terms as the Selectmen deem advisable and to execute quit-claim deeds for such property.

Budget Committee recommends adoption of this article.

Art. 33. To see whether or not the Town will vote to raise and appropriate the sum of \$50.00 to be paid to the State of Maine Publicity Bureau to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine in accordance with the provisions of Chapter 91, Sec. 108 of the R. S. of 1954.

Budget Committee makes no recommendation.

Art. 34. To see if the Town will vote to accept the provisions of the Revised Statutes of 1954, Chapter 90 A, Section 61, and authorize and direct the Board of Selectmen to appoint members of the Planning Board, in turn to join and appoint Representatives to a York County Regional Planning Committee in accordance with Section 64, same statute.

Art. 35. To act on any further business that may be legally brought before the meeting.

The Selectmen hereby give notice that they will be in session at the Town Hall at nine o'clock in the morning of the day of said meeting for the purpose of revising and correcting the lists of voters.
