**DIRECTIONS to Wells Conference Center, University of Maine campus, Orono:** Exit I-95 at mile 193, Stillwater Ave. From the south, on the ramp turn right onto Stillwater Avenue, Orono. ## PRESIDENT'S MESSAGE



As I wrap up my second year as State President, I have been reflecting on AAUW and my role within the organization. I was quite shocked to realize that I have been a member of AAUW for nearly half of my life. I am sure many of us can claim that, although it may be a bit more eye opening to realize that I haven't yet celebrated my 40th birthday. I will

soon, but I can still claim to be 39 for a couple more months! Some in AAUW Maine are likely sick of hearing me talk about membership and the need to be actively recruiting younger members; however, with our recent February 1 Count report from Association, I can tell you that the need is more important than ever before. We are down to 229 members statewide (not counting National members, formerly known as Members-at-Large), a 12% drop from last year. At this rate, in eight years, we will not have enough members in Maine to support state or branch operations.

I was recently at a Waterville branch meeting where I challenged the members to remember the reasons why they joined AAUW and, more importantly, to examine why they continue to be members of our great organization. Most likely, many of you joined when you were considered a "younger member," in your 30s and 40s. What attracted you to the organization? Were you the youngest member in the branch or were there others your age? My grandmother gave me the gift of membership when I graduated from college. She had been a longtime member, and AAUW was important to her. She was my mentor, so AAUW became important to me. My branch in California did the smartest thing they could do. They nominated me to be on the board during my first year!

I was hooked -- on the mission, the organization, and the leadership skills I was learning and on the friendships I was making. I was 22. I strongly believe that these reasons are STILL desired by young women and that we need to market AAUW better. Because we haven't been actively recruiting younger members over the years, marketing AAUW and showing women what we have to offer them, becomes not only more difficult but also necessary. Further, while our organizational age is climbing, our numbers are declining because we don't recruit new members. Why? Are we so comfortable in our groups that it has become difficult to challenge the status quo? What if those women in Bakersfield, CA had felt that

way? I certainly would not have been invited onto the board and would not state president today!

It is not easy to look in the mirror and be honest. But, it is imperative that we do just that. If you care as much about AAUW as I do, then you know that we have to evolve our branches back to the mission-based groups that they used to be, 30-40 years ago. To be blunt, most young women today do not join social clubs; they prefer to be part of a movement, to learn leadership skills helpful in the job market, and to have networking opportunities. If we can't see our way to offering these benefits, AAUW in Maine will suffer and disappear. I challenge you to get involved with your local branch and move the activities beyond the scope of a social group. Think back to what attracted you to AAUW in the first place; then help your branch create and activate a positive, growth-producing plan. Many resources are available at [aauw.org](http://aauw.org) to help you. I am here to help with this process; I hope to be a member of a thriving AAUW organization for many years to come--please join me!

These extra funds help us meet our annual budget in the face of decreasing membership and allow us to join in activities and programs that support advocacy and education for women and girls.

## MAINE'S 2009 CONTRIBUTIONS TO AAUW

AAUW-Maine sent \$317 to LAF and \$317 to Educational Programs with funds raised from basket sales at the 2009 convention. Four branches contributed a total of \$1,570 to the Educational Opportunities Fund and \$840 to the Legal Advocacy Fund. Individual members added totals of \$285 and \$85, respectively, to those funds, as well as \$10 to the Eleanor Roosevelt Fund, \$10 to Leadership Programs, and \$125 to general "AAUW Funds." Finally, through the note card and similar programs members provided unrestricted support in the amount of \$847. Thus, a grand total of \$4,406 was donated. It is probably not surprising in these economically challenging times to see a slight downturn from 2008, but let's keep our goals high for 2010!

## CALLING ALL NATIONAL MEMBERS!

"National members" of AAUW were formerly known as "Members-at-Large." People become a National members of AAUW for a variety of reasons, one of which is that while they support the mission, they do not have time to participate in local branch activities. ## NATIONAL EQUAL PAY DAY-APRIL 20, 2010

Equal Pay Day is the symbolic day each year when women's earnings finally "catch up" to men's from the previous year. As many of you know, women earn, on average, 77 cents to a man's dollar- 76 cents here in Maine. It is not too late for your branch, or you as an individual, to mark the day publicly. The Waterville branch will have an Op Ed run in their local paper. Individuals can write letters to the editor or to our Senators, demanding the passage of the Paycheck Fairness Act. If you own a business, you could offer your female clients 23% off for the day (Pat Rathbun in Presque Isle did this last year!). Call attention to the issue in your Facebook status. ### AAUW IMPACT GRANT COMING TO A CLOSE

Last summer, AAUW Maine was awarded a Public Policy Impact Grant to be implemented during the 2009-2010 membership year. We decided to use the grant funds to facilitate a year-long collaboration with the Maine Women's Lobby/Maine Women's Policy Center. In the fall, we dedicated part of the funds to co-sponsor the Breakfast with Champions events with the Maine Women's Policy Center. These notable events were held in Presque Isle, Bangor, and Portland. In addition to the great showing of AAUW members at each event, many other notable figures were present including several candidates for governor. We brought Lisa Maatz, AAUW's Public Policy Director, to Maine as a speaker for each of the Breakfasts. The remainder of the grant effort will be focused on cross-promoting our organization with the Maine Women's Lobby members. Our hope is to encourage their members to sign up for and use the AAUW Action Alerts and the AAUW website and to collaborate further with AAUW Maine and its branches.

### E-STUDENT AFFILIATE OPPORTUNITY

## Help Stop H1N1 Influenza: Support Paid Sick Days Legislation

When you work hard in Maine, you should be able to care for yourself and your family when illness strikes, especially in the case of a public health crisis such as pandemic flu. Unfortunately, nearly one out of every two full-time workers in Maine is denied even a single paid sick day. As a result, employees must choose: either come to work and risk spreading their illness or stay home and risk losing a day's pay... or even their job.

AAUW of Maine is a member of the coalition promoting legislation to prevent the spread of H1N1 influenza by ensuring the provision of earned paid sick time. This legislation would:

- Provide for paid time off in the event of a public health emergency to provide critical care for yourself or a family member.
- Exempt businesses that already provide paid sick days as part of their combined time off policies (sick, vacation and/or holiday all combined into one).
- Include time to recover from illness, receive preventative care, or to use in relation to domestic violence, sexual assault, or stalking.
- Guarantee workers one hour of paid sick time for every 40 hours worked (approximately 6 days annually) at large businesses with 25 or more employees.
- Guarantee workers one hour of paid sick time for every 80 hours worked (approximately 3 ¼ days annually) at small businesses with fewer than 25 employees.

The vast majority of American voters believe that paid sick days are already guaranteed. But the truth is that three quarters of low-wage workers and nearly half of full-time workers lack this protection.

According to a 2007 survey done by Lake Research Partners, 87% of Maine voters believe that Maine should require paid sick days. They are a workplace standard whose time has come. Get involved! Contact the Maine Women's Lobby at 207.622.0851 or [info@mainewomen.org](mailto:info@mainewomen.org).
