PRESIDENT'S REPORT

from Charmen Goehring-Fox, President, AAUW Maine

Welcome back to another spirited AAUW year! This year may prove to be a pivotal year in both AAUW Maine and in the organization as a whole. Here in Maine, a task force, formed last spring, will begin to seek answers from our members regarding AAUW Maine's future and how it will look. Questions being addressed are "will we have conventions," "how will our state meetings be formatted," "how will AAUW Maine be marketed," and more. Our goal will be to speak with every member to best decide how to proceed forward. Please be forthcoming in your responses as AAUW Maine is your organization, and your responses will reflect the energy and purpose we give it. This year is a national AAUW convention year, in Washington DC, where we will also be using the "one member, one vote" procedures for the first time. The guidelines created by the Board and staff are online at <http://www.aauw.org>, so feel free to check them out. Because the convention is in our neck of the woods, it would be nice to have a Maine delegation in attendance. My husband and boys will be joining me, and we plan to ride Amtrak to Washington. While I spend time in program and business sessions, they will be attending Nationals baseball games and visiting monuments! I hope you will join us!

This summer, our staff, especially Lisa Maatz and the rest of the public policy office in Washington DC, have been advocating diligently for the Paycheck Fairness Act. We have one last opportunity in this congressional session to get this bill passed in September, before Congress recesses and gets wrapped up in elections. The House passed their version back in January 2009, and, if we can't get Senate Bill No. 182 to a vote before the session ends in December, we will have to start all over in both houses. The Paycheck Fairness Act is the companion piece to the Lilly Ledbetter Fair Pay Act. It will bring penalties for pay discrimination into line with other civil rights violations, and help increase education and data collection. Most importantly, the act would provide protection against retaliation against workers who share or inquire about salary information. Such protections would have been crucial for Lilly Ledbetter! This legislation helps employees resolve pay discrepancies before going to court. In August, I met with staff from both Senators Collins' and Snowe's offices to advocate for this bill. We hope our discussions will lead the Senators to co-sponsor the bill. **It would be extremely helpful to have AAUW members email, call, or write messages urging them to act now and support the Paycheck Fairness Act.** There are sample dialogs and letters on AAUW's website, or you can contact me for the information. You may have received an email from AAUW with a "Let's-Get-It-Done-Now calendar"; many helpful links are there as well.

As you begin your branch activities this year, be thinking of ways to involve prospective members. Think of ways to market your branch and its events to the public, to students, to our National members (previously "Members-at-Large"). Sometimes, all it takes is a personal invitation! Spend some time on the accessible and revamped AAUW website and use some of the many, many tools we have at our disposal. As I have said before, if we all just invited (continued on page 2)

one person to join AAUW, we will have doubled our membership and helped ensure our organization's relevancy into the future. Also, please be thinking of ways to build coalitions within your communities. As a state organization, we belong to the Coalition for Maine Women, the Maine Choice Coalition, and continue to collaborate with the Maine Women's Lobby. What can you develop in your area?

THE FUTURE OF MAINE AAUW

Everyone's voice needs to be heard.

LILLY LEDBETTER, THE PAYCHECK FAIRNESS ACT, & YOU

On March 30, 2010, Lilly Ledbetter came to Augusta, to meet with Maine leaders on the eve of Maine Equal Pay Day. Her reception was sponsored by the Maine Women's Policy Center and the WAGE Project. Ms. Ledbetter is the plaintiff in the employment discrimination case *Ledbetter v. Goodyear Tire & Rubber Co.* and the woman for whom the Lilly Ledbetter Fair Pay Act is named. AAUW Maine members joined in celebrating the ongoing transformation of the American workplace through Lilly's historic advocacy and in spotlighting opportunities for further action that will bring workplaces up to date with the needs of today's families. You may recall that when the Lilly Ledbetter Fair Pay Act was signed by President Obama in January 2009, AAUW's own Linda Hallman and Lisa Maatz were in the front row for this event.

The companion bill to the Ledbetter Fair Pay Act, the Paycheck Fairness Act, was passed by the House of Representatives last year. Getting it through the Senate is AAUW's top legislative priority right now. AAUW has been leading coalition efforts to pass this pay equity bill, and the efforts of our Action Network members and coalition partners have led to a higher number of Senate co-sponsors than ever before.

The number of legislative days left on the calendar is dwindling. If the Senate does not pass the Paycheck Fairness Act before the end of the year, we'll have to start all over again in both chambers of Congress next year. Women cannot afford to wait for that to happen.

The Paycheck Fairness Act, a much needed update of the 45-year-old Equal Pay Act, is a comprehensive bill that would create stronger incentives for employers to follow the law, empower women to negotiate for equal pay, and strengthen federal outreach, education and enforcement efforts. The bill would also deter wage discrimination by strengthening penalties for equal pay violations and by prohibiting retaliation against workers who ask about employers' wage practices or disclose their own wages. In short, the bill updates the law to reflect the practices and processes under more recent civil rights laws.

Because it's crunch time for the Paycheck Fairness Act, your help is needed. Because women earn less than men, on average, they must work longer to receive the same amount of pay. Senators Snowe and Collins have not indicated if they will co-sponsor the bill or vote for it. Please write them, call their offices, or email them. The more of us that contact them in support of the law, the more they will listen. **PLEASE DO NOT DELAY IN DOING THIS. SEPTEMBER IS THE MONTH WHEN THE BILL WILL EITHER BE VOTED ON OR DROPPED.**

Keep Maine Connected CAMPAIGN ONGOING

At the March 2010 meeting of the AAUW Maine Board, the *Keep Maine Connected Campaign* was wholeheartedly endorsed. The annual goal of \$2,000 is the same as last year. These extra funds help us meet our annual budget in the face of decreasing membership and allow us to join in activities and programs that support advocacy and education for women and girls.

GETTING OUT THE VOTE

On July 1, 2010, AAUW's Lecia Embery led a conference call with close to 100 AAUW members from around the country on the call. She aimed to inform us about AAUW's efforts to encourage women of all ages to vote. She also discussed an important new initiative aimed at getting high school and college women to run for student government: *Elect Her - Campus Women Win* is a training offered on college campuses. More campuses will be chosen for *Elect Her* in the spring of 2011. This sounds like a great program, and would fit well with the goals of Maine NEW Leadership institute, which will be offered again at UMaine in June 2011. A representative of Women's Campaign Forum (formerly Women's Campaign Fund, founded in 1964 to support pro-choice women candidates of either party) spoke about their *She Should Run* initiative, in which AAUW is a partner. She stressed that women have to be asked to run for office and that many women feel they are not "qualified" to run. AAUW members can go to their website and "nominate" a woman to run, and the Forum will contact her and give her information about organizing a campaign--a great way to encourage women to consider running for office! 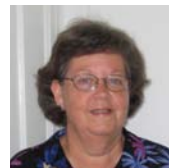
Lecia encouraged AAUW branches to work to turn out women's votes among young women, to hold informal gatherings, and to register women voters. She suggested that we might network with our campus voter registration activities and sponsor candidates' forums for local legislative candidates. Some branches develop AAUW "voter guides"; Maine Women's Lobby could supply information on voting records for incumbent legislators and also for many first-time candidates. If a branch sponsors a candidates' night, Lecia urged us to ask specific questions about AAUW issues.

If the branch does not sponsor a candidates' night, Lecia asked us to attend candidates' forums sponsored by other organizations, ask questions on AAUW issues, and hold up an AAUW sign. Letters to the editor to promote our events and support AAUW issues are good also.

It is important to note that AAUW does not endorse or oppose any candidate, but we can do voter education through forums, letters, registering new voters, etc. Members can email questions about what we are allowed to do to votered@aauw.org.

National AAUW: Rewarding Experiences

One of the most interesting and rewarding experiences I have had in AAUW has been serving at the national level. If you are interested, a variety of positions exist in which you might serve. It was Maine AAUW President Jeanne Hammond that encouraged me to apply to serve on a grants and fellowships review panel. I still am in touch with friends I made through that process. I also served on the national board of directors first as a director-at-large and then as Vice President for Programs.

Applications for the national Board of Directors are due on October 1 and are relatively easy to complete. See http://www.aauw.org/member_center/nsb_positiondescriptions.cfm for the link to the form.

Other positions that are available include those for national committees (college/university, finance, fundraising, governance, legal advocacy fund, membership, and public policy), task forces (branch program resources, communications, research, social media), leadership corps, and student advisory council.

Reviewers are needed for the applications for fellowships and grants: American Fellowships, Career Development Grants, Community Action Grants, International Fellowships, and Selected Professions Fellowships. THE ACHIEVEMENT CITATION AWARD: 2011

The Achievement Citation Award nominations in 2010 were nil. You need to try a lot harder for 2011. The deadline is January 31, 2011. Nomination forms and instructions will be sent to the Branches in late October 2010. I'm beginning to sound like a broken record, which many among us can still recall.

The basic requirements include:

- The nominee should be a woman in Maine who has made a distinctive contribution in some AAUW field of interest or study (service to state, to education, to arts, or to humanity, for example).
- The nominee should have a valid connection with the state.
- The nominee should exhibit achievement over and above job-related activities.
- The nominee should be a "pioneer" in her area.

Additional considerations include:

- The nominee does **not** have to be a member of AAUW and does **not** have to be an "unsung" heroine.
- The achievement does **not** have to be employment related.
- Other qualifications may be non-traditional fields and significant contribution to community/region/state, women's issues, or a particular field.

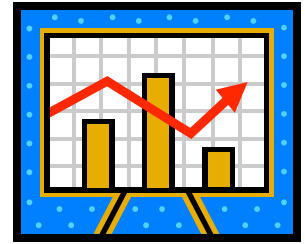

THE WAGE (WOMEN ARE GETTING EVEN) PROJECT



We often talk of collaborations that forward the mission of AAUW. One of our collaborators is the WAGE Project. Many members of AAUW Maine know Annie Houle, who has been a major contributor to the WAGE Project in the state. The WAGE Project, Inc. is a 501(c)3 charitable organization established for one purpose: to end discrimination against women in the American workplace in the near future. To do that, WAGE inspires and helps working women to take the steps needed so that every woman is paid what she's worth.

WAGE is led by Eveyln F. Murphy, author of *Getting Even: Why Women Don't Get Paid Like Men and What To Do About It*, and by Annie Houle, National Director of Campus and Community Initiatives.

The wage gap results from various forms of sex discrimination in the workplace, including discrimination in hiring, promotion and pay, sexual harassment, occupational segregation, bias against mothers, and other ways in which women and women's work are undervalued. The wage gap increases with age. Women between the ages of 25-34 earn 83.8% of the wages of men at the same age. This difference increases such that women between the ages of 55 and 64 face a wage gap of 59.6%. Young women do not escape the wage gap either. If you graduated from college in 2000, your pay started much further behind men's than the pay of women who graduated a decade earlier. In 1991, the wage gap between young women and men with college degrees was only 9 percent, or a few thousand dollars difference. But in 2000, the wage gap for young women and men with those same credentials was 31 percent.

This WAGE Project offers workshops called "start smart" around the country. These workshops provide juniors and seniors in college as well as graduate students with knowledge and skills when approaching the job market to negotiate salaries and benefits so that they receive fair and realistic compensation. The workshop explains the consequences of the gender-based wage gap for young women and teaches personal budgeting, compensation benchmarking, and negotiating skills related to salary and benefits. The workshop is ~2.5 hours long and includes essential time for role playing and Q&A. If you want to start such a workshop on your campus, contact Annie Houle at ahoule@wageproject.org.
