Report of the Superintendent of Schools

February 7, 1933.

To the Honorable School Committee and Board of Selectmen:

LADIES AND GENTLEMEN :—

It gives me pleasure to submit for your consideration my eighth annual report of schools. In this report I propose to follow the practical method of presenting those aspects of your educational system which best portray the actual work in your schools.

ENROLLMENT

The schools of North Kennebunkport have had an ever increasing enrollment during the period of depression. The increased numbers have tended to remain when once they have been enrolled in our schools. The Iron Bridge and Burnham Schools have received the greatest increase. It has been necessary to purchase a few new seats in order for pupils to be accommodated at the Iron Bridge School.

A close statistical study of the census and enrollment of public school pupils of North Kennebunkport is rather interesting. The census of pupils between the 5th and 21st years listed between 1926 and 1933 shows the year 1927 to have the high record of 203 pupils, while 1931 has the low record of 111 pupils. The average census for the period of this study is 143.12 pupils.

The enrollment over this period from 1926 to 1933 has a range growth from 54 pupils to 95 pupils. You will notice that, while the local schools have received this increase, the tuition pupils of elementary grades have an almost inverse ratio of decrease. In 1926 there were 31 elementary pupils in schools outside of the town for

whom tuition was paid. The reports of 1933 show only eight pupils in the elementary schools outside of the town. The high school pupils range from 17 in 1929 to 9 last June. It is evident, however, at this time that tuition pupils of both elementary and high schools will be materially increased in the school statistics this June. There are, at present, 16 pupils in high school and 12 pupils in elementary schools outside the local schools. May I impress upon you that indications are that increased enrollment in local and tuition pupils will tend to keep up the steady development as long as the depression lasts. Your attention is directed to a table appended to the report showing this tendency toward increased enrollment by years. The average number of elementary tuition pupils between 1927 and 1933 is 19.75 pupils. The average number of high school pupils over the same period is 10.57 pupils. The point is, that we have a number in high school now in excess of the average for the eight-year period. The increase in enrollment of pupils in local elementary schools for the period from 1926 to 1933 is 17.5.

The unusually large enrollment has necessitated the purchase of textbooks that were not planned for in the budget. The pupils making up this enrollment will, for the most part, be promoted this Spring. The textbook needs will be as great next year as they have been this year. This should be taken into account in making your budget.

The transfer of pupils from Burnham School to the Durrell School, by vote of the town at the meeting last March, was a wise move. If the present enrollment at Burnham continues, either more pupils must be transferred to Durrell, or great crowding must go on at Burnham, much to the detriment of those now attending the school.

There is need of an adequate flag pole at Irving School, in order that the flag may be displayed according to the requirements of the State law.

The attendance of North Kennebunkport teachers at the State and local teachers' meetings has been a source of professional growth. The methods and teaching devices which have been gathered on these occasions have been rewarding. The monthly contact with the teachers of Dayton, Saco and Old Orchard Beach has also been a source of inspiration and help.

Our system has been administered with a great deal of advanced planning. The calendar, plan books, office data and reports for State and local authorities have been announced in advance with sufficient direction so that the schools could all work with the same general understanding.

The examination questions have been, as usual, made out by the teachers, with twenty questions for each subject. These papers have been read by the superintendent, and ten representative questions have been selected from those submitted. Each teacher has been impressed that every time examination questions are submitted to the office, they are a test of the teacher's ability to organize her subject matter as educational material for the classroom. I think some of your teachers have made excellent progress in this type of work.

The plan book of each teacher is expected to be so comprehensive that anyone reading these outlines of work may follow the work of any grade from September to June, and give appraisal of the effort made. I have found that some of your teachers, over a period of years, have been doing excellent work with the plan book. Moreover, I feel that this fine work of planning will and does show in the education of your children.

Your attention is called to the tuition situation. Outside high schools may charge an amount not to exceed \$100 per pupil for a school year of 36 weeks, providing this amount does not exceed the cost per capita based on the number of pupils attending the school in question.

This amount is, therefore, a per capita cost schedule. It now seems likely that the high school tuition which your pupils incur will be charged on this basis. It would seem probable that the total cost per pupil for North Kennebunkport will be raised.

The school officials of North Kennebunkport have made every effort to keep the expense of the schools at a minimum, commensurate with the type of education which you demand for your boys and girls.

REPAIRS

The tendency this year, it seems to me, will be to try and pass over items in the school budget like repairs. I liavc only this suggestion, which is a conviction as well, that some outside repairs on your school buildings should be done even this year. They are suffering- greatly for outside paint. The prices of these materials are lower, while the neglect of upkeep is expensive. You have done well in the past in keeping your buildings in fairly g-ood repair. I desire that a reasonable amount of this v\ork be done each year so the school property may be maintained effectively and efficiently without large outlay. This policy tends to spread the tax burden so that it does not fall too heavily on any one year.

The School Committee members have shown an interest in every problem that has been brought to their attention. The marriage and removal to another town of Dorothy Smith Stephens makes it necessary to elect two members to the School Committee at the annual meeting. I wishi to take this opportunity to express the grateful feeling of the entire community to Mrs. Stephens for her

valued and unsurpassed service. Personally, I wish to add my tribute to her talent and splendid character. The sterling and steadfast qualities which she brought to the School Committee are appreciated by all who have worked with her for the childhood among you.

I have had a feeling, since the depression has shown so many ugly sides to our national and economical life, that our schools should take on more activities in which the home and the community could be brought closer together. Your people, as a body of citizens, should be in closer accord with, and have a much keener insight of, those vital aims and aspirations manifested in the schools. I desire the teachers to visit the homes of their children, the better to understand school problems.

The Selectmen have been helpful in giving wise counsel and aid when approached with school problems. They approved of the purchase of seats at the Iron Bridge School and the purchase of such extra textbooks as have been requested by the teachers. This is the finest tribute to their determination to serve your town in these trying times, and it is a pleasure for me to bring this type of cooperation to your attention.

The statistical data appended to this report will be read with interest.

Article 5. To see what sum of money the town will vote
to raise for high school tuition.

Article 6. To see what sum the town will vote to raise for repairs and insurance on school buildings.

Article 7. To see what sum the town will vote to raise for free textbooks.

Article 8. To see what sum the town will vote to raise for school supplies.

Article 9. To see if the town will vote to raise a sum of money for purchase of school flags.

Article 10. To see if the town will vote to raise the sum of one hundred seventy-five dollars for salary of superintendent of schools.

Article 11. To see what sum of money the town will vote to grant and raise for the repair of roads and bridges, and see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on highways.

Article 12. To see if the town will vote, grant and raise a sum of money to cut and destroy all bushes on State highway, State aid and third class roads, to comply with Chapter 145, P. L. 1927, and if so, how much.

Article 13. To see if the town will vote, grant and raise the sum of four hundred fifty-three dollars to repair and maintain third class road, to comply with Sections 43 to 47 of Chapter 28, Revised Statutes 1930, as amended by Chapter 151, Public Laws 1931.

Article 11. To see if the town will vote "yes" or "no" on the question of raising money necessary to entitle the town to receive State aid as provided in Chapter 25 and Section 19 of the Revised Statutes of 1916.

Article 15. To see if the town will vote to raise the sum of five hundred thirty-three dollars for improvement of the State aid road, as accepted by the State Highway Commission, the above amount being the maximum amount which the town is allowed to raise under the provisions of Chapter 25 and Section 18 of the Revised Statutes of 1916.

Article 16. To see if the town will appropriate the sum of \$2,665.00 for the improvement of the State aid road, as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the above amount being the maximum which the town is allowed to raise under the provisions of Section 21, Chapter 25, R. S., as amended by Chapter 258, P. L. 1917, Section 5.

Article 18. To see what sum the town will vote to raise for the removal of snow.

Article 21. To see if the town will raise a sum of money to be used in payment for services of out-of-town fire companies.

Article 22. To see if the town will raise a sum of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the

Article 23. To see if the town will vote to raise a sum of money for the control of brown tail moths.

Article 24. To see if the town will vote to raise a sum of money to reduce the indebtedness.

Article 25. To see what sum the town will vote to pay for the collection of taxes.

Article 26. To see if the town will vote to deliver, in the name of the town, a quitclaim deed, or other document, to such person or persons as may be necessary to correct error caused by recording tax deeds of Florence R. Hayes, Collector, to the Town of North Kennebunkport, of property of Charles L. Day, said deeds being dated February 21, 1931, and recorded in York County Registry of Deeds, Book 776, pages 117 and 118, respectively, the taxes on said property having been paid prior to the expiration of the redemption period.

Article 27. To see if the town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town Treasurer be and he is hereby authorized and directed to borrow from time to time a sum or sums not exceeding- in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town Treasurer and countersigned by the municipal officers of the town.
