REPORT OF THE SUPERINTENDENT
OF SCHOOLS

January, 1943.

To the Honorable School Committee, Board of Selectmen,
and Citizens of North Kennebunkport:

LADIES AND GENTLEMEN!

This is my eighteenth annual report of schools and I wish at the outset to state that your town and pupils have been extremely fortunate in being able to have all schools open and operating with efficient and well qualified teachers. Many rural towns have had great difficulty in maintaining schools because of the shortage of teachers.

One of your teachers has been on leave of absence because of sickness of her husband. Her place has been ably filled by Margaret Pearson, one of your own number. It is likely that if one of your teachers should accept a more lucrative position, you would be unable to fill her place at any price.

Your appropriations have generous balances in the common school and high school accounts. This is due to the equalization fund and has worked out greatly to the advantages of education in North Kennebunkport.

The advance in teachers' salaries and the extra in textbook and supply accounts has been taken care of from this equalization fund.

I desire at this time to say that educationally North Kennebunkport is better off than any town within my knowledge and mostly for the reason that children have had the textbooks which are the tools of education. You cannot impart the culture of our age without tools. I have heard there were those who thought that one book on a subject was sufficient. May I go on record as saying, with all the emphasis at my command, that if children are to arrive at that stage of maturity to deal adequately with the complexity of the prob-

lems of our day, their schools and teachers must have the tools of education, textbooks, and other aids in abundance. The problems of this age cannot be resolved by half-educated, or poorly-educated citizens. The education of the past is not adequate for the demands of the future.

The transportation of school pupils in North Kennebunkport has gone forward this year in a satisfactory manner. The Federal Government has much more to say about such matters than in the immediate past. Regulations of Transportation of Public School pupils has rulings coming through which transcend State requirements or in some cases countermand them.

Your enrollment last fall was as follows: Irving School, 18 pupils; Iron Bridge, 27 pupils; North Chapel, 32 pupils; Durell, 37 pupils; Burnham Primary, 24 pupils; and Burnham Grammar, 45 pupils; these numbers vary some, but in the main, reveal the teacher load at the respective schools.

Last spring it seemed that a new school might be made necessary by the congestion at Durell, Burnham, and Iron Bridge, but even if the present arrangements could not have sufficed, it is doubtful if teacher help could have been procured to man another school. The congestion has not materially changed and will probably remain stationary until the opening of school in September, at which time you may be under obligation of caring for an overflow of pupils in new quarters. However, much depends on industry and labor conditions beyond our control or vision.

Your teachers have played a magnificent role in assisting expertly in the draft, rationing, bond and stamp sales, and in the scrap drive. All of these activities add up to a fine and invaluable contribution to the cause of our United Nations' Effort to win the war. It is with deep and abiding appreciation that I review the teachers' part in the great victory effort in which they have loyally done their part.

REPORT OF PUBLIC HEALTH NURSE

To the Citizens of the Town of North Kennebunkport:

I hereby submit my annual report as public health nurse for the year beginning January 1, 1942, and ending December 31, 1942.

Each school was visited twice during the year to complete the regular health inspection. Other visits were made to some schools to make special inspections for evidence of pediculosis or of skin diseases. Three trips were made to schools which were found closed, some because of illness of the teacher and others because of fuel oil rationing day.

More than the usual number of home visits were made this year particularly because of children found with serious vision defects. Efforts were made to aid in securing correction of these defects. Arrangements were made with the Red Cross for financial assistance in one case. Time was spent in the home and at the Webber Hospital, Biddeford, making arrangements for one child to have an operation for tonsil and adenoids removal.

WARRANT

For Town Meeting, March 1, 1943

COUNTY OF YORK, SS.

To Florence R. Hayes, Constable of the Town of North
Kennebunkport, in said County, GREETINGS :

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town Hall, in said town, on the first day of March, 1943, at ten o'clock in the forenoon, to act on the following articles, to wit:

Article 1. To choose a moderator to preside at said meeting.

Article 2. To see if the town will vote to dispense with the check list at this meeting.

Article 3. To choose all necessary town officers for the ensuing year.

Article 4. To see what sum of money the town will vote to raise for the support of common schools.

Article 5. To see what sum of money the town will vote to raise for high school tuition.

Article 6. To see what sum of money the town will vote to raise for repairs and insurance on school buildings.

Article 7. To see what sum of money the town will vote to raise for free textbooks.

Article 8. To see what sum of money the town will vote to raise for school supplies.

Article 9. To see what sum of money the town will vote to raise for the salary of superintendent of schools.

Article 10. To see what sum of money the town will vote to raise for the repair of roads and bridges.

Article 11, To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour to be paid for labor on highways.

Article 12. To see what sum of money the town will appropriate for State aid road construction (in addition to the amounts regularly raised for the care of ways, and highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Article 13. To see if the town will vote to raise a sum of money to cut and destroy all bushes on State highways. State aid and third class roads, to comply with Chapter 145, Public Laws of 1937.

Article 14. To see if the town will vote to raise the sum of four hundred and seven dollars to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933.

Article 15. To see if the town will vote to raise the sum of \$1,080.00 to pay bond and interest coming due this year.

Article 16. To see what sum of money the town will vote to raise for the removal of snow.

Article 17. To see what sum of money the town will vote to raise for the support of the poor.

Article 18. To see what sum of money the town will vote to raise for the contingent.

Article 19. To see if the town will vote to raise a sum of money to provide for the services of a public health nurse, this action made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Article 20. To see what sum of money the town will vote to pay for the collection of excise taxes.

Article 21. To see if the town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and hereby is authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate, ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Article 22. To see if the town will authorize the treasurer of the town (with the approval of the board of selectmen) to sell and dispose of all tax titles held by the town on such terms as they deem advisable, and to execute quitclaim deeds for such property.

Article 23. To see what sum the town will vote to pay for the collection of taxes.

Article 24. To see what sum of money the town will vote to raise for the services of out-of-town fire companies,

The selectmen hereby give notice that they will be in session at the Town Hall at nine o'clock in the forenoon on the day of said meeting, for the purpose of revising and correcting the list of voters.
