UPCOMING LEGISLATION

The following is a brief summary of a few of the key pieces of legislation we will be working on in the Second Session. Unless noted otherwise, we are in support of these bills.

LR 2574 An Act To Prohibit Managed Care Plans From Requiring Inappropriate Early Discharge of Maternity Patients and Newborns—Sen. Jill Goldthwait

Exact language not yet available. However, the intent is to insure that women and newborns receive appropriate health care. This bill is in response to an increasing trend by insurance providers to only cover a 24-hour postpartum stay. Guidelines from the American College of Obstetricians and Gynecologists and the American Academy of Pediatrics provide that, "when no complications are present, the postpartum hospital stay ranges from 48 hours for vaginal delivery to 96 hours for caesarean birth, excluding the day of delivery."

LR 2782 An Act To Amend The Insurance Code With Respect To Domestic Abuse—Rep. Bonnie Green

Exact language not yet available. The intent of this bill is to prevent insurance companies from excluding coverage for losses, or denying a claim based on the claimant's abuse history.

LR 2745 An Act to Prohibit Stalking—Rep. Michael Saxl

Exact language not yet available. The intent of this bill is to strengthen the current (and inadequate!) protections from stalking. The bill will address the following issues: revised bail guidelines, agreements with other states to notify each other of existing protection from abuse orders, mandatory minimum sentence for violation of a protection from abuse order and making the act of stalking a crime.

LD 1448 An Act to Reconcile Rights and Responsibilities with Respect to Sexual Orientation and Related Matters—Sen. Georgette Berube

Although the title of this bill might lead one to believe that it has merit, the content is very troubling. One particularly offensive implication contained in the bill is that gay men and lesbians are child molesters. This bill may be withdrawn. If it is not, we will strongly oppose it.

LD 1512 An Act to Ensure Fairness and Choice to Patients and Providers Under Managed Health Care—Sen. Dale McCormick

The purpose of this bill is to provide fundamental protection to patients and providers in managed health care plans. Some key provisions are: patients understand the coverage and incentives in such plans, providers receive due process relative to plan selection and denial of participation, patients are given as many options as possible, consistent with cost-containment strategies.

BREAKFAST OF CHAMPIONS

The Maine Women's Lobby heard speakers address women's issues from a global and local perspective at their annual breakfast in Portland in October. Joanne Polumbo-McCallie, Head Coach of the University of Maine Black Bear women, and Lois Reckett, Director of the Family Crisis Shelter, spoke on the 1995 theme, *Women's Issues from Bangor to Beijing*.

Polumbo-McCallie took the UMaine Black Bear women to their first NCAA tournament, and was named North Atlantic Conference Coach of the Year. Having been offered a position at another college, Polumbo-McCallie used public negotiations to focus attention on drastic funding inequities between sports programs for men and women at the University of Maine, a publicly funded institution.

Reckett is a familiar face in women's advocacy in Maine. A member of the National Board of Directors for the National Organization for Women, Reckett discussed her recent participation in the United Nations' International Conference on Women, and the call for eliminating the Vatican as a nation-state at the United Nations.

Keeping You Informed from the Chair

As we wind down the first half of our fiscal year, it seems appropriate to not only reflect upon the Lobby's successes but also to focus on the priorities for the next six months.

I wish that each of you could have been at our December Board meeting! Had you been there, you would have experienced, as I did, incredible positive energy, creativity and commitment to improving the lives of Maine women and girls. The thirteen Board members present drove from Orono and Portland, Thorndike, and Dresden, Rome and Auburn to enthusiastically do the work needed to lead the Maine Women's Lobby. The organization is indeed fortunate to have such a talented group of women as its Board of Directors. This group has made my job easy and fun.

We will retreat in early February to do our annual "visioning" and long range planning. We plan to spend a Saturday in the country thinking and dialoguing about where the Lobby has been, where it is today and where it needs to be over the next two to three years. This, then, will guide our goals and budget for the 1996-1997 fiscal year. Please write, call, E-mail or fax us with your ideas and input for this planning session. Better yet, consider joining us for the day to influence our direction and priorities.

We hosted our Breakfast of Champions in the Fall with an emphasis on gender equity in women's sports via Coach Joanne Palumbo from the University of Maine at Orono's Women's Basketball Team and a report on the Beijing International Women's Conference from Lois Reckett who 'was there'. We've added over 30 new members and have had a better than 75% renewal rate from existing members. We have raised almost 20% of our \$22,000 budget goal for the Women's issues Leadership Council (WILC). We are delighted to report receipt of a generous grant from the Rockefeller Foundation. We worked to assist Maine Won't Discriminate in defeating Question 1. We've secured the skills and expertise of two interns to help in the office several days a week.

As we move into the new year, we will, as always, be present and visible in the Maine House and Senate. We will actively shepherd legislation for focusing on the discharge of maternity patients, insurance code amendments for victims of abuse and violence and stalking. We are tracking the outcome of other proposed legislation such as a bill aimed at increased choice in managed health care plans and a spate of other health-related bills. Watch for our Legislative Alert in January for more specific information.

Do plan to attend our Legislative Reception in March in the Augusta area. Consistent with our annual ritual, you'll receive raffle tickets early in the year and we hope you'll continue to support us in making this a highly lucrative event. Our sister organization, the Women's Development Institute, has assumed statewide responsibility for the coordination of activities and publicity associated with April's "Take Our Daughter's To Work Day". We hope to increase participation in the day by women and girls who wouldn't, in the normal course of their lives, participate. Funding is aggressively being pursued at this time and we hope to report more specific news in the near future.

Most importantly, let me take this opportunity to thank each and everyone of you for your continued support and enthusiasm for our work. Without you, our achievement's would not be possible. On behalf of the Maine Women's Lobby and the Women's Development Institute, I extend warmest wishes for a new year filled with happiness, fulfillment and prosperity!

Well, Election Day is finally behind us and I'm sure that many of you are still recovering from the countless hours you spent working to defeat Question 1. It was a significant victory—good job! Unfortunately, more work lies ahead. We still need to pass legislation that will prohibit discrimination in the areas of employment, housing, public accommodation and credit based upon sexual orientation. Although Senator Dale McCormick has withdrawn her bill intended to ensure such protection the issue continues to command our attention. Our work this next year will be to educate our friends and neighbors and develop the atmosphere needed for passage in the 118th Legislative Session.



In October, I was pleased to be invited to a conference in Michigan that was sponsored by Region 9A of the United Auto Workers. It was a five day event that brought together union members, community activists and progressive elected officials from across New England. For me, it was an increasingly rewarding five days. Hearing union members clearly articulating the connections between the low wage job market and AFDC receipt was a surprise. And I was delighted when I heard them referring to women who needed public assistance as "unemployed workers" not as "welfare queens."

By the end of our stay all of us had a much greater appreciation of the interconnectedness of all of our issues. We had come to the conference separate, focused on our own issues—labor, women, the environment, civil rights—and we left recognizing that the struggle of one needed to be the struggle of us all.

I believe this lesson will be invaluable as we enter the second regular session in January. Please call the office (622-0851) if you would like to become more active at the Lobby this session.

TAKE OUR DAUGHTERS TO WORK DAY

In September, the Women's Development Institute (WDI) accepted the role of statewide sponsor of Take Our Daughters to Work Day. Hurricane Island Outward Bound, former sponsor of the event in Maine, approached us hoping that WDI might bring greater statewide visibility, public support, and participation to the nationally recognized event. WDI has been looking for an opportunity to work with girls and young women around self esteem and personal aspirations, so taking on the event is a perfect match.

WDI convened the first meeting of a steering committee in early December. The committee will plan a media strategy, will seek the support of key education, business and political leaders in the state, and will be responsible for distributing materials to local organizing efforts. The committee has also identified groups of girls to target for participation, such as: girls from low income families, "at-risk" youth, Native American and Franco American girls, lesbians and home schooled girls.

A SUCCESSFUL TENTH ANNUAL MAINE WOMEN'S STUDIES CONFERENCE

On December 1 and 2, the Women's Studies Program at the University of Southern Maine organized and held the 10th Annual Maine Women's Studies Conference. This event provides the opportunity for women to come together from around the state and discuss a specific topic as it relates to women. The title of this year's event was "Women, Education: The Difference it Makes". This interdisciplinary conference took place on the Gorham Campus and included papers, panels and workshops focused on feminist research, educational application and political activism.

The conference got off to an exciting start on Friday evening with keynote speaker Blythe Clinchy, Professor of Psychology at Wellesley College and co-author of Women's Ways of Knowing. Saturday was filled with workshops which included topics such as introducing girls to science and math, educating working-class girls in rural Maine, teaching women's history, literacy education, experiences of lesbian teachers, the influence of role models, welfare reform and education, and multicultural teaching in economics.

The Maine Women's Lobby staffed a table on Saturday, and shared valuable information with conference participants about the work of the lobby. Thank you to Jenna Menhert, Wendy Betts and Jan Conley, Maine Women's Lobby Board Members, for working at this event. Be sure to watch for next year's conference!
