Introduction.

As the great luminary that rises in the east to open and adorn the day spreads warmth, light and cheerfulness to all within its reach, so Freemasonry in like manner, had its birth in the East and spread to the West cementing, in fraternal relation, all those who were disposed to submit to its sublime teachings and harmonize their conduct in conformity to its tenets.

No general history of Freemasonry need ever be written, as every man is supposed to be more or less a Mason, having engrafted within him a portion of that unwritten and divine attribute which will survive through all ages and conditions of human existence and of that better part that pervades all nature, a precious heirloom inherited by our first parents from the Grand Master of the Universe.

When that little band of exiled men, oppressed and forced to quit their native land, landed on Plymouth Rock, they carried to their rude forest homes the sublime teachings of this grand and noble inheritance. So as a universal principle, Masonry from time immemorial has been transmitted, unimpaired, from generation to generation until the present time. Tradition and legend have traced Masonry to the Pharaohs, the Temple of Solomon, and even to the building of the Pyramids, but the form in which it is now generally known dates from the seventeenth century and is of British origin. It was introduced into France in 1725, Russia 1731, Germany 1740. Grand Lodges now exist in all the principal countries of the Old and New Worlds. The first lodge in New England was organized in Boston in 1733, and not long after the Revolution, Grand Lodges were opened in all the states.

The history of the Cambridge Lodge is characteristic of nothing different from the history of numerous other Masonic Lodges that are being or have been written. It has had a flood tide of prosperity as well as periods of depression, and those members who have annually been called to preside over its affairs have, as a rule, given their best efforts to promote its interests. As a result of their labors Cambridge Lodge has become powerful and united, giving an assurance that the forthcoming decade of history will find the lodge still prosperous and growing in membership.

History of Cambridge Lodge, No. 157.



Under the Jurisdiction of the Grand Lodge of Maine.

About the year eighteen hundred and sixty-seven, a number of brethren of different lodges, having the good of the craft at heart and wishing at the same time to disseminate the knowledge of Masonry, attempted, by a petition to the Grand Lodge of Maine, dated March 13, 1867, to organize a Masonic Lodge at Cambridge, to be called Island Lodge. This petition bore the names of eighteen well known brothers, among whom were Bailey, Ring, Herrick, Bailey, Austin and Chadbourn, of Penobscot Lodge, of Dexter; Brothers Moore, Wentworth, Morrill, Burdin, Goff, Page and Austin, of Mt. Kineo Lodge of Abbot, since removed to Guilford; Brother Bailey, of Mosaic Lodge, of Foxcroft, and Brother Yetton, of Eureka Lodge, of Rhode Island. For some cause the Grand Lodge did not see fit to grant the petitioners a dispensation. The project languished until the year 1870, when a second attempt was made to establish a lodge at the same place with success.

The names of those whose names appear on this second petition were Brothers Sands Bailey, S. Everett Bailey, William A. Herrick, John Russell, John W. Cole, Elisha Knowles, F. D. R. Morrill, Andrew W. Ham, Hiram P. Ring, Charles Ham, Frank R. Kimball, Charles M. Burdin, Cornelius G. Burdin, Lorenzo D. Wentworth, Jonathan B. Mitchell, Nathan L. Means, David Ring, Jos. J. Chadbourn, W. H. Burdin, Lewis S. Reed, W. F. Grant and G. E. Bailey. A dispensation was granted the above mentioned to form themselves into a regular lodge of Free and Accepted Masons, May 5, 1870, to be called Cambridge Lodge.

A permanent organization was effected this year by the appointment of William A. Herrick, John W. Cole and Floraman D. R. Morrill, Worshipful Master, Senior and Junior Wardens, respectively. The W. M. designated the remaining officers.

The first petition acted upon by the new lodge was that of Samuel C. Morrill, July 12, and six petitions in all were received. Two were raised and admitted to membership, namely: Samuel C. Morrill and Albert W. Murray.

There were eight communications held during the year, the first one being held in a small building provided for that purpose, situated on the west side of Main Street, nearly opposite what is known as Mitchell & Bailey's store, above the bridge. This building was designated, by the members, in a jocular way, as the "Box," being very small and cramped but answering every purpose as a temporary lodge room for the young lodge whose membership was small compared to what it was destined to be. With a little labor and at a nominal expenditure this room was fitted up and occupied for lodge purposes until November of this year, at which time the new hall was completed and occupied. This hall was constructed under the supervision of a board of trustees and purchased by the lodge September 26, 1871.

The commencement of this year found the new lodge well established in their new home, and with better accommodations came a corresponding increase of work. Indeed the year 1871 will be remembered as the most prosperous in the history of the lodge. Twenty-four petitions were received and acted upon. Five were rejected, and nineteen accepted. Thirty-one communications were held during the year. There was no installation until July 11, when the lodge was consecrated by the Grand Lodge, after which instructive and entertaining remarks befitting the occasion were listened to from W. Warren Phillips, Grand Tyler. Eighteen were raised and admitted to membership. The names of those receiving the M. M. degree were Ira H. Horne, Mar. 25; G. L. Wilder, April 4; Cyrus Libby, May 16; B. D. Libby, May 30; E. F. Leighton, May 30; Horace Ham, Aug. 15; R. G. Whitney, July 11; Wm. R. Woods, June 27; J. D. Morrill, Aug. 15; Elijab N. King, Aug. 29; John Pease, 2d. Sept. 26; Judson P. Smith, Sept. 26; James W. Hinkley, Sept. 26; David H. Whittier, Sept. 26; Silas P. Farrar, Oct. 28; Chas W. Huff, Nov. 7; James B. Lewis, Nov. 21; Charles A. Mitchel. Nov. 21. There were admitted from other lodges, three. These were Brothers D. H. Bartlett, July 29; Ira Austin, July 29; and Lewis S. Reed, July 29. It was voted Oct. 24, to purchase two lots of land, one on the south side and the other on the west side of the present lodge lot.

A committee was appointed Jan. 31, consisting of Brothers A. W. Ham, S. Everett Bailey and John W. Cole, to draft a code of by-laws and determine the design of the seal to be used by the lodge on receiving a charter. At the stated communication of April 4, nine petitions were entered, the largest number received at any one time during the history of the lodge.

Voted May 30 to receive clergymen free.

Twenty-two communications of the lodge were held during the year. Twelve petitions for degrees and two for membership were received and acted upon. Of the petitions for degrees, five were accepted and seven rejected.

The petitions for membership were Bros. Nathan and Emanuel

Meands, accepted July 16 and Oct. 15 respectively.

A public installation was held. Officers were installed by

One death occurred this year, that of Bro. Charles W. Huff, and was the first loss in membership the new lodge sustained. Bro. Huff died of consumption, in Parkman, Me., June 28, 1872, and was buried with Masonic honors. He received the degrees of masonry in Cambridge Lodge, Nov. 7, 1871, having been a member about eight months. He was born in Wellington, Me., May 15, 1839, where he lived until he was about twenty-four years of age. Later he came to Parkman, Me., where he resided until his death. Bro. Huff was an upright and conscientious man and Mason and his loss was keenly felt. Resolutions of respect to his memory, through a committee consisting of Bros. N. L. Hooper, L. D. Wentworth and John Russell, were adopted by the lodge.

The lodge sustained a pecuniary loss this year in the partial destruction of the lodge building by a terrific tornado which passed through this place on the afternoon of Sunday, May 31. Nearly every building in the place was more or less damaged and the appearance of our beautiful village after the storm passed was pitiful in the extreme. The two-story hall building was carried bodily some ten feet, unroofed and otherwise damaged some hundreds of dollars. At a stated communication June 30, some measures were taken to repair the loss and contributions were solicited of other lodges. A committee of seven was appointed and assigned to different places as follows: G. E. Bailey, Dover; F. D. R. Morrill, Monson; J. B. Mitchell, Newport; S. Everett Bailey, Skowhegan; L. D. June 6 it was voted that a committee of three or more be appointed to make the necessary arrangements to attend the Masonic dedication at Dexter, Bros. George Mitchell, Lewis S. Reed, Henry Watson and Benson M. Arno being designated to act in that capacity.

At the stated communication of Oct. 3, it was voted that a committee of five be appointed by the chair and confirmed by the lodge to draft a plan for reducing or paying the lodge Bros. William A. Herrick, Andrew W. Ham. indebtedness. John W. Cole, Rufus G. Whitney and John Pease, 2d, were appointed and confirmed as such.

Oct. 31, the committee on lodge indebtedness reported in favor of raising one thousand dollars by assessment and of increasing the dues to two dollars per year, which report was accepted and tabled until next regular meeting for discussion. The motion was passed over until Dec. 26, when it was voted to make an assessment of one thousand dollars on the members of Cambridge Lodge, to be brought up for final action at the next stated communication.

One death occurred this year, that of Bro. Josiah A. Folsom. and a committee of three was appointed to draft resolutions of respect to the memory of the departed brother. Bros. George Mitchell, L. D. Wentworth and John W. Cole were designated. Brother Folsom was born in Newmarket, N. H., March 23, 1815, being the youngest of a family of five children. He spent the early years of his manhood as teacher in the public schools, and was led soon after to adopt medicine as a profession, studying and attending lectures in New York. He was in Providence, R. I., practicing as a physician in 1842, being at that time an involuntary participant in the celebrated Dorr rebellion and was arrested and imprisoned by the adherents of Governor King. Coming to Cambridge, Me., in the fall of 1843, he married and, until a short time before his death, attended strictly to professional duties, building up a large and lucrative practice. A correspondent of the Rockingham County Advertiser speaks of Bro. Folsom as an honest, hospitable and benevolent man, extending the hand of charity in the hour of need, for his heart was always free to relieve the wants of the poor. About two years before his death he became afflicted with cancer in the face, which soon assumed so malignant a form that he was obliged to give up his business and go to New York for medical treatment. Returning, he stopped at his brother-in-law's, in

Newmarket, N. H., where, after much suffering, he died, Aug. 16th, within one-half mile of his birthplace. Bro. Folsom was made a Mason in Cambridge Lodge, Jan. 3, 1871.

Voted Feb. 27, to make an assessment of five dollars on each and every member of Cambridge Lodge. Thirteen communications of the lodge were held. Three petitions were received and acted upon. One was rejected and two accepted. Total number of members March 1, was seventy-seven. The M. M. degree was conferred on Fred Whittier, April 24; Dudley B. Whitney, July 24. Death has again entered our lodge, taking therefrom Brother Sands Bailey, first secretary and honorary member, who died at Winthrop, Maine, of catarrhal consumption, July 24. Brother Bailey was born at Leeds, Me., May 17. 1806, and went to Dover, Me., about the year 1850 or 1851. While at that place he received the degrees of masonry in Mosaic Lodge of Foxcroft, and August 6, 1851, was raised to the sublime degree of M. M. Thence he removed to Winthrop in the year 1858, to Lowell, Mass., in 1860, and from there to Cambridge, Me., September, 1863, where he assisted in organizing Cambridge Lodge. He resided at the latter place some ten years, a respected and zealous Mason. The last years of his life were passed with his daughter at Winthrop.

Ring, Charles W. Burdin, Jonathan B. Mitchell, Lorenzo D. Wentworth, Joseph J. Chadbourn, Elisha Knowles, Frank R. Kimball, S. Everett Bailey and William R. Burdin, original petitioners for a lodge at Cambridge, Samuel C. Morrill, Nathaniel L. Hooper, Henry Watson, Albert W. Murray, G. L. Wilder, Levi E. Bailey, Ira H. Horne, Nahum Morrill and Josiah A. Folsom, who were raised by said brethren while working as a lodge under a dispensation granted them for that purpose by the Grand Lodge of Maine, and C. R. Herrick, John W. Cole, Floraman D. R. Morrill, Sands Bailey, G. E. Bailey, John Russell, Andrew W. Ham, Charles Ham, Hiram P. Ring, Charles M. Burdin, Jonathan B. Mitchell, Lorenzo D. Wentworth, Joseph J. Chadbourn, Elisha Knowles, Frank R. Kimball, S. Everett Bailey, William H. Burdin, Samuel C. Morrill, Nathaniel L. Hooper, Henry Watson, Albert W. Murray, G. L. Wilder, Levi E. Bailey, Ira H. Horne, Nahum Morrill, Josiah A. Folsom and C. R. And we do hereby declare the precedence of said lodge in the Grand Ledge and elsewhere, to commence from May 5, A.
