REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Committee and Citizens of Cary:

In accordance with the school laws of Maine, I hereby submit my second annual report as superintendent of schools of Cary. The same elementary schools have been maintained the past year as the year before. Cary is fortunate in having local teachers who are capable of carrying on the schools so efficiently. Attendance has been very satisfactory. We are working towards a uniform system of textbooks, so that pupils moving from one district to another will still be using the same text books.

Our Health Program is being carried along again this year. Special rates are being given to all school children in regard to glasses and teeth. Our students in high school can have these rates as well as those in the grades.

In regard to repairs, very little was done last year. Wood putty was put on some of the windows in the Wilcox School and a stove was bought for the Skedgell. The Smith school is very much in need of repairs. Ceiling and walls need to be fixed. We need new blackboards.

Our regular equalization fund for last year was \$120. This year we are receiving an additional sum of \$375.00. The law specifically provides that the equalization fund shall be expended for those purposes designated by the Commissioner of Education. Namely, lengthening of the school year, purchase of text books, reference books, teaching supplies and equipment. No part of the equalization fund can be utilized for reducing appropriations at the annual meeting of the town. Towns at their annual meetings in 1938 should make appropriations at least on a level with those made in 1937. Otherwise, they may forfeit any right to share in the distribution of equalization in December, 1938. In other words the entire equalization fund is to be devoted for the further improvement of educational efficiency beyond the present standards.

The text book, supply and repair accounts show an un-

expended balance. We would not have this balance if all school bills were paid.

We have the smallest number of tuition students in school now that we have had for some time. Two graduate in June and we expect three more to enter in the fall. Your school committee has increased the length of the school year to 34 weeks. This is because we are receiving additional funds from the state.

Your school committee recommends the following budget for the coming year:

WARRANT

To Philip Putnam, a constable in the Plantation of Cary, in the County of Aroostook Greeting:

In the name of the State of Maine, you are hereby requested to notify and warn the inhabitants of said Plantation of Cary, qualified by law to vote in town affairs, to assemble at the Smith School house in said Plantation of Cary on the twenty eighth day of March A. D. 1938 at 1.30 o'clock P. M. to act on the following articles to wit:

- Art. 1. To choose a moderator to preside at said meeting.
- Art. 2. To choose all necessary Plantation officers for the ensuing year.
- Art. 3. To see what sum of money the inhabitants of Cary Plantation will vote to raise, and raise, for the support of schools, including tuition, repairs, and such as is necessary for the ensuing year.
- Art. 4. To see what sum of money the inhabitants of Cary Plantation will vote to raise, and raise, for the repairs of Town roads and bridges for the ensuing year.
- Art. 5. To see if the inhabitants of Cary Plantation will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State Aid as provided in Section 20, Chapter 28, Revised Statutes of 1930.
- Art. 6. To see what sum of money the inhabitants of Cary Plantation will appropriate and raise, for the improvement of the section of State Aid road, as outlined in the report of State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways,

and bridges, under the provision of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 175, Public Laws of 1937.

- Art. 7. To see if the inhabitants of said Cary Plantation will vote to raise, and raise, the sum of four hundred and sixty (\$460.00) to pay patrolman's wages for the ensuing year.
- Art. 8. To see if the inhabitants of Cary Plantation will vote to raise, and raise, the sum of one hundred and sixty-nine dollars (\$169.00) for the maintenance of improved sections of Third Class Road, or to be used in connection with the Third Class apportionment made by the State for the improvement of Third Class roads.
- Art. 9. To see what sum of money the inhabitants of Cary Plantation will vote to raise, and raise, to pay Plantation Charges for the ensuing year.
- Art. 10. To see if the inhabitants of Cary Plantation will "yes" or "no" on snow removal.
- Art. 11. To see what sum of money the inhabitants of Cary Plantation will vote to raise and raise, for snow removal.
- Art. 12. To see if the inhabitants of Cary Plantation will fix a time when taxes shall be due and payable, will vote to make any discount on taxes paid at such time or times as it may determine, and if so, what percent. Also for a time and rate of interest to be added upon unpaid taxes.
- Art. 13. To see if the inhabitants of Cary Plantation will vote to authorize the Assessors to sell and convey real estate the Plantation holds tax liens and deeds on, and give quitclaim deeds of same.
 - Art. 14. To see if the inhabitants of said Plantation

will vote to buy snow fencing, how many feet, and how much money will they raise to pay for same.

- Art. 15. To see what sum of money the inhabitants of Cary Plantation will vote to raise, and raise, to pay towards town debt.
- Art. 16. To see what sum, if any, the inhabitants of Cary Plantation would recommend to take from the joint state aid account for the purpose of applying bituminous surface treatment to state aid roads, in excess of the requirements of Section 2, Chap. 132 P. L. 1935.
- Art. 17. To see what sum of money the inhabitants will vote to raise, and raise, to be expended by the Aroostook Anti-Tuberculosis Association for the suppression and control of tuberculosis.
- Art. 18. To act on any other business that may be legal at said meeting.
