Shakespeare's timeless tale of fiery wit, confused identities, lost love and love scorned is Marcia Douglas's choice for spring 2004, as she brings to the stage *Much Ado About Nothing*. It has been four years since the School of Performing Arts has presented a Shakespearean play, so this selection will well serve the needs of theatre students and provide students from across campus with a cultural event. This play will also appeal to the Shakespeare-appreciating public who were deprived of their dose of the Bard when the Bangor waterfront Shakespeare series was cancelled last summer.

Marcia offered students the opportunity to enroll in a course on Acting Shakespeare so they would be prepared to participate in the play with more in-depth knowledge. Most students who were enrolled in the course were cast in the play, along with ten others.

The story involves Claudio, who returns from battle and falls in love with the beautiful maid, Hero. The scheming Don John, however, is bent on destroying their happiness. Meanwhile, a merry war of words rages between Beatrice and Benedick, whose love for each other is obvious to everyone but themselves. Join us for this bittersweet adventure through the joys and sorrows of life, in one of the Bard's most popular works.

Guest scenic and lighting designers have been hired, due to the elimination of the faculty position. The College of Liberal Arts and Sciences has agreed to fund these two positions.

We are requesting \$4,800 from Cultural Affairs. This is slightly higher than the amount we usually propose for a non-musical, although less than what we request for a musical. Costume expenses are a bit higher than average due to the period of the play. We need to build several platforms for this set, and due to rising lumber prices, design expenses are higher than usual.

The Committee notes that it does not fund more than 50% of the amount for any given program. It also asks applicants to consider the most reasonable honoraria possible, as there may not be funding for the higher amounts.

A total of 17 students enrolled in Marcia's course on Acting Shakespeare so they would be prepared to participate in the play with more in-depth knowledge. Most students who were enrolled in the course were cast in the play, along with ten others.

The public responded well to the Shakespeare production, which drew 1,146 audience members. Students were well-represented in the audience, with a total of 501 in attendance.
