Dear Mrs. Jackson:

May I reply to your letter addressed to me here in Orono as well as to the one addressed to the President of the University of Maine in Portland since that is a branch of the University of Maine. The NAACP has taken the initiative seeking to end discriminatory practices in their institutions.

We in relation to the University, I am glad to report that in the administration of admissions, residence halls, student employment, scholarships, participation in general extra-curricular life, all students are considered as individuals. The same policy is effective in faculty and staff employment, also.

3- fraternities or sororities
In relation to sororities and fraternities, the Board of Trustees took the following action on February 6, 1957:

"That it shall be the University policy to withhold approval of the establishment of any new fraternity or sorority which excludes persons from membership because of race, color, religion, or national origin."
