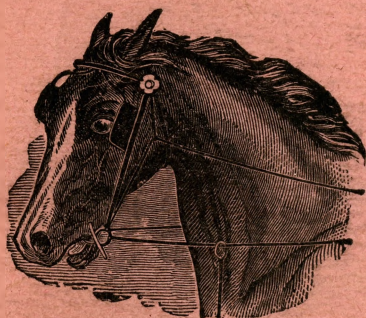

CAUTION

If there are any outstanding unpaid tickets at the close of this meeting, same will be redeemed within period of ninety days at offices of State Racing Commission, Augusta, Me., otherwise, money will be forfeited and same will be returned to Oxford County Fair Association.

TERMS USED IN BETTING

Straight: Means a horse must win or be first.

Place: Means a horse must be first or second.

Show: Means a horse must be first, second or third.

Combination tickets: \$3.00: Is \$1 Straight: \$1 Place; \$1 Show.

THE DAILY DOUBLE

The Daily Double play is on the first and third races, but all tickets for the Double must be purchased prior to the running of the first race. Keep your tickets on the Double until the official winning combination has been announced.
