The Sixth Annual Awards Ceremony – June 14, 2017

Co-Presidents Susan Mikesell and Bianca Chambers

More than fifty participants were welcomed by Susan Mikesell, Co-President, to the Sixth Annual Awards ceremony held in the Morrell Room, Curtis Memorial Library. This event celebrated the outstanding community organizations we are proud to support. It is the culmination of what we do as members of the Maine Women's Giving Tree.

Susan recalled that the Maine Women's Giving Tree awarded its first three grants in 2012. The total amount then was \$15,000. This year, we awarded eight grants totaling \$45,285. Including these grants we will have assisted 25 non-profit agencies with 40 programs for a total community investment of over \$195,000. Our only regret is that we were unable to fund every application we receive, because we understand all too well that human service needs in Maine are greater than ever before, while the available public resources to address them are shrinking year by year.

Bianca Chambers, Co-President, added her welcome and thanked everyone for coming to our most important event, the culmination of our grantsmanship—the heart and soul of the

Membership Meeting, Grants Committee Report – May 17, 2017

The membership continues to be well-served by the dedicated members of the Grants Committee and Grant Reviewers. They have worked extremely hard to ensure that a thorough, confidential, ethical, and equitable review process was implemented and was as objective as is possible. Due to the stress placed on the review process by the large number of grants (29) submitted during the previous grant cycle, the 2016/17 Grants Committee decided to experiment with limiting grant requests to a specific focus: "Child Well-being, ages 0-18". In September, letters were sent to all agencies in our Community of Interest explaining this cycle's focus and asking for Letters of Intent. We received 18 Letters of Intent from which we selected 14 who were invited to submit grant applications. These applications were distributed to reviewers on February 14. Early in May, grant reviewers met in two separate Panel Meetings to discuss reviews and make recommendations, which were then

reviewed by the Grants Committee. Difficult decisions had to be made as the total amount requested was \$103,379 which was well beyond the \$50,000 available funding. Discussion focused on how best to distribute our resources to have the greatest impact on our communities.

The Grants Committee and Grant Reviewers met in June to debrief and evaluate the entire grant review process. The outcomes of this meeting, and recommendations for your consideration, will be shared at the Annual Meeting in September.

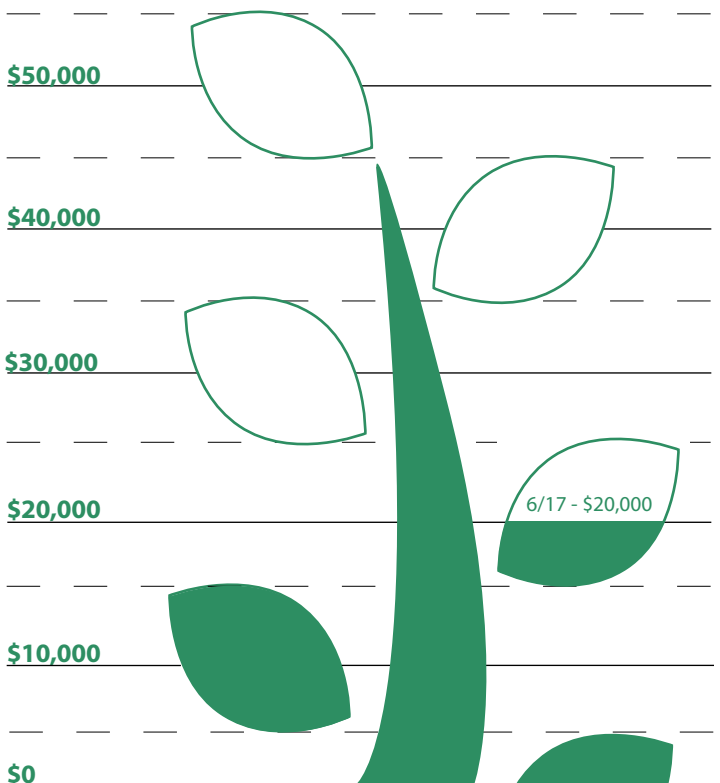
