III. Summary of program requiring funding (title; featured artist(s); speaker(s); scheduled date(s):

Professor Ian Lustick will present a lecture entitled "Time, Israel, and the Demise of Developed States: The 'Solutions' that History Provides" on 14 April at 7:30 in 100 Neville Hall as part of the Schonberger Peace and Social Justice Memorial Lecture Series. Professor Lustick will also deliver a luncheon talk for the Socialist and Marxist Studies Series on 14 April at 12:30 in the Bangor Lounge in the Memorial Union on "American Foreign Policy and the Israeli-Palestinian Conflict." Both talks will discuss important issues concerning the volatile Middle East and US foreign policy.

Professor Ian Lustick is the Bess W. Heyman Professor of Political Science at the University of Pennsylvania. He is a scholar of international reputation and a specialist on the modern history of the Middle East. He is the author of six books and the editor of five books, and he has published dozens of articles on the Middle East in major academic journals. He received numerous awards and grants, including from the National Endowment for the Humanities, the National Science Foundation, and the United States Institute of Peace. In his most recent book *Trapped in the War on Terror* (2006) he argues that the War of Terror is an irrational policy for fighting America's enemies. He argues that the War on Terror was initially conceived of by neo-conservatives who were determined to shift the direction of US foreign policy towards unilateralism. But because of political features unique to the US system, Lustick argues, the War on Terror has ultimately turned into something beyond anyone's control. Lustick is also the founder and past president of the Association for Israel Studies.

Summary of Program

Dr. Ian Lustick, the Bess W. Heyman Professor of Political Science at the University of Pennsylvania, visited the University of Maine on Thursday, April 14, 2011 and delivered two lectures, both followed by discussions. The first lecture, "American Foreign Policy and the Israeli-Palestinian Conflict (12:30 – 1:45 pm, Bangor Lounge, Memorial Union) was part of the Socialist and Marxist Studies Series. The second lecture, "Time, Israel, and the Demise of Developed States: The 'Solutions' that History Provides" (7:30 pm in 100 Neville Hall) was the annual Howard B. Schonberger Peace and Social Justice Memorial Lecture.

Professor Lustick is one of the most prominent American scholars on the Middle East with a particular expertise on Israeli-Arab relations. Aside from his numerous publications and academic achievements, he has also served as a consultant to various U.S. administrations. Both presentations were of very high quality academically and very engaging, stimulating substantial periods of Q & A. The evening event lasted for almost two hours with most people remaining until the end. Many stayed for a reception and continued to discuss the current situation in the Middle East with Professor Lustick.

Audience

Each event was attended by approximately 90 people including students, faculty, staff, and people from the outside community.

How was the event promoted?

The lectures were very well advertised throughout the campus and in the local media. Flyers were posted, were handed out at various events, and put in appropriate faculty mailboxes. In addition, letters announcing the events were mailed to everyone who has ever given money to the Schonberger Memorial Lecture Fund. Publicity was disseminated electronically using a variety of UMaine listservs, as well as those of the Peace and Justice Center of Eastern Maine and Congregation Beth El.
