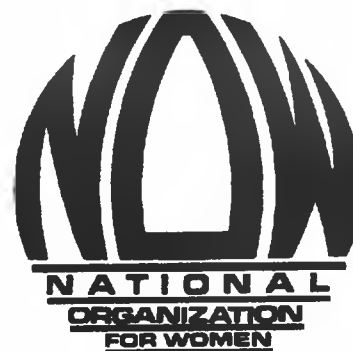

LATE TERM ABORTION ON CAPITOL HILL

On March 20th, the U.S. House voted overwhelmingly to approve H.R. 1122, the "'Partial Birth Abortion' Act." On May 15th the U.S. Senate also passed the bill, but fell a mere three votes short of a "veto-proof" margin. President Clinton has pledged to veto the measure, but national anti-choice activists have vowed to pressure members of the U.S. Senate to win the three crucial votes necessary to enact the ban into law, in spite of the President's objections.

What can I do?

•Please sign the Maine Choice Coalition petition. Once a "veto override" date is set in the U.S. Senate, the petitions will be submitted to Senators Snowe and Collins. Please call Valerie at 622-7524 ext. 20 for a petition.
