FBI

As you may be aware the FBI has been engaging in harassment of feminist activists in general and lesbian activists in particular. If you are approached, be aware that: 1) You don't have to give your social security number to anyone for identification; 2) You have a legal right not to talk to investigators. Don't lie or say you don't know anything. Just refuse to answer; 3) Don't let agents into your house without a warrant; and 4) Get legal advice. NATIONAL CONFERENCE

As you know the National NOW Conference is scheduled for Philadelphia in October. Because there have been reports of consideration of moving the Convention site (to Seattle), the Eastern Regional State Coordinators and others meeting in Boston in April passed the following resolution: "Regardless of whether or not the National Board or Executive Committee attempts to move the National Conference, we will not recognize such a blatant political act and will attend the Conference in Philadelphia. We insist that the organization honor its moral commitment to the membership and its financial commitment to the Philadelphia Convention."

NATIONAL BY-LAWS VOTE

The normal procedure for by-laws revisions is for all proposals submitted by members, chapters, or states to be considered by the National By-Laws Committee and then recommended to the National Board for approval. If approved, they would then go to the membership via a mail ballot. (By-laws may also be revised at the National Conference). This was the procedure used for proposals 1 and 2 which were printed in the March, April Do It NOW. They were proposed (as uncontroversial) by the By-Laws Committee who asked that the National Board (by a Board mail ballot) vote to include them in Do It NOW.

However, included with them were two proposals on a delegate system for the National Conference and a quorum for that Conference which were sent to the Chairone of the Board by Tulsa Oklahoma NOW. These proposals were included without the By-Laws Committee's knowledge and in precedence over many other proposals sent in previously for consideration by chapters and others. In addition, a lawsuit is being brought to enjoin their second printing in Do It NOW on the grounds that the results of the Board balloting have not been validated. (Cont.)

If they are sent out in the May/June Do It NOW you should be aware in voting that the delegate system proposed would disenfranchise over half our members in Maine who are at-large and decrease the representation of two of our larger chapters, Presque Isle and Lewiston-Auburn, whose charters have been held up for reasons which are not clear. Further, as delineated in Do It NOW the quorum proposal calls for an exceedingly large number of credentialled participants in relation to our past practice.

WHY:

On January 22, 1973 the Supreme Court of the United States upheld the right of women to safe, legal, abortion. The hierarchy of the Roman Catholic Church would deprive us of this right by using their immense resources of money, church staff, religious orders, power, and political influence to lobby for a Compulsory Pregnancy Amendment to the Constitution. We plan to expose and challenge this threat to the principle of separation of church and state.
