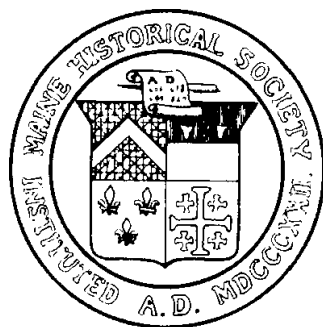

The Baxter Award, established to promote excellence in the research and writing of Maine history, is presented annually to the author of the best article, as determined by the Editorial Committee, appearing in the *Quarterly* during the volume-year.
