Warrant for Town Meeting

Androscoggin, ss. State of Maine.

To L. C. Mendall, Constable of Greene in said County,

GREETING:

In the name of the State of Maine, you are hereby requested to notify and warn the inhabitants of said town of Greene, qualified by law to vote in town affairs to assemble at the Town House in said town on the 10th day of March, 1924 at ten o'clock in the forenoon to act on the following articles to wit:

Art. 1. To choose a moderator to preside at said meeting.

Art. 2. To see if the town will vote to accept the reports of the town officers.

Art. 3. To choose all necessary Town Officers for the ensuing year.

Art. 4. To see if the town will choose one or more Road Commissioners.

Art. 5. To see if the town will grant and raise such sum of money as may be necessary for the maintenance and support of schools, current expenses, and cost of poor, repairs of roads and bridges, and defray all other town charges for the year ensuing, including the snow bills for the past year.

Art. 6. To see what sum of money the town will grant and raise to pay for High School tuition for the ensuing year.

Art. 7. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to enable the town to State aid as provided in Section 19. of Chapter 25 of the Public Laws of 1916.

Art. 8. To see if the town will appropriate the sum of \$533.00 for the improvement of the section of State aid road as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways, and bridges; the above amounts being the maximum which the town is allowed to raise under the provisions of Section 18, Chapter 25 of the Public Laws of 1916.

Art. 9. To see what sum of money the town will grant and raise to pay on debt and interest for the ensuing year.

Art. 10. To see what sum of money the town will grant and raise for Memorial Day, for the ensuing year.

Art. 11. To see what sum of money the town will grant and raise for the salary of the Superintendent of Schools for the ensuing year.

Art. 12. To see what sum of money the town will grant and raise for a Grammar School graduation.

Art. 13. To see if the town will vote to authorize the Treasurer to make a temporary loan.

Art. 14. To see if the town will vote to raise money and what sum for the maintenance of State and State aid highways within the limits of the town under the provisions of Section 9 and 18 of Chapter 130 of the Public Laws of 1913.

Art. 15. To see what sum of money the town will grant and raise for cleaning and repairs of school houses.

Art. 16. To see what sum of money the town will grant and raise for text books and supplies for schools.

Art. 17. To see if the town will vote to instruct the Road Commissioners regarding the expenditure of the money raised for roads and bridges.

Art. 18. To see what sum of money the town will grant and raise to aid in controlling the White Pine Blister Rust in Greene.

Art. 19. To see what sum of money the town will grant and raise for the purpose of teaching music in the public schools for the ensuing year.

Art. 20. To see if the town will vote to grant and raise the sum of twenty five dollars for the purpose of compulsory education.

Art. 21. To see what sum of money the town will grant and raise for the repair of fence and to care for the Greenwood Cemetery for the ensuing year.

Art. 22. To see if the town will vote to instruct the Treasurer to place the C. B. Mower and the Rebecca Cutler trust funds in the bank, taking the money out of the amount in the Treasury at the date of closing the books in 1924.

Art. 23. To see what sum of money the town will vote to pay a man, and a man and team per day for labor on the roads; also compensation for all Town Officials.

Art. 24. To see if the town will vote to accept \$400 as a trust fund, the interest to be used for the care of the Bradbury lot in the Greenwood Cemetery.

Art. 25. To see if the town will vote to instruct the Road Commissioner to open the old road between L. B. Green's and Viola Beal's and discontinue the present road through L. B. Green's field.

Art. 26. To see if the town will vote to instruct the Tax Collector to give a discount of 2 per cent on all taxes paid in full before July 1st, 1924.

Art. 27. To see if the town will accept the list of jurors as prepared by the Selectmen, Clerk and Treasurer.

The Selectmen give notice that they will be in session for the purpose of revising the voting list at the town house at nine thirty o'clock in the forenoon of the day of said meeting.

REMARKS

In regard to work done the past year in most departments you will see a Balance instead of an Overdraw and you will see the result in the Treasurers' report under "Cash in Treasury". The Road Commissioners both of them show substantial balance.

We have built 1,100 ft. of State Aid Road at a cost to the Town of \$546 24 and to the State of \$708 89.

We have built 1,125 ft. of Third Class Road at a cost of \$1,382.11. All paid by the State.

Through the efforts of our representative Hon. F. A. Morse we received a Legislative Resolve of \$500.00 to be used on the Star Mail Route. \$462.68+ cost of inspection was expended on the Route from the State road through Frank Turk's field which with the new stone and cement culvert placed by the Town shows a very great improvement.

In our State Aid Repairs we have expended in smoothing, cutting bushes and resurfacing, \$262.48. We have resurfaced with gravel nearly one third of our improved road.

In regard to our Road Machines we have one good machine which has been used but two seasons the other machine is past repair and if we have two Road Commissioners we need another machine the coming season.

The machine purchased last was bought by P. N. Rose out of this part of the amount raised for Repair of Roads. As there is no article in the Warrant for a new machine the Town if they see fit can raise a sufficient amount for roads to enable the other commissioner to purchase a machine.

Town Orders cashed for the year amount to \$22,474.52, and the number of orders drawn were 776.

We regret that we were obliged to overdraw on Current Expense and Cost of Poor but we had some Pauper bills which we did not anticipated and we had made our overlay smaller than common.

We have honestly tried to serve you to the best of our ability and the results, we herewith submit and we wish to sincerely thank you for your support, and courtesy during the past year.

Report of Superintendent of Schools

To the Superintending School Committee and the Citizens of the Town of Greene, Maine:

I, herewith respectfully submit for your consideration my first annual report of the condition and progress of the Greene schools since the beginning of this present school year.

Inasmuch as I assumed my duties in this school union during the latter part of July, you will understand that much of my task, thus far, has been to become acquainted with the people, the locality, and with conditions as I have found them, and meanwhile to keep the functioning of the schools as perfectly ordered as I could do. Mr. Blaisdell, my predecessor, sought to leave the work in such a condition that I might experience the minimum of difficulty in becoming familiar with it, and I have appreciated those especial efforts on his part.

I am aware that my work of supervision has not progressed as efficiently as would have been possible had I not been obliged to spend time in becoming familiar with my district and conditions existing in it. I have found that the clerical duties connected with my work have often made encroachments upon my time to the extent of causing my neglect of other duties, less insistent in their immediate demands, but none the less vitally important to the success of the work. A part time clerk to handle the correspondence, file permanent records, tabulate statistics, and do the other numerous more-or-less mechanical tasks of the office would free the superintendent for more efficiency in the real work of supervision. It would make possible the undertaking of a much larger and more worth while program.

For the most part, I can commend to you the work of your teachers. I have found them a serious group of workers,

and quite willing to cooperate with me. An oft repeated saying is that a school is no better than its teacher. In other words, a competent, capable teacher is very sure to meet with success in almost any situation for which her training fits her, while a teacher lacking natural aptitude and experience is likely to meet with an uncertain degree of success, even tho well trained. A teacher, who possesses a sincere liking for young folks is almost certain to teach a good school. Experience counts for much in the success of teaching. Regardless of training, there are many methods of school management that generally seem to be acquired only thru actual teaching experience. However, training is essential. The present trend among progressive school officials is to demand increased training of their teachers, endeavoring to encourage their attendance at the summer courses offered by normal schools and colleges. This movement for better trained teachers is entirely praiseworthy, and should rightly entail upon the town the duty of increased remuneration for the services of any teacher, who is thus willing to better fit herself for her position. I hope that when the time for the re-hiring of the teachers arrives, that I may be in a position to make to them some definite proposal in this regard. Of your present corps of teachers three are normal graduates, and the others have pursued partial normal courses. The work of Miss Williams, as helping teacher has been especially commendable. She is a conscientious and hard working teacher.

None of the school houses came in the way of extended repairs during the year. The amount raised for the remodeling of the Lane School according to state specifications was not expended, as it proved to be insufficient, according to the best estimates obtainable from builders. Because the \$600.00 would be sufficient by only about one half, it was the committee's judgement to leave the work not undertaken, rather than half done. The school building is greatly in need of being remodeled, however. To my mind it is **IMPERATIVE** that this be done this coming summer. Mrs. Hodg-

kins, who is teaching there this present year, is handling the difficult situation very capably and well. I believe that, properly, the school should be divided in primary and grammar, and placed under the instruction of two teachers.

The general attendance in the schools has been only what one might call fair. That it has not been better has been in some measure due to the epidemic of whooping cough. The best of attendance is only possible thru the close cooperation of school and home. There is hardly any legitimate excuse, other than sickness and extreme weather for keeping a child of compulsory school age from school. I believe, that, as a rule, parents are sincere in wanting their children to be in school, because they can understand, as well as school officials, that the best individual progress of their children depends as does the best welfare of the school in its entirety, upon the most complete possible attendance.

Hot noon lunches have been served in all of the schools this winter, and have firmly established themselves as being very worthwhile.

As special objectives in their work of instruction, this year, the teachers have, among other things, kept the following in mind: (1)—Alternation and grouping of grades in certain subjects. (2)—Alternating days for certain subjects. The purpose of these has been to reduce the daily teaching schedule, thereby permitting of more intensive and thorough work. (3)—Stressing of primary reading. (4)—More attention to silent reading in the upper grades. The foundation in reading obtained by the pupil in the lower grades is basic to his entire learning progress during his school career, and therefore demands especial emphasis.

With the help of teachers, I began a revision of the course of study, but time has prevented its satisfactory completion and utilization. I would hope to have this work done for the beginning of another year.

I think that I have arranged the financial statement accompanying this report in a manner sufficiently clear to en-

able anyone to ascertain the present standing of the various accounts, and also the distribution of expenditures. No equalization money was received from the state because of the fact that the local school rate is lower than that upon which the fund is based. Too, it will be so another year. The rates upon which this money is granted are: school rate .0106, and municipal rate .0428.

The carefully worked out recommendations of the School Committee for school appropriations at the annual March meeting are included at the end of this report. These estimates represent minimum requirements.

In closing I desire to express myself as sincerely grateful for the much needed advice and material help rendered me by all of the members of the School Committee. Without this, the work could not have satisfactorily progressed. My work has been wholly pleasant for me.

The citizens of Greene, also, have been very cordial to me. I assure you that such kindness is much appreciated.
