To the Inhabitants of Jackman Plantation

Today marks the end of another year and the beginning of a new one. Your officers have endeavored to make it a good year and herewith submit their Annual Reports of the financial condition of the Plantation of Jackman for the fiscal year ending March 1st, 1945.

Included in this report are those of the Selectmen, Overseers of the Poor, Road Commissioner, Treasurer, Auditor, Health Officer, Clerk, Superintendent of Schools, Post-War Planning Committee and the complete audit for the year ending March 1st, 1944; in which audit we are pleased to have you note that our net debt on March 1st, 1945 was \$11,827.95 and on March 1st, 1944, was \$5,034.13, as per the balance sheet of Exhibit A, showing a net reduction of \$6,793.82.

This year the Plantation was awarded the certificate of Superior Merit for its Annual report of the fiscal year ending March 1st, 1944.

Again, the state of war, brought on responsibilities have not lessened but increased, and we wish to take this opportunity to thank all the Plantation Officials for their splendid cooperation, and particularly those serving in a "gratis" capacity. They have spared no time and efforts and have done their job well.

We wish to thank all the Inhabitants of our Plantation for the splendid part they have played in our many appeals of rationing, Community Chest Drive and others, particularly the War Bond Drives. It is gratifying indeed, to know that in the three drives conducted during 1944, bonds were sold by the Committee totaling \$138,316.10. We are also deeply appreciative of the part played by the schools and wish to thank "Our Citizens of Tomorrow" for their cooperation. The Plantation has recently received a citation depicting the picture of a pursuit plane which has been marked for its Inhabitants before going into combat. We are sure everyone is proud of having

a share in these contributions. Your cooperation has helped to expand the "greatness and work" accomplished by the Plantation.

We wish to take this opportunity to express our thanks to the Daughters of Isabella and Knights of Columbus for co-sponsoring and donating to the Plantation its "Honor Roll," dedicated to our Boys of World War II; also to all those who may have in some silent manner helped to make the day of that Dedication one to be never forgotten.

We are grateful indeed to the Theatre management for allowing the Plantation to use their hall for "The Salute to Wood Caravan."

The Civilian Defense Corps became inactivated in December 1944, and to all members and Chairmen of the various committees, as well as Air Raid Wardens, our sincere thanks for your willingness to patriotically serve as such in this locality.

We appreciate the part played in Municipal affairs by all of its Inhabitants; we can only show you our gratitude by our cooperation and trying to conduct such, as advantageously as possible.

In starting another year the Plantation will undoubtedly again face many unforeseen obligations but trust that with your help and good will, "Success" with its fullest meaning will be achieved.

In spite of the teacher shortage in Maine continuing to be acute, we have been fortunate in keeping all classes operating full time.

Mr. Erskine, Mr. Fuller and Mrs. Fuller began the year in the High School. At Christmas Mr. Fuller asked for a leave of absence until April on Doctor's orders. It was granted. Mr. Robert Noon and Mrs. Ernest Wilson were engaged to each take part of Mr. Fuller's classes.

Mrs. Fuller had planned to stay on but circumstances forced her to ask, also, for leave from the last of January until Mr. Fuller could come back.

While it was impossible to find an experienced teacher to take her place we found, in the person of Miss Elaine MacArthur, one who is doing very well in following Mrs. Fuller's plans, keeping the classes together and making it possible for them

to earn their points toward graduation. From my observation I would say that she would make a very successful teacher.

Mrs. Johnston in the grammar school is going good work and her pupils show excellent progress this year.

We were shocked to learn that Mrs. Nichols met with such a serious and unusual accident in January by falling through the hot air register in the primary room. We are glad that she is reported as recovering nicely and hope she will soon be able to resume here duties. We were fortunate in securing Mrs. Harry Sands of Moose River as substitute.

Last summer the cap of the High School was insulated which makes the building warmer, lessens leakage due to water freezing and backing up under the shingles, and we hope will save fuel.

The building is in dire need of remodeling or renovating if it is to be used many more years. The plumbing is giving trouble and the heating arrangement is not satisfactory. Three hot air furnaces that are now being used to heat the building should be replaced by something that would heat the building more efficiently, economically and with less hazard from fire.

As a result of a recent survey by a representative of the State Department of Education, it was found that the height of the rooms is too little in proportion to the width making the lighting on the far side of all classrooms inadequate. It was shown by using a light meter that some desks were receiving less than half the required amount of light from the windows on an overcast day. We have rearranged the seats to help care for this but even at that the artificial lights will have to be used more than usual.

Some of the needs of a modern school system are facilities for visual education such as motion picture projector, slide projectors, film strip projectors, and the like. There are none of these at Jackman High and they should be provided.

The laboratory should be enlarged and more adequately equipped. In fact it is a state law that \$75.00 shall be spent on the

laboratory each year until it fulfills certain minimum requirements. This we have been doing for the past two years.

The State Legislature passes the enabling act making area schools possible, I hope that the communities in the Jackman area will plan to take advantage of this opportunity to get a modern well equipped school to better meet the needs of the children for years to come.

We are asking for only 10% more money in our budget this next year but we feel that we can run as usual with the amount providing we have no unforeseen emergencies. It should be pointed out, however, that the school tax rate in Jackman for last year of .01210 is 4 mills less than the average for the state. We should have had to raise \$8,213.00 to bring it to the average rate.

I wish to thank all the citizens and school board members who have helped make the year a pleasant one.

Report of High School Principal

I herewith submit my annual report to the superintending school committee and citizens.

There is a small increase in enrollment over that of last year. A larger entering class than usual is expected next Fall based upon present eight grade enrollment in Jackman and Moose River.

The boys and girls of today are the citizens of tomorrow and therefore are the most valuable wealth of any community. Teachers, pupils and townspeople have worked together very well in carrying on extra-curricular activities and deserve much commendation.

Much help has been given the boys and girls in sports by Langdon Holden, Arthur Crandall, Mrs. Austin O'Brien and others.

The superintendent and members of the School Board have been most helpful and it has been a real pleasure as always to work with such an understanding and friendly group.

Much appreciation is due the citizens of the community for their generous help and cooperation.

Report of Public Health Officer

To the citizens of Jackman Plantation the Health Officer submits the following report:

Today the problem of community health is a complex one. It is based on a great many factors, however, discussion of which is beyond the scope of a health officer. This report will, therefore, be limited to birth and death rates and incidence of contagious diseases for the past year.

During this time there were thirty-four cases of contagious disease in the community. There were no deaths caused by contagious disease. A summary of the types of illness in this class, is as follows:

Measles: 17 cases. (Remnants of the February 1944 epidemic.)

Chicken Pox: 10 cases. (Scattered throughout the year at irregular intervals.)

Scarlet Fever: 2 cases. (Contracted out of town.)

Typhoid Fever: 1 case. (Contracted out of town.)

Venereal Diseases: 4 cases.

Figures given on birth and death rates, in this report, will deal only with those having legal residence in Jackman; regardless of whether or not the birth or death actually took place in this community.

There were fourteen deaths, which include those of two soldiers who died in action, one accidental death, and deaths of eleven adults who succumbed to various illnesses.

There were twenty-two babies born to Jackman residents, including one set of twins. There were no still births.

In general, I wish to offer two suggestions. It is within the reach of everyone to be immunized against typhoid fever, diphtheria, whooping cough, and small pox. This is particularly important in war times. It is also suggested that some organized effort be made to induce a dentist to come to Jackman once or twice a month, as this is a service that is in great demand.

Postwar Planning Committee

It is with a great deal of pleasure I wish to submit the following report of the Post-War Planning Committee.

At the Annual Plantation Meeting, held on March 20th, 1944, the following committee was elected to serve: Percy L. Colby; Fred S. Moore; Ralph J. Letourneau V. L. Szanton, M. D. and Arlene R. Letourneau.

The first meeting of this committee was held on August 25th, 1944 and upon motion made and duly seconded, Arlene R. Letourneau was elected Chairman and Secretary. At this time, the situations discussed were many and varied, among which were a local hospital; hardwood mill; purchasing of lots for the purpose of increasing beauty and interest in our community; sidewalks and Federal Highway.

On August 27th, a short conference was held with Congresswoman Margaret Chase Smith. The particular reason for this was for suggestions and advice about any plans already considered and under way in Washington. She also notified us that our cause of the Federal building and Federal highway had been placed by her in the proper offices. She has been very co-operative and has kept us continually informed on any subjects interesting us locally.

Another meeting was held on October 10th, at which time the Committee felt we should list our resources for future development as one of our main objectives.

This committee also met with the joint school boards and Municipal officers at which time, through the efforts of Mr. Glenn Robinson, Superintendent of Schools, we were able to get much information in Consolidated Area Schools from Mr. William O. Bailey of the State Department of Education. This Committee wishes to go on record as endorsing to the fullest extent an Area school in this section, in so far as the proper legislation will allow.

Park development and the Airport as possible projects have also been taken up; these objects or goals are of course all in the making and no one can definitely ascertain what will happen after the War is over; however, if we have plans ready, have them submitted to the proper authorities, we can certainly feel that we will be among the first for consideration. There are at present 31 Authorized Committees in the State, with only two of these being in Somerset County; we are happy to know that Jackman is one of these.

At the last Annual Plantation meeting, five hundred dollars (\$500.00) was appropriated; it is our wish this would be considerably increased at this meeting, thereby giving the Post-War Planning Committee an idea of how much money will be available.

The members of this Committee, have served "gratis," each and everyone of them have attended every meeting, they have shown splendid cooperation and by this have manifested a deep interest in the future of our community. The time and efforts of your committee will help to build the foundation of our future.

Your Chairman wishes in behalf of the Plantation to extend to every member of this Committee a "Hearty Thank You" for the grand way in which they have co-operated, and for the opportunity given to work with them.

Warrant for Annual Plt. Meeting

To Philip Nadeau, Constable of the Plantation of Jackman in
the County of Somerset: Greetings:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the Plantation of Jackman, in said county, qualified by law to vote in said Plantation affairs to meet at the Town Hall in said Plantation on Monday the nineteenth day of March, A. D. 1945 at ten o'clock in the forenoon, then and there to act on the following articles, to wit:

Art. 1—To choose a moderator to preside at said meeting.

Art. 2—To choose a town clerk for the ensuing year.

Art. 3—To elect three selectmen also to be known as assessors, five overseers of the poor, treasurer, auditor, one member of the school board, fire warden for town, fire warden for forests, surveyor of wood and bark, sealer of weights and measures.

Art. 4—To elect a road commissioner, fix his compensation and have it understood that one hundred dollars of the common road money shall be set aside for fall use after the State Patrol is laid off if needed at said time and pass all votes respecting the same.

Art. 5—To elect a tax collector of Plantation taxes, fix his compensation and it shall be understood that the person elected tax collector of Plantation taxes will be required to make a full and complete settlement with the Treasurer of the Plantation no later than February 20th, 1946.

Art. 6—To elect an excise tax collector, fix the compensation, and it shall be understood the person elected excise tax collector shall be required to turn over all excise tax money collected to Plantation Treasurer and to make a complete settlement on or before February 20th, 1946.

Art. 7—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the Annual Audit for year of 1944 and pass all votes respecting the same.

Recommended by Budget Committee \$100.00

Art. 8—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the making and repairing of roads and bridges for the ensuing year and pass all votes respecting the same.

Recommended by Budget Committee \$1,300.00

Art. 9—To see what sum of money, if any, the Plantation will vote to raise and appropriate to entitle it to State Aid and pass all votes respecting the same.

Art. 10—To see what sum of money, if any, the Plantation will vote to raise and appropriate to entitle it to State Aid on Unimproved roads under the Patrol System and pass all votes respecting the same.

Recommended by Budget Committee \$928.20

Art. 11—To see what sum of money, if any, the Plantation will vote to raise and appropriate to entitle it to expend on State Maintenance—that is known as the 50-50 Road and pass all votes respecting the same.

Recommended by Budget Committee \$100.00

Art. 12—To see what sum of money, if any, the Plantation will vote to raise and appropriate for maintaining Third Class Roads for the ensuing year and pass all votes respecting the same.

Recommended by Budget Committee \$127.00

Art. 13—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the purpose of cutting bushes, and pass all votes respecting the same.

Recommended by Budget Committee \$400.00

Art. 14—To see what sum of money, if any, the Plantation will vote to raise and appropriate for sidewalks, and pass all votes respecting the same.

Art. 15—To see what sum of money, if any, the Plantation will vote to raise and appropriate for repairing and maintaining the so called "Nichols' Road" and pass all votes respecting the same.

Recommended by Budget Committee \$750.00

Art. 16—To see what sum of money, if any, the Plantation will vote to raise and appropriate to be expended for Snow Removal, for the ensuing year and pass all votes respecting the same.

Recommended by Budget Committee \$2,000.00

Art. 17—To see what sum of money, if any, the Plantation will vote to raise and appropriate for Town Officers for the ensuing year and pass all votes respecting the same.

Recommended by Budget Committee \$910.00

Recommended by Budget Committee \$4,000.00

Art. 22—To see if the Plantation will vote to direct the Selectmen to take possession for the Plantation of all real estate upon which tax liens have been placed, and redemption period has expired, and to sell or otherwise dispose of the town's interest in such real estate as they deem advantageous to the Plantation and to authorize the Selectmen, in behalf of and for the Plantation to execute all deeds or other documents as may be necessary to effect the above actions, and pass all votes respecting the same.

Art. 23—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the Jackman Public Library, and pass all votes respecting the same.

Recommended by Budget Committee \$100.00

Art. 24—To see if the Plantation will vote to raise and appropriate the sum of \$7,940.72 for the support and maintenance of the schools to be apportioned as follows: Consolidated schools \$6,815.72; Superintendent of Schools \$400.00; J. H. S. Graduation \$25.00; School Repairs \$700.00 and pass all votes respecting the same.

Recommended by Budget Committee \$7,940.72

Art. 25—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the payment of interest charges and coupons on bonds and pass all votes respecting the same.

Recommended by Budget Committee \$1,400.00

Art. 26—To see what sum of money, if any, the Plantation will vote to raise and appropriate for street lighting and pass all votes respecting the same.

Recommended by Budget Committee \$1,140.00

Art. 27—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the purchase of Treasurer's and Collector's Bonds, for the ensuing year and pass all votes respecting the same.

Recommended by Budget Committee \$48.00

Art. 28—To see what sum of money, if any, the Plantation will vote to raise and appropriate for the purpose of paying the Collector of Plantation taxes and pass all votes respecting the same.

Recommended by Budget Committee \$600.00

Art. 29—To see if the Plantation will vote to instruct the Tax Collector to pay to all who pay their taxes in full before June 1st., 1945, 2% of the tax assessed and pass all votes respecting the same.

Art. 30—To see if the Plantation will vote to charge interest at a rate of 6% on all taxes remaining unpaid after September 1st., and pass all votes respecting the same.

Art. 31—To see what sum of money, if any, the Plantation will vote to raise and appropriate to employ a Bureau of Health and Welfare Nurse and pass all votes respecting the same.

Recommended by Budget Committee \$50.00

Art. 32—To see if the Plantation will vote to instruct the Selectmen to deduct from payroll 20% of any money due person or persons who are indebted to the Plantation for taxes and pass all votes respecting the same.

Art. 33—To see what sum of money, if any, the Plantation will vote to raise and appropriate for repairs on the Town Hall and pass all votes respecting the same.

Recommended by Budget Committee \$250.00

Art. 34—To see if the Plantation will vote to raise and appropriate a sum of money to build the so called Nadeau street in its proper location and pass all votes respecting the same.

Art. 35—To see if the Plantation will vote to authorize the Selectmen and Treasurer to make temporary loans in anticipation of taxes and to issue and negotiate notes thereof, or renewals therefor, or any notes in places of the original notes when paid, to an amount which at any time shall not exceed in the aggregate the total tax levy of the preceding municipal year and all such notes to mature and to be paid during such current year by taxes, in accordance with the provisions of the R. Art. 39—To see if the Plantation will vote "Yes" or "No" relative to the appointment of a budget committee and pass all votes respecting the same.

Art. 40—To see if the Plantation will vote to instruct the Selectmen and Treasurer to set aside \$1,000.00 from the General Cash left on hand, to be used in Post War Work; such money to be placed in a Post War Fund in addition to the \$500. raised at the last Annual Town Meeting, in a bank designated by the Treasurer and pass all votes respecting the same.

Recommended "Ought to Pass" by the Budget Com.

Art. 41—To see if the Plantation will vote "Yes" or "No" on the appointment of a "Post War Planning Committee" for the ensuing year. Such committee to make their report at the next Annual Town Meeting and pass all votes respecting the same.

Art. 42—To see what sum of money, if any, the Plantation will vote to raise and appropriate to help buy fuel for heating the Town Hall and pass all votes respecting the same.

Recommended by Budget Committee \$200.00

Art. 43—To see what sum of money, if any, the Plantation will vote to raise and appropriate to repair or renew septic tank on Spruce street and pass all votes respecting the same.

Recommended by Budget Committee \$500.00

Art. 44—To see what sum of money, if any, the Plantation will vote to raise and appropriate to put Chloride on Forest and Spruce streets and pass all votes respecting the same.
