TOWN OF FRYEBURG

*To Francis D. Swan, Constable of the Town of Fryeburg,
in the County of Oxford:* GREETING:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Fryeburg, qualified by law to vote in town affairs, to meet at the town house in said town on Monday, the 6th day of March, A. D. 1922, at 10 o'clock in the forenoon to act on the following articles, to wit:

ARTICLE 1. To choose a Moderator to preside at said meeting.

ARTICLE 2. To choose a Clerk for the ensuing year.

ARTICLE 3. To see if the town will vote to accept the town reports for year ending February 7, 1922.

ARTICLE 4. To see if the town will vote to elect one member of its board of three selectmen to hold office for one year, one to hold office for two years, and one to hold office for three years.

ARTICLE 5. To elect three Selectmen, Assessors and Overseers of the Poor and vote their salary.

ARTICLE 6. To elect a Treasurer for the year ensuing and vote the compensation.

ARTICLE 7. To elect one member of the School Board. Stillman F. Barker's term expires.

ARTICLE 8. To elect one or more Road Commissioners for the year ensuing and vote their compensation.

ARTICLE 9. To elect a Tax Collector and vote the compensation.

ARTICLE 10. To elect one or more Fire Wards and vote their compensation.

ARTICLE 11. To elect an Auditor for the year ensuing, and vote the compensation.

ARTICLE 12. To elect all other necessary town officers.

ARTICLE 13. To see what sum of money the town will grant and raise for bridges for the year ensuing.

ARTICLE 14. To see what sum of money the town will grant and raise for the repair of roads for the year ensuing.

ARTICLE 15. To see if the town will vote "yes" or "no" on the question of raising money necessary to entitle it to State Aid as provided in Section 19 of Chapter 25 of the Revised Statutes of 1916.

ARTICLE 16. To see if the town will appropriate and raise the sum of six hundred dollars (\$600) for the im-

provement of the section of State Aid Road as outlined in the report of the State Highway Commission in addition to the amounts regularly raised for the repair of roads and bridges.

ARTICLE 17. To see if the town will grant and raise the sum of two hundred and fifty dollars (\$250) for patrol work on State Aid unimproved roads.

ARTICLE 18. To see if the town will grant and raise the sum of five hundred and twenty-five dollars (\$525) it being the amount required by law for the repairs of the State Highway leading through East Fryeburg. and also the sum of two hundred and ninety dollars (\$290) for the State Aid improved road.

ARTICLE 19. To see if the town will grant and raise a sum not exceeding three thousand dollars (\$3,000) together with seven hundred and eighteen dollars and seventy cents (\$718.70) the amount now in the treasury appropriated for this purpose and unexpended, for the rebuilding of the road in Fryeburg Village commencing at Maine Central R. R. Station and running to Main Street of said village and by way of Smith Street.

ARTICLE 20. To see if the town will grant and raise the sum of two thousand dollars (\$2,000) for the repairs of the road at North Fryeburg, commencing at place built last year and building towards W. J. Pitman's.

ARTICLE 21. To see if the town will grant and raise the sum of twenty-five hundred dollars (\$2,500) to rebuild the road across the McNeil Meadow, so called, with a starting point at the junction of the roads at First Street.

ARTICLE 22. To see if the town will grant and raise the sum of one thousand dollars (\$1,000) to pay note held by U. S. Trust Company, it being the amount the Selectmen were authorized to hire to build the Special Resolve Road, so called, through Emerson's Swamp.

ARTICLE 23. To see if the town will grant and raise the sum of fifty dollars (\$50) for Grover Post G. A. R.

ARTICLE 24. To see if the town will vote to move the memorial water trough, and if it so votes, grant and raise a sum of money for the same.

ARTICLE 25. To see what sum of money the town will grant and raise for Silent Policemen to be situated at the head of Portland, Oxford and Elm Streets, and elsewhere in town where needed, said Silent Policemen to be built of

concrete or iron as the town votes.

ARTICLE 26. To see if the town will vote to buy, build or reconstruct two snow rollers and raise a sum of money for the same.

ARTICLE 27. To see what sum of money the town will grant and raise for the year ensuing for the support of schools.

ARTICLE 28. To see what sum of money the town will grant and raise for school books for the year ensuing.

ARTICLE 29. To see what sum of money the town will grant and raise for school supplies for the year ensuing.

ARTICLE 30. To see what sum of money the town will grant and raise for the repairs of schoolhouses for the year ensuing.

ARTICLE 31. To see if the town will vote to pay the School Board for their services, and how much.

ARTICLE 32. To see if the town will grant and raise a special fund of ten dollars (\$10.00) for each school in town the same to be expended for school improvements in every school that raises and expends a like amount for school improvements.

ARTICLE 33. To see if the town will grant and raise the sum of five hundred dollars (\$500) to remodel the East Fryeburg Schoolhouse.

ARTICLE 34. To see if the town will vote to pay the tuitions of its pupils who may attend Fryeburg Academy, to the extent of twenty-five dollars (\$25.00) per term; it appearing to said town that the average cost of such pupils at said Academy for the preceding school year of 1920-1921 amounts to over one hundred dollars for that year; and if it so votes, to see what sum of money it will raise and assess for that purpose.

ARTICLE 35. To see what sum of money the town will grant and raise for tuitions at Fryeburg Academy.

ARTICLE 36. To see if the town will vote to refund to such pupils attending said Academy or to their parents or legal guardian, who have paid to Fryeburg Academy the sum of five dollars for the Fall term of 1921 and Winter term of 1922, such payment of five dollars being in excess of the sum of twenty dollars paid by the town for each pupil during said term; and if it so votes, to see what sum of money it will raise and assess to meet such payments.

ARTICLE 37. To see what sum of money the town will

grant and raise for the support of the poor for the year ensuing.

ARTICLE 38. To see what sum of money the town will grant and raise for current expenses for the year ensuing.

ARTICLE 39. To see if the town will vote to ratify the actions of its selectmen in the execution and delivery by them in its behalf, of deed of release in favor of George W. Weston, dated January 30, 1922, given for the purpose of establishing the west line of Pine Hill tract, so called, in said town, as conveyed said town by Minnie A. Bradley Mattson, and in accordance with the conditions of her deed to said town.

ARTICLE 40. To see if the town will accept the list of jurors as prepared by the Selectmen, Town Clerk and Treasurer.

ARTICLE 41. To see what action the town will take in relation to brown tail moths.

ARTICLE 42. To see if the town will authorize the Selectmen to borrow five thousand dollars (\$5,000) if needed to meet bills.

ARTICLE 43. To see if the town will vote to discount all taxes paid before June 15th, three per cent.

ARTICLE 44. To see if the town will vote to take a new re-valuation and raise money for the same.

ARTICLE 45. To see if the town will vote to employ a School Physician and raise a sum of money for the purpose.

To act on any other business that may legally come before said meeting.

The Selectmen give notice that they will be in session for the purpose of correcting the list of voters in said town and hearing and deciding upon the application of persons claiming to have their names entered upon said list at the town house, at nine o'clock in the forenoon of the day of said meeting.

REPORT OF HEALTH OFFICER

YEAR ENDING FEBRUARY 1, 1922

To the Board of Selectmen and Citizens of Fryeburg:

There were many more cases of communicable diseases which were not reported, as required, by law, through carelessness or lack of knowledge of the health laws, and for the benefit of such I refer to the following:

SEC. 48. Whenever any householder knows, or has reason to believe, that any person within his family or household has smallpox, diphtheria, scarlet fever, cholera, typhus or typhoid fever, cerebro-spinal meningitis, measles, mem-

branous croup, so called, whooping-cough or any other disease which is made notifiable by the rules and regulations of the state board of health, he shall within twenty-four hours give notice thereof to the health officer of the town in which he resides, and such notice shall be given either at the office of the health officer, or by letter or telephone, the communication to be mailed or delivered to him within the time above specified.

SEC. 49. No householder in whose dwelling there occurs any of the notifiable diseases, shall permit any person suffering from any such disease, or any clothing or any other property to be removed from his house, without the consent of the health officer, and the said health officer shall prescribe the conditions of removal.

SEC. 50. No parent, guardian or other person, shall carelessly carry about children or others affected with infectious diseases, or knowingly or wilfully introduce infectious persons into other person's houses, or permit such children under his care, to attend any school, theatre, church or any public place.

SEC. 51. Whenever any physician knows, or has reason to believe, that any person whom he is called upon to visit, has or is infected with any of the notifiable diseases, such physicians shall forthwith give notice thereof to the health officer of the town in which such person lives.

SEC. 53. No person affected with smallpox, scarlet fever, diphtheria, or other quarantinable disease, and no person having access to any affected with any of said diseases, shall mingle with the general public until such sanitary precautions as may be prescribed by the board of health shall have been complied with.

SEC. 65. Whoever wilfully violates any provisions of the preceding sections, or of said regulations and by-laws, or neglects or refuses to obey any order or direction of any local board of health or officer authorized by said provisions, or wilfully interferes with any person or thing, to prevent the execution of the provisions of said sections or of said regulations and by-laws, shall be punished by a fine of not more than fifty dollars.

REPORT OF THE SUPERINTENDENT OF
SCHOOLS

*To the Superintending School Committee and Citizens of
Fryeburg:*

It is with pleasure that I submit my fourth annual report of the condition, progress and needs of the schools of Fryeburg.

TEACHERS—To fill the vacancies occurring at the close of the spring term the following were secured: Grammar School, Miss Pearl E. Pierce, a graduate of Farmington Normal School; Intermediate School, Miss Blanche Dow, a graduate of Farmington Normal School; North Fryeburg, Mrs. Lilly Doe, a normal graduate; West Fryeburg, Miss Helen Merrifield, a graduate of Ashland County Training School; Toll Bridge, Miss Gertrude Foster, a partial normal course; Center, Miss Thelma Burns, a graduate of Westbrook High School. On account of sickness in her family Miss Burns was not able to return for the winter term and Mrs. Merton Bell was secured to fill the vacancy. I am pleased to report that these new teachers are taking up their work in a promising manner. I believe that we have an excellent corps of teachers and trust that we shall be able to retain them. There is still a scarcity of trained and experienced teachers and it will be necessary to maintain the present scale of wages with provision for increase in worthy cases in order to get and keep good teachers.

EDUCATIONAL MEETINGS—Two teachers' meetings have been held with full attendance, at which school problems have been discussed. All of the teachers attended the State Teachers' Convention at Portland. An educational Meeting has been held at East Fryeburg with the Grange. The program consisted of exercises by the East Fryeburg School, quotations on education, discussion of the questions: "Needs of our schools", and "What can be done to advance the educational interests of the town", and exhibits of school work. There was a full attendance from that section of the town and all seemed much pleased with the work which their school is doing. Similar meetings are to be held with Panguis Grange and Fryeburg Grange. The spirit of co-operation shown by all the Granges in furthering the educational interests of the town is especially pleasing.

INDOOR FIELD MEETS—Two Indoor Field Meets have been held. The following are some of the events: health

booklets, health compositions, physical drills, writing, spelling, history projects, geographical projects, health posters, best percentage in health chores, recitations, product map, relief map, potato races, and pulling up. This work shows a marked improvement over that of last year, especially in spelling, writing and projects. Both pupils and parents have shown much interest in the meets and both meets were well attended. I believe that such contests serve to stimulate the schools and that much better work will result.

THE HEALTH CRUSADE—Miss Nellie Jordan of the Maine Public Health Association visited all the schools in the fall and gave interesting talks on the Health Crusade work. All the pupils have become Health Crusaders and are doing the health chores. We urge that parents aid in this work by helping the children to remember their chores. The teachers report excellent results from the Crusade work. A number of children have stopped drinking tea and coffee and are drinking milk and cocoa in order to get up to normal weight. Some have stopped eating so freely of candy and are eating more fruits. While doing the "health chores" the children will form health habits which will mean a great deal in developing them physically.

MEDICAL INSPECTION—Under the provisions of the State law many towns are raising money for medical inspection and to care for cases where the parents are unable to have necessary work done. There are many cases of adenoids, also enlarged tonsils, and some cases of eyes and teeth, which need attention. If the need for attention to these or other defects was reported to the parents by a physician in most cases the children would receive the needed attention. Many cases of retardation are due to physical defects, which can easily be remedied.

REPAIRS—A Smith Heating and Ventilating System and Chemical toilets have been installed, a new chimney built, the roof shingled, and the lighting changed at North Fryeburg. These improvements have put the building into excellent condition.

At Toll Bridge the stove has been jacketed and a ventilating system installed.

IMPROVEMENT LEAGUE WORK—The Grammar School League has purchased a croquet set, a baseball, a football, and has raised \$20.00 to purchase books for the school library.

The Intermediate League has paid \$3.44 towards a foot-

ball and raised \$5.00 for Near East Relief.

The Primary League has purchased a fine picture.

The Village Leagues together have purchased a Victrola and records at a cost of \$48.35.

The North Fryeburg League has purchased a picture, a mirror, two books and paid \$6.00 towards a large dictionary.

The Center League has purchased a Victrola, eight records and two pictures at a cost of \$41.75.

The East Fryeburg League has had a bookcase made and a new flag pole raised.

The Toll Bridge League has purchased singing books, a pencil sharpener, a clock, three books and is planning to get a Victrola and records. This league did the janitor work during the fall term, earning \$10.50 in this way.

The Harbor League has purchased six records, two reference books, and has paid \$6.00 towards a large dictionary.

Together the leagues of the town have raised and expended for school improvements \$150.00. This, however, is a small part of the work done. Each league has regular meetings and the members learn how to conduct them and get practice in speaking before their schoolmates and visitors. Each league has held one or more entertainments, besides exhibitions and exercises on special days. The members also aid in keeping the rooms and yards clean and orderly. I believe this kind of work to be practical and a splendid training for citizenship.

From the town School Improvement Fund ten dollars has been used towards the purchase of a large dictionary for each of the following schools: Harbor, North Fryeburg and Intermediate. Ten dollars has been used towards the purchase of a Victrola for the Center School and ten dollars will also be used towards the purchase of a Victrola for the Toll Bridge School. Two hundred geographical pictures, a map of Europe and two books have been purchased for the village schools. This fund is proving a great help in this work and should be continued.

Figures indicate the number of terms the honor has been earned.

As the winter terms do not close in time to get attendance records for the spring report these records will hereafter include records of the winter term of the previous year.

This year the honor pupils have averaged twenty-five for each term, a gain of five per term over last year's record. The percentage of attendance is 87.5% an increase of 3.5% over that of last year. These are encouraging gains but there should be a longer Honor List and the percentage of attendance should be over ninety. An effort should be made by teachers, pupils and parents to make still further improvement. An added reason for good attendance is the fact that the new law allows approximately two cents to the town for each day a pupil is in school.

RECOMMENDATIONS

1. That Parents visit the schools more often and get first hand information regarding what their children are doing.

2. That provision be made for medical inspection and attention in cases where there is need.

3. That the policy of remodelling a building each year be continued and the East Fryeburg building be remodelled.

4. That the following amounts, which the School Committee after careful consideration voted to recommend, be raised:
