

REPORT OF ENGINEERS

Green & Wilson Civil and Constructing Engineers Waterville, Maine

W. S. Stanley, Chairman, Board of Assessors, Monhegan, Maine Dear Sir[:]

We have carefully considered the matter of sewage disposal and protection of the water supply in your village and find the following facts.

There are several dwellings and three hotels on the watershed of the bog from which the water supply is taken. The greater part of these buildings now have private septic tanks which ought to reduce, to a large extent, any pollution which may reach the bog. The other dwellings having bathrooms and water closets should be provided with septic tanks. The bog is about five feet above ordinary high water mark and not more than three feet at extreme high tide.

The bog is surrounded by hard ground or ledge with very little soil cover.

We understand that the water has been held up covering the bog during the winters for many years.

We have considered two propositions relative to a sewer system.

As the water system operates only through the warmer months, we considered a sewer system, mostly on the surface, to discharge near or at the bathing beach. Such a system should be of cast iron pipe from

4 inches to 10 inches and would cost between \$3000 and \$4000.

We considered another system with the pipes from 6 inches to 12 inches, placed in the ground, discharging as in the first case. Owing to the amount of ledge encountered the cost would amount to \$8000 to \$10000.

In either case of a sewer the disposal of the sewage at the beach constitutes a further serious problem. The difference in levels between the bog and high water is so small that either a sewage pump would be necessary or a large concrete tank capable of holding ten hours run of sewage and controlled by a tide gate. As a pump would require constant care and attention, we would not recommend it, but have only the tank with tide gate control. This would cost some \$3000.

The total cost of these sewer systems would amount to, approximately, the following.

Sewer System on Surface	\$3,500.

We have also considered a ditch, carefully graded to the outlet at the dam, going completely around the bog at its edge, this ditch to be about two feet wide on the bottom with sloping sides and to average about a foot in depth. This would not lower the water below the present level as the shore is a little higher than the middle of the bog. This would probably catch the greater part of the sewage and carry it off so that considerably less pollution would occur, but there should be no sewage allowed to enter the ditch until it had been through a septic tank.

This ditch can be dug for about \$500.

In view of the above we recommend:

1. That the bog be not flowed in the winter.

2. That the ditch be constructed around the bog.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the citizens of Monhegan, Greetings:

I shall begin my eighth annual report with a few statistics which should be a matter of record. The school census of last April showed 22 young people between the ages of 5 and 21 resident in the town. The enrollment in the school this winter term is 14, 3 less than a year ago. Three pupils are attending Secondary School. During the spring term, Mrs. Clara Burton was teacher and she was paid \$25 per week. She was reelected for the present year at \$23 per week. She resigned at the end of the fall term and her place has been taken by Mrs. Auvena Currier of Dryden at \$22 per week. In this way we have given heed to the demand for lower school costs by reducing the salary 12%.

Mrs. Currier comes to us with a normal school diploma, 11 years of successful experience in both

common school and high school, and with excellent recommendations. It seems apparent that her work as teacher is meeting with the approval of parents and children.

A reference to my report of a year ago will recall to your attention that we had four pupils who finished the eighth grade and graduated last June. It did not seem best to you to provide an additional teacher and regular High School work on the Island thru your action at Town Meeting. Only one of the four children entered High School in the fall.

Private arrangements were made with Mrs. Burton for instruction for the three remaining pupils by tutoring. The subjects selected were such as are commonly taken in the first year of High School. The pupils were present at school forenoons for study but received none of the teacher's time. They returned for an hour's recitation after school was dismissed at night. In this way much has been accomplished. It is not the equal of regular work in a Secondary School but earnest study and good teaching have secured results. We were glad for Mrs. Currier to carry on this feature of the work. The parents have paid for this instruction privately.

Monhegan children are fortunate in having friends who are glad to try to bring them advantages which otherwise would not be possible. Mr. Pyle's work with the boys on projects which might be termed Manual Training is valuable. Miss Richard's work on music with the pupils at school has been very helpful.

In the midst of the greatest uncertainty which civilization has ever faced, the school continues to be an absolutely essential factor in the development of sound bodies, alert minds and upright characters in boys and girls. We hold these two propositions to be true:

1. The man and woman of the future who have been given a sound foundation in health will be better able to enjoy the comforts and to combat the discouragements which may come.

2. The man and woman who have trained minds as well as trained hands will be much better off than those who have only trained hands.

The fact that some member of my family usually accompanies me on my visits to Monhegan gives testimony to the friendship which Monhegan people have shown us in so many ways. It has been a pleasure to work with your boys and girls this year.

SEVENTH. To see if the plantation will grant and raise a sum of money necessary to defray the charges of the Superintendent of Schools.

EIGHTH. To see if the plantation will grant and raise a sum of money necessary for printing the plantation Annual Reports.

NINTH. To see if the plantation will grant and raise a sum of money and how much for Discounts and Abatements. TENTH. To see if the plantation will grant and raise a sum of money and how much to be expended for advertising the natural resources, advantages and attractions of the State of Maine.

ELEVENTH. To see if the plantation will vote to raise a sum of money and how much to keep in repair the Plank Walk at the Ice Pond.

TWELFTH. To see if the plantation will vote to change the date of closing the plantation books from Feb. 21st to Feb. 10th to allow more time for making up and printing the plantation Reports.

THIRTEENTH. To act on any and all business that may lawfully come before the meeting.

You are hereby directed to serve this warrant by Posting at the Post Office in said plantation at least seven (7) days before the time of this meeting, hereof fail not and have you there and then this warrant with your doings thereon at the time and place of the said meeting.
