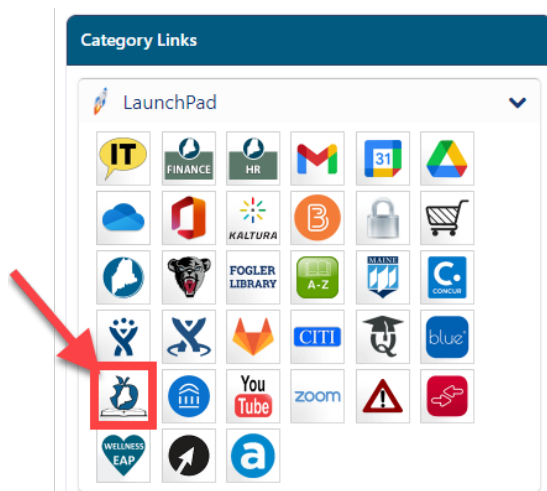
## 2024-2025 Compliance Training is Live!
