It is a deplorable fact, that with an enumeration of 142 scholars between the ages of 4 and 21 years, our average attendance has been less than 36 per cent. We have expended \$362.05 for conveyance of scholars, yet our average attendance has fallen off about 5 per cent from last year.

Many of our text books are old and badly worn, if you expect to

maintain schools in the future it will be necessary to appropriate money to buy better books.

This year completes a term of five years of almost consecutive service, as your superintendent of schools, I feel the force of age and most respectfully decline any more honors from you.
