# Superintendent of Schools' Report

---

*To the Citizens and School Committee of the Town of Glenburn:*

I herewith submit the annual report of the schools for the year ending March 1, 1918.

In reviewing the work of the past year, I find many things which point to a successful year, there has been very few complaints made by the parents; the daily attendance has been better than last year, this alone would enable teachers to do better work.

The Spring term in the Center school was taught by Grace Ogden Blanchard; as you will see by this report she also taught in the West school, all of her work has been very satisfactory to all. The Fall term was taught by Miss Grace Trefethen, excellent work done. The Winter term was taught by Miss Maria Mooney, a graduate of U. of M., her school was one of the best taught in town this year. The Spring term in the Gibbs school was taught by Miss Adelia Randall; the Fall and Winter terms by Miss Nettie Leathers, this school showed marked improvement and much credit is due Miss Leathers.

Miss Marguerite Littlefield taught the Spring term in the Vickery school with good success; the Fall and Winter terms were taught by Mrs. Leila Stubbs, this school is in excellent condition and satisfaction was given to all; the Spring term in the West school was taught by Miss Pearl Chase with marked success. Miss Chase was obliged to resign on account of sickness after teaching 10 weeks of the Fall term, Mrs. Blanchard finished the term, also taught the Winter term with excellent results.

## REPAIRS

The repairs made in Gibbs' District add much to the comfort of the pupils, some of the out-buildings are sadly in need of repair; I would suggest that money be appropriated to erect a new building at the West school.
