TOWN WARRANT

Penobscot, ss.

*To Samuel B. Drew, Constable of the Town of Glenburn in
said County:*

Greetings:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the Town of Glenburn, qualified by law to vote in town affairs, to assemble at the Town Hall in said town on the 11th day of March, 1940, at 10:00 in the forenoon to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at the meeting.

Art. 2. To choose a Town Clerk for the ensuing year.

Art. 3. To act on reports of town officers for the past year.

Art. 4. To choose a Town Treasurer for the ensuing year.

Art. 5. To choose Selectmen, Assessors and Overseers of the Poor for the ensuing year.

Art. 6. To choose one or more Road Commissioners for the ensuing year.

Art. 7. To choose one member of the School Board for three years.

Art. 8. To choose a Cemetery Board for the ensuing year.

Art. 9. To choose all other necessary town officers.

Art. 10. To see what sum of money the town will vote to raise for Highways and Bridges.

Art. 11. To see what sum of money the town will vote to raise for Cutting Bushes on State, State Aid, Third Class and Special Resolve Highways.

Art. 12. To see what sum of money the town will vote to raise for Snow Removal.

Art. 13. To see what sum of money the town will vote to raise for Patrol Maintenance.

Art. 14. To see if the town will vote to raise the sum of \$431.00 for Maintenance of Third Class Highways.

Art. 15. To see what sum of money the town will vote to raise for General Government.

Art. 16. To see what sum of money the town will vote to raise for Protection of Persons and Property.

Art. 17. To see what sum of money the town will vote to raise for Health and Sanitation.

Art. 18. To see what sum of money the town will vote to raise for Charities and Corrections.

Art. 19. To see what sum of money the town will vote to raise to pay interest.

Art. 20. To see what sum of money the town will vote to raise and appropriate for advertising our natural re-

sources, advantages and attractions under the Provisions of Chapter 5, Section 82 of the Revised Statutes of 1930, said sum to be expended under the supervision of the State of Maine Publicity Bureau.

Art. 21. To see what action the town will take in regards to establishing another school at Glenburn Center.

Art. 22. To see what sum of money the town will vote to raise for the same.

Art. 23. To see what sum of money the town will vote to raise for Common Schools.

Art. 24. To see what sum of money the town will vote to raise for Textbooks and Supplies.

Art. 25. To see what sum of money the town will vote to raise for Schoolhouse Repairs.

Art. 26. To see what sum of money the town will vote to raise for High School Tuition.

Art. 27. To see what action the town will take in regards to having a well on the town common for the schools and town hall.

Art. 28. To see what sum the town will raise and appropriate for State Aid Road Construction in addition to the amount regularly raised for the care of Ways, Highways and Bridges under the Provisions of Section 19, Chapter 28, Revised Statutes of 1930 or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Art. 29. To raise and appropriate a sum of money to apply on Overdrawn Accounts.

Art. 30. To see if the town will raise and appropriate \$36.00 for Public Health Nursing in Glenburn, said sum to be expended by the Bureau of Health for local service.

Art. 31. To see what sum, if any, the town would recommend to take from the Joint State Aid Account for the purpose of applying bituminous surface treatment to State Aid road in excess of the requirements of Section 2, Chapter 132, Public Laws of 1935, providing the state will accept our 3rd Class Highway as a State Aid.

Art. 32. To see what sum of money the town will raise and appropriate for the Maintenance of the Private Way in Beechwood Park.

Art. 33. To see if the town will vote to charge interest on unpaid taxes after a date to be fixed by the town.

Art. 34. To set the rate of interest and date after which interest will be charged.

Art. 35. To see what action the town will take in regards to the Hearse House at Lake View Cemetery.

Art. 36. To see what sum of money the town will raise and appropriate to repair the same.

Art. 37. To see if the town will vote to authorize the Town Treasurer and Board of Selectmen to sell and convey in the name of the inhabitants of the town the interest in in any real estate that the town may have acquired by virtue of proceedings for the collection of taxes.

Art. 38. To see if the town will vote to authorize the Town Treasurer, with the consent of the Selectmen, to hire money necessary to meet bills during the municipal year in anticipation of and to be paid out of current year's taxes

and to execute and deliver the negotiable promissory note or notes of the town therefor.

Art. 39. To establish wages of Foremen, Laborers, Trucks and Teams on Town Highways.

Art. 40. To see what action the town will take in relation to Collection of Taxes.

Art. 41. To see what sum the town will vote to raise to pay on the Town Debt.

Art. 42. To see what sum, if any, the town will vote to raise to Surface the Upper Cross Road from Glenburn Center to the driveway of the Appleby Farm, provided the owner of the Appleby Farm furnishes gravel and filling for the same.

Art. 43. To see what sum of money the town will raise and appropriate for the Maintenance of the Special Resolve Roads.

Art. 44. To see what sum of money the town will raise for repairing the fence at Pleasant View Cemetery.

Art. 45. To see what action the town will take in regards to Rent of Town Hall.

Art. 46 To see what action the town will take in regards to the P. A. Smith Settlement in 1936.

Art. 47. To see what action the town will take in regards to Daylight Saving Time.

Art. 48. To transact any other business that may legally come before the meeting.

The Selectmen give notice that they will be in session at the Town Hall for the purpose of revising and correcting the list of voters at 9:00 o'clock in the forenoon of the day of the meeting.

Hereof fail not and make due return of this Warrant with your doings thereon not later than 10:00 o'clock in the forenoon of the day of the meeting.

INSTRUCTION

The instructors now in the schools are the same as in the previous year. To retain the same teachers, when they have proven successful, is a very decided asset in proving educational privileges for the young people. These teachers were able to adjust the schools on a working basis immediately after the opening of the fall term.

A matter of considerable concern is the situation regarding the primary school. After the schools opened last year it became evident that one teacher could not do justice to these pupils and Mrs. Mildred C. Cookson was employed as assistant. This arrangement worked out very well last year, and, because of the continued large enrollment, has been carried on during the present year. It will be noted that there is an increase of seven pupils in the school over the registration last year. In making a check-up of the number in the entering class for the next school year it is probable there will be no reduction in the number of pupils in the school. The situation in this school resolves itself into the question as to whether or not the town wishes to continue the present method, or to establish another school by a division of the grades, and that raises the question of providing a place for another school. It should have your careful consideration.

TEXT-BOOKS AND SUPPLIES

The expenditure for these items has been rather large owing to the large number of pupils registered and the necessary changes made in the adjustment of the courses in the grades. Where there have been changes no books have been discarded but have been used in the arrangement of the work. It would appear that the principle requirement for the next year would be purchases for filling in the required texts. The expense for supplies remains practically the same from year to year, being averaged by the number of pupils.

EQUALIZATION FUND

The town has received the sum of \$559.00 as its apportionment of the equalization fund. This apportionment becomes a part of the general school fund and is available for general expense in the department.

Notice has been received that the town will receive the sum of \$972.00 as the probable allocation of this fund in December, 1940. This fund is apportioned to the town for the purpose of meeting so far as possible a minimum program in the schools, and should be used as a fund to improve the educational opportunities in the town. It should be borne in mind that in order for a town to share in this fund its appropriations for school purposes must produce a tax rate equal to or in excess of the average of tax rates for the state for school maintenance. These suggestions have been emphasized by Dr. Bertram E. Packard, Commissioner of Education, in his outline of the apportionment.

CONVEYANCE

The conveyance of the pupils is one of the most difficult problems with which the superintending school committee is faced. During the present school year eleven children are being conveyed to the West Glenburn school and fifty eight are being conveyed to the Center schools. The conveyance at the Center is about equally divided between the two conveyances. Before the opening of the fall term an enumeration was made of those attending school from the New Road so-called, and there are seventeen being conveyed from that part of the town.

Considering the financial condition of the department, it is felt that the present arrangement for conveyance is the only one that can be made by the town. If the conveyance drivers could be paid enough to warrant an investment in regular school busses and be assured of a contract for a term of years to guarantee the expense involved, this ques-

tion would be very largely adjusted. It is merely called to your attention for such consideration as you may wish to give it.

HEALTH

You are again urged to give attention to the reports from teachers regarding the health and health conditions of the pupils. It is often an evident fact that the health of a child seriously affects the work in school. Kindly give these matters your attention for the welfare of the young people.

A new arrangement has been put into effect by the state in the matter of the work of the district nurse. At the present time this town is being included in a district and has a nurse whose assigned duties include work in the schools. It is hoped this work will be cordially supported.

REPAIRS

The large item of expense in this department for the past year has been the expense for painting the West Glenburn school building on the outside. It was necessary to replace a considerable number of clapboards and to install a new door. This work has not only greatly improved the appearance of the building but will preserve the surface. Other repairs have been of a minor nature and only such as are required from time to time. A few desks had to be purchased for the primary room.

A suggestion is made that during the coming year the interior of the West Glenburn school building be painted so as to complete the work on this building. Banking boards are needed for both buildings at the Center. If it should be decided to make a division of the schools at the Center, it would be necessary to provide blackboards for any room made available. A matter for consideration by the town is the fact that after the close of the school year there will

probably be available a considerable amount of desirable school furniture at a saving in price. This opportunity may well have the consideration of the town.

SAFETY

We are in need of material for instruction in this subject so that it may be kept before the young people with the emphasis that it deserves.

The State Department of Education is placing considerable stress on the subject, not alone in its relation to the highway traffic problem, but as a subject for prevention of all kinds of accidents and the general care of the health. A general cooperation is strongly urged to make the welfare of all a subject of interest to all.

These estimates are made after a careful consideration of the probable expense in the department. The amount of the equalization fund to be received is taken into consideration.

The expense for high school tuition will remain approximately the same as for this year. The cost of maintenance of the elementary schools will vary but little from this year. It will be slightly less if the town provides for the electric light expense from another department. The expense for text books will probably be rather less than for this year

as the pupils become better supplied. The cost of school supplies will be about the same, as that expense remains constant on a per pupil basis.

The estimate for repairs is based on caring for the overdraft, providing for banking boards at the Center, and further equipment.

CLOSING

A summary of the year indicates that the usual progress has been made in the schools, as the children go ahead from grade to grade.

Surveys of school conditions are made from time to time and they serve to arouse us to the fact that there is need of still more progress with a richer curriculum to give the boys and girls as good a foundation as is possible upon which to build their future education whether it be in higher institutions of learning or out of school.

Their education is not finished with the termination of the term or with the school year, and the best help and guidance they can have is only to lead them to a better understanding of how to do still better work in their association with others in the everyday affairs of life.
