TOWN WARRANT

To Raymond A. Waterhouse, a Constable of Poland in the County of Androscoggin and State of Maine:

Greetings:

In the name of the State of Maine you are hereby required by law to notify and warn the inhabitants of the Town of Poland qualified by law to vote in Town Affairs to meet at the Town Hall in said Town of Poland on Monday, the twelfth day of March, 1945, at ten o'clock in the forenoon to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

Art 2. To hear and act upon the reports of the Town Officers.

Art 3. To see what sum of money the inhabitants of the town will vote to raise and appropriate to pay tuition of the scholars attending High School of other towns and support of common schools, and for textbooks and supplies.

Art. 4. To see what sum of money the inhabitants of the town will vote to raise and appropriate for repairs of school property.

Art. 5. To see if the inhabitants of the town will vote to raise and appropriate the special sum of \$600.00 for the purpose of conveying some of the pupils of the Poland Corner School from said school to some other school or take any other action thereon.

Art. 6. To see if the inhabitants of the town will take any action regarding the building of a consolidated school building and to see if the inhabitants of the town will raise and appropriate a sum of money for a building fund to be used whenever such a building is built.

Art 7. To see if the inhabitants of the town will vote to appoint a committee to act in conjunction with the superintending school committee to choose a site for the building proposed under the previous article and to serve as a building committee.

Art 8. To see if the inhabitants of the town will vote to allow the Moderator to appoint a committee of three who will nominate three citizens of the Town of Poland, one of whom is to be named Chairman of this Committee, which Committee is to make a thorough study of the possibility of the consolidation of all the schools in Town, to serve without pay, said nominations to be confirmed by vote of the Meeting, and the Committee is to submit their report at the next regular Town Meeting.

Art. 9. To see if the inhabitants of the Town will vote to raise and appropriate the sum of \$75.00 for the School Board.

Art. 10. To see what sum of money the inhabitants of the town will vote to raise and appropriate for the support of roads and bridges.

Art. 11. To see if the inhabitants of the town will vote to raise and appropriate \$500.00 to continue the road building from the end of work done in 1944 on Johnson Hill that began at Arthur White's and ended at Lloyd Thompson's.

Art. 12. To see what sum of money the inhabitants of the town will vote to raise and appropriate to pay snow bills.

Art. 13. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$893.00 for maintenance of Third Class Roads under provisions of Sections 44, 46, Chapter 28, R. S. 1930, as amended by Sections 4, 5, Chapter 229, P. L. 1937.

Art. 14. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$1,850.90 for maintenance of State Highways and Special Resolve Highways during the ensuing year under the provisions of Sections 9, 18, 36, 37 and 38, Chapter 28 R. S. 1930, and Section 9, Chapter 149 P. L. 1935.

Art. 15. To see if the inhabitants of the town will vote to fix the compensation of the Road Commissioner.

Art. 16. To see if the inhabitants of the town will vote to fix the compensation of the Town Treasurer.

Art 17. To see if the inhabitants of the town will vote to fix the compensation of the Selectmen, Assessors, Overseers of the Poor and Town Clerk.

Art. 18. To see what sum of money the inhabitants of the town will vote to raise and appropriate for salaries of Superintendent of Schools and Town Officers.

Art. 19. To see if the inhabitants of the town will vote to receive bids for candidates for Tax Collector.

Art. 20. To see what sum of money the inhabitants of the town will vote to raise and appropriate to pay Tax Collectors Commissions, Abatements and Discounts on Taxes.

Art. 21. To see if the inhabitants of the town will vote to allow on personal and real estate tax bills for 1945 a cash discount of 2% if paid on or before July 1, 1945.

Art. 22. To determine whether the inhabitants of the town will vote to authorize and empower the Selectmen and Treasurer to sell at public or private sale in such manner, on such conditions, for such amounts and upon such terms of payments as they in their discretion may deem advisable any or all real estate now held by the Town, title to which is claimed either by virtue of the tax deed lien procedure provided by Section 72 of Chapter 14 of the R. S. 1930 et sequi, or by virtue of the tax mortgage lien procedure provided by Chapter 244, Public Laws 1933 et sequi.

Art. 23. To determine whether the inhabitants of the town will vote to authorize the Town Treasurer to sign, seal and execute and deliver good and sufficient quit claim deeds without covenant to any and all purchasers of property sold under the terms and provisions of the vote set out in the above article of this warrant. This article is not to be voted upon in event the vote upon the proposition set out in the above article of this warrant is negative.

Art. 24. To see if the inhabitants of the town will vote to authorize the Selectmen and Treasurer to procure temporary loan or loans not to exceed \$25,000.00 in anticipation of taxes for purpose of paying obligations of the Town, such note to be paid during the current municipal year out of money raised during current municipal year by taxes.

Art. 25. To see what sum of money the inhabitants of the town will vote to raise and appropriate for the support of the poor.

Art. 26. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$50.00 to pay interest on temporary loans.

Art. 27. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$650.00 to pay Insurance on Town Property and Compensation Insurance.

Art. 28. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$250.00 for fuel and janitor's salary for Town Hall and Office.

Art. 29. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$150.00 to pay Treasurer's, Tax Collector's and Constable Bonds and recording deeds and liens.

Art. 30. To see what sum of money the inhabitants of the town will vote to raise and appropriate for the Miscellaneous Account, consisting of Fire Protection, Auditing Books, Office Supplies, Lights, Telephone and Printing Reports, etc.

Art. 31. To see if the inhabitants of the town will vote to retain from bills due from the Town, amounts due the Town for unpaid taxes due from persons presenting such bills, which are one or more years in arrears.

Art. 32. To see if the inhabitants of the town will vote to authorize the taxpayers to call the nearest fire department in case of fire without permission from the Selectmen and have Selectmen instruct the fire departments to this effect.

Art. 33. To see if the inhabitants of the town will vote to accept Sections 36, 37, 38 and 39, Chapter 26, R. S. 1930, relative to giving the Town Officers a right to have buildings removed that are dangerous as regards fire or human life.

Art. 34. To see if the inhabitants of the town will vote to allow the Moderator to appoint a committee of three who will nominate seven citizens of the Town of Poland to act as a Budget and Advisory Committee for the term of one year and to serve without pay, said nominations to be confirmed by a vote of meeting.

Art. 35. To see whether or not the inhabitants of the town will vote to raise and appropriate the sum of \$100.00 for advertising the natural resources, advantages and attractions under provisions of Chapter 5, Section 82 of Revised Statutes, said money to be expended through the State of Maine Publicity Bureau.

Art. 36. To see if the inhabitants of the Town of Poland will appoint a committee of three to solicit funds for Christmas presents for service men and women.

Art. 37. To see if the town will raise and appropriate \$100.00 for Public Health Nursing in Poland, said sum to be expended by the State Bureau of Health for local service.

Art. 38. To see if the inhabitants of the town will vote to raise and appropriate the sum of \$250.00 to cooperate with the Maine Forest Service and the Federal Government in the control of the White Pine Blister Rust in accordance with Revised Statutes Chapter 11, Sections 62, 63, 64.

Art. 39. To see if the inhabitants of the town will vote to purchase a truck and snow plow for the plowing of snow that would cost approximately \$10,000.00 and the cost of the equipment to be financed over a period of four or five years. This truck is to be used for plowing snow only.

Art. 40. To see if the inhabitants of the town will vote that the first payment on the new equipment, not to exceed \$2,500.00, be made from funds in the Town Treasury, and to authorize the Town Treasurer to make payment from such funds.

Art. 41. To see if the inhabitants of the town will vote to authorize the Selectmen to lease from the State of Maine Highway Commission the necessary snow equipment to adequately plow the roads in Town, provided the Bill which is now in our State Legislature is passed which authorizes the State Highway Commission to purchase snow removal equipment which is to be leased to any towns desiring same for this type of work.

Art. 42. To see if the inhabitants of the town will vote to accept the Gerry Fund, the interest of which is to be used toward the upkeep of the Highland Cemetery, West Poland.

The Polls will be open for balloting for Town Officers from 2.00 to 7.00 o'clock in the afternoon.

The Selectmen give notice they will be in session at the Town Office on March 8, 9 and 10, 1945, in the afternoon from 1.00 to 5.00 for the purpose of correcting the list of voters.

In accordance with Chapter 16, Section 3, Revised Statutes of 1944, the records of the town of Poland have been audited for the fiscal period February 1, 1944 to February 1, 1945 inclusive.

Our examination was made in accordance with the generally accepted auditing standards applicable in the circumstances and included all procedures which we considered necessary.

Insofar as we can ascertain within the scope of our examination, the result discloses that the many financial transactions of this town have been properly handled and in accord with accepted accounting practices.

Comments of Auditors Allen and Daniels who conducted the examination, are incorporated in this report. These may prove of interest to you.

COMMENTS

CASH

As far as could be ascertained, all receipts were recorded and the cash was deposited in the bank.

Expenditures were made by check from properly authorized warrants, supported by invoices and payrolls on file.

The cash balance was reconciled with the bank.

TAXES—PROPERTY AND POLL

The 1944 tax commitment was found to be in agreement with the assessors' records. The balance due from the Collector on this commitment is represented by unpaid taxes taken from the records.

Payments recorded as received on tax liens and deeds were found to have been applied against the proper items.

As applied to the current commitment, the cash collection of the 1944 taxes was 97.5%, while all taxes collected during the current year amounted to 101%.

EXCISE TAX

The excise tax collections were verified with the copies of the receipts as follows:

TRUST FUNDS

The trust fund investments were examined and all income withdrawn appeared to have been properly expended. The balance was left on deposit.

NET SURPLUS

Reference to Exhibit A indicates that as of the close of the municipal year, there was a Net Surplus in the amount of \$8,413.93, as compared to a Net Surplus of \$7,301.09 shown the year previous, which represents a gain of \$1,112.84.

GENERAL

Our test check of paid invoices and payrolls indicated they were proper charges and correctly recorded.

Withholding Tax deductions were examined and appeared to be properly recorded.

The records of dog licenses issued by your Town Clerk showed collections of \$233.10, however, \$235.90 was paid to the State Treasurer or an overpayment of \$2.80.

With the exception of cash and trust funds, no external verification was made of your asset and liability accounts.

REPAIRS

The repairs have been very small for the past year. The Poland Spring building was divided by a partition so that we have two rooms. This has been more satisfactory than the former arrangement. Ten outside windows were purchased for this building.

RECOMMENDED REPAIRS

The furnace should be rebuilt or a new one installed at Poland Springs. The building needs painting exterior and interior. Water seeps through the foundation wall and keeps the basement wet most of the time. This should be repaired.

A new ceiling is needed at Poland Corner building. The roof at West Poland should be shingled this year. All of your schoolhouses need painting.

It is recommended that \$1,000 be appropriated for repairs.

SCHOOLS

The Poland Corner School has been crowded. This should come before the town meeting for a decision. Since some of your teachers are working under a permit, another teacher cannot be added. It would seem best to convey a part of the pupils to another school.

There were many changes in teachers. The new teachers are—Georgia McKnight at the Empire School; Beulah Kimball at Bailey Hill; Stella Lane at Harris Hill; Phyllis Brackett at Poland Spring Primary.

CONCLUSION

It can be truly stated that the War has effected your schools. It has been a very difficult job to try to keep everything on an even keel; to find teachers, secure fuel and necessary supplies.

I want to thank each member of the school committee for the help given me, to the teachers for their aid and the parents who have endured.

REPORT OF THE PUBLIC HEALTH NURSE—1944

Nursing service is no longer just a matter of bedside nursing care. Public Health Nursing Service has developed during the past 30 years to a program that includes not only care of the sick, but the prevention of disease, and the promotion of health. In spite of a growing fund of medical knowledge and skill, too much preventable sickness still persists, too many physical defects go neglected. There is much need for greater community education in all phases of Public Health.

An average of two days a month has been spent in Poland. Child Hygiene, maternity service, venereal disease and tuberculosis control; home, school, and community sanitation problems have called for demonstrations by your Public Health Nurse at same time during the year. Forty-one home visits and 56 interviews with community officials and teachers were made in connection with health activities.

Three child health conferences were held in East Poland, Poland Corner and West Poland. The average attendance was 41 but 17 of these were school children coming for immunization only. That makes an average of 8 infants or preschool children to each conference which is a very small attendance for the amount of time and expense involved. One of our objectives for 1945 should be to double the interest and attendance if these conferences are to be continued.

Much time has been spent in school health work. Hearing tests with the audiometer for all children above the second grade were given, and six children showing more or less loss of hearing were referred to their family physician.

Diphtheria and smallpox immunizations were offered in all schools and child health conferences. At the request of the health council tuberculin tests were also offered, 155 smallpox and 206 diphtheria immunizations were given.

One hundred and seventy-one Tuberculin tests revealed several individuals with positive reactions. These followed up with chest x-rays, all of which were satisfactory.

Through the nurses' influence and the help of the local Red Cross, two children had much needed tonsil and adenoid operations.

It is a tragic commentary on the health record of our nation that half of the first three million young men of this Wars' Selective Service examinations were rejected for general military service. It is doubly tragic because many of the defects might have been prevented or corrected in infancy or childhood. These facts help to impress on us the urgent need for an adequate health education program. The whole community must share in such a program if optimum health is to be obtained for all during the post war period. For this reason we are especially happy in the organization of the Poland Health Council of which Mrs. Fannie Verrill is the President.

Our big objective in 1945, working together with Health Officer, Mr. George Pulsifer and the Poland Health Council is to study the community health and develop a health education program for the promotion of maximum Public Health.

We wish to express our appreciation to the Poland Health Council and all others who helped in health work in Poland this year.

REPORT OF POLAND RED CROSS

Facing this past year under war time conditions, we found ourselves deprived of the services of a dentist as well as a school nurse. However, Dr. Williams conducted three clinics, which included all our schools, and although we were not able to do any dental work, we sponsored five throat operations and one pair of glasses. We sent \$1,400. to headquarters as our quota on the War Relief Drive, and spent \$131.25 for furnishings for army kit bags which our members made.

Dr. Williams has again conducted three clinics in Poland this year, and upon the results of these clinics we shall base our work in the schools for the coming year. We cannot provide the regular dental clinics of pre-war days, but any children between 5 and 12 years of age who need Red Cross Aid may have it if the parents, or teacher, will apply for it through the secretary, Glenys Walker.

Our quota for this year for the War Relief Fund is \$1,400. This fund includes the annual membership drive, and Mrs. Max Richardson, who is chairman of Roll Call, reports that already we have come a long way toward recognizing our goal. Our Valentine Party, Feb. 14, netted \$178.56. We hope to be able to raise the rest of our quota during the next few weeks.

We all realize that this past year has been difficult in many ways for all of us, and, more than ever, do we appreciate the wonderful support of everyone who has helped to make this difficult year a success.

On behalf of the entire group of officers and committees, I thank you.

Poland, Maine, February 1, 1945

In the past year we have had the usual cases of Chicken Pox, Measles, German Measles, Mumps, Pneumonia, Scarlet Fever, Impetigo, Pediculosis and nuisance cases. These have been taken care of and reported to the State Department of Health as required.

There have been Clinics under the supervision of Doctor Arms our District Health Officer, Doctor Williams and Miss McClunin our Public Health Nurse. A more detailed report of this will be found under Miss McClunin's report and that of the Poland Red Cross.

The same Plumbing Inspector, Mr. Elmer F. Walker and Deputy, Mr. A. F. Waterhouse have been reappointed for 1945.

Free vaccination for Small Pox will be given all, who apply in the month of March.

We appreciate, and ask for the continued cooperation of all our Citizens in carrying out this health work.
