# REPORT OF THE PUBLIC HEALTH NURSE

1942

---

Another year has rolled around and we are still at war; a war which affects our lives and work.

The health of our children must be protected and conserved and for their benefit we must not relax our vigil in education for good nutrition, prevention of disease, and the correction of remedial defects.

The examination of the men for military service has shown the need for better medical examinations for our children. Aside from the complete physical examination, which includes a chest X-ray, the men are given immunization against the various communicable diseases.

If the government realizes the need for our service men to have this thorough physical check-up and protection, shouldn't we, the present citizens of the communities, feel responsible for seeing that such services are available for the health and welfare of our future citizens?

During 1942 the nurse has tried to carry on a well rounded public health program. One of the most important accomplishments of the year was the organization of a community health committee. This committee has aided greatly in the success of many projects.

As in the past years, much stress was placed on the maternal and child health phase of the work. Expectant mothers were visited to urge regular medical supervision. Eight visits were made to mothers during the post partum period to stress the importance of regular feeding and sleeping habits for infants, and sufficient amounts of rest for the mother.

Forty-two visits were made in behalf of infants and forty-nine visits in behalf of preschool children. Mothers were given advice in relation to feeding habits, the necessity of children to develop a sense of independence, and the need for early protection against preventable communicable diseases.

In the spring a vaccination clinic was held in the schools. Dr. Smith, assisted by the nurse, vaccinated 219 children.

The District Health Officer gave the tuberculin test to sixty-two high school children. Sixteen X-rays were taken.

Two hundred and thirty-five school children were given the audiometer test, which detects hearing defects. Follow-up visits were made in the homes of children showing such defects.

In 1943 the following activities should be increased: Immunization program against the preventable communicable diseases, with a better understanding of the methods for controlling the spread of those diseases which cannot be prevented, and a community responsibility for increasing its health index.

With the slogan "Cooperation for 1943," we will look forward to BETTER HEALTH for 1944.

*To the Superintending School Committee and Citizens of Winterport:*

For the sixth consecutive year it becomes my duty and pleasure to present this report for your careful consideration. In many ways this has been a most difficult year and to those who have given loyal support we are grateful.

### CHANGES

#### TEACHERS

In view of the great shortage of teachers, we have been most fortunate this year with regard to our teaching force. At the High School Miss Mary Vannah, language teacher, resigned to become married and Miss Ruth Hawkins, a graduate of Bates College with two years' experience, was secured for this position. Mr. Hopkins left for a better paying teaching job and Mr. Donald Raymond, a

graduate of Farmington State Normal School, took over this work. In January Mrs. Mabel Lord, who had served the Commercial Department so efficiently for five years, left us for a more remunerative position in government office work, and Miss Hilda Banks, a senior at the Maine School of Commerce, took over the work immediately. We were able to keep the Commercial Department in continuous operation, which many schools have been unable to do because of the great demand for government office positions.

At the grade school, Mr. Sumner Clark, as principal, felt it his duty to continue farm work, and Mr. Leon Beal, a Farmington graduate, was secured as principal. He was soon drafted for the "armed forces" and Mr. John Carleton, for several years a teacher in the Winterport schools, took over the principalship, only to be called for Selective Service in a short time. By that time teachers were becoming most difficult to obtain under any circumstances. However, we obtained the services of a competent and well-trained teacher with experience in the person of Mrs. Elsie Trecartin as principal. But yet our troubles were not over, another teacher was still needed and Miss Rachel Green, a graduate of North Dakota Normal School, was found to teach Social Sciences in the four upper grades. As Miss McCann, who for four years had done splendid work in grade two left for the marriage state, Miss Helen Staples, a graduate in 1942 of Farmington, was secured for this important position in sub-primary and Miss Shirley Curtis took over Miss McCann's grade two room. As Mr. Kenneth Matthews, supervisor of music, left in the fall to enter the Portland shipyard, that position has been vacant this year. The teacher supply for Maine schools next year is most limited. We will, however, do our best for your schools next year.

#### TEXTBOOKS

Present conditions reveal the wisdom of the past five years of placing our textbook supply in the schools on an efficient basis in both grade and high schools. This year we have added to an already excellent textbook equipment. Noteworthy has been the set

of aeronautic textbooks for the high school, together with such supplementary material as new airway maps of the world. A fine list of current periodicals keeps the students well informed on present-day issues. Teachers, parents and pupils find splendid results from the manuscript or print writing which we introduced into the three lower grades four years ago. The high cost of textbooks and the probable difficulty of obtaining them reveal the wisdom of having our present good supply of textbooks on hand.

### REPAIRS

Minor repairs have been made on both buildings during the summer vacation. The greatest single item was the work done in a two-coat varnish job for the grade school interior. Most of our money from this account went for insurance this year. It is planned to paint the exterior of the high school building this next summer and to erect a heavy wire fence around the high school yard. Some interior painting will need to be done at this building. Our heating and lighting systems in both buildings continue to give excellent service and good dividends for our children. We were most fortunate to have secured Mr. John Arbuckle and Mr. Carl Knowles for the important positions of school building custodians. They have given real satisfaction in these jobs.

### SCHOOL PROBLEMS

Some problems we have always with us. A major problem is that of transportation. The Office of Defense Transportation has notified us that school officials and parents must cooperate to the fullest extent if we are to continue our transportation of school children. We are advised that school buses ought not to go off a trunk highway unless children live more than two miles from the place where a school bus passes over such a highway. Therefore, children ought to walk to a highway and also the school bus ought to make a few central stops instead of the costly practice of stopping at each home along the route. Our town gives unusually fine transportation service to our school children.

Last year we advised you in our report that school expenses would be considerably higher this year. The salaries of teachers had to be raised; this was only playing fair with the teachers who remained with us, as well as new teachers coming into the system. In spite of these increased costs many of them unforeseen, our financial statement will reveal a substantial balance this year. Again we come before you with the budget recommendations and to your happy surprise there is not a single dollar advance asked for in any account. We believe that with careful planning and wise buying the following amounts will be sufficient:

## TOWN WARRANT

---

### STATE OF MAINE

To FRED C. MERRY, a Constable of the Town of Winterport, in  
the County of Waldo, GREETINGS:

In the name of the State of Maine, you are hereby requested to notify and warn the inhabitants of the said Town of Winterport, qualified by law to vote in town affairs, to assemble in Union Hall in said town on Monday, March 29, 1943, at 9 o'clock A. M., to act on the following articles, to wit:

Art. 1. To choose a Moderator to preside at said meeting.

Art. 2. To choose a Clerk for the ensuing year.

Art. 3. To choose three or more Selectmen.

Art. 4. To fix the compensation of the Town Treasurer for the ensuing year.

Art. 5. To choose a Town Treasurer

Art. 6. To fix the compensation of the Collector of Taxes for the ensuing year.

Art. 7. To choose a Collector of Taxes.

Art. 8. To see what sum of money the town will vote to raise to pay unpaid outstanding bills against the Town or act thereon.

Art. 9. To fix the compensation of Road Commissioner or Commissioners and wages to be paid men, teams and trucks employed on the highway and to choose one or more Road Commissioners.

Art. 10. To choose one or more members of the Superintending School Committee.

Art. 11. To see what sums of money the town will vote to raise for the support of Common Schools, Free High School, High School Conveyance, Music, Free Textbooks and High School Library, School Supplies and Laboratory Equipment, Repairs, Insurance and Miscellaneous.

Art. 12. To see if the town will vote to authorize the Superintending School Committee to appoint a School Physician and to provide proper facilities for the performance of his duties.

Art. 13. To see if the town will vote to name the Winterport Municipal Airport Fernald Field in honor of Roy L. Fernald, who conceived, promoted and obtained said airport as a national defense project for his home town.

Art. 14. To see if the town will vote to authorize the Selectmen to enter into an agreement for the management of lands purchased by the Soil Conservation Service within the town of Winterport, if and providing said Board of Selectmen deem the same advisable.

Art. 15. To see what sum of money the town will vote to raise for the promotion of the agreement in Article 14.

Art. 16. To see if the town will raise and appropriate \$125.00 for public health work in Winterport, said sum to be expended by the Bureau of Health, State Department of Health and Welfare, in cooperation with local authorities.

Art. 17. To fix the rate of discount, if any, for the prompt payment of taxes and the time when said discount shall cease; to fix the time when the taxes due the town shall become collectible and payable; to determine whether interest shall be charged on taxes remaining unpaid after that date and the rate of such interest; to see if the town will vote to instruct its Collector of Taxes for the ensuing year to collect all such taxes within the limit made by the State law for the collection of taxes and instruct the Municipal Officers to require the Collector to give a bond for his faithful compliance with the vote under this article.

Art. 18. To see what sum the town will appropriate for State Aid road construction (in addition to the amount regularly raised for the care of ways, highways and bridges), under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Art. 19. To see what sum of money the town will vote to raise for repairs on the Haley Road.

Art. 20. To see if the town will vote to discontinue the road from the foot of Conant's Hill to top of said hill at the Ebberson place.

Art. 21. To see what sums of money the town will vote to raise for the maintenance of State and State Aid Highways, also for the maintenance of Third Class Highways during the year within the limits of the town, and maintenance of Special Resolve Road.

Art. 22. To see what sums of money the town will vote to raise for the repairs of Highways and Bridges and for clearing snow from the roads the ensuing year, for cutting bushes, for sidewalks, and tarring town streets.

Art. 23. To see if the town will vote to raise the sum of \$500.00 to build the road leading from the four corners near Theodore Clements' place toward town line.

Art. 24. To see if the town will vote to discontinue the Staples Road from the Arthur Lufkin place to the former A. L. Hackett place.

Art. 25. To see if the town will vote to appropriate a sum of money to complete the resurfacing and tarring of the Cole's Corner Road, so-called, from the Thibodeau farm to Carleton's Corner.

Art. 26. To see if the town will vote to raise \$200.00 to cooperate with the Maine Forest Service and the Federal Government in the control of white pine blister rust within the confines of the town.

Art. 27. To see what directions or instructions shall be given the Selectmen about authorizing suit in court for enforcement of liens for unpaid taxes and concerning those cases now pending in court, or act thereon.

Art. 28. To see what action shall be taken about sale or disposal of property deeded to town by Sheriff's Deeds or otherwise, or act thereon.

Art. 29. To see what sums of money the town will vote to raise for Support of Poor, for Salaries of Officers, for Abatement of Taxes, for Hydrant Rental and for other miscellaneous town expenses, for Interest on Town Debt and Discount on Taxes, and for Mother's Aid.

Art. 30. To see what sums of money the town will vote to raise for Memorial Purposes, for Free Library, for Winding Town Clock, for Lighting Streets, for Care of Monument Lot, and also for Care of Town Lots in Oak Hill Cemetery.

Art. 31. To see what sum of money the town will vote to raise for the purchase of new Fire Truck.

Art. 32. To see what sums of money the town will vote to raise for Fire Department Maintenance, Fire Truck Housing and Equipment.

Art. 33. To choose three or more Assessors of Taxes.

Art. 34. To choose three or more Overseers of the Poor.

Art. 35. To choose one or more Constables.

Art. 36. To choose one or more Fire Wardens and fix the compensation.

Art. 37. To choose a Fire Inspector.

Art. 38. To see what action the town will take regarding organizing a Volunteer Fire Department.

Art. 39. To see what action the town will take in conjunction with the Town of Frankfort in regard to building dam on Marsh Stream at West Winterport to help control flood condition.

Art. 40. To choose one or more Fence Viewers.

Art. 41. To choose one or more Measurers of Wood, Bark and Lumber, Shingles, Clapboards, Hoops and Staves.

Art. 42. To choose one or more Sealers of Leather and Sealers of Weights and Measures.

Art. 43. To see if the town, for the purpose of procuring a temporary loan or loans to and for the use of said town in conducting its municipal business in the current municipal year of 1943 and in anticipation of and to be paid out of the taxes of the current municipal year of 1943, will authorize and direct the Town Treasurer, subject to the approval of the Selectmen, to borrow from time to time during said municipal year, a sum or sums not exceeding in the aggregate the sum of seven thousand five hundred dollars, and to make, execute and deliver the negotiable note or notes of the town therefor, payable within said current municipal year and upon such terms as shall be satisfactory to said Town Treasurer and Selectmen, any debt or debts incurred hereunder to be paid out of money raised by taxation during the present municipal year.

Art. 44. To see how much money the town will vote to raise to pay on outstanding bonds and notes.

Art. 45. To see if the town will vote to instruct all town officials to withhold payment of half of any money due any person who is indebted to the town for taxes or any other purpose until that debt due the town is paid or satisfied.

Art. 46. To see if the town will vote to instruct its Selectmen not to accept any bill against the town unless it is approved by the head of the department of town affairs for which the bill is rendered and unless the same is in proper form.

Art. 47. To see if the town will vote to authorize the Selectmen and Treasurer of the town to sell and convey in the name of the Inhabitants of the Town of Winterport, the right, title and interest of the town in and to any or all real estate conveyed to the inhabitants of the town in proceedings for the collection of taxes.

Art. 48. To see if the town will vote to authorize the Selectmen and Treasurer of the town to release and convey in the name of the Inhabitants of the Town of Winterport, to the owner at the time of assessment of the tax, or to his heirs or assigns, the right, title and interest acquired by the town in and to any or all real estate conveyed to the Inhabitants of the Town of Winterport in proceedings for collection of taxes, on payment of the amount of debt, interest and charges due on the respective parcels.

Art. 49. To see if the town will vote to raise the sum of \$400.00 for defense purposes.

Art. 50. To see if the town will vote to procure from the Federal or State government or one of its agencies such fire fighting equipment and apparatus as hose trucks, pumpers, hook and ladder trucks and other fire fighting devices that can be procured therefrom for the proper and necessary protection of the Winterport Airport and appurtenances, a national defense area, as well as for our local municipal needs at no cost to the town.
