





Report of Superintendent of Schools

To the Superintending School Committee:

I herewith submit to you, and through you to the citizens of the town, my first annual report as superintendent of the schools of Isle au Haut.

In beginning this report I wish to state that upon assuming my new duties at the opening of the spring term of 1916, I found the standard of scholarship and general condition of the schools to be excellent. In consequence of this I feel that much appreciation and credit should be given to your former superintendent, Mr. Tyler M. Coombs, whose interest and labors have accomplished much. It has been my purpose and aim to continue the good standing of these schools and to make any improvements that time and opportunity might make possible.

Since my connection with these schools commenced, only one change in the teaching force has been necessary, this being caused by the resignation of Miss Mary French after a year of service in the East Side school. This absence of frequent changes of teachers has been very fortunate for the welfare of the schools. We are also fortunate in having teachers of Normal school training, which in my judgment makes their work much more efficient and profitable.

As we have expended only a part of the fund of \$50, advanced by the state for purchase of equipment I would suggest that a suitable flag pole be erected for the Thoroughfare school and a flag and pole be furnished also for the East Side school. The firs. mentioned school has already been furnished with a new flag. This detail is made necessary by law and is an influence for patriotism which should not be overlooked. Some much needed new books have been purchased, among these a new and uniform set of geographies, the best to be had. Next year a uniform set of new arithmetics should be introduced.

As the plaster walls and ceiling in the new building have become less fresh and bright than they were when first put on I would suggest that something be done to them when it becomes possible. Muresco, or a similar material, in proper tints to be most restful to eyesight, would add much to the beauty of the room and be an advantage in the way of sanitation.

In view of the fact that the work of the year has been remarkably free from friction or complaint the school work has had very little to interfere with steady progress. The average daily attendance has been high at all times except during a period of the winter when sickness cut into the number who could attend.

Before closing this report I wish to thank the town officials, teachers and public who have all done much to make the work of the year pleasant.

Town Warrant

To Albert L. Rich, one of the constables of the town of Isle au Haut, Maine, in the county of Knox, Greeting:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the said town of Isle au Haut, qualified by law to vote in town affairs to assemble at Revere Hall in said town, on Monday, March 5, A. D. 1917, at nine o'clock in the forenoon, to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

Article 2. To choose a Town Clerk for the ensuing year.

Article 3. To choose a Board of Selectmen for the ensuing year.

Article 4. To choose Assessors of Taxes.

Article 5. To choose Overseers of the Poor.

Article 6. To choose a Town Treasurer and vote his compensation.

Article 7. To choose a Collector of Taxes and vote his compensation.

Article 8. To choose a member of the School Board for three years.

Article 9. To choose a Town Auditor.

Article 10. To choose Constables.

Article 11. To see if the town will vote to unite with other towns, in the employment of a Superintendent of Schools, provided a satisfactory union can be made.

Article 12. To choose a Fire Warden and vote his compensation.

Article 13. To choose Surveyors of Wood and Lumber.

Article 14. To see what sum of money the town will raise and appropriate for the support of poor.

Article 15. To see what sum of money the town will raise and appropriate for current expenses.

Article 16. To see what sum of money the town will raise and appropriate for the support of public schools.

Article 17. To see what sum of money the town will raise and appropriate for text books and supplies.

Article 18. To see what sum of money the town will raise and appropriate for repairs on school buildings.

Article 19. To see if the town will vote "Yes" or "No" on the question of appropriating and raising money necessary to entitle the town to state aid, as provided in section 20 of chapter 130, of the Public Laws of 1913.

Article 20. To see if the town will raise and appropriate the sum of \$300 for the improvement of the section of the state aid road as outlined in the report of the state highway commission, in addition to the amounts regularly raised for the care of ways, highways and bridges; the above amount being the maximum which the town is allowed to raise under the provisions of section 19 of chapter 130 of the Public Laws of 1913.

Article 21. To see what sum of money the town will raise and appropriate for snow bills.

Article 22. To see what sum of money the town will raise and appropriate for repairs on roads and bridges.

Article 23. To see what sum of money the town will raise and appropriate for the insurance of school buildings.

Article 24. To see what sum of money the town will raise and appropriate for the maintenance of town hall, or act anything relating thereto.

Article 25. To see if the town will vote to instruct the town treasurer to hire, with the approval of the selectmen, whatever money that may be required to defray town expenses for the ensuing year.

Article 26. To see what sum of money the town will raise and appropriate to pay overdraw on state road.

Article 27. To see whether the town will vote to raise money, and what sum, for the maintenance of state and state aid highways during the ensuing year, within the limits of the town, under the provisions of sections 9 and 18, of chapter 130 of the Public Laws of 1913.

Article 28. To see if the town will vote to decide on a certain date, on which all taxes should be paid, also decide on a rate of interest for all taxes not paid after that date.

Article 29. To see what action the town will take in regard to clearing bushes from Old School lot.

Article 30. To see if the town will vote to buy a safe, for town records, or act anything relating thereto.

Article 31. To act on any other business that may come before said meeting.
