REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Superintending School Committee and Citizens of
Isle au Haut:

I herewith submit my third annual report as superintendent of schools. We have maintained a school year of

thirty-four weeks since last town meeting, an increase of two weeks over last year. The state department of education is advising at least thirty-five weeks. The schools in Stonington are now having thirty-six weeks.

The work of the school is advancing in efficiency under the direction of Miss Dodge. I think that Miss Dodge is an excellent teacher; she seems to take a deep interest in the welfare of the pupils and has given excellent satisfaction so far as I know. I hope that we may be able to secure her for next year.

The toilet arrangement at the West Side will not comply with the requirements of the new law. I believe the town will be better satisfied with chemical toilets than any other and they should be installed in a building attached to the schoolhouse with the vault ten feet away from the schoolroom. The equipment for the building will cost around one hundred fifty dollars.

We get all school moneys from the state now in a lump sum to be used for text books and supplies as well as for the ordinary expenditures so I recommend that the town raise money for the Support of Schools in a lump sum which will include everything except repairs and the superintendent's salary. I recommend that the sum of \$1,100.00 be raised for the Support of Schools for the next fiscal year. The school committee will recommend for repairs.

To Wm. E. Robinson, a constable in the town of Isle au Haut,

Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the said Town of Isle au Haut, qualified by law to vote in town affairs, to assemble at Revere Hall, in said town on March 26th, A. D. 1923 at nine o'clock in the forenoon to act on the following articles to wit:

- Art. 1. To choose a Moderator to preside at said meeting.
2. To choose a Town Clerk for the ensuing year.
3. To choose a Board of Selectmen for the ensuing year.
4. To choose Assessors of Taxes.
5. To choose Overseers of Poor.
6. To choose a Town Treasurer and vote his compensation.
7. To choose a Collector of Taxes and vote his compensation.
8. To choose one or more members of the School Board.
9. To see if the town will vote to elect a Road Commissioner, one or more, fix his term of office, not to exceed three years, have the Selectmen appoint, or they themselves act as Commissioners as is provided by Chapter 92, of the Public Laws of 1919, or act anything relating thereto.

10. To choose two or more Constables.
11. To choose a Fire Warden and vote his compensation.
13. To choose Surveyors of Wood and Lumber.
14. To see what sum of money the town will raise and appropriate for support of Poor.
15. To see what sum of money the town will raise and appropriate for current expenses.
16. To see if the town will vote to act on the written recommendation of the School Board in regard to the location of schools, the coming year, or act anything relating thereto.
17. To see what sum of money the town will raise and appropriate for schools, including high school tuition and text books and supplies.
18. To see what sum of money the town will raise and appropriate for school house repairs.
19. To see what sum of money the town will raise and appropriate for the salary of Superintendent of Schools.
20. To see what sum of money the town will raise and appropriate to pay on tractor debt and interest on same, or act anything relating thereto.
21. To see if the town will vote "Yes" or "No" on the question of appropriating and raising money necessary to entitle the town to State Aid as provided in Section 19 of Chapter 25 of the Revised Statutes 1916.
22. To see if the town will appropriate and raise the sum of \$300.00 for the improvement of the section of State Aid Road as outlined in the report of the State Highway Commission, in addition to the amount regularly raised for

the care of ways, highways and bridges, the above amount being the maximum which the town is allowed to raise under the provisions of Section 18, Chapter 25 of the Revised Statutes of 1916.

23. To see what sum of money the town will raise and appropriate for repairs on State Aid Roads.

24. To see what sum of money the town will raise and appropriate for repairs on roads and bridges.

25. To see what sum of money the town will raise and appropriate for cutting bushes from road limit or act anything relating thereto.

26. To see what sum of money the town will raise and appropriate for roads—snow bills.

27. To see what sum of money the town will raise and appropriate for the maintenance of Town Hall.

28. To see what sum of money the town will raise for Mothers' Aid Fund.

29. To see what action the town will take for the better protection of deer on Isle au Haut, or act anything relating thereto.

30. To see if the town will vote for the Treasurer to hire with the approval of the Selectmen what ever money may be required to defray town expenses for the ensuing year.

31. To see if the town will vote a certain date on which all taxes shall be paid, also to decide on a rate of interest for all taxes unpaid after that date or act anything relating thereto.

32. To act on any other business that may come before said meeting.

The selectmen hereby give notice that they will be in session for revising and correcting the list of voters, at Revere Memorial Hall, at nine o'clock in the forenoon, on the date of said meeting.
