IMPORTANT NOTICE TO TAXPAYERS

+ + +

All taxpayers should read the following requirements and comply with them.

Section 35 Chapter 81, Revised Statutes of Maine, 1944. "Before making any assessments, the assessors shall give reasonable notice in writing to the inhabitants by posting notifications in some public place in the town, or shall notify them, in such other ways as the town directs, to make and bring in to them true and perfect lists of their polls and their estates real and personal, not by law exempt from taxation, of which they were possessed on the 1st day of April of the same year. If any resident owner after such notice, or any non-resident owner after being reasonably requested thereto by the assessors, does not bring in such list, he is thereby barred of his right to make application to the assessors or the county commissioners for any abatement of his taxes, unless he offers such list with his application and satisfies them he was unable to offer it at the time appointed. The request upon non-resident owners may be proved by a notice sent by mail directed to the last known address of the taxpayer or given by any other method that brings notice home to the taxpayers."

Annual Report of Public Health Nursing Services in
Hartland for the year 1966

The primary purpose of public health nursing is to provide nursing service to people at home, at school, at work, in clinics and health centers, so that individuals, families and the community as a whole will be helped to achieve and maintain optimum health. The public health nurse carries out this purpose by giving preventive and restorative nursing services to individuals and families, and by assisting with organized community programs for the prevention of illness and promotion of health.

The State Department of Health and Welfare conducts Orthopedic, Pediatric, Cardiac, Cystic Fibrosis, Hemophilia, Cleft Palate Evaluation, Hard of Hearing and Speech Clinics and the Clinic for Mentally Retarded Preschool Children. Referrals to these clinics have been made at the request of the family physician. Home visits have been made to assist families in carrying out clinic recommendations for treatment.

Four child health conferences have been held offering health examinations and immunizations to infants and preschool children. Immunizations were given against the following diseases: diphtheria, tetanus and whooping cough—21; poliomyelitis—21; and smallpox—10. A community clinic was held offering measles vaccine to preschool and school children. The vaccine was given to 140 children.

Sixty-nine tuberculin skin tests were given to school personnel and pupils in grades 1 and 7. Home visits have been made when necessary to discuss problems with parents.

I wish to thank everyone who has helped to promote better health in your community.

The examination was conducted in accordance with generally accepted auditing standards applicable in the circumstances and included all procedures which were considered necessary. Insofar as could be determined within the scope of the examination, the financial transactions of the Town appear to have been appropriately handled with such exceptions as may be noted in the accompanying comments.

Exhibits and schedules incorporated in this report present the financial position of the Town at January 31, 1967, and the result of its operations for the year then ended.

Recommendations are also offered which are considered to be worthy of your consideration.

An analysis of the deposits with the Treasurer indicates that tax collections were deposited promptly by the Tax Collector with the Treasurer.

During the year, unpaid taxes assessed against real estate which totaled \$1,760.58 were secured by liens. All liens had been recorded and all paid liens had been discharged. Waivers had been obtained when partial payments had been accepted. Unmatured tax liens totaled \$1,124.99 at the year end. Cash collections on tax liens totaled \$1,845.87. One lien in the amount of \$7.28 was written off. Sales of tax acquired property amounted to \$196.41 of which \$47.66 represented profit on sale.

LIABILITIES

Tax anticipation notes totaling \$84,029.79 were paid during the year. This amount included \$58,983.21 of new notes and one note of \$25,046.58 carried from last year.

Outstanding notes totaling \$53,260.27 were retired during the year. One new note in the amount of \$8,683.84 was issued and was outstanding at the year end.

RESERVES AND SURPLUS

The cemetery water fund amounted to \$1,070.28 and was invested in a savings account in the First National Bank, Pittsfield. Interest earned amounted to \$41.42. The savings account was verified by examination of the passbook.

Unexpended balance in the Civil Defense account of \$200.00 was carried to the 1967-68 year. The Pine Grove Cemetery account amounted to \$2,234.02 at the year end.

As a result of the current year's operations, the surplus was increased \$10,660.94 and totaled \$24,035.46 at the year. At the annual town meeting, it was voted to transfer \$4,600.00 from surplus, \$4,400.00 to pay Moore Dam note and \$200.00 for Civil Defense.

TRUST FUNDS

The investments of the trust funds were verified by examination of the bank passbooks and physical inspection of the securities. All investments were found to comply with statutory requirements.

All income received appeared to have been properly recorded and expended in accordance with the terms of the bequests.

New trust funds totaling \$300.00 were accepted at the last town meeting and new funds totaling \$450.00 are being held pending acceptance at the 1967 town meeting.

GENERAL

Excise tax receipts totaling \$11,110.25 were verified by examination of the copies of receipts retained by the Tax Collector. At the annual town meeting it was voted to transfer \$1,000.00 of excise tax receipts, \$500.00 for repair of Moore Dam gates and \$500.00 to Moody Road bridge. The balance of \$10,110.25 was not appropriated and was credited directly to surplus.

To Theodore F. Griffith, a constable in the Town of Hartland, in the County of Somerset.

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Hartland in said County, qualified by law to vote in town affairs, to meet and assemble at the Hartland Town Hall in said town, Saturday, the eighteenth day of March A.D. 1967 at ten o'clock in the forenoon, then and there to act on the following articles:

Art. 1. To choose a moderator to preside at said meeting.

Art. 2. To choose a clerk for the ensuing year.

Art. 3. To see if the town will vote to accept the report of the Municipal Officers and other town officials.

Art. 4. To choose necessary town officers, selectmen, overseers of the poor and assessors.

Art. 5. To elect a resident of Hartland to serve on the Board of Directors of School Administrative District 48 for a three year term.

Art. 6. To see if the town will vote to elect one or more road commissioners for the ensuing year.

Art. 7. To see if the town will vote to instruct its selectmen to appoint a road commissioner for the ensuing year.

Art. 8. To see if the town will vote to pay the state rate for laborers, foremen and trucks on any town work, \$500.00 each for the combined office of selectman, assessor and overseer of the poor, \$100.00 for town clerk, \$100.00 for fire chief and \$100.00 for Registrar of Voters.

Art. 9. To see when the town will vote to have their taxes committed, when they will make them payable, what rate of interest shall be charged, and from what dates or anything relating thereto. June 1, Polls — June 1, Estate — October 1, Interest if unpaid December 1, at 6 per cent.

Art. 10. To see if the town will vote to authorize the tax collector to allow a discount for early payment of taxes, and if so, at what rate.

Art. 11. To see if the town will vote to authorize the selectmen and treasurer to procure loans in anticipation of taxes and to issue notes therefor, or renewals thereof, in accordance with Section 109 of Chapter 91, of the Revised Statutes of 1954 as amended.

Art. 12. To see what sum the town will vote to raise and appropriate for repairs to village streets and bridges.

Budge Committee recommends \$2,500.00.

Art. 13. To see if the town will vote to employ two traffic guides under the jurisdiction of the school directors, one to be stationed in Warren Square and the other at the intersection of Pittsfield Avenue and Main Street, and to raise and appropriate the sum of \$850.00 for compensation of the guides for the ensuing year.

Budget Committee recommends \$850.00.

Art. 14. To see if the town will vote to employ a special officer under the jurisdiction of the selectmen, to perform such work as they may direct and to raise and appropriate the sum of \$700.00 as compensation for said officer.

Budget Committee recommends \$700.00.

Art. 15. To see what sum the town will vote to raise and appropriate to be expended on winter roads, including clearing snow from Pittsfield Ave. sidewalk.

Budget Committee recommends \$10,500.00.

Art. 16. To see what sum the town will vote to raise and appropriate for State Aid Construction, (in addition to the amount regularly raised for the care of ways, highways and bridges,) under the provisions of Section 44 and 49, Chapter 23 of the revised Statutes of 1954 as amended.

Budget Committee recommends \$2,928.00.

Art. 17. To see what sum the town will vote to raise and appropriate for payment of Health and Welfare services for the ensuing year.

Budget Committee recommends \$5,000.00.

Art. 18. To see what sum of money the town will vote to raise and appropriate for Christmas lighting.

Budget Committee recommends \$250.00.

Art. 19. To see what sum the town will vote to raise and appropriate for civil defense for the ensuing year.

Art. 20. To see what sum of money the town will vote to raise and appropriate for salaries of town officers.

Budget Committee recommends \$9,000.00.

Art. 21. To see what sum of money the town will vote to raise and appropriate for insurance, heat and maintenance of town hall.

Budget Committee recommends \$2,000.00.

Art. 22. To see what sum of money the town will vote to raise and appropriate for contingent account, formerly called town charge account.

Budget Committee recommends \$5,500.00.

Art. 23. To see what sum the town will vote to raise and appropriate for Workman's Compensation Insurance for the ensuing year.

Art. 24. To see what sum the town will vote to raise and appropriate for hydrant rental.

Art. 25. To see if the town will vote to raise and appropriate for public nursing in Hartland \$250.00. Said amount to be expended by Maine Department of Health and Welfare, Bureau of Health for local service.

Art. 26. To see what sum the town will vote to raise and appropriate for street lighting for the ensuing year.

Budget Committee recommends \$2,800.00.

Art. 27. To see what sum the town will vote to raise and appropriate for maintenance of Fire Department for the ensuing year.

Budget Committee recommends \$4,000.00 from surplus.

Art. 28. To see what sum the town will vote to raise and appropriate for maintenance and improvement of the town dump.

Budget Committee recommends \$2,500.00.

Art. 29. To see what sum the town will vote to raise and appropriate to be paid to the Hartland Volunteer Fire Dept. for service on Red Network Fire Alarm.

Budget Committee recommends \$100.00.

Art. 30. To see what sum the town will vote to raise and appropriate for repairing roads and bridges in summer and cutting bushes other than village streets.

Budget Committee recommends \$3,500.00.

Art. 31. To see what sum the town will vote to raise and appropriate for care and improvement of cemeteries.

Budget Committee recommends \$1,500.00.

Art. 32. To see what sum the town will vote to raise and appropriate for support of Hartland Free Library.

Budget Committee recommends \$2,000.00.

Art. 33. To see what sum the town will vote to raise and appropriate for the payment on debt and tax notes in addition to any amount on interest collected on taxes and tax liens.

Budget Committee recommends \$1,500.00.

Art. 34. To see if the town will vote to raise and appropriate the sum of \$75.00 to be paid to the State of Maine Publicity Bureau to be expended and used for advertising and natural resources, advantages and attractions of the State of Maine in accordance with provisions of Chapter 80, Section 95 of the Revised Statutes of Maine.

Budget Committee recommends \$75.00.

Art. 35. To see if the town will vote to raise and appropriate the sum of \$15.00 to be paid to Somerset County Soil Conservation District to assist them in their program.

Budget Committee recommends \$15.00.

Art. 36. To see what sum of money the town will vote to raise and appropriate for repair and hot topping of Moore Street.

Budget Committee made no recommendation.

Art. 37. To see if the town will vote to accept the following sums to be invested and the interest therefrom only to be expended on the cemetery lots as follows:

Art. 39. To see if the town will vote to have the names printed in the annual report of persons receiving assistance from town health and welfare funds, provided such persons are not exempt by law.

Art. 40. To see if the town will vote to have a committee of 12 citizens appointed to cooperate with the selectmen in preparing a recommended budget for the next annual meeting.

Art. 41. To see if the town will direct the selectmen to appoint a tax collector and treasurer for the ensuing year and authorize them to fix his salary.

Art. 42. To see if the town will vote to ask the assessors to abate taxes on new homes for one year after beginning construction with a tax value of not less than \$1,000.00; and industries maintaining a payroll of not less than 15 persons.

Art. 43. To see if the town will vote to raise and appropriate the sum of \$1,500.00 to be expended under the direction of the P.T.C.C. Swimming Pool Corp. for a supervised recreation program for children.

Budget Committee recommends \$1,500.00.
