

To the School Board and Citizens of Hebron:

I respectfully submit herewith the annual report of the Superintendent of Schools.

The town of Hebron has maintained four elementary schools during the past year, enrolling a total of sixty-nine pupils as follows:

It was found to be more feasible to convey the Salo children instead of boarding them. Rent was found for the Levine family near enough to a school to eliminate transportation.

The usual standards of attainment have been maintained during the past year. Almost without exception, pupil progress has been commensurate with his ability and energy. Certain projects have been carried out with commendable success. Even the extra curricula activities, so-called, such as holiday programs and community night exercises have correlated closely with the educational program.

Three of the Hebron teachers attended summer school at Farmington during the summer vacation. An occasional summer at Normal School is of great value, not only to the teacher, but to her pupils and school. Good work has been done by all the teachers and the professional attitude is good. Hebron teachers attended most of the teachers' meetings held at Buckfield during the fall.

HEALTH

The pupils have taken much interest in the health charts and also the six and seven point pupil attainments. Parents should encourage pupils in these worthwhile activities. The health program is based on the soundest of medical and scientific evidence and much of the sickness of today could be avoided. Remember that there was a time when vaccination for small pox was considered a "fad." The county nursing service is a valuable contribution to the school program, and it is recommended to the voters of Hebron. This service has passed beyond the experimental stage.

A forward step in pupil welfare was initiated by the State for the first time this fall in supplying milk to certain pupils who might profit by it. This has been done in larger cities and towns for several years with very satisfactory results. It should prove equally beneficial in the smaller towns.

REPAIRS

The Sodom schoolhouse was shingled during the summer vacation. At the Nelson School, new blocking and supports were placed under the floor. Both these jobs were urgent. The appropriation for repairs was insufficient to cover the cost of the work done during the past year; consequently, there is an overdraft in this account.

The following list is suggested for the coming year:

Nelson-1. Needs a new floor

2. Finishing of inside paint job

B. Hill-1. Leak around belfry

2. Door needs repairing

There is some question regarding repairs on the Nelson school. The attendance hardly justifies the continuance of the school. If the Pulkkinen family should move away, only one Hebron pupil would be left in this district. Five of the children come from Oxford. Of course there is a possibility of other children moving into the neighborhood, and the cost of transportation is an indefinite factor. At the present time the cost of maintaining the Nelson school, exclusive of repairs, is as follows:

If conveyance to the Academy school were provided at \$8 per week, the cost would amount to \$256 per year of 32 weeks. \$354-\$256 equals \$98, saving to the town if this worked out practically as it does on paper.

If Oxford paid more tuition, the situation would be modified considerably.

FINANCIAL

The Hebron School Board at its regular session on March 7, 1933, reduced the length of the school year from 36 to 32 weeks, the minimum allowed by statute. This retrenchment was made imperative because of reduced appropriations. The financial saving by this step is as follows:

The total common school expenses for 1932-33 amounted to 4,421.95. The total common school expenses for 1933-34 amount to 3,605.43. 4,421.95-3,605.43=8816.52. This is a reduction of 18.4 per cent in one year, or a reduction of 28 per cent for the two year period ending February 1, 1934. In the two year period ending on the same date, teachers' wages alone have been reduced 24 per cent. Expenditures for high school tuition are based on the following number of tuition pupils:

Warrant for Town Meeting

STATE OF MAINE

COUNTY OF OXFORD, SS.

To A. T. Eastman a constable in the Town of Hebron, in said county.

In the name of the State of Maine, you are hereby requred to notify and warn the inhabitants of said Town of Hebron, qualified by law to vote in town affairs, to assemble at Hebron Grange Hall in said town, on the fifth day of March, 1934, at ten o'clock in the forenoon, to act on the following articles to wit:

Art. 1. To choose a moderator to preside at said meeting.

Art. 2. To choose a clerk for the ensuing year.

Art. 3 To see if the town will accept the report as printed.

Art. 4. To choose a treasurer for the ensuing year.

Art. 5. To choose a chairman to the board of Selectmen.

Art. 6. To choose a second Selectman.

Art. 7. To choose a third Selectman.

Art. 8. To choose one member of Overseers of Poor for three years.

Art. 9. To choose a board of Assessors.

Art. 10. To choose a road commissioner for the ensuing year and fix his compensation.

Art. 11. To choose one member of the school board for three years.

Art. 12. To choose a collector and fix his compensation.

Art. 13. To choose a fire ward and fix his compensation.

Art. 14. To choose all other town officers.

Art. 15. 'To see what sum of money the town will grant and raise for support of poor.

Art. 16. To see what sum of money the town will grant and raise for summer work, roads and bridges, patrol labor, cutting bushes, and widening roads.

Art. 17. To see what sum of money the town will raise for winter work.

Art. 18. To see if the town will grant and raise the sum of \$1,300.00 in payment of note due March 12, 1934, on tractor.

Art. 19. To see what sum of money the town will grant and raise for town officers' bills, including school committee.

Art. 20. To see what sum of money the town will grant and raise for miscellaneous account.

Art. 21. To see what sum of money the town will grant and raise for A. A. Dwinal Post for Memorial Day.

Art. 22. To see what sum of money the town will grant and raise for free high school, according to the school laws of 1903.

Art. 23. To see what sum of money the town will grant and raise for common schools.

Art. 24. To see what sum of money the town will grant and raise for shingling No. 8 and Center school houses.

Art. 25. To see what sum of money the town will grant and raise for office expense account.

Art. 26. To see what sum of money the town will grant and raise for text books.

Art. 27. To see what sum of money the town will grant and raise for repairs.

Art. 28. To see what sum of money the town will grant and raise for superintendence salary for 1934.

Art. 29. To see if the town will vote to authorize the school committee to continue school where an average attendance of eight pupils has not been maintained the past year, if they consider it necessary.

Art. 30. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle he town to State Aid, as provided in Section 19 of Chapter 25, of the Revised Statutes of 1916.

Art. 31. To see what sum the town will appropriate and raise for the improvement of the section of State Aid road as outlined in the report of the State Highway Commission (in addition to the amounts regularly raised for the care of Ways, Highways and bridges) under the provisions of Section 19, Chap. 28, Revised Statutes of 1930, or under the provisions of Sec. 3, Chap. 175, Public Laws of 1933.

Art. 32. To see if the town will vote to grant and raise the sum of \$150.00 to cut bushes and maintain State Aid Road to entitle the town to receive State apportionment.

Art. 33. To see if the town will vote to grant and raise the sum of \$413.00 to maintain third class road to entitle the town to receive third class road money from the State Art. 34. To see if the town will vote to grant and raise the sum of \$100.00 to cut bushes and maintain resolve road to enable the town to receive resolve money from State.

Art. 35. To see if the town will vote to grant and raise the sum of \$3,000.00 to pay unpaid notes.

Art. 36. To see what sum of money the town will vote to grant and raise for payment of interest for the ensuing year.

Art. 37. To hear report of Library Trustees and act on same.

Art. 38. To see what sum of money the town will vote to grant and raise for Moody Library.

Art. 39. To see if the town will vote, that for the purpose of procuring a temporary loan, to, and for the use of the town, to pay indebtedness of the town due and to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and he is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate what is needed, and to execute and deliver the note or notes of the town therefor signed by the town treasurer and countersigned by the municipal officers of the town.

Art. 40. To see if the town will vote to authorize the town treasurer, with the approval of the Selectmen to execute a quit claim deed in behalf of the town, releasing its rights in and to real estate held hy it by tax deeds, upon payment of interests at 8 per cent taxes and costs.

Art. 41. To see if the town will vote to determine the time when the commitment of taxes shall be made, at what time they shall be payable, and what rate of interest shall be collected (from and after such time.)

Art. 42. To see if the sum of \$32.00, or more, will be raised for school nursing in the town of Hebron under the auspices of the Bureau of Health of the State Department of Health and Welfare.

Art. 43. To see what action the town will take in regards to hiring the Grange Hall.

Art. 44. To see if the town will vote to buy the typewriter now rented by the municipal officers.

Art. 45. To see if the town will vote to instruct the Selectmen to petition the county commissioners to discontinue the old road from the Bearce four corners leading north to Paris town line, No. 4 Hill road, so called. Art. 46. To transact any other business that may legally come before the meeting.

Hereof fail not and have you this warrant with your doings thereon. The Selectmen hereby give notice that they will be in session for the purpose of revising and correcting the list of voters at the Grange Hall at nine o'clock in the forenoon on the day of said meeting.
