Had the taxes been paid as promptly last year as heretofore, the interest-bearing debt would have been reduced fully \$3,000.00. However, the town is a gainer, because it borrows money at four per cent., while the individual tax-payer who fails to save the six per cent. discount, actually pays the town six and four-tenths per cent. interest.

Report of Committee on Crushing Plant.

To the Selectmen of York:-

The undersigned, having been appointed by your honorable board, a committee to investigate the matter of stone crushing and of the advisability of the town purchasing a crushing plant, beg leave to make the following report:

We visited several towns that are using a Portable Crusher and all are well satisfied with them. In Amesbury, Mass., we found a crusher that had been in use about twelve years and is doing good work. They all speak very highly of crushed stone as a material to repair roads and streets; and for hilly roads is a material that will not wash but very little. A road properly built or repaired with crushed stone is very durable. We find a large number of crushers of different makes in the market, and all guaranteed to do good work. Your committee were well pleased with the Austin Portable Crusher. It will take in a stone 7x13. The crusher, elevator, revolving screen, 15 H. P. engine, all complete, guaranteed to crush from eight to twelve tons of stone per hour, can be purchased for \$1,250. The above is all mounted on wheels and easily moved to different localities and put up in running order in about five hours. Cost of running after stone is delivered at the mill is about \$1.00 per hour. We also find a crusher of the Aultman pattern highly recommended; can be purchased for \$1,000 on the spot, and if the town wisely concludes to own a plant we would advise looking at this plant, which is owned by N. M. Dummer, Rowley, Mass. Also a plant owned by the U. S. Government which has been in use at Fort Constitution, New Castle, N. H., which is for sale. Your committee are convinced

that if a certain per cent. of the annual appropriation for repairing highways, say 25 per cent., be expended in crushing stone and repairing our main thoroughfares, that in a few years we should see a very great improvement in our roads. We earnestly recommend that an appropriation of \$1,400 be made for the purchasing of a stone crushing plant with bins attached to receive the stone from the screen.

School Report.

To the Citizens of the Town of York:

The following outline of the work of the several schools of York during the school year just closed is submitted:

CENTER SCHOOL.

The spring term of the grammar school was held in the hall of the Town House and was taught by Miss Kate Moulton, as was also the fall term, which was held in the new upper room of the school-house.

Miss Moulton is too well known as a teacher to require an introduction to the public. Suffice it to say that her two terms in this school were both satisfactory and profitable.

Mr. Gilman L. Moulton is now teaching the winter term and with an excellent success. Mr. Moulton, who has been teaching but a comparatively short time, has made rapid advancement, having had experience in most of our best schools and is doing good work in his present position. This school will be fortunate if it shall be able to retain his services in future terms.

INTERMEDIATE SCHOOL.

This school, as its name indicates, embraces those scholars between the primary and grammar grades.

The spring term was taught by Miss Effie Moulton, an experienced and competent teacher, who would have been retained in this school, only that her services were needed in a more difficult one.

Miss Gertrude A. Junkins taught the fall term with excellent success and is still engaged in the winter term. Fine progress has been made during the year in all the branches taught, and in certain of them the progress has been exceedingly good—especially in writing, map drawing and composition. Lessons have been well learned and deportment perfect.

PRIMARY DEPARTMENT.

This school is the largest in numbers of any school in town and requires proportionately more patience in the teacher. Fortunately, the present incumbent, Miss Mary A. McIntire, possesses this quality in a high degree, and as a consequence, the school moves along with a minimum of friction.

While with so many and so young scholars progress is necessarily slow, yet progress has been steady and something has been learned and something accomplished each day.

Miss McIntire has had charge of the school during the entire school year.

RAYNES NECK.

Miss Theodosia L. Barrell taught the spring term of the school at Raynes Neck and Miss Annie E. Trafton the fall and winter terms. Both of these ladies are experienced teachers and if proper progress has not been made, the fault is not theirs. I am glad, however, to be able to report that the school is in a prosperous condition and that considerable advancement has been made.

Much improvement in the appearance of the school-room and in the comfort of teacher and scholars has been made by the extensive repairs upon the building and the introdution of modern furniture.

BEECH RIDGE.

Miss Mattie O. Barrell taught the spring and fall terms of this school and Miss Kate Moulton the winter term.

This simple statement would be a sufficient guarantee that the Beech Ridge School has enjoyed a profitable year, without making any further comment. This is a good school. The pupils are well disposed, well trained and polite. These qualities combined with good recitations render the school a pleasant one to visit.

BRIXHAM.

The spring and fall terms were under the tuition of Miss Elizabeth Rogers, a teacher too well known to need a notice here. Miss Rogers takes a deep interest in her schools and spares no pains to make the exercises interesting as well as profitable. Both of these terms were exceedingly profitable.

Mr. Fred M. Wilson, of Kittery, is teaching the winter term, with a fair prospect of success.

SCOTLAND.

The spring term of the Scotland school was taught by Miss Gertrude A. Junkins, under whose tuition great improvement was made in the studies pursued.

Miss Gertrude Paul taught the fall term and Miss Elizabeth Rogers the winter term.

Notwithstanding the frequent change of teachers, which, ordinarily is not desirable, the school has made great progress. Especially is this true in some individual cases.

CIDER HILL.

Mr. Gilman L. Moulton taught the spring term of the Cider Hill School with such success that the people of the district were desirous that his services should be retained. It was, however, desirable that he should take charge of a more advanced school and Miss Theodosia L. Barrell was employed for the fall and winter terms.

This is a good school and the work accomplished in the year is highly satisfactory.

SCITUATE.

The spring and fall terms of the Scituate School were taught by Miss Abbie T. Thompson, who was quite popular with the school.

Miss Mary Nowell is now teaching the winter term.

- I do not think so much progress has been made in this school as should have been made, nor as much as we had a right to expect. While some of the pupils have attended every session, a great many more have been irregular in attendance especially some of the older scholars.

This is a matter to be deplored and more especially so as this school has usually, until within a year or two, been remarkable for the regularity of attendance and the good deportment of the scholars.

It is to be hoped that another year will bring a reform in this particular.

AGAMENTICUS.

The spring and fall terms of the Agamenticus School were taught by Miss Mary Nowell with good success. Attendance good, deportment fair and recitations creditable.

The school-house and surroundings have been greatly improved and the pupils have furnished the house with window shades and a nice calendar clock, and now have a very pleasant and comfortable room.

The winter term is under the tuition of Mr. George A. Littlefield of Wells, a teacher of much experience.

NORTH VILLAGE.

This school while the smallest in town shows the largest relative average attendance and, as a consequence, good progress is usually reported. The present year is not an exception to this rule, but shows a steady gain.

Miss Mary F. Wilson taught the spring term, Miss Louise P. Grant the fall term and Miss Emma A. Grace is now teaching the winter term.

By the absence of the two most advanced pupils who are attending the high school, this school is reduced to seven pupils.

CLAY HILL.

Mr. William L. Grant taught the spring term, Miss Emma A. Grace the fall term and Mrs. Nellie F. Chapman the winter term, which is still in progress.

Notwithstanding this undesirably frequent change of teachers, the school has made commendable progress.

The attendance, though not all that could be desired, has been fairly good.

PINE HILL.

Spring term taught by Samuel H. Junkins, fall and winter terms by Miss Mary A. Perkins. Miss Perkins is a teacher of some experience and her efforts are attended with a good degree of success.

Singing is a branch of education introduced by her into the school and constitutes a very pleasing, as well as profitable exercise. It would be a good thing if all the teachers were capable of teaching this desirable accomplishment in their schools.

All three terms of this school have been crowned with success.

CAPE NEDDICK.

The spring term of the Cape Neddick School was taught by Miss Grace E. Preble of Eastern Maine, of whom, as the the holder of a state certificate, considerable was expected.

This expectation, however reasonable, was doomed to disappointment, as the school failed to receive the inspiration from the teacher, of interest and enthusiasm needed to its success. Not all the blame for failure, however, lay with the teacher, the scholars are entitled to a good share of it, in that they seemed to cherish an unreasonable and unwarrantable dislike toward her and contributed to her burden by their unbecoming conduct.

Miss Effie Moulton thaught the fall term and is now conducting the winter term with her usual ability.

YORK BEACH.

The grammar school at York Beach was taught in the spring term by Mr. Alfred Bartlett, a graduate of Dartmouth.

In this case, also, great expectations came to naught as the school was a failure and much dissatisfaction was expressed by both scholars and parents. Mr. Gilman L. Moulton in the fall term infused some life into the school and awakened an interest which gave a fresh impetus to the exertions of the pupils, which produced satisfactory results.

The winter term is under the tuition of Mr. A. B. Hoag of New Hampshire, an experienced and capable teacher, and satisfactory results are anticipated.

PRIMARY DEPARTMENT.

The school at York Beach having become too large to be conducted with profit, it was determined to establish a primary department, under a separate management.

This was done. A room was hired and a teacher employed. The school was started with twenty pupils, ranging in ages from four to ten years, with Mrs. E. P. Moore as teacher.

In the fall and winter terms Miss Lettie M. Emery had charge of the school.

The children are young and restless, but the teachers patiently performed their duties and the result has been specially gratifying.

Additional accommodations are greatly needed at the Beach, as these schools must be continued, and it is better and cheaper to have suitable school buildings than to hire unsuitable rooms at exorbitant rents.

For the reason that the winter term of the schools has not yet closed, having been delayed by the great storm, I am unable to give the usual abstract from teachers' registers.

FREE HIGH SCHOOL.

The free high school has been in charge of Mr. C. C. Putney for the entire school year and, considering the rather poor attendance, has been reasonably successful, though less so than could have been desired.

The school has been small in numbers, hence less interest seems to have been manifested than might exist in a larger school. Another disadvantage is the irregularity in attendance of many of the pupils enrolled. Still another disadvantage is the fact that certain pupils attend the school only in the winter term.

The law requires that a course of study shall be maintained in all the free high schools, so that scholars may pursue the same to the end and be graduated.

A course of study has been introduced into this school and has been maintained, though under difficulties on account of circumstances above mentioned.

The law also requires that all candidates for admission to free high schools shall pass a satisfactory examination in order to be admitted. Compliance with this requirement has excluded some from the school who sought admission thereto.

The school still being in progress, I am unable to present the usual abstract from the teacher's register.

WARRANT FOR TOWN MEETING,

MARCH 14, 1898.

STATE OF MAINE.

To Bradford S. Woodward, Constable of the Town of York:

In the name of the STATE OF MAINE you are hereby required to notify and warn the inhabitants of said town of York, qualified by law to vote in town affairs, to assemble, in the Town House in said town, on Monday, the fourteenth day of March, A. D. 1898, at nine o'clock in the forenoon, to act on the following articles, to wit:—

First.—To choose a Moderator to preside in said meeting.

Second.—To choose a Town Clerk, three Selectmen, Assessors of Taxes and Overseers of the Poor, Town Treasurer, Collector of Taxes and Constable, Town Agent, three School Committeemen, one Road Commissioner, one or more Auditors of Accounts, Truant Officer, Constables, and all other officers necessary for the ensuing year.

Third.—To see what sum of money the town will vote for the support of common schools the ensuing year.

Fourth.—To see what sum of money the town will vote for the support of a Free High School the ensuing year.

Fifth.—To see what sum of money the town will vote for the purchase of text books the ensuing year.

Sixth.—To see what sum of money the town will vote for the repairs of school-houses the ensuing year.

Seventh.—To see what sum of money the town will vote to defray the incidental expenses of the town for the ensuing year.

Eighth.—To see what sum of money the town will vote for the repairs of highways and bridges the ensuing year.

Ninth.—To see what sum of money the town will vote for the purpose of removing snow from the highways. Tenth.—To see what sum of money the town will vote to pay the interest on and for the reduction of the debt of the town the ensuing year.

Eleventh.—To see what sum of money the town will vote for the support of the poor the ensuing year.

Twelfth.—To see what sum of money the town will vote to purchase a safe for the town records.

Thirteenth.—To see if the town will appropriate the sum of two thousand dollars to make an addition to the school-house and lot at York Beach, or to purchase a new lot and build a new school-house and dispose of the old school-house and lot. On petition of Frank H. Ellis and eighty-three others.

Fourteenth.—To see if the town will authorize its School Committee to join with another town or towns and procure a Superintendent of Schools as is provided by statute, and, if so, to appropriate a sum of money to pay this town's proportion of the salary of said Superintendent according to law.

Fifteenth.—To see what action the town will take relative to the vote of the town last year appropriating the sum of one thousand dollars annually, for the term of twenty years, to supply the town with a hydrant service.

Sixteenth.—To see if the town will vote a sum of money toward building the highway from a point near the residence of John F. Plaisted to South Berwick line as ordered by the County Commissioners, and take such other action as may be deemed necessary relative to the same. On petition of C. E. Gerrish and twelve others.

Seventeenth.—To see what action, if any, the town will take relative to the bequest of \$100, in trust to the town, by Miss Mary Ann S. Derby, late of Alfred, deceased, for the care and preservation of the burial lots of her family, in the cemetery at the Village. By request of G. W. S. Putnam, executor.

Eighteenth.—To see if the town will vote to raise a sum of money not exceeding two hundred dollars to be expended in repairing the highway leading from Tenney's bridge over Tenney's hill as far as the height of land on the road leading

to Cape Neddick and York Beach. On petition of Edward C. Moody and six others.

Nineteenth.—To see if the town will vote to instruct and authorize the Treasurer to hire money on the credit of the town to meet pressing liabilities.

Twentieth.—To see if the town will vote to allow a discount on taxes paid on or before January 1, 1899.

Twenty-first.—To fix the remuneration of town officers for services for the ensuing year.

Twenty-second.—To see what action the town will take upon the report of the committee appointed by the Selectmen in accordance with the vote of the town at its last annual meeting to investigate and report upon the advisability of the purchase of a stone crusher by the town, and, if necessary, to make such appropriation as may be deemed wise therefor.

Twenty-third.—To see if the town will approve the lease made by the Selectmen with the Portsmouth, Kittery and York Street Railway for the erection and maintenance of a line of poles across the town farm for the feed wire of said railway.

Twenty-fourth.—To pass any other vote or votes that may be necessary and legal for the administration of the affairs of the town the ensuing year.

The Selectmen hereby give notice that they will be in session for the purpose of revising and correcting the list of voters at their office on Friday and Saturday, March 11th and 12th, from 2 to 5 p. m.
