Tuesday, June 14, 2016 & Wednesday, June 15, 2016

Article. 1. To elect a Moderator to preside at said meeting and to vote by written ballot.

Richard Dailey was elected Moderator and sworn to the Statute Oath by Town Clerk Laurie Chadbourne.

Article. 2. To elect the following Town Officers by secret ballot as required by 30-A MRS § 2528:

1 Selectman, Assessor, Overseer of the Poor; 3 year term

Karen M. Hawkins received 198 votes.

Kenneth J. Murphy received 307 votes.

Glenn “Bear” Zaidman received 534 write-in votes and was elected.

George Bradt received 1 vote.

There were 105 blank votes cast.

2 Planning Board Regular Member; 3 year term

Deborah A. Brusini received 492 votes and was elected.

Donald S. Collins received 645 votes and was elected.

Catherine J. Pinkham received 437 votes.

There were 57 miscellaneous write-in votes.

There were 659 blank votes cast.

2 MSAD #61 Director; 3 year term

Debra C. Albert received 737 votes and was elected.

Karen L. Eller received 674 votes and was elected.

There were 18 miscellaneous write-in votes.

There were 861 blank votes cast.

1 Water District Trustee; 3 year term

Wesley F. Gorman received 942 votes and was elected.

There were 13 miscellaneous write-in votes.

There were 190 blank votes cast.

Article 3. To vote by secret ballot on the following “Question 1. Shall an Ordinance entitled “June 14, 2016 Amendments to the Bridgton Sewage Ordinance to Promote Economic Development in the Downtown Area by Revising the Current Method of Sewer Allocation to Free Up Existing Unused Capacity in the Bridgton Sewer System” be enacted?”

Board of Selectmen Recommend a "YES" Vote

Yes received 677 votes and had passage.

No received 446 votes.

There were 22 blank votes cast.

Article 4. To vote by secret ballot on the following “Question 2. Shall an Ordinance entitled “June 14, 2016 Amendments to the Town of Bridgton Shoreland Zoning Ordinance” be enacted?”

Board of Selectmen Recommend a "YES" Vote

Yes received 626 votes and had passage.

No received 436 votes.

There were 83 blank votes cast.

Article 5. To vote by secret ballot on the following “Question 3. Shall an Ordinance entitled “June 14, 2016 Amendments to the Town of Bridgton Site Plan Review Ordinance” be enacted?”

Yes received 623 votes and had passage.

Moderator Dailey recessed the Town Meeting until June 15, 2016 at 7:00 P.M.

Wednesday, June 15, 2016

143 resident voters were in attendance; 9 non-residents were in attendance.

Members of the Board of Selectmen Present: Bernard N. King, Jr., Chairman; Robert J. McHatton, Sr., Vice-Chairman; Kenneth J. Murphy; Paul E. Hoyt; Gregory N. Watkins.

Administration Present: Robert Peabody, Town Manager; Anne Krieg, Economic and Community Development Director; Faye Daley, Health Officer; Jim Kidder, Public Works Director; Richard Stillman, Police Chief; Laurie L. Chadbourne, Town Clerk; Rob Baker, Code Enforcement Officer; Robert Fitzcharles, Transfer Station Manager; Georgiann Fleck, Deputy Town Manager; Glen Garland, Fire Chief; Charisse Keach, Finance Officer; Gary Colello, Recreation Director; Todd Perreault, Emergency Management Director.

Moderator Dailey called the Town Meeting to order at 7:00 P.M. and recited the Pledge of Allegiance. There were no objections to Moderator Dailey conducting the meeting in accordance with the Maine Moderators Manual (sixth edition, 2005). He requested that voters go to the microphone and identify themselves when speaking. All in favor to recognize non-resident department heads Code Enforcement Officer Rob Baker and Finance Officer Charisse Keach. Moderator Dailey thanked Lake Region Television for providing audio equipment and video coverage. Moderator Dailey also thanked the Election Clerks for their assistance on Tuesday, June 14th.

Chairman King thanked all that voted yesterday and the voters in attendance tonight. He thanked and commended all that have volunteered their time serving on various town committees. He also thanked Student Representative Colleen Messina for her time and dedication to the Board. Selectman King then presented a plaque of appreciation to Kenneth J. Murphy for his recent term on the Board. Selectman Murphy then congratulated Bear (Glenn Zaidman) on his election to office and thanked the Board and citizens for their support during his term.

Moderator Dailey read the results of Article 1 through Article 7 from the June 14, 2016 Referendum Election.

Motion was made by Mr. Renneker to bring Articles 38, 39 and 40 forward; 2nd from the floor. Motion was made by Mr. Renneker to amend the motion and bring Articles 39, 40 and 41 forward; 2nd from the floor. All in favor.

Article 39. To see if the Town, pursuant to 23 M.R.S. § 3025, will vote to accept the dedication made by Estate of Edwin Rolfe, Jr., Lopez Properties, LLC, Harlan Johnson, James Neal, PMT Properties, LLC, R. Rolfe Corporation, Michael D. Andrew, Linwood M. Higgins, Linda D. Beagle and Juliana Noel Beagle Corbett, of an easement in a strip of land bounded and described as follows: a fifty foot wide strip of land known as "Home Run Road," and to accept and establish a town way on said strip of lane.

To see if the Town will vote to purchase two parcels and the structures and improvements thereon adjoining Nulty Street and currently owned by Andrew and Lisa Clark for an amount not to exceed \$185,000, and to see if the Town will appropriate \$190,000 from the Unassigned Fund Balance for the purchase price and associated closing costs.

Article 41. Subject to the Town acquiring title to two parcels and the structures and improvements thereon adjoining Nulty Street and currently owned by Andrew and Lisa Clark, to see if the Town will appropriate \$150,000.00 from the Unassigned Fund Balance to re-pave the existing parking area for bus parking and to renovate the existing structure to include a Welcome Center and public bathrooms.

Article 29. To see if the Town will vote to authorize the Board of Selectmen to enter into boundary line agreements with abutting property owners to establish the boundary line of any property of the Town, including the boundary lines of the rights-of-way of roads.

Article 30. To see if the Town will vote to authorize the Board of Selectmen to waive the foreclosure of a tax lien mortgage pursuant to 36 MRS § 944 upon a finding by the Board of Selectmen that ownership of the property subject to the lien would be contrary to the Town's best interest.

Article 31. To see if the Town will vote to authorize the Board of Selectmen, on behalf of the Town, to sell and dispose of any real estate acquired by the Town for non-payment of taxes thereon, on such terms as they deem advisable, and to execute quitclaim deeds for the property. Property to be disposed of by written policy and on terms the Board of Selectmen deem advisable.

Article 31 was passed as written.

Article 32. To see if the Town will vote to authorize the Board of Selectmen, on behalf of the Town, to sell and dispose of any real estate acquired by the Town for non-payment of wastewater assessments thereon, on such terms as they deem advisable, and to execute quitclaim deeds for the property. Property to be disposed of by written policy and on terms the Board of Selectmen deem advisable.

Article 32 was passed as written.

Article 33. To see if the Town will vote to authorize the Board of Selectmen to sell Town owned land that the Board of Selectmen has determined to be surplus and to conduct the sale of such land by sealed bid, public auction or through an agent or multiple listing, whichever the Board of Selectmen deems to be in the best interest of the Town and to deliver a quitclaim deed to the successful purchaser. The net proceeds of any sale shall be deposited into the Town's general fund.

Article 33 was passed as written.

Article 34. To see if the Town will vote to authorize the transfer of all unexpended balances to fund balance, excepting those carried forward funds, and to authorize any overdrafts that may occur in the Town operations in the 2016/2017 fiscal year to be taken from fund balance.

Article 34 was passed as written.

Article 35. To see if the Town will vote to authorize the Board of Selectmen to sell or dispose of equipment that is no longer of any use, or is unusable.

Article 36. To see if the Town will vote to authorize the Board of Selectmen and Treasurer, on behalf of the Town, to accept gifts, real estate, and funds, including trust funds, that may be given or left to the Town.

Article 36 was passed as written.

Article 37. To see if the Town will vote to authorize the Board of Selectmen to apply for and accept grants on behalf of the Town, and to expend the proceeds thereof for the purposes for which they are received, provided that the terms of the grants do not require the Town to expend other funds which have not been appropriated by the Town.

Article 37 was passed as written.

Article 38. To see if the Town will vote to participate in the Cumberland County Housing and Community Development Programs of the Federal Department of Housing and Urban Development, including but not limited to the Community Development Block Grant Program (CDBG) and the HOME Program; to designate its population to be included in the calculation of Cumberland County's funds by the U.S. Department of Housing and Urban Development and to authorize the Board of Selectmen to execute an agreement with Cumberland County to formalize the same.

Article 38 was passed as written.
