**RESULTS OF TOWN MEETING
TOWN OF BROWNFIELD
JULY 1, 2011 – JUNE 30, 2012**

To: Carl Mills, a citizen of the Town of Brownfield, County of Oxford, State of Maine.

Greetings: In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Brownfield, in said County, qualified by law to vote in Town affairs, to meet in the Brownfield Town Office in said Town on Tuesday, the 7th day of June 2011 A.D. from 9:00 A.M. until 8:00 P.M. for the election of Town Officials and the vote on any referendum questions. The polls will open as soon as Article 01 has been acted upon. All other articles, beginning with Article 02, will be voted upon at the Brownfield Community Center in Brownfield, Maine on Wednesday, the 8th day of June 2011 A.D. at 7:00 P.M.

This meeting was called to order by Town Clerk, Wanda Bartlett, at 9:00 A.M. and the following Articles were acted upon.

ARTICLE 01: To elect a Moderator to preside at said meeting who will follow the Rules of Procedure from the Maine Moderators Manual.

The floor was opened for Nominations and Robert Wallstrom was nominated, elected and sworn in as Moderator. The Polls were then opened for voting. There were 99 votes cast in this Election out of a possible 1,133 registered voters. Meeting was then recessed until 7:00 P.M. on Wednesday, June 8th at the Brownfield Community Center.

Moderator Robert Wallstrom reconvened the Town Meeting at 7:00 P.M. on Wednesday, June 8th and read the results from the June 7th elections and a copy is available at the Town Office for review. The following articles were then acted upon.

ARTICLE 02: To see if the Town will vote to dispense with the check list.

Moved and seconded. Article carried as written.

ARTICLE 03: To see if the Town will vote to authorize the Selectmen to appoint all necessary Town officials in accordance with 30-A MRSA 2601.

Moved and seconded. Article carried as written.

{All department payroll requests are proposed with a three percent (3%) cost of living adjustment except for the Selectmens' stipend.}

ARTICLE 04: To see if the Town will vote to raise and appropriate the sum of \$35,387 for the Deputy Clerk/Clerical Assistant position. This amount represents an increase from 30 to 40 hours per week.

As a point of reference, the Total Proposed under the Selectmen's Recommendation should be \$18,300. Moved and seconded. Several attempts to amend this Article failed and a motion was again made and seconded to vote on the Selectmen's Recommendation. A motion was then made and seconded to vote on this Article by written ballot. Article carried by written ballot with 32 voting Yes and 23 voting No. Motion carried with \$18,300 being raised and appropriated.

ARTICLE 33: To see if the Town will vote to increase the General Assistance line item under the **non-fixed** administrative expenses of the Town to \$5,500 from \$3,500. (This Article will be passed over if the Food Pantry gets the \$4,000 they requested in ARTICLE 32.)

Budget Committee Recommendation = did not vote

Selectmen Recommendation = \$5,500 (3-0-0)

Article was passed over.

ARTICLE 34: To see if the Town will vote to authorize the Selectmen to apply up to \$300,000 of other income (surplus) received by the Town during the 2010/2011 fiscal year (principally excise taxes, interest on delinquent taxes, state reimbursement income and Selectmen's overlay) to reduce the overall amounts to be granted and raised for fiscal year 2011/2012, thereby lowering the taxes needed to be raised by the Town.

Moved and seconded. Article carried as written.

ARTICLE 35: To see if the Town will vote to charge seven percent (7%) interest annually on taxes (and amounts owed to the Town) not paid by November 15, 2011 and May 15, 2012.

Moved and seconded. Article carried as written.

ARTICLE 36: To see if the Town will vote to set the interest rate to be paid by the Town on abated taxes at three percent (3%) for the fiscal year.

Moved and seconded. Article carried as written.

ARTICLE 37: To see if the Town will vote to hold its' Annual Town Meeting on Tuesday, June 5, 2012 and Wednesday, June 6, 2012.

Moved and seconded. A motion to amend this Article to change the date of Wednesday, June 6 to Saturday, June 9 failed. Article then carried as written.

ARTICLE 38: To see if the Town will vote to increase the property tax levy limit established for the Town by State law, in the event that the municipal budget approved under the preceding articles results in a tax commitment greater than this property tax levy limit.

Moved and seconded. Article carried as written.

ARTICLE 26: After being tabled until the end of the Meeting, this Article was brought back up for discussion. An amendment was made to raise and appropriate \$83,000 towards paving taking \$5,500 from the Transfer Station Reserve Account to pave at the Transfer Station and taking \$50,000 from URIP and \$27,500 from Excise Tax Revenue to repair Sam Brown Hill Road and to pave half of Shepherds River Road. Article carried as amended with the above recommendation.

A motion was made and seconded to adjourn. Motion carried and meeting adjourned at 10:55 P.M.

As a point of interest, 105 voters were in attendance at the open portion of Town Meeting.
