To: Michelle Day, a citizen of the Town of Brownfield, County of Oxford, State of Maine.

Greetings: In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Brownfield, in said County, qualified by law to vote in Town affairs, to meet in the Brownfield Town Office in said Town on Tuesday, the 9<sup>th</sup> day of June 2015 A.D. from 8:00 A.M. until 8:00 P.M. for the election of Town Officials and the vote on any referendum questions. The polls will open as soon as Article 01 has been acted upon. All others articles, beginning with Article 02, will be voted upon at the Brownfield Community Center on Wednesday, the 10<sup>th</sup> day of June 2015 A.D. at 7:00 P.M.

**ARTICLE** 01 To elect a Moderator to preside at said meeting who will follow the Rules of Procedure from the Maine Moderators Manual.

Meeting was called to order at 8 A.M. Gene Bergoffen was elected as Moderator. Meeting reconvened at 7 P.M. with Moderator Gene Bergoffen welcoming all in attendance.

ARTICLE 29 To see if the Town will vote to authorize the Selectmen to apply up to \$150,000 of other income (general fund) received by the Town during the 2014/2015 fiscal year (principally excise taxes, interest on delinquent taxes, state reimbursement income and Selectmen's overlay) to reduce the overall amounts to be granted and raised for fiscal year 2015/2016 thereby lowering the taxes needed to be raised by the Town.

ARTICLE

30To see if the Town will vote to authorize the Selectmen on behalf of the Town, to sell a certain parcel of land by such method and on such terms and conditions as they deem appropriate, and to execute and deliver a municipal quitclaim deed without covenant upon receipt of full payment for same. Said parcel containing 0.3 acres more or less and located off Route 160 on Burnt Meadow Pond, being the same parcel as was conveyed to the Town by quitclaim deed of Yetta E. Brickman and recorded in the Oxford County Registry of Deeds in Book 305 Page 826, also being the same parcel as Lot U06-050-000 as shown on the Town's tax maps.

Moved and seconded. A motion to amend the article to sell the property to a certain

individual for a certain price failed. A motion to amend the article to remove the Book and Page carried. Article carried as amended.

ARTICLE 31 To see if the Town will vote to charge seven percent (7%) interest annually on taxes (and amounts owed to the Town) not paid by November 15, 2015 and May 15, 2016.

Moved and seconded. Article carried as written.

**ARTICLE** 32 To see if the Town will vote to set the interest rate to be paid by the Town on abated taxes at three percent (3%) for the fiscal year.

Moved and seconded. Article carried as written.

**ARTICLE** 33 To see if the Town will vote to hold its Annual Town Meeting on Tuesday, June 14, 2016 and Wednesday, June 15, 2016.

Moved and seconded. Article carried as written.

ARTICLE 34 To see if the Town will vote to increase the levy limit established for the Town by State law in the event that the municipal budget approved under the preceding articles results in a tax commitment greater than this property tax levy limit.

Moved and seconded. Article carried as written.

**ARTICLE** 35To see if the Town will vote to authorize the Board of Selectmen to accept any grants and/or donations of money or property providing the donations or grants serve the best interest of the Town.

#### Moved and seconded. Article carried as written.

**ARTICLE** 36To see if the Town will vote to authorize the Board of Selectmen to explore the benefits of a Zero Sort Recycling System; and, if found to be beneficial to the Town, be authorized to take whatever action is necessary to implement such system.

#### Moved and seconded. Article carried as written.

ARTICLE 37To see if the Town will vote to authorize the Board of Selectmen on behalf of the Town, to sell and dispose of property acquired by tax process at public sale, except where it is being sold back to the former owner, or party who has succeeded to the title of the former owner, when a private sale may be utilized. "Public Sale" shall not mean "Public Auction", but shall mean a sale pursuant to such published notice in newspaper of general circulation within the Town as the Selectmen deem appropriate with notification of 30 days prior to the sale. The terms and conditions of any such sale shall be as the Selectmen deem advisable. In all cased, conveyance is to be made by municipal quitclaim deed.

#### Moved and seconded. Article carried as written.

**ARTICLE** 38 To see if the Town will vote to authorize the Board of Selectmen to sell or dispose

of any personal property or equipment belonging to the Town providing the property or equipment is no longer needed; and, that the proceeds from the sale of or equipment be deposited into the reserve account of the department that sells the equipment or property, except that any transfers from other reserve accounts be paid first.

Moved and seconded. Article carried as written.

Motion made and seconded to adjourn. Meeting adjourned at 9:50 P.M.
