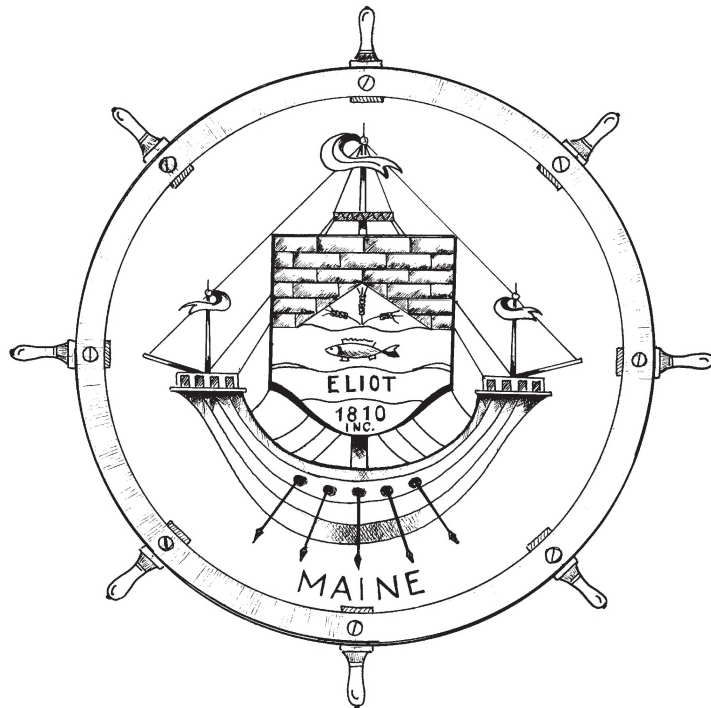



Dear Town of Eliot:

As the new session of Congress began, I was honored to become the longest, currently serving member of the U.S. Senate to have never missed a roll call vote. As the 111th Congress ended, I cast my 4,563rd consecutive vote. It is a privilege to represent you in Washington, D.C. and I appreciate this opportunity to share some of my recent work as we look forward to the opportunities and challenges that lie ahead in the 112th Congress.

Creating jobs and strengthening our economy remain our nation's most pressing challenges. Far too many families and individuals throughout Maine and our nation are still suffering from a sluggish economy and high unemployment. That is why it was so vital for Congress to extend the 2001 and 2003 tax relief laws. I strongly supported a two-year extension because allowing these laws to expire would have resulted in one of the largest tax increases in our nation's history, and job killing tax hikes could well have plunged our economy deeper into recession.

Last year, I spoke to small business owners throughout Maine who told me that a tax increase could result in a loss of jobs and threaten the viability of their businesses. It is good news that Congress passed the two-year extension of these tax relief laws before 2010 came to a close, providing more certainty to businesses and relief for all taxpayers.

After years of repeated but unsuccessful attempts by the Maine delegation to address the federal truck weights law, I authored a successful truck weights pilot program in 2009 that was in effect for one year. The pilot program permitted trucks weighing up to 100,000 pounds to travel on Maine's federal interstates, where these trucks belong, rather than being diverted to secondary roads, through small communities, downtown areas, and school zones. The benefits have been evident: improved safety, lower costs, reduced energy use, and reduced emissions. I was disappointed that the U.S. House of Representatives failed to take action either to extend the pilot program or to make it permanent. Making the truck weights program permanent will be one of my top priorities this year and will be the first bill I introduce in the new Congress.

The President signed into law a number of bills that I authored or coauthored. I was proud to join Senator Joe Lieberman in leading the effort to repeal the so-called "Don't Ask, Don't Tell" law that applied to our armed forces. This long-overdue repeal enables the U.S. to join 35 of our closest allies in welcoming the military service of any qualified individual who is willing and capable of serving our country.

My efforts to counter the smuggling of illegal drugs across the Canadian border into Maine, and vice versa, were advanced when the President signed the "Northern Border Counternarcotics Strategy Act." I was the lead Republican sponsor of this law, which requires the Office of National Drug Control Policy to develop a counternarcotics strategy similar to that of the Southwestern border in collaboration with our Canadian partners. The Senate Homeland Security Committee also conducted an extensive investigation into the Fort Hood terrorist attack. We will soon release a report with recommendations on how to reduce the possibility of such an attack in the future.

Former Senator Evan Bayh and I authored a new law that establishes a new Advisory Council to develop a national plan for combating Alzheimer's disease. For the first time, this law charges federal agencies to develop a strategy to advance efforts to fight this devastating disease, at no additional cost to taxpayers.

As far too many people know, Alzheimer's disease inflicts pain and hardship on families, and costs Medicare and Medicaid billions, yet our nation has been lacking a national strategy to focus on this disease.

Maine's natural resource industries are essential to our prosperity. Last October, along with other Delegation members, I testified at an International Trade Commission hearing that resulted in a ruling that Chinese and Indonesian paper companies had been engaging in illegal trade that is unfair to our domestic industry. During the debate on the Food Safety Modernization Act, I successfully advocated for an amendment, backed by Maine's small and organic farmers, to protect our small farms from excessive regulation.

In my ongoing efforts to save jobs in Maine, I succeeded in convincing the EPA to rework regulations known as "boiler MACT" in a manner that protects the environment and public health without jeopardizing jobs in the forest products industry. I also authored successful legislation to provide small contractors more time to comply with EPA lead-based paint regulations. The high fines for non-compliance would have put many small contractors in Maine out of business.

Working with the University of Maine, I helped advance the development of deep water, off-shore wind energy. Last summer, Energy Secretary Steven Chu visited UMaine at my request, which resulted in an announcement that the Department would dedicate \$20 million to develop and test deepwater offshore wind technologies. UMaine remains on the cutting edge of this work, which has the potential to create 15,000 jobs.

I secured funding for a number of important transportation projects in 2010. For example, following my request, U.S. Transportation Secretary Ray LaHood announced that the Department would award \$10.5 million for Maine's effort to save freight railroad service in Northern Maine, and \$20 million for the rehabilitation of the Memorial Bridge between Kittery and Portsmouth.

As a member of the Senate Armed Services Committee, I worked to ensure that our men and women in uniform have the resources and support they need to protect our freedom. In 2010, I supported efforts to improve health care and other services for our military personnel and veterans, and authored key provisions to strengthen our national defense by supporting the vital work at Bath Iron Works, the Portsmouth Naval Shipyard, Pratt & Whitney, the Maine Military Authority, and other Maine industries. Following my letter last year to the President's top budget official urging him to include increased funding for the DDG-51 program in next year's budget, Defense Secretary Gates recently announced that the Pentagon would seek an additional DDG-51 in its five-year budget.

The 112th Congress will bring extraordinary challenges as we work to improve the economy, lower the unemployment rate, seek ways to reduce federal spending to bring the federal debt under control, and debate a host of other important issues. I am grateful for the opportunity to serve Eliot and Maine in the United States Senate. I'm proud to live in a state where individuals work so hard to sustain their communities.

We hold town meetings where neighbors can find compromise amid their disagreements, while still being able to say hello the next morning at the corner store. We help our neighbors through tough times by sending care packages to overseas troops, donating to local food pantries, and raising money for sick members of the community. And we work with each other to make the most out of bad situations.

Local groups and businesses are working with me to fight for regulations that recognize the successful conservation efforts of our fishermen, don't overburden our small family farms, and protect our paper companies from Chinese trade practices meant to undercut them.

We're educating workers for new jobs, like in Kennebec Valley to train solar technicians, at SMCC for composite materials, and the University of Maine for other green jobs.

And we're taking care of our people by making sure veterans get the benefits they've earned, families aren't bankrupted by illness, and seniors don't lose their hard-earned savings to the excesses of Wall Street.

Any property owner who is planning to hot-top a driveway connected to any highways should contact either the Public Works Director or the State Highway Supervisor according to jurisdiction. It may be necessary to correct a drainage problem or to prevent a condition, which might be objectionable or hazardous to traffic. Anyone planning a street with the intention of requesting the Town to accept it as a public way should first obtain information as to the requirements of the Town as to width of right-of-way, construction and drainage, etc.

NOTICE FOR BOAT MOORINGS

All boat moorings within tidal waters of the Town of Eliot must be approved by and registered with the Harbormaster.

ASSESSOR'S NOTICE

All taxpayers are requested by the Municipal Assessor of Eliot to furnish true and perfect lists of all their properties in Eliot, which they possessed on the first of April 2010. If any resident does not furnish this list, he is hereby barred to his right to make application to the Assessor, or any appeal there from, for any abatement of his taxes. The Assessor will accept such list brought or mailed to the Town Office from April 2 to April 30 during regular office hours.

NOTICE FOR ALARM SYSTEMS

Any resident with either a burglary alarm system or fire alarm system in his/her house or business is requested to contact the Eliot Police Department. The Department has forms to fill out so that the Police will be aware of your system. This information will aid in response to your alarm.

NOTICE

For efficient emergency service, all houses should have properly displayed house numbers.

The Town will provide any reasonable accommodation for any disabled resident to attend any Town function or meeting. Please notify the Administrative Assistant at Town Office of the need. This is in accordance with the ADA Law.

NOTICE FOR OUTDOOR RECREATIONAL FACILITY USE

The Community Service Department is responsible for the management of the Dixon Road Recreation Area, Boat Basin, Frost Tufts Park, and William Murray-Rowe Park. All park related business should be referred to the Community Service Department Director at (207) 451-9334.

The Board of Selectmen, in order to protect and maximize the use of the Town's recreational facilities, has adopted policies and procedures for the operation of these facilities. Copies of these policies and procedures are available at the Community Service Department.

Reservations for the private use of the pavilion at the Boat Basin and Frost Tufts Park are made at the Community Service Department. Fees are collected seven days per week from May 1st to the Sunday of Columbus Weekend. Reservations must be made in advance. Phone reservations are no longer accepted.

Fees are collected at the Boat Basin from Friday of Memorial Day Weekend through Labor Day. Collection of fees will occur on Fridays, Saturdays, Sundays, and any holiday that falls on a Monday. Fees are collected from 5:00am-5:00pm. Season passes can be purchased at the Community Service Department beginning April 1st and at the Boat Basin when fees are collected. (Residents, \$5.00 per launch and \$60.00 Season Pass; Non-residents, \$10.00 per launch and \$120.00 Season Pass). At no time may disabled boats, vehicles, equipment, or any other means block access to the ramp.

Reservations for league or private use of the athletic fields and courts are made at the Community Service Department. Reservations are taken for the current calendar year only. The public will still have free access to the fields and courts if they have not been reserved. Please note that the Department will not rent out the tennis courts or basketball courts to the extent that the public does not have free daily access.

THE ELIOT RECYCLING PROGRAM



The object of recycling is to place materials that used to be thrown away back into the productive economy where they can be made into useful products. TRANSFER STATION TEMPORARY PERMITS

Temporary permits to Eliot residents using a vehicle registered out-of-town may be issued by the Town Clerk, or agent, for a period not to exceed thirty (30) days. Registration numbers for the vehicle and the Eliot address will be required. Permits will be turned into the Attendant at the Transfer Station at any time.

An Eliot resident may obtain one-day permits through the Town Clerk's Office for a contractor or temporary help in his employ to haul appropriate waste from his property. Under normal circumstances, three (3) days advance notice and registration numbers for the vehicle to be used will be required. Permits will be turned in to the Transfer Station Attendant.

RULES FOR THE ELIOT TRANSFER STATION

1. The long-term permit shall be restricted to authorized persons (property owners, residents, seasonal residents, nonresident military personnel with proof of residency in Eliot and active duty status, Eliot businesses and their agents, and other persons authorized to dispose of solid waste in Eliot.
2. The Town Clerk shall keep a record of each permit issued with the name and address, vehicle registration number and any other information deemed appropriate.
3. When applying for a permit, please show the registration for the vehicle on which you wish to display the permit.
4. If your vehicle is not registered in Eliot, the name on the registration must be the same as the name on your Eliot address.
5. No vehicle registered to an out-of-town (or out-of state) business will be issued a dump sticker.
6. Defective permits must be returned into Town Hall for a replacement.
7. Vehicles leased to an Eliot resident or Eliot business may obtain a permit if they supply the lease agreement, registration and Eliot address.
8. The Eliot Municipal vehicles shall be **exempt** from permits.
9. Any vehicle not properly displaying a current permit shall not be allowed to dump any material at the facility. Permits must be displayed by hanging from the vehicles rear view mirror.

Non-compliance with the above rules is subject to Article 106.1 of the Waste Recycling and Disposal Ordinance.

REPORT OF SAD #35

To the Citizens of Eliot;

It is both a privilege and an honor to serve on the Board of Directors for MSAD 35. Our students are an integral part of the life and future of this town, and our schools are a significant asset. Therefore, it is with great pride that I report to you on the business and accomplishments of our schools this year.

This district is one of our largest local employers. We have a total of 370 employees who work diligently to educate our 2,444 students. We own 6 buildings with an insured value of \$80 million, and 123 acres of land with an assessed value of \$3.7 million. We also own 28 busses and 5 vans. We manage and operate a \$26.5 million budget. MSAD 35 is a large and impressive operation.

All of this supports an active and successful student body. As in past years, our students performed very well on state and national assessments this year. They scored above the average in Maine and NH, and either matched or exceeded the schools in York County. The theater department presented another remarkable district musical in the fall, "The Ragged Child," which included students from grades 3–12. Our math team captured division first place. Our Student Government kids won the "We The People" competition in Maine, and will travel to Washington, DC to compete nationally. Our skiers are SMAA champions, our wrestling team won the MPA Sportsmanship award, and our cheerleaders won their regional championship. In addition, 51% of our winter athletes were on the honor roll.

It is the excellent work of our teachers and our administrators, along with the value we - as a community - place on a complete education, which accounts for this success. We provided consistent and rigorous professional development for our teachers this year, with the goal of always moving ahead, strengthening our curriculum, and increasing student achievement. We do this, despite the fact that as a district, we are in the bottom quartile of the state with regard to per-pupil spending, and also spend 16% less on administration than the state average.

Our support comes from other sources as well. Of particular note is The Marshwood Education Foundation (MEF), a local, non-profit organization founded by community members with the goal of supporting creative and innovative education in MSAD 35. The MEF grants this year included: a hoop house project at Central School (part of a new outdoor classroom currently under construction), an outdoor fine arts project also at CES, a literary initiative at MMS, and a team-building opportunity at MMS. These grants, funded entirely from private sources, complement the work already being done in MSAD 35.

We are also fortunate to have active and generous PTOs in our schools, and many classroom volunteers. In addition, our athletic booster clubs raised \$125,000 this year to support critical components of our sports programs.

We will keep all of this in mind as we prepare next year's budget. In this coming year, FY2011, we will receive a reduction of \$80,000 in revenue, and our fixed costs will go up \$700,000. Since we are a "people business," the lion's share of our expenditures (75%) is found in contracted salaries and benefits. Another important cost is fuel: we budget for 115,000 gallons of heating oil, 55,000 gallons of diesel, and 7,000 gallons of gasoline, which total roughly \$558,000. As you well know, these costs are going up, too.

Currently, our budget is not yet finalized. As is the case every year, we will strive to balance the needs of our students with those of our taxpayers. Our student population is declining, so we must evaluate our programs for efficiency. We must keep classes at optimum levels, long a hallmark of this district. We must care for our buildings and grounds, which are an investment for all of us. And we must offer competitive salaries to attract and retain skilled staff. Our job is to put all of this together in a way that keeps our schools strong and our taxes reasonable.

Also at this writing, the Board is fully engaged in choosing a new superintendent for the district. Of all our jobs, this is perhaps the most important, as the superintendent is the educational leader for our schools, and is the only person we hire directly. We take this task very seriously, and will give it a great deal of attention and our best thought. We hope to have a new superintendent in place by the start of our next fiscal year, July 1, 2011.

Every school year is a pleasure and a challenge, and 2010/2011 is no exception. We welcome your questions and your thoughts, and encourage you to attend our meetings or to contact us personally.

WILLIAM FOGG LIBRARY

The William Fogg Library Thrives during Tough Economic Times!

The William Fogg Public Library is thriving despite the fact that these can be difficult times for libraries. We know that, in this day of e-readers and multiple information choices, we must work doubly hard to earn your support. We see ourselves as, of course, a place to borrow books, videos, and audio books for readers of all ages. But we are also Eliot's source for free audio and e-book downloads through our subscription to the Maine Infonet download program. We have access to 63 databases, covering all your reference needs, also through Maine Infonet. And for those who are intimidated by our highly technological world, we are just the place to learn what it's all about.

During the winter and spring of 2010, we gave the U.S. Census Bureau a place to test, interview, and hire town residents for part-time jobs. Every February, March, and April we make room for the AARP to offer free tax preparation, and last year nearly 100 of you took advantage of this service. We allow Eliot residents to hold classes, both in the library and the Worster Room at the Fogg Homestead, on anything from crochet to French to financial planning. Various support groups and community organizations use our space for monthly meetings.

In the Kent Children's Room, we introduced Eliot's youngest readers to the world of books through our Lapsit Story Time for infants and fostered important early literacy skills in the Toddler and Preschool Programs. Many more participated in the Story Book Art Program, the Make-it, Take-it, Craft Table, and Crochet Club. We hosted visits from Eliot Elementary School students, the Girl Scouts and Boy Scouts, took the second graders on a tour of the Fogg Homestead as part of their Eliot history unit, and traveled to local preschools and daycare centers to bring the library experience to children in the community. We participated in the Bicentennial Parade and offered historic crafts for families

Last summer over 175 children, from preschoolers to teenagers, participated in the annual summer reading program. Last year's theme was "Make a Splash @ Your Library," and we had a full calendar of events. It was a wet and wild summer as we learned to play Frisbee from a world champion, explored the inside of a giant whale, learned all about dragonflies and even helped to collect over 100 lbs of trash at the Eliot Boat Basin. This summer we are looking forward to expanding our horizons with the "One world, Many Stories" theme. Come on in and see us!

REPORT OF THE ELIOT POLICE DEPARTMENT

Dear Citizens of Eliot:

Our mission and our core values are tied directly to the services we provide the Town of Eliot. In 2004 when I was selected as your Police Chief there were no core values and there was not a mission or a direction for this department to move in. The creation of our mission has provided guidance and our Core Values have defined the standards by which we provide those services.

2010 has been a successful year in many ways and has built on our mission. We are at full strength for the first time in years with the graduation of Officer Ryan Sanford from the Maine Criminal Justice Academy. Officers have been able to receive and be recognized for achieving higher levels of training. And we have made our community a safer place.

We continue to hold the line on crime and our clearance rate of serious crimes was 59.1% for 2010. We reduced Crimes Against the Person by 30% and Property Crimes by 48%. Arrests increased by 15%. Calls for Service increased by 12%. Traffic related issues were also impacted. Once again we reduced crashes by 13%. \$35000.00 in fines went to the State of Maine.

At the Town Meeting in 2010 I told you I would not take a nearly \$5000.00 pay raise and I did not. Along with a savings by the reclassification of the secretary and changing our phone carrier, we realized a savings of close to \$14,000.00

We were able to upgrade our service weapons this year as the weapons our officers were carrying were more than 10 years old and in need of replacement. This was at a cost of about \$10,000.00. With the trade of our weapons, weapons that have been seized and ammunition we were able to get the required holsters, magazine pouches, ammunition and the weapons themselves at no cost to the taxpayers. We actually ended with a \$200.00 credit.

One of our goals has been to create a volunteer service for our department. As people have graduated from our Senior Police Academy we have gained a number of volunteers to assist in several programs like directing traffic for events and emergencies, calling the elderly and greeting the Troops at Pease Trade port. The Eliot Police Auxiliary members have donated 595 hours of service to our community. The International Association of Chiefs of Police estimates volunteers, like our auxiliary officers, are worth \$19.51 per hour. This means they have donated time worth about \$11,600.00 to our community.

I believe your police department is providing a good return of the investment you make both in tax dollars and support for the department. We are looking forward to 2011 and we hope to continue to improve and move towards becoming leaders in the police community by setting the standards for Appearance,

Attitude, Aptitude and Accountability. I encourage you to get to know us by visiting our department, our website or talking with our officers. We are a part of this community and we want to work together with all of you to make this the best town in Maine to live, work and raise a family.

REPORT OF THE ELIOT PUBLIC WORKS DEPARTMENT

I would like to start by thanking the Board of Selectmen and the residents of Eliot for their support as I settle into my position with the Town of Eliot. In August, I was hired as the Town's Public Works Director to manage the Highway, Transfer Station, and Sewer Departments.

HIGHWAY DEPARTMENT

The Town endured another winter with above average snowfall making it the seventh highest snow fall year on record with the storms coming on a back to back basis over an eight to ten week period of time. The Town of Eliot has a distinct reputation of having the best maintained roadways in the area during the winter months for which you should be proud. I tried to uphold that reputation while trying to minimize expenditure for maintenance. As we enter into the spring/ summer months. I have put together an ambitious work schedule for maintenance activities in the Highway Department with drainage upgrades/ improvements, tree maintenance, roadway repairs, guardrail repairs, catch basin cleaning, paving, etc. I will be looking to repair roadway sections that are in severe and dangerous shape for you as residents. This work will be performed with the intent that when the repairs are complete and when roadways are overlaid with asphalt the pavement life expectancy is prolonged (i.e. more bang for your "buck"). I will be looking to develop a pavement management plan that identifies the condition of each roadway, when it was last paved, traffic volume, and the extent of the repairs needed to facilitate a stable roadway so a funding mechanism can be established for yearly paving projects.

TRANSFER STATION DEPARTMENT

I have started to evaluate the operation of the Transfer Station. I will be looking to increase efficiency and cut costs with the intent to being as level funded as possible to save you as tax payer's money. I have been fortunate enough to purchase a truck to be utilized as a roll-off truck so the Town can haul its own waste materials to the appropriate waste disposal facilities. The cost savings to the Town of Eliot in regards to hauling costs is approximately \$75,000.00 on an annual basis. I have also evaluated the waste disposal facilities costs and am looking to reduce costs there in the approximate sum of \$35,000.00. Other cost savings mechanisms have been implemented to increase efficiency and decrease costs, such as, upgrades to a trash compacting unit, and stepping up our compliance on recycling to decrease the amount of Municipal Solid Waste (MSW/ Trash) disposal and increase recycling for which the Town obtains a form of revenue. I understand change is difficult and upsetting at times, but the intent is to decrease budgets and increase efficiency while saving the tax payers of Eliot money. I would like to thank you for your understanding.

SEWER DEPARTMENT

As the development of the T.I.F (Tax Increment Financing) Program looks for approval from the residents of Eliot, I along with other members of Town staff and the Board of Selectmen look to do our do diligent to provide you with the best possible plan for the sewer upgrades for the Town so you as residents can be well informed and make the best decision on factual information. The department is looking to perform additional I/I work to look for in flows which directly reflect on the cost of the Towns sewer budget. Upon completion of the I/I work the department will look to resolve and repair any and all deficiencies within the existing sewer system. Any significant repairs requiring additional funding can then be budgeted for within the upcoming years.

Several hundred fire permits were issued last year for open burning. Residential burning permits are available Monday–Friday for burning from 5pm until midnight weather permitting from the Town Clerks office. They may be obtained during normal business hours. This past year over 250 permits were issued through that office relieving you of some of the problems contacting a warden. Open burning permits may be obtained from Kittery Dispatch Center, 200 Rogers Road, every day weather permitting. The hours of the permit are the same as if issued in Eliot.

We continue to follow the State Forestry guidelines for open burning and the limitations of the materials that can be burned. Visit their web site for more information.

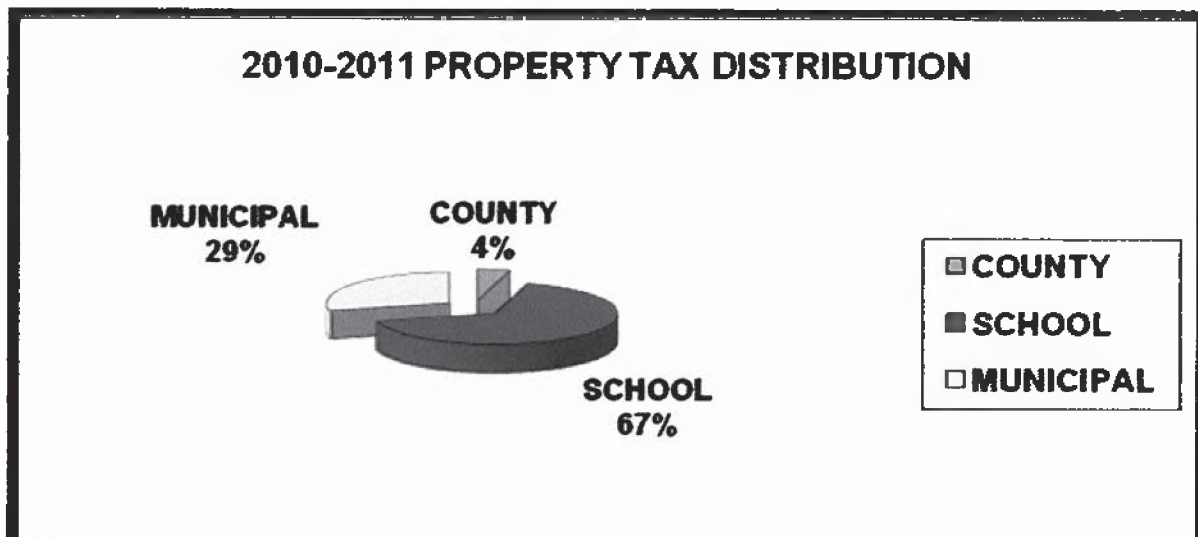
REPORT OF THE ASSESSOR

If you are the owner of record on April 1, you will receive the current year's tax bill. Please forward to the new owner if you sell your property after April 1. Prorating of taxes between the buyer and seller does not involve the municipality. Often times' monies are collected for taxes at the closing but are not paid to the municipality.

The annual cutoff date for making an application for a Veteran's Exemptions is April 1. If you are a veteran who will be 62 years of age before April 1, or an unremarried widow of a veteran, who would have been 62 years of age before April 1, you may be entitled to a Veteran's Exemption. If you are a disabled veteran, regardless of age, you may also be eligible for an exemption. Please contact the Town Hall for a Veteran's Exemption Application and a complete list of qualifications.

The Homestead Exemption annual cutoff date is April 1. You must be a resident of the State and have owned a homestead in the State for one year on April 1. Please remember that taxpayers need only apply once. Applications are available at the town office and online at:

REPORT OF THE ELIOT PLANNING BOARD FOR 2010

The Eliot Planning Board (Board) is an appointed board consisting of five regular voting members and two alternates. The Board reviews land use applications for compliance with the Eliot Code of Ordinances. The Board also reviews the Ordinances and revises them, as required, to comply with State mandates and the wishes of the community.

The Board holds regularly scheduled meetings on the first and third Tuesday of every month. The first monthly meeting is normally reserved for Planning Board administrative business such as ordinance review and update. The second monthly meeting is normally reserved for review of land use applications. The Board occasionally schedules additional meetings as required to accomplish our workload. A total of 23 meetings were conducted in 2010 in addition to site walks conducted as a part of application review.

A total of 21 applications were submitted for review and approval by the Board. The complex nature of many of these applications required the applicant to appear before the Board multiple times to earn Board approval.

In 2009 the Planning Board completed the first phase of revising the subdivision and site review ordinances by consolidating the two chapters for a more streamlined review process. In 2010, the Board continued to work with the Southern Maine Regional Planning Commission to further revise the subdivision/site review ordinance and implement the policies and strategies outlined in the 2009 Comprehensive Plan including a new ordinance requiring the use of open space development standards for subdivisions with five lots or more in the Critical Rural Overlay district. The Board hopes to present this amendment at the next annual town meeting.

Current voting members of the Board include Chairman Stephen Beckert, Vice Chairman Jeff Duncan, Dwight Snow, Chris Place, and Dennis Lentz. Alternates include Larry Bouchard and Greg Whalen. Kate Pelletier is the Planning Assistant and acts as our recording secretary.

The Board continues to hold a 10-minute public input session during the first meeting of each month. The public input session is intended to solicit feedback from the public on topics not associated with applications under Board review. The Board encourages participation and would like to see more input during these scheduled times.

The number of growth permits allowed under Section 29-5 for 2011 is 30. An additional 3 growth permits shall be allocated for affordable housing.

REPORT OF THE ELIOT CONSERVATION COMMISSION

The following paragraphs give a brief summary of a few items that the Eliot Conservation Commission has been working on this past year. We meet the first Wednesday of the month at 7:00pm at the Town Hall and we welcome the public's attendance.

Our most recent project underway is the enhancement of the Johnson Lane Town Forest. Currently the forest consist of seven town own lots, not all of which are adjoining. Our goal is to make the forest one contiguous parcel. To this end the town has contracted with a local surveyor to accurately establish the lot boundaries of the town owned lots as well as the adjacent lots. From there we will pursue the acquisition of additional lots to meet our contiguous goal.

We are continuing our involvement with the efforts by Friends of The York River to have the York River classified as "Wild and Scenic" by the National Park Service. The York River originates here in Eliot and with this classification control will still remain local but municipalities and local conservation groups can receive funds to be used towards its preservation.

The Commission continues to support Great Works Regional Land Trust, which serves Eliot, Wells and the Berwick's. The ECC has recently supported GWRLT with their efforts to remove the Shoreys Brook dam and to increase the brook's water quality. This project will go a long way towards alleviating the excessive silt and sediment buildup that has plagued the brook for years.

The ECC is also working with Southern Maine Regional Planning Commission to determine the feasibility of establishing "Green Belts" of interconnected sidewalks, road shoulders, and trail networks to improve non-motorized access to various destinations and focus areas throughout all sections of town. The Commission would like to get the input of Eliot's residents on this project. We are encouraging all residents to fill out the 'Bicycle and Pedestrian Survey' either at the Town Hall or by visiting the town's web site's home page and clicking on the link.

We are continuing with the implementation of open space planning for Eliot as specify in the Comp Plan. Our goal is to preserve environmentally significant land as well as lands with recreational opportunities for Eliot citizens. We are looking for residents that are willing to assist us with this endeavor.

We encourage and welcome Eliot resident's involvement with the various ECC's projects. You do not need to be a member of the Commission to be involved. We have several resident non-members that attend our meetings and provide us with valuable input and support.

Thank you for allowing us to serve the town of Eliot.

REPORT OF THE HARBOR MASTER

To the citizens of the Town of Eliot:

A schedule of the hours and specific days for mooring renewals has been mailed and posted at the Town Office. ***All moorings must be renewed, in place and the mooring number properly displayed on the mooring buoy by June 1st of each year.***

Assigned mooring numbers must be clearly visible on mooring balls, 3 inches or larger. Mooring numbers are listed on the top right corner of mooring permits. This avoids confusion as to who the owner of a mooring is and eliminates the possibility of being mistaken as an abandon mooring, which constitutes removal.

At the time of your mooring installation or service a GPS location should be taken by your contractor or yourself if possible and provide to the Harbor Master at the time of mooring renewal. This information will aid the Harbor Master and your contractor to locate your mooring should it be lost or need servicing.

To remain on the mooring waiting list, an updated renewal application must be mailed annually to the Harbor Master **by June 1st** to avoid being removed from the list. Anyone wishing to be placed on the mooring waiting list for the first time may obtain an application at the Town Office and return it to the Harbor Master by mail. If your mailing address or phone number changes, contact the Harbor Master so your file can be updated. Keeping your information up-to-date will help the Harbor Master contact you should a mooring become available.

Exemption card are available for those of you who use a skiff at the Boat Basin to access your mooring. The mooring holder is required to present his/her exemption card and proper identification to the attendant each time you use boat ramp to launch your skiff. No exceptions will be made. The mooring holder's name, a description of the skiff and the Harbor Master's signature are identified on the exemption card.

If you are not intending to use your mooring this season and would like to place it on the temporary mooring list please contact the Harbor Master. At that time your mooring will be assigned to someone who needs a mooring and they will be responsible to service your mooring and pay the seasonal renewal fee. If you have question on how the program works please contact me.

ELIOT ENERGY COMMISSION REPORT

Year-End Status Report, 2010

The Mission of the Eliot Energy Commission is to promote increased energy conservation, efficiency and local energy production throughout the town of Eliot.

Our meetings are held at Town Hall on the second Wednesday of the month at 6:30 pm.

All members of the public are welcome to join our meetings and help with our work.

We welcome additional energy (the human kind) to help with current projects and start new ones. If you are interested in energy issues, please read below to get a sense of what we are addressing within Eliot. Please join us at a meeting to learn more. You do not need to be a committee member to help on a project or share your input.

In 2010, the Eliot Energy Commission:

- Gained 1 new highly-qualified member, and created an active sub-committee for carbon reduction efforts
- Attended meetings of other Eliot town committees and those of neighboring towns Energy committees to develop collaborative relationships and mutual assistance
- Received \$8,000 of a \$10,000 American Reinvestment and Recovery Act fund grant to conduct energy audits and support services to municipal buildings in Eliot
- Worked directly with the KEYS Region Energy Coalition to determine administration and appropriation of \$500,000 additional ARRA funds granted to the Coalition for a community-wide weatherization revolving loan fund
- Advised the Board of Selectmen on the Mayor's Agreement for Climate Change, setting goals for greenhouse gas emissions reductions and informing the BOS on energy issues
- Participated in Maine Cool Communities activities and published in their newsletter
- Completed a scientific and comprehensive inventory process to determine municipal energy use and greenhouse gas emissions for FY 2008, resulting in the baseline Greenhouse Gas Emissions (GHG) Inventory for Eliot. The inventory will assist Eliot in understanding where the greatest opportunities for energy efficiency measures lie, and provide

a roadmap to the "low hanging fruit" for immediate attention. (NOTE: the GHG Inventory is available on the Eliot website)

- Wrote and submitted to the Board of Selectmen a professional-grade Report, "Eliot Greenhouse Gas Emissions Inventory", complete with energy expenses and CO2 emission measures by municipal building.
- Presented the results of the GHG Inventory and Report to the Board of Selectmen and the public in a slide Presentation with charts and graphs indicating the most significant emissions sources and most effective cost-saving opportunities, as well as future projections of costs with and without remediation (NOTE: the GHG Presentation is available on the Eliot website)
- Developed an outline and began research for the Eliot Climate Action Plan to complement the Comprehensive Plan in determining where and how Eliot can save energy and costs into the future, using the data from the GHG Inventory to guide recommendations and future energy planning
- Began collecting data for the second annual GHG Inventory (FY2009 data) to measure energy use and carbon output changes that result from enacted energy efficiency measures, and to measure increases or decreases in energy use over time
- Developed an internship for a Marshwood High student to learn about greenhouse as emissions and energy management; interviewed and hired an intern. Monique Lallis is now working with the EEC to complete the second annual GHG Inventory.
- Wrote an RFQ to solicit building performance analysis at the Police Station, contracted for the analysis, oversaw the work and analyzed the ensuing report in collaboration with the Police Chief. (Note: the analysis is paid for from the grant funding listed above)
- Worked on an amendment to Eliot's wind power ordinance to allow temporary and experimental small-scale wind turbines; taught adult education classes on turbines
- Participated in Eliot Festival Days, sharing energy information with the public
- Launched the Eliot Carbon Challenge at Festival Days, being an online carbon calculator for citizens to calculate, improve and track their carbon footprint (greenhouse gas emissions from daily life) at www.myenergyplan.net , sponsored by Clean Air-Cool Planet and the Maine Dept. of Environmental Protection
- With Maine DEP sponsorship, hired a graduate-level intern to bring the Eliot Carbon Challenge to Marshwood students and their families

- Gave several well-attended free public talks on energy issues at the William Fogg Library and wrote and published a number of educational articles in local newspapers and newsletters

The Committee worked with the Eliot Planning Board to bring a Height Ordinance change to the Commercial Zone to the voters for approval. Due to some confusion, the proposed Ordinance was defeated by a narrow margin. A revised Ordinance will be on the ballot this June, and we will urge Eliot citizens to support the revised version, which has clear language regarding the application of the Ordinance to ONLY the Commercial District.

The Committee continued sending letters welcoming businesses that choose to locate or expand their operations in Eliot. The letter welcomes the businesses and provides a link to the Committee. We offer our support should there be any issues that the business needs to have addressed.

Chuck Bradbury joined the Committee this year. Mr. Bradbury's Company, Bradbury Promotions, produce the "Eliot Guide Book", which contains lots of information about Eliot as well as a listing of Eliot businesses. The Guide Book was distributed for free throughout Town. Kristin McMullen Orr was elected Committee Chair this year. Craig Goss left the Committee due to work commitments. REPORT OF THE SEWER COMMITTEE

The Sewer Committee holds regular meetings twice a month at 4:15 PM, on the first and third Wednesdays, and Special Meetings are called when needed. The public is invited to attend.

The Committee continues to review the past/present/future sewer problems of Eliot, including:

- ✓ The inflow and infiltration (I&I) problem has continued to be addressed by voluntary inspections by the CEO. Plans are under way to have a professional company perform the final rigorous testing for illicit connections. Detecting and eliminating these will lower our quarterly treatment costs paid to Kittery, and will allow Eliot's present system to meet our needs longer before having to increase the gallon allotment from the treatment plant.
- ✓ The regular maintenance of the Sewer System continues to be performed by contracted professionals, with the assistance and oversight of our Department of Public Works as needed.
- ✓ The mapping details of the sewer system continue to be integrated with the Town G.I.S., to include the several private systems, to aid system maintenance.
- ✓ The "odor issue" seems to be greatly reduced when periodic cleaning of the private system is performed.
- ✓ The committee continues to assist and contribute to the development and finalizing of the TIF District program.

REPORT FROM THE HEALTH OFFICER

This past year there were very few complaints regarding potential health risks to Eliot residents brought to the health officer.

On October 12, 2010, with the help of the Home Health Visiting Nurses of Southern Maine, 96 local citizens including the town employees and some non-residents, were vaccinated for the seasonal flu and H1N1. Thirty-two of those were paid for by the town of Eliot. The numbers were smaller than in previous years due to the availability of vaccinations through local drug stores and primary care providers. There was adequate flu vaccine this year and no shortages expected.

As the health officer, I was called upon to assist an elderly resident with her medication regime for 4 months until other arrangements could be made.

One violation of health statutes was brought to my attention in January, 2011. A complaint was made against a local convenience store serving food regarding the presence of a cat. The state statutes were provided to the vendors and the cat was removed from the premises. All other potential complaints that came to my attention were resolved without my involvement. One concern was related to dog waste present at Dead Duck Boat Landing. I would like to remind all Eliot residents that it is part of the town ordinances that all dog owners are responsible for cleaning up their dog's waste whether it be on the road or in a park.

In an effort to promote walking in Eliot and to keep residents safe while on the roads, reflective armbands were made available for free at the town hall and at a local fast food restaurant. A number of light bands and flashlights were also distributed at the Halloween party at the Elementary School.

During the town meeting, in an effort to address potential budget shortfalls, I offered to serve the community on a volunteer basis. This was rejected, however my pay was reduced to \$200.00/year (an \$800.00 savings) so I remain a paid employee with appropriate coverage.

I look forward to a healthy 2011/2012 and encourage all Eliot residents to take advantage of the beautiful surroundings in the town for walking, running, biking and other physical activities.

REPORT OF THE SOLID WASTE/RECYCLING COMMITTEE

The Solid Waste / Recycling Committee has undergone some changes in the past year. Bill Shapleigh has retired as Road Commissioner and stepped down from the committee. Joel Moulton (*was hired as the Public Works Director*) and Donald Webber both have joined the committee.

Residents of Eliot generate 2,000,000 pounds of trash a year. Yes, that is a "2" followed by 6 zeroes. (*Which equals approximately to a \$75,000.00 expenditure in your tax dollars for disposal of the Towns Municipal Solid Waste*). Both the Public Works Department and the Committee feel you as residents **can do better.**

The Department and committee propose the following solutions to help reduce expenditures:

- 1) Transfer Station employees *are available to assist* all residents to better understand what can be recycled as well as enforcing compliance with current recycling requirements. *If you are not sure of what can be recycled please inquire with an attendant.*
- 2) Review of current signage *and recycling literature* at the Transfer Station followed by improvements where necessary.
- 3) Development of ongoing training programs to better educate the residents of Eliot.

The *department and committee* hope that all residents will support these efforts. Please do your part to help reduce the cost of operating the Transfer Station by removing all recyclable materials from your trash. This reduces the cost of trash disposal and increases the revenue generated from sale of our recycled materials *which helps off set the operating cost of the facility.* The intent of the department and committee is to try to level fund the operation of the Transfer Station and reduce the tax burden for the operational costs of the facility.

The intent of the stepped up enforcement and mandatory recycling is to reduce the volume of trash being generated, so not to be forced to go to a pay-to-throw system where residents pay a fee for each bag of trash that is brought to the Transfer Station to offset disposal costs. The committee hopes that through community wide support of current recycling requirements, we can avoid the need for a pay-to-throw system.

REPORT OF THE BUDGET COMMITTEE 2011-2012

The Budget Committee is a group independently elected to review the various municipal department budgets from the point of view of the taxpayers. The committee serves as an advisory body to all the citizens of Eliot, especially those who show up to vote on the budget warrant articles at Town Meeting.

Again, we are very concerned about another large rise in the municipal spending plan proposed for Eliot by the Board of Selectmen, this year increasing by some \$555,291 or 13.1% over last year.

We realize that part of this stems from a proposal to restore and rebuild the town's road infrastructure and recommend that this should have a high priority, but be spread over a reasonable timeframe. The need for this work should be a wakeup call for us to prioritize our spending and trim expenses elsewhere in the budget.

\$103,000 of this proposed budget rise is due to a 17.6% increase over last year in fringe benefits for union and non-union employees... we recommend the administration work seriously on the problem of spiraling retirement and health insurance costs to the town, instead of just passing them on to the taxpayer each year, else we may need to reduce personnel and services.

Note that the budget also relies on a projected \$100,000 (8.7%) increase in excise tax and other income- if this money does not come in, the cash reserve in our undesignated fund balance (UFB), from which the town pays its bills, will be further reduced from its already depleted state.

The committee recommends a \$230,556 reduction in the BOS spending plan as reflected in the following department budget warrant articles:

#4	town administration	\$ 16,000
#6	police department	\$ 13,724
#8	cruiser reserve	\$ 15,000
#10	fire department, compensation	\$ 12,667
#13	highway department	\$ 73,165

also, in four designated reserve fund warrant articles:

In this continuing strained economic climate, we believe it is NOT prudent to withdraw the proposed \$100,000 from the UFB (almost 10% out of the town's projected balance) to fund four of the designated reserves this year. Revenue from current taxes or other income should be used to fund these reserves. If we want to allocate money to designated reserve funds and do not have the money, it is time to reduce other spending or defer to next year.

Although these recommendations do not get the budget expense to our goal of level funding for this year, the committee feels this would reasonably provide for the function and services of the town and move Eliot toward a more financially sound position, while limiting our citizens' ever-increasing property tax burden.

The Budget Committee has for some years recommended that warrant articles reflect the true cost of each department's total operating budget, including *all* salaries and fringe benefits, so that citizens at Town Meeting can have a clear understanding of each part of the budget on which they are voting. Again this year, base payroll cost *is* listed by department in the warrants -- however, fringe benefits including FICA, Medicare, health insurance, and retirement costs are still not included in the warrant article \$ total. These employee benefit costs are significant, 18% of this year's increase, and are included by department, in the 44th warrant article.

The Budget Committee will hold a public informational meeting at the Town Hall on Monday, June 13, 2011 at 7:00pm.

Your Town Meeting is at the Marshwood Middle School on Saturday, June 18, 2011 at 6:30pm.

As of June 30, 2010 there were 5,598 registered voters in the Town of Eliot. With the combination of additions and deletions to the voter list between July and June, we had an increase of 83 voters from the previous year. Of the 5,598 registered voters 2,238 voters were not enrolled in a political party, 1,703 were enrolled as Republicans, 1,543 were enrolled as Democrats and 114 were enrolled in the Green Independent Party.

Any resident may register to vote at the Town Clerk's Office during normal business hours. It is required that proof of identity as well as proof of residency be shown at the time of registration. You may also register to vote at the Registrar's table on Town Meeting/Election Day with the appropriate identification and residency requirements.

I would like to take this opportunity to thank all of my Deputy Registrars and Election Workers for their continued willingness to support me with such an important part of Eliot's Municipal Government. The support I receive from these dedicated individuals allows me to prepare and execute an election with confidence.

The Staff in the Clerk's office is fully trained through Maine Municipal Association and State Department sponsored trainings so that we can assist you with all of your needs. It is always our goal to offer the most efficient customer service possible whether in the office or through an online service that we have chosen to participate in. We are always looking for ways to improve upon our existing services and welcome any suggestions.

For those residents who are computer savvy be sure to check out the Clerk's Page of the Municipal Website (www.eliotmaine.org), this is where you will find the various links to the online services offered to our residents. IF & W Online Boat Registration Renewal System, the newest online service introduced in 2008 that allows our boating enthusiasts to renew boat registrations online has proven to be a great addition to Eliot's online services. Between July 2009 and June 2010, forty five boat registrations were renewed online by our residents and I anticipate that with each boating season that number will increase.

The Clerk's Office and Board of Selectmen are still actively investigating the acceptance of debit and credit cards for payment of the various transactions processed in the office. This is a service that many have asked for in recent years. Recent law changes allow government entities to process debit and credit card payments without losing revenue from the budget by assessing the fees back to the user. We are currently running a survey to get feedback from our residents to see if there is enough interest to move forward. The survey and drop box for collection can be found in the front lobby of the Town Office.

On September 7, 2009 Eliot lost Bruce P. Trott, a truly dedicated public servant to the Town of Eliot. Bruce served in many capacities over the years and was a

frequent face seen here at "Town Hall". Bruce was a huge support to me over the years especially when I first became Town Clerk in 2004. His words of support and encouragement to me such as "you can do it kid" are missed but will never be forgotten.

I would like to take this opportunity to thank Pat Levesque, Sheila Hatch and Brenda Harvey, an extremely dedicated team that I am proud to work side by side with. I would also like to thank my "Co-Workers" in all other Town Departments and the many volunteer Board and Committee members for their dedication to serving the great Town of Eliot and making it the "gem" that it is.

A late fee of \$25.00 will be assessed on any dog that is licensed after January 31st. The new licenses arrive from the State and can start being issued for the following year on October 15th, so register early to avoid the late fee.
